Convergence rate for random walk approximations of mean field BSDEs

Abstract

We study the rate of convergence w.r.t. a Wasserstein type distance for random walk approximation of mean field BSDEs. This article continuous [BGGL21], where the rate of convergence of a Donsker-type theorem for standard BSDEs is studied.

1 Introduction

In this article we fix $0 \le t_o < T$ and assume a stochastic basis $(\Omega, \mathcal{F}, \mathbb{P}, (\mathcal{F}_s)_{s \in [t_o, T]})$, satisfying the usual conditions, carrying a one-dimensional standard Brownian motion $B = (B_s)_{s \in [t_o, T]}$ starting identically at zero, such that \mathcal{F}_{t_0} and B are independent and $\mathcal{F}_s = \mathcal{F}_{t_0} \lor \sigma(B_r - B_{t_0})$: $r \in [t_o, s]$, and assume $\mathcal{F} = \mathcal{F}_T$. We are concerned with the discretization of solutions to mean field BSDEs of the form

$$Y_{s}^{t,x} = g\left(B_{T}^{t,x}\right) + \int_{s}^{T} f\left(r, B_{r}^{t,x}, Y_{r}^{t,x}, Z_{r}^{t,x}, [Y_{r}^{t_{o},\xi}], [Z_{r}^{t_{o},\xi}]\right) dr$$

$$- \int_{s}^{T} Z_{r}^{t,x} dB_{r}, \qquad t_{o} \leq t \leq s \leq T, \qquad (1.1)$$

for

$$(t_o, \xi) \in [0, T] \times L^{2\varepsilon}(\Omega, \mathcal{F}_{t_o}, \mathbb{P})$$
 under Assumption 2.2.

So, the process $B_r^{t,x} := x + B_r - B_t$, $t \le r \le T$ is a Brownian motion starting at time t in $x \in \mathbb{R}$. The notation $[\eta]$ will stand for the law of the random variable η . As generators we consider maps

$$f: \Omega \times [t_o, T[\times \mathbb{R} \times \mathbb{R} \times \mathcal{P}_2(\mathbb{R}) \times \mathcal{P}_2(\mathbb{R}) \to \mathbb{R}.$$

The set $\mathcal{P}_2(\mathbb{R})$ is the set of probability measures with a finite second-order moment, endowed with the Wasserstein distance i.e.

$$\mathcal{W}_2(\mu, \mu') := \inf_{\pi} \left(\int_{\mathbb{R}^d \times \mathbb{R}^d} |x - x'|^2 d\pi(x, x') \right)^{1/2}$$

for $(\mu, \mu') \in \mathcal{P}_2(\mathbb{R}) \times \mathcal{P}_2(\mathbb{R})$, the infimum being taken over the probability distributions π on $\mathbb{R} \times \mathbb{R}$ whose marginals on \mathbb{R} are respectively μ and μ' . Notice that if X and X' are random variables of order 2 with values in \mathbb{R} and defined on the same probability space, then by definition we have

$$W_2([X], [X']) \le \left[\mathbb{E}|X - X'|^2 \right]^{1/2}.$$
 (1.2)

Moreover, $(Y^{t_o,\xi}, Z^{t_o,\xi})$ solves (1.1) with (t,x) replaced by (t_o,ξ) . The assumptions on g and f will be specified below.

Mean field BSDEs (also called McKean-Vlasov BSDEs) have been introduced in [BDLP07] and [BLP07] in a more particular framework: in [BDLP07], the authors study the mean field problem in a Markovian setting and prove the existence and the uniqueness of the solution when the terminal condition is of type $\eta = \mathbb{E}[g(x, X_T)]_{|x=X_T}$ where X is a driving adapted stochastic process, and the generator is defined by $\mathbb{E}[f(s, \lambda, \Lambda_s)]_{|\lambda=\Lambda_s}$ where $\Lambda_s = (X_s, Y_s, Z_s)$. In [BLP07], the authors extend the result of existence and uniqueness to a more general framework and link the mean field BSDE to non local partial differential equation.

Mean field forward BSDEs (mean field FBSDEs in the following) arise naturally in the probabilistic analysis of mean field games or mean field control problems. Mean field games are introduced by [LL06a] and [LL06b] to model games with interactions between many similar players. In this theory, each player's dynamics and cost take into account the empirical distribution of all agents. For example, in [AD19], the authors model pedestrian crowd by using a mean field game approach and solve the problem with a mean field FBSDE. Optimal control problems of mean field type can be interpreted as large population limits of cooperative games, where the players collaborate to optimize a joint objective [Lac17]. For example, in [AC21], the authors solve an optimal portfolio with mean field risk minimization problem. It is therefore a relevant challenge to solve such equations numerically.

Numerical methods for mean field FBSDEs are of natural interest already for some time (see [Ala15], [CT15], [CCD19]). Usually, forward McKean-Vlasov SDEs are solved by using particle algorithms (see for example [AKH02], [TV03], [Bos15]) in which the McKean-Vlasov term is approximated by the empirical measure of a large number of interacting particles with independent noise. Adapting such algorithms to the backward problem is not obvious as the high dimension of the involved Brownian motion (given by the number of particles) induces, a priori, a high dimension backward problem with negative consequences for the numerical implementation. The above mentioned papers on numerical methods for mean field FBSDEs do not use particle systems. In [CT15], the authors present a cubature method for decoupled mean field FBSDE. In [CCD19], the authors consider the case of strongly coupled mean field FBSDE. They propose a scheme whose principle is to implement recursively Picard iterations on small time intervals. The scheme is based on a variation of the method of continuation. In [GMW22], the authors propose several algorithms to solve mean field FBSDEs based on neural networks to estimate the solution or its gradient through minimization problems. We also refer to [CCSJ21], [FZ20] and [HHL23] for other papers based on deep learning methods. In [ABGL22] the authors solve non Markovian mean field BSDEs by using Wiener chaos expansion and particle system approximation. In [ZM23], the authors propose first order and Crank-Nicholson numerical schemes to solve certain kinds of mean field BSDEs. They provide L^p error estimates for the proposed schemes.

In this work we propose to approximate the solution $(Y^{t,x}, Z^{t,x})$ to (1.1) using a scaled random walk. For $n \in \mathbb{N} := \{1, 2, 3, ...\}$ we set $h := \frac{T}{n}$ and we consider for $t_k := kh, \ k = 0, 1, ..., n$, the scaled random walk

$$B_{t_k}^n := \sqrt{h} \sum_{m=1}^k \zeta_m,$$

where $(\zeta_k)_{k\geq 1}$ is an i.i.d. sequence of Rademacher random variables. One of the first studies on the approximation of standard BSDEs (i.e. f may depend on Y and Z, but not on their laws) by a random walk scheme is due to Briand, Delyon and Mémin in [BDM01]. They

proposed an approximation based on Donsker's theorem. They showed that the solution (Y, Z) to a standard BSDE can be approximated by the solution (Y^n, Z^n) to the BSDE

$$Y_t^n = G(B^n) + \int_{]t,T]} f(B_{s-}^n, Y_{s-}^n, Z_s^n) \, d\langle B^n \rangle_s + \int_{]t,T]} Z_s^n \, dB_s^n, \quad 0 \le t \le T.$$

where

$$B^n_t := B^n_t \quad \text{for } t \in [0,T], \quad \text{where} \quad \underline{t} := \max \left\{ t_k \mid k \in \{0,...,n\} \right. \text{ and } t \geq t_k \right\}$$

and the quadratic variation of $(B_t^n)_{t\in[0,T]}$ is deterministic and it holds

$$\langle B^n \rangle_s = h \sum_{k=1}^n \delta_{t_k}((0,s]).$$

They proved, in full generality (meaning that G(B) is only required to be a square integrable random variable) that (Y^n, Z^n) converges weakly to (Y, Z). However, the question of the rate of convergence was left open. For general path-dependent terminal conditions G(B) this question is open, the Markovian case $G(B) = g(B_T)$ has been studied in [BGGL21]: Assuming Assumption 2.3 without the singularity $(T - t \vee t')^{-\frac{1}{2}}$ it was shown in [BGGL21, Theorem 12] that

$$\mathcal{W}_p\left(Y_s^{t,x}, Y_s^{n,t,x}\right) \le c_{(1.3)} \left(1 + |x|\right)^{\varepsilon} n^{-\alpha \wedge \frac{\varepsilon}{2}},\tag{1.3}$$

$$\mathcal{W}_p\left(Z_s^{t,x}, Z_s^{n,t,x}\right) \le c_{(1.4)} \frac{(1+|x|)^{\varepsilon}}{\sqrt{T-s}} n^{-\alpha \wedge \frac{\varepsilon}{2}} \tag{1.4}$$

for any $p \in [1, \infty[$ and constants $c_{(1.3)}, c_{(1.4)} > 0$ depending at most on $(T, \varepsilon, \alpha, f, g, p)$. This result exploits the PDE structure behind the Markovian case and a result of Emmanuel Rio [Ri09] which directly implies that there exists a constant $c_p > 0$ such that $\mathcal{W}_p(B_1^n, \mathcal{G}) \le c_p n^{-1/2}$ for $n \ge 1$ and $p \ge 1$, when \mathcal{G} is a standard Gaussian random variable. The rate in (1.3) and (1.4) improve [GLL20a] and [GLL20b], where the L_2 distance was studied which resulted in an order of $n^{-1/4}$ for smooth coefficients.

In this paper we aim at extending the result obtained in [BGGL21] to the case of mean field BSDEs of type (1.1). Our random walk approximation of (1.1) can be written for $t \ge t_o$ as

$$Y_{s}^{n,\underline{t},x} = g(B_{T}^{n,\underline{t},x}) + \int_{]s,T]} f(r \wedge t_{n-1}, B_{r}^{n,\underline{t},x}, Y_{r}^{n,\underline{t},x}, Z_{r}^{n,\underline{t},x}, [Y_{r}^{n,t_{o},\xi}], [Z_{r}^{n,t_{o},\xi}]) d\langle B^{n} \rangle_{r}$$

$$- \int_{]s,T]} Z_{r}^{n,\underline{t},x} dB_{r}^{n}, \quad s \in [\underline{t},T].$$

$$(1.5)$$

where we put, for $x \in \mathbb{R}$ and $0 \le t \le s \le T$,

$$B_s^{n,t,x} := x + B_s^n - B_t^n.$$

(We use $r \wedge t_{n-1}$ for f because it is defined on $[t_o, T[\times \mathbb{R} \times \mathbb{R} \times \mathbb{R} \times \mathcal{P}_2(\mathbb{R}) \times \mathcal{P}_2(\mathbb{R}) \to \mathbb{R}$ only.) We aim to estimate the error between $(Y^{t,x}, Z^{t,x})$ and $(Y^{n,t,x}, Z^{n,t,x})$ under a suitable distance. We refer to Theorem 1.1 for a precise statement. To study this error we introduce

$$f_n(r, x, y, z) := f(r \wedge t_{n-1}, x, y, z, [Y_r^{t_o, \xi}], [Z_{r \wedge t_{n-1}}^{t_o, \xi}])$$
(1.6)

and freezing the distributions $[Y_s^{t_o,\xi}]$ and $[Z_{s\wedge t_{n-1}}^{t_o,\xi}]$ we consider the BSDEs driven by a Brownian motion (for $s\in[t,T]$)

$$Y_{\mathsf{f}_{n},s}^{t,x} = g\left(B_{T}^{t,x}\right) + \int_{s}^{T} \mathsf{f}_{n}\left(r, B_{r}^{t,x}, Y_{\mathsf{f}_{n},r}^{t,x}, Z_{\mathsf{f}_{n},r}^{t,x}\right) dr - \int_{s}^{T} Z_{\mathsf{f}_{n},r}^{t,x} dB_{r},\tag{1.7}$$

and by a random walk (for $s \in [\underline{t}, T]$)

$$Y_{\mathsf{f}_n,s}^{n,\underline{t},x} = g(B_T^{n,t,x}) + \int_{]s,T]} \mathsf{f}_n(r,B_{r^-}^{n,t,x},Y_{\mathsf{f}_n,r^-}^{n,\underline{t},x},Z_{\mathsf{f}_n,r}^{n,\underline{t},x}) \, d\langle B^n \rangle_r - \int_{]s,T]} Z_{\mathsf{f}_n,r}^{n,\underline{t},x} \, dB_r^n. \tag{1.8}$$

Then we split our problem into three steps by introducing $(Y_{\mathsf{f}_n,s}^{t,x},Z_{\mathsf{f}_n,s}^{t,x})$ and $(Y_{\mathsf{f}_n,s}^{n,\underline{t},x},Z_{\mathsf{f}_n,s}^{n,\underline{t},x})$ into the study of the error:

$$\operatorname{error}((Y^{t,x}, Z^{t,x}), (Y^{n,t,x}, Z^{n,t,x})) \leq \operatorname{error}((Y^{t,x}, Z^{t,x}), (Y^{t,x}_{\mathsf{f}_n}, Z^{t,x}_{\mathsf{f}_n})) \\
+ \operatorname{error}((Y^{t,x}_{\mathsf{f}_n}, Z^{t,x}_{\mathsf{f}_n}), (Y^{n,\underline{t},x}_{\mathsf{f}_n}, Z^{n,\underline{t},x}_{\mathsf{f}_n})) \\
+ \operatorname{error}((Y^{n,\underline{t},x}_{\mathsf{f}_n}, Z^{n,\underline{t},x}_{\mathsf{f}_n}), (Y^{n,\underline{t},x}, Z^{n,\underline{t},x})).$$
(1.9)

Besides that we are in the mean field setting and have to handle the approximation of the mean field terms in parallel to the classical terms, there is another problem with the above splitting: Although we can interpret (1.7) and (1.8) as the classical setting without mean field terms, in order to estimate the corresponding $\operatorname{error}((Y_{\mathsf{f}_n}^{t,x},Z_{\mathsf{f}_n}^{t,x}),(Y_{\mathsf{f}_n}^{n,\underline{t},x},Z_{\mathsf{f}_n}^{n,\underline{t},x}))$ we cannot use the estimate (1.4) because the singularity in time (if squared) is not integrable. We will therefore prove a new version of [BGGL21, Theorem 12] (especially a new version of (1.4)) in Lemma 7.6 where the convergence rate and the singularity are connected.

Now we formulate the main result, the convergence rate for the distributions on the path space in Wasserstein sense. Let $\Gamma(B, B^n)$ denote the set of all the processes $(\mathcal{B}, \mathcal{B}^n)$ with \mathcal{B} continuous and \mathcal{B}^n being càdlàg that have the same finite dimensional distributions as B and B^n , respectively.

Theorem 1.1. Suppose that Assumption 2.2 holds. Then for any $p \geq 2$ and $\beta > \frac{1}{2}$ there is a constant $c = c(T, \varepsilon, \alpha, \beta, |g|_{\varepsilon}, |f|_{\alpha;t}^{loc}, |f|_{\varepsilon;x}, L_f, c_{f_0}^{(2)}, f_0, \xi) > 0$ such that for all $n \geq n_0$,

$$\inf \left\{ \left(\mathbb{E} \sup_{s \in [t,T]} \left| \mathcal{Y}_s^{t,x} - \mathcal{Y}_s^{n,t,x} \right|^p + \mathbb{E} \left(\int_t^T \left| \mathcal{Z}_s^{t,x} - \mathcal{Z}_s^{n,t,x} \right|^2 \mathrm{d}s \right)^{\frac{p}{2}} \right)^{\frac{1}{p}} \right\} \\ \leq c \ p^{\frac{1}{2} \vee (\beta + \varepsilon)} (1 + |x|)^{\varepsilon} \frac{|\log(n+1)|^{\varepsilon + \beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}},$$

where the processes $(\mathcal{Y}^{t,x}, \mathcal{Z}^{t,x})$ and $(\mathcal{Y}^{n,t,x}, \mathcal{Z}^{n,t,x})$ solve (1.1) and (1.5) with driving processes \mathcal{B} and \mathcal{B}^n , respectively, and the infimum is taken over all $(\mathcal{B}, \mathcal{B}^n) \in \Gamma(B, B^n)$.

The proof and a local version (Theorem 8.1) of Theorem 1.1 will be given in Section 8.

The article is organized as follows: Section 2 introduces the notation and assumptions. In Section 3 we recall facts about function spaces describing an exponential tail behaviour. Section 4 states results on the random walk approximation of the Brownian motion. Regularity properties of u and ∇u (where u represents the solution of the PDE associated to the standard BSDE) are proven in Section 5. After recalling the discrete scheme in Section 6, we establish in Section 7 the convergence rates of the three error terms introduced in (1.9). Section 8 contains the proof of Theorem 1.1, but also the more general version Theorem 8.1 which can be applied to any coupling (B, B^n) of the Brownian motion with the random walk.

2 Notation and assumptions

If E is a metric space and $1 \leq p < \infty$, then $\mathcal{P}_p(E)$ will denote the space of probability measures on $(E, \mathcal{B}(E))$ with finite pth moment.

Definition 2.1. For $p \geq 1$ and $\mu, \mu' \in \mathcal{P}_p(\mathbb{R})$ we introduce the *p*-Wasserstein distance $\mathcal{W}_p(\mu, \mu')$ by setting

$$\mathcal{W}_p(\mu, \mu') := \inf_{\gamma \in \Gamma(\mu, \mu')} \left(\int_{\mathbb{R}^2} |x - y|^p \gamma(dx, dy) \right)^{\frac{1}{p}},$$

where $\Gamma(\mu, \mu')$ is the set of all probability measures on $\mathcal{P}_p(\mathbb{R}^2)$ with marginals μ and μ' .

Assumption 2.2. There exist $0 < \varepsilon \le 1$ and $0 < \alpha \le 1$ such that it holds:

(i) The function $g: \mathbb{R} \to \mathbb{R}$ is ε -Hölder continuous: for all $(x, x') \in \mathbb{R}^2$ one has

$$\left|g(x)-g\left(x'\right)\right| \leq |g|_{\varepsilon} \left|x-x'\right|^{\varepsilon}, \quad where \quad |g|_{\varepsilon}:=\sup_{x\neq y} \frac{\left|g(x)-g(y)\right|}{\left|x-y\right|^{\varepsilon}}.$$

(ii) The function $f:[t_o,T[\times\mathbb{R}\times\mathbb{R}\times\mathbb{R}\times\mathcal{P}_2(\mathbb{R})\times\mathcal{P}_2(\mathbb{R})\to\mathbb{R}]$ is locally α -Hölder continuous in time, ε -Hölder continuous in space and Lipschitz continuous with respect to (y,z,μ,ν) : for all (t,x,y,z,μ,ν) and (t',x',y',z',μ',ν') in $[t_o,T[\times\mathbb{R}\times\mathbb{R}\times\mathbb{R}\times\mathcal{P}_2(\mathbb{R})\times\mathcal{P}_2(\mathbb{R})]$ one has

$$\begin{aligned}
|f(t,x,y,z,\mu,\nu) - f(t',x',y',z',\mu',\nu')| \\
&\leq |f|_{\alpha;t}^{loc} \frac{|t-t'|^{\alpha}}{(T-t\vee t')^{\frac{1}{2}}} + |f|_{\varepsilon;x} |x-x'|^{\varepsilon} \\
&+ L_{f}(|y-y'| + |z-z'| + \mathcal{W}_{2}(\mu,\mu') + \mathcal{W}_{2}(\nu,\nu')).
\end{aligned} (2.1)$$

(iii) One has $\int_{t_0}^T |f(t,0,0,0,\delta_0,\delta_0)|^2 dt < \infty$.

Under Assumption 2.2 there exists a unique solution $(Y^{t_o,\xi}, Z^{t_o,\xi})$ to

$$Y_s^{t_o,\xi} = g\left(B_T^{t_o,\xi}\right) + \int_s^T f\left(r, B_r^{t_o,\xi}, Y_r^{t_o,\xi}, Z_r^{t_o,\xi}, [Y_r^{t_o,\xi}], [Z_r^{t_o,\xi}]\right) dr - \int_s^T Z_r^{t_o,\xi} dB_r,$$

$$t_o \le s \le T,$$
(2.2)

see [Li18, Theorem A.1]. In Section 5.1 we consider generators with frozen measure components, that is, generators of the type $f:[t_o,T[\times\mathbb{R}\times\mathbb{R}\times\mathbb{R}\to\mathbb{R}])$. For clarity, we rephrase Assumption 2.2 for these generators:

Assumption 2.3. There exist $0 < \varepsilon \le 1$ and $0 < \alpha \le 1$ such that Assumption 2.2(i) holds and the generator $f: [t_o, T] \times \mathbb{R} \times \mathbb{R} \to \mathbb{R}$ satisfies

$$\left| \mathsf{f}(t,x,y,z) - \mathsf{f}(t',x',y',z') \right| \le \left| \mathsf{f} \right|_{\alpha \wedge \frac{\varepsilon}{2};t}^{loc} \frac{\left| t - t' \right|^{\alpha \wedge \frac{\varepsilon}{2}}}{(T - t \vee t')^{\frac{1}{2}}} + \left| \mathsf{f} \right|_{\varepsilon;x} \left| x - x' \right|^{\varepsilon} + L_{\mathsf{f}} \left(\left| y - y' \right| + \left| z - z' \right| \right)$$

$$\tag{2.3}$$

for all $(t, x, y, z), (t', x', y', z') \in [t_o, T] \times \mathbb{R} \times \mathbb{R} \times \mathbb{R}$.

Remark 2.4. Although global Hölder continuity in time for the generator was assumed in [BGGL21], the results can still be proved under local Hölder continuity given in (2.3). We will discuss the necessary changes in Section 7.2.

We collect the notation we use in the sequel:

Remark 2.5. We will use $n \ge n_0(T, L_f, t_o)$ in the sequel. In particular, this ensures $n_0 > TL_f$, so that we have a unique solution to (1.5) and (1.8) (see [BDM01]). Our assumption on n_0 also guarantees the requirements for Lemma 7.5 (that generalizes [BGGL21, Lemma 14]) and that $t_{n-1} > t_o$.

3 The function spaces M_{φ}

We assume an increasing bijection $\psi:[1,\infty)\to[1,\infty)$ and define for a random variable $f:\Omega\to\mathbb{R}$ the quantity

$$|f|_{M_{\varphi}^0} := \inf \left\{ c > 0 : \mathbb{P}(|f| > \lambda) \le e^{1 - \psi(\lambda/c)} \text{ for } \lambda \ge c \right\} \quad \text{for} \quad \varphi(t) := \frac{1}{\psi^{-1}(1 + \log(1/t))}.$$

As particular functions we consider

$$\psi_{\gamma}(x) := x^{\gamma} \quad \text{and} \quad \varphi_{\gamma}(t) := \frac{1}{\sqrt[\gamma]{(1 + \log(1/t))}} \quad \text{for} \quad \gamma \in [1, \infty).$$

We will use the following two statements:

Lemma 3.1 ([Gei97, Lemma 5.2]). If there is an a > 1 such that

$$\inf_{\lambda \ge 1} \frac{\psi(a\lambda)}{\psi(\lambda)} > 1,$$

then one has

$$\left| \sup_{1 \le i \le N} \frac{|f_i|}{\psi^{-1} (1 + \log i)} \right|_{M_{\varphi}^0} \le c_{(3.1)} \sup_{1 \le i \le N} |f_i|_{M_{\varphi}^0}$$
 (3.1)

for all random variables $f_1, \ldots, f_N : \Omega \to \mathbb{R}$ on some probability space $(\Omega, \mathcal{F}, \mathbb{P})$, where $c_{(3.1)} = c_{(3.1)}(\varphi) > 0$.

Lemma 3.2 ([GG24, Section 18.3]). For $\gamma \in [1, \infty)$ there is a constant $c_{(3.2)} = c_{(3.2)}(\gamma) \ge 1$ such that

$$\frac{1}{c_{(3.2)}} |f|_{M_{\varphi\gamma}^0} \le \sup_{p \in [1,\infty)} \frac{||f||_{L^p}}{\sqrt[q]{p}} \le c_{(3.2)} |f|_{M_{\varphi\gamma}^0}. \tag{3.2}$$

We will use the Hoeffding inequality [Hoe63] (see also [GG24, Section 7.12.4]) that says in the language of this section that

$$\sup_{n \in \mathbb{N}} \left\| \frac{\zeta_1 + \dots + \zeta_n}{\sqrt{n}} \right\|_{M_{\varphi_2}^0} < \infty, \tag{3.3}$$

where $(\zeta_k)_{k\geq 1}$ is an i.i.d. sequence of Rademacher random variables.

4 Random walk approximation of the Brownian motion

One direction of the following result is based on a result of J. Komlós, P. Major and G. Tusnády [KMT75, Theorem 1] which states (for the special case of Rademacher random variables we consider here) that if $(g_i)_{i=1}^{\infty}$ are i.i.d. standard Gaussian random variables, then there is a sequence of Borel functions $f_n : \mathbb{R}^{2n} \to \mathbb{R}$, $n \in \mathbb{N}$, such that

$$(\zeta_n)_{n\in\mathbb{N}} := (f_n(g_1, g_2, ..., g_{2n}))_{n\in\mathbb{N}}$$

are independent Rademacher variables and it holds for $S_k := \sum_{j=1}^k \zeta_j$ and $T_k := \sum_{j=1}^k g_j$, that

$$\mathbb{P}\left(\sup_{1\leq k\leq n}|S_k - T_k| > C_{(4.1)}\log n + x\right) \leq K_{(4.1)}e^{-\lambda_{(4.1)}x} \quad \text{for} \quad x > 0 \text{ and } n \geq 1,$$
 (4.1)

where $C_{(4.1)}, K_{(4.1)}, \lambda_{(4.1)} > 0$ are constants. We also need the following relations:

Lemma 4.1 ([GG24, Theorem 18.2.11, Example 18.2.14], [Gei97, Lemma 5.2]).

(i) For $p \in [1, \infty)$ there exists a constant $c_{(4.2),p} > 0$ such that

$$\left\| \sup_{1 \le k \le n} |g_k| \right\|_{L^p} \ge \frac{1}{c_{(4.2),p}} \sqrt{\log(n+1)} \tag{4.2}$$

for all $n \in \mathbb{N}$ and i.i.d. standard Gaussian random variables g_1, \ldots, g_n .

(ii) Assume $\alpha \in (0, \infty)$ to be fixed and i.i.d. random variables h_1, \ldots, h_n such that $||h_1||_{L^q} \le \sqrt[q]{q}$ for $q \in [1, \infty)$. Then for $p \in [1, \infty)$ one has

$$\left\| \sup_{1 \le k \le n} |h_k| \right\|_{L^p} \le c_{(4.3)} \sqrt[\alpha]{p} \sqrt[\alpha]{\log(n+1)} \tag{4.3}$$

with $c_{(4,3)} = c_{(4,3)}(\alpha) > 0$.

The following theorem gives the path-wise convergence rate for the random walk approximation.

Theorem 4.2. There is a constant $c_{(4.4)} = c_{(4.4)}(T) > 0$ such that for all $p \in [1, \infty)$ and $n \in \mathbb{N}$ it holds that

$$\frac{1}{2}\sqrt{\frac{T}{2n}}\frac{1}{c_{(4.2),p}}\sqrt{\log(n+1)} \le \inf_{(\mathcal{B},\mathcal{B}^n)\in\Gamma(B,B^n)} \left\{ \left(\mathbb{E}\sup_{t\in[0,T]} |\mathcal{B}_t - \mathcal{B}_t^n|^p\right)^{\frac{1}{p}} \right\} < c_{(4.4)} p \frac{\log(n+1)}{n^{\frac{1}{2}}}.$$
(4.4)

Proof. For the <u>lower bound</u> we observe that

$$\left(\mathbb{E} \sup_{t \in [0,T]} |B_t - B_t^n|^p\right)^{1/p} \\
\geq \left\| \sup_{m=1,\dots,n-1} \left| \sqrt{\frac{T}{n}} \sum_{k=1}^m \zeta_k - B_{\frac{2mT}{2n}} \right| \vee \left| \sqrt{\frac{T}{n}} \sum_{k=1}^m \zeta_k - B_{\frac{(2m+1)T}{2n}} \right| \right\|_{L^p} \\
\geq \sqrt{\frac{T}{n}} \left\| \sup_{m=1,\dots,n-1} \left| \sum_{k=1}^m \zeta_k - \sum_{k=1}^{2m} \frac{1}{\sqrt{2}} g_k \right| \vee \left| \sum_{k=1}^m \zeta_k - \sum_{k=1}^{2m+1} \frac{1}{\sqrt{2}} g_k \right| \right\|_{L^p} \\
\geq \frac{1}{2} \sqrt{\frac{T}{2n}} \left\| \sup_{k=1,\dots,n-1} |g_k| \right\|_{L^p} \\
\geq \frac{1}{2} \sqrt{\frac{T}{2n}} \frac{1}{c_{(4,2),n}} \sqrt{\log(n+1)},$$

where we used that $\inf_{a\in\mathbb{R}}(|a|\vee|a-b|)\geq \frac{1}{2}|b|$ for any $b\in\mathbb{R}$, while the last inequality follows from Lemma 4.1.

Upper bound: We may assume $n \geq 2$. We put $(\Omega', \mathcal{F}', \mathbb{P}') := (\Omega, \mathcal{F}, \mathbb{P}) \otimes (\Omega, \mathcal{F}, \mathbb{P})$. Then $(\Omega', \mathcal{F}', \mathbb{P}')$ carries a Brownian motion $(B_t)_{t \in [0,2T]}$. We choose $n \in \mathbb{N}$ and put $t_k = k \frac{T}{n}$, k = 0, 1, ..., 2n. This provides us with the 2n i.i.d. Gaussian random variables

$$(B_{t_k} - B_{t_{k-1}})_{k=1}^{2n}$$

from which the $\zeta_1,...,\zeta_n$ can be constructed following [KMT75, Theorem 1]. Then for $(B^n_t)_{t\in[0,T]}$ as defined above with $B^n_{t_k}=\sqrt{h}\sum_{m=1}^k\zeta_m$ we have

$$\begin{split} \sup_{t \in [0,T]} |B_t - B_t^n|^p &= \left(\max_{1 \le k \le n} \sup_{t \in [t_{k-1},t_k)} |B_t - B_{t_{k-1}}^n|^p \right) \vee |B_{t_n} - B_{t_n}^n|^p \\ &\leq 2^{p-1} \left(\max_{1 \le k \le n} \sup_{t \in [t_{k-1},t_k)} (|B_t - B_{t_{k-1}}|^p + |B_{t_{k-1}} - B_{t_{k-1}}^n|^p) \right) \vee |B_{t_n} - B_{t_n}^n|^p \\ &\leq 2^{p-1} \left(\max_{1 \le k \le n} \sup_{t \in [t_{k-1},t_k)} |B_t - B_{t_{k-1}}|^p + \max_{1 \le k \le n} |B_{t_k} - B_{t_k}^n|^p \right). \end{split}$$

FIRST TERM: Here we prove that

$$\left(\mathbb{E}\max_{1 \le k \le n} \sup_{t \in [t_{k-1}, t_k)} |B_t - B_{t_{k-1}}|^p\right)^{1/p} \le c_{(4.5)} \sqrt{\frac{\log(n+1)}{n}}.$$
(4.5)

To verify this, we define

$$h_k := \sup_{t \in [t_{k-1}, t_k)} |B_t - B_{t_{k-1}}|.$$

The sequence is an i.i.d. sequence of random variables. By definition,

$$\left(\mathbb{E} \max_{1 \le k \le n} \sup_{t \in [t_{k-1}, t_k)} |B_t - B_{t_{k-1}}|^p\right)^{1/p} = \left\|\max_{1 \le k \le n} |h_k|\right\|_{L^p}.$$

By Doob's maximal inequality we get for $q \in [2, \infty)$ that

$$||h_1||_{L^q} \le \frac{q}{q-1}||B_{t_1}||_{L^q} = \frac{q}{q-1}\sqrt{\frac{T}{n}}||B_1||_{L^q} \le \frac{q}{q-1}\sqrt{\frac{T}{n}}\kappa\sqrt{q} \le [2\sqrt{T}\kappa]\sqrt{\frac{q}{n}},$$

where $\kappa > 0$ is an absolute constant. In other words,

$$\|\sqrt{n}h_1\|_{L^q} \le [2\sqrt{T}\kappa]\sqrt{q}.$$

Using (4.3) implies

$$\left\| \max_{1 \le k \le n} \sqrt{n} |h_k| \right\|_{L^p} \le \left[c_{(4.3)} 2\sqrt{T} \kappa \right] \sqrt{p} \sqrt{\log(n+1)}.$$

SECOND TERM: By the inequality (4.1), for $x \ge 1$ and $n \ge 2$, we have for $S_k := \sum_{j=1}^k \zeta_j$ and $T_k := \sum_{j=1}^k \frac{B_{t_j} - B_{t_{j-1}}}{\sqrt{h}}$

$$\mathbb{P}\left(\sup_{1\leq k\leq n}|S_k - T_k| > (C_{(4.1)} + 1)x\log(n+1)\right) \leq \mathbb{P}\left(\sup_{1\leq k\leq n}|S_k - T_k| > C_{(4.1)}\log n + x\right)$$
$$\leq K_{(4.1)}e^{-\lambda_{(4.1)}x}.$$

This is the same as

$$\mathbb{P}\left(\sup_{1\leq k\leq n}\left[\sqrt{n}|B_{t_k}-B_{t_k}^n|\right]>(C_{(4.1)}+1)x\log(n+1)\right)\leq K_{(4.1)}e^{-\lambda_{(4.1)}x}.$$

And this implies that

$$\left\| \sup_{1 \le k \le n} \left[\sqrt{n} |B_{t_k} - B_{t_k}^n| \right] \right\|_{L^p} \le c_{(4.6)} \, p \, \log(n+1) \tag{4.6}$$

with
$$c_{(4.6)} = c_{(4.6)}(C_{(4.1)}, K_{(4.1)}, \lambda_{(4.1)}) > 0.$$

5 Regularity properties of u and ∇u

In this section we generalize some regularity results obtained in [BGGL21]. If $f : [t_o, T[\times \mathbb{R} \times \mathbb{R} \times \mathbb{R} \to \mathbb{R}]$ is a generator satisfying Assumption 2.3, then we define

$$u(t,x) := Y_t^{t,x}.$$

We will use that, a.s.,

$$Y_s^{t,x} = u(s, B_s^{t,x})$$
 and $Z_s^{t,x} = \nabla u(s, B_s^{t,x})$ (5.1)

on [0,T]. For this, we need regularity properties of u(t,x) and $\nabla u(t,x)$.

5.1 Regularity results for the case with frozen mean field terms

In this section we generalize some regularity results obtained in [BGGL21]. Investigating the proof of [BGGL21, Lemma 6] about regularity properties of u(t, x), one can see that the global Hölder continuity of f in time is not used to show regularity properties for u. Therefore, the lemma holds true under Assumption 2.3 as well.

Lemma 5.1 ([BGGL21, Lemma 6]). Under Assumption 2.3 there exists a constant $c_{(5.2)} = c_{(5.2)}(T, \varepsilon, |g|_{\varepsilon}, |f|_{\varepsilon;x}, L_f, c_{f_0}) > 0$ such that for $u(t, x) := Y_t^{t,x}$ and for all $(t, x) \in [t_o, T] \times \mathbb{R}$,

$$|u(t,x)| \le c_{(5.2)} (1+|x|)^{\varepsilon}, \qquad |u(t,\cdot)|_{\varepsilon;x} \le c_{(5.2)}, \qquad |u(\cdot,x)|_{\varepsilon/2;t} \le c_{(5.2)} (1+|x|)^{\varepsilon}. \tag{5.2}$$

We introduce for $\beta > \frac{1}{2}$ the function $\Phi_{\beta} :]0, \infty[\to]0, \infty[$ given by $\Phi_{\beta}(r) := \left(\log\left(\frac{1}{r \wedge \hat{r}}\right)\right)^{\beta}$, with $\hat{r} = e^{-2\beta}$. If $\beta = 0$ we let $\Phi_0 := 1$. We derive some properties of the function Φ_{β} for later use.

Lemma 5.2. Let $\beta > 1/2$ or $\beta = 0$ and $\hat{r} = e^{-2\beta}$. Then:

- (i) Φ_{β} is non-increasing and $\Phi_{\beta}(r) = \left(\log\left(\frac{1}{r\wedge\hat{r}}\right)\right)^{\beta} \geq 1$ for all $r \in]0,\infty[$.
- (ii) The map $]0,\infty[\ni r\mapsto r^a\Phi_{\beta}(r^2)$ is non-decreasing for all $a\geq 1$.
- (iii) $\Psi_{2\beta}(r) := r \left(\log \left(\frac{1}{r \wedge \hat{r}} \right) \right)^{2\beta} = r \Phi_{\beta}(r)^2$ is non-decreasing and concave, and, if $\beta > \frac{1}{2}$, bounded by $\Psi_{2\beta}(\hat{r}) = e^{-2\beta} (2\beta)^{2\beta}$.

Proof. If $\beta = 0$, then all the properties (i)–(iii) are clearly true, so we can focus on the case $\beta > \frac{1}{2}$.

- (i) If $\beta > 1/2$, then it follows that $\left(\log\left(\frac{1}{r}\right)\right)^{\beta} \geq 1$ for all $r \in]0, e^{-2\beta}]$, and obviously Φ_{β} is non-increasing.
- (ii) We see that $r \mapsto r^a \Phi_{\beta}(r^2)$ is non-decreasing for $a \ge 1$ since for $r < \hat{r}$ we have

$$\frac{\mathrm{d}}{\mathrm{d}r} \left(r^a \Phi_{\beta}(r^2) \right) = r^{a-1} \left(\log \left(\frac{1}{r^2} \right) \right)^{\beta - 1} \left(a \log \left(\frac{1}{r^2} \right) - 2\beta \right),$$

which is positive for small r. In fact, $\left(a\log\left(\frac{1}{r^2}\right)-2\beta\right)=0\iff r=e^{-\frac{\beta}{a}}$ implies that the expression on the RHS is positive for all $r\in]0,e^{-\frac{\beta}{a}}[$, but $\hat{r}=e^{-2\beta}.$

(iii) For $r < \hat{r}$ we have

$$\Psi'_{2\beta}(r) = \left(\log\left(\frac{1}{r}\right)\right)^{2\beta-1} \left(\log\left(\frac{1}{r}\right) - 2\beta\right).$$

Hence the RHS is non-negative for all $r \in]0, e^{-2\beta}]$, and one easily checks that $\Psi_{2\beta}'' \leq 0$ for $r \in]0,1[$.

Remark 5.3. By the help of Φ_{β} we achieve and will use square integrability in time since for $\beta > 1/2$ it holds

$$\int_0^T \frac{1}{s|\Phi_{\beta}(s^{\varepsilon})|^2} ds < \infty.$$

We will show regularity properties of ∇u by the help of the following lemma.

Lemma 5.4. For any continuous function $F:[t_o,T[\times\mathbb{R}\to\mathbb{R} \ and \ H(u,s):=\frac{B_s-B_u}{s-u} \ for \ 0\leq u< s\leq T \ we have the following: if <math>\varepsilon>0$, $c_{(5.3)}>0$ and $0\leq r\leq t< s\leq T$, the relation

$$|\mathsf{F}(s,x) - \mathsf{F}(s,x')| \le c_{(5.3)} \frac{|x - x'|^{\varepsilon} \Phi_{\beta}(|x - x'|^{2\varepsilon})}{(T - s)^{\gamma} \Phi_{\beta}(|T - s|^{\varepsilon})} = c_{(5.3)} \frac{\Psi_{2\beta}(|x - x'|^{2\varepsilon})^{\frac{1}{2}}}{(T - s)^{\gamma} \Phi_{\beta}(|T - s|^{\varepsilon})},\tag{5.3}$$

where $\gamma \geq 0$ and $\beta = 0$ or $\beta > \frac{1}{2}$ and $\bar{\beta} = 0$ or $\bar{\beta} > \frac{1}{2}$, implies

$$|\mathbb{E}(\mathsf{F}(s, B_s^{r,x}) H(r, s) - \mathsf{F}(s, B_s^{t,x}) H(t, s))|$$

$$\leq c_{(5.3)} \frac{\sqrt{b_{\varepsilon}} \Phi_{\beta}(|t-r|^{\varepsilon} b_{\varepsilon}) \Phi_{\beta}(|s-t|^{\varepsilon} b_{\varepsilon})}{(T-s)^{\gamma} \Phi_{\beta}((T-s)^{\varepsilon})} \frac{(t-r)^{\frac{\varepsilon}{2}} \Phi_{\bar{\beta}}((t-r)^{\varepsilon})}{(s-t)^{\frac{1}{2}} \Phi_{\bar{\beta}}((s-t)^{\varepsilon})}.$$

$$(5.4)$$

In particular,

(i) for $\gamma = \beta = 0$ we have that $|\mathsf{F}(s,x) - \mathsf{F}(s,x')| \le c_{(5.3)}|x-x'|^{\varepsilon}$ which implies for all $\bar{\beta} > \frac{1}{2}$

$$|\mathbb{E}(\mathsf{F}(s, B_s^{r,x})H(r, s) - \mathsf{F}(s, B_s^{t,x})H(t, s))| \le c_{(5.3)} \frac{\Psi_{2\bar{\beta}}(|t - r|^{\varepsilon})^{\frac{1}{2}}}{(s - t)^{\frac{1}{2}}\Phi_{\bar{\beta}}(|s - t|^{\varepsilon})}$$
(5.5)

(ii) for $\gamma = \frac{1}{2}$, $\beta > \frac{1}{2}$ we have that $|\mathsf{F}(s,x) - \mathsf{F}(s,x')| \le c_{(5.3)} \frac{|x-x'|^{\varepsilon} \Phi_{\beta}(|x-x'|^{2\varepsilon})}{(T-s)^{\frac{1}{2}} \Phi_{\beta}(|T-s|^{\varepsilon})}$ which implies for $\bar{\beta} = 0$ that

$$|\mathbb{E}(\mathsf{F}(s,B_{s}^{r,x})H(r,s) - \mathsf{F}(s,B_{s}^{t,x})H(t,s))| \leq c_{(5.3)} \frac{\Phi_{\beta}(|s-t|^{\varepsilon}b_{\varepsilon})}{(s-t)^{\frac{1}{2}}} \ \frac{\Psi_{2\beta}(|t-r|^{\varepsilon}b_{\varepsilon})^{\frac{1}{2}}}{(T-s)^{\frac{1}{2}}\Phi_{\beta}(|T-s|^{\varepsilon})}, \tag{5.6}$$

where $b_{\varepsilon} := \mathbb{E} |B_1|^{2\varepsilon} \leq 1$.

Proof. We have

$$\begin{split} & \left| \mathbb{E} \left[\mathsf{F}(s, B_s^{r,x}) H(r, s) \right] - \mathbb{E} \left[\mathsf{F}(s, B_s^{t,x}) H(t, s) \right] \right| \\ &= \left| \mathbb{E} \left[\left(\mathsf{F}(s, B_s^{r,x}) - \mathsf{F}(s, B_s^{t,x}) \right) \ H(r, s) \right] + \mathbb{E} \left[\left(\mathsf{F}(s, B_s^{t,x}) - \mathsf{F}(t, x) \right) (H(r, s) - H(t, s)) \right] \right| \\ &\leq \mathbb{E} \left[\left| \mathsf{F}(s, B_s^{r,x}) - \mathsf{F}(s, B_s^{t,x}) \right| \ |H(r, s)| \right] + \mathbb{E} \left[\left| \mathsf{F}(s, B_s^{t,x}) - \mathsf{F}(t, x) \right| \ |H(r, s) - H(t, s)| \right]. \end{split}$$
 (5.7)

For the first term on the RHS we get by applying the Cauchy-Schwartz inequality that

$$\mathbb{E}\left[\left|\mathsf{F}(s, B_{s}^{r,x}) - \mathsf{F}(s, B_{s}^{t,x})\right| \frac{|B_{s} - B_{r}|}{s - r}\right] \\
\leq \frac{c_{(5.3)}}{(T - s)^{\gamma} \Phi_{\beta}((T - s)^{\varepsilon})} \mathbb{E}\left(\Psi_{2\beta}(|B_{t} - B_{r}|^{2\varepsilon})^{\frac{1}{2}} \frac{|B_{s} - B_{r}|}{s - r}\right) \\
\leq \frac{c_{(5.3)}}{(T - s)^{\gamma} \Phi_{\beta}((T - s)^{\varepsilon})} \left(\mathbb{E}\Psi_{2\beta}(|B_{t} - B_{r}|^{2\varepsilon})\right)^{\frac{1}{2}} \frac{1}{(s - r)^{\frac{1}{2}}}.$$
(5.8)

Since by Lemma 5.2 the function $\Psi_{2\beta}$ is concave, Jensen's inequality permits to move the expectation inside, and recalling that $b_{\varepsilon} = \mathbb{E}|B_1|^{2\varepsilon}$ we have

$$\left(\mathbb{E}\Psi_{2\beta}(|B_t - B_r|^{2\varepsilon})^{\frac{1}{2}} \le \Psi_{2\beta}(\mathbb{E}|B_t - B_r|^{2\varepsilon})\right)^{\frac{1}{2}} = \sqrt{b_{\varepsilon}}|t - r|^{\varepsilon/2}\Phi_{\beta}(|t - r|^{\varepsilon}b_{\varepsilon}). \tag{5.9}$$

By Lemma 5.2(i) the function $\Phi_{\bar{\beta}}$ is non-increasing, implying that $\frac{\Phi_{\bar{\beta}}((t-r)^{\varepsilon})}{\Phi_{\bar{\beta}}((s-r)^{\varepsilon})} \geq 1$. Furthermore, since $(s-r)^{\frac{1}{2}}\Phi_{\bar{\beta}}((s-r)^{\varepsilon}) \geq (s-t)^{\frac{1}{2}}\Phi_{\bar{\beta}}((s-t)^{\varepsilon})$ (see Lemma 5.2(ii)), we get from (5.9) that

$$\frac{\left(\mathbb{E}\Psi_{2\beta}(|B_{t}-B_{r}|^{2\varepsilon})\right)^{\frac{1}{2}}}{(s-r)^{\frac{1}{2}}} \leq \Phi_{\beta}(|t-r|^{\varepsilon}b_{\varepsilon})\sqrt{b_{\varepsilon}}\frac{(t-r)^{\frac{\varepsilon}{2}}\Phi_{\bar{\beta}}((t-r)^{\varepsilon})}{(s-r)^{\frac{1}{2}}\Phi_{\bar{\beta}}((s-r)^{\varepsilon})}
\leq \Phi_{\beta}(|t-r|^{\varepsilon}b_{\varepsilon})\sqrt{b_{\varepsilon}}\frac{(t-r)^{\frac{\varepsilon}{2}}\Phi_{\bar{\beta}}((t-r)^{\varepsilon})}{(s-t)^{\frac{1}{2}}\Phi_{\bar{\beta}}((s-t)^{\varepsilon})}.$$
(5.10)

In a similar way we estimate the second term of (5.7), that is,

$$\mathbb{E}\left[|\mathsf{F}(s, B_s^{t,x}) - \mathsf{F}(s, x)| |H(r, s) - H(t, s)|\right] \\
\leq \frac{c_{(5.3)}}{(T - s)^{\gamma} \Phi_{\beta}((T - s)^{\varepsilon})} (\mathbb{E}\Psi_{2\beta}(|B_s - B_t|^{2\varepsilon})^2)^{\frac{1}{2}} \frac{(t - r)^{\frac{1}{2}}}{(s - r)^{\frac{1}{2}}(s - t)^{\frac{1}{2}}}, \tag{5.11}$$

where we used that $\mathbb{E}|H(r,s)-H(t,s)|^2 \leq \frac{t-r}{(s-r)(s-t)}$ (see the proof of [BGGL21, Proposition 10]). From $\frac{t-r}{s-r} \leq 1$ it follows

$$\frac{(t-r)^{\frac{1}{2}}}{(s-t)^{\frac{1}{2}}(s-r)^{\frac{1}{2}}} \le \frac{(t-r)^{\frac{\varepsilon}{2}}}{(s-t)^{\frac{1}{2}}(s-r)^{\frac{\varepsilon}{2}}}$$

by which we get thanks to (5.9) and Lemma 5.2(ii) that

$$(\mathbb{E}\Psi_{2\beta}(|B_{s}-B_{t}|^{2\varepsilon}))^{\frac{1}{2}} \frac{(t-r)^{\frac{1}{2}}}{(s-t)^{\frac{1}{2}}(s-r)^{\frac{1}{2}}} \leq \Phi_{\beta}(|s-t|^{\varepsilon}b_{\varepsilon}) \frac{\sqrt{b_{\varepsilon}}(t-r)^{\frac{\varepsilon}{2}}}{(s-t)^{\frac{1-\varepsilon}{2}}(s-r)^{\frac{\varepsilon}{2}}} \\
\leq \Phi_{\beta}(|s-t|^{\varepsilon}b_{\varepsilon}) \frac{\sqrt{b_{\varepsilon}}(t-r)^{\frac{\varepsilon}{2}}}{(s-t)^{\frac{1-\varepsilon}{2}}(s-r)^{\frac{\varepsilon}{2}}} \frac{\Phi_{\bar{\beta}}((t-r)^{\varepsilon})}{\Phi_{\bar{\beta}}((s-r)^{\varepsilon})} \\
= \Phi_{\beta}(|s-t|^{\varepsilon}b_{\varepsilon}) \frac{\sqrt{b_{\varepsilon}}(t-r)^{\frac{\varepsilon}{2}}\Phi_{\bar{\beta}}((t-r)^{\varepsilon})}{(s-t)^{\frac{1}{2}}\Phi_{\bar{\beta}}((s-t)^{\varepsilon})}. \quad (5.12)$$

The assertion (5.4) follows by inserting (5.10) and (5.12) into (5.8) and (5.11), respectively. Here we recall that by Lemma 5.2(i) we have $\Phi_{\beta} \geq 1$ so that

$$\Phi_{\beta}(|t-r|^{\varepsilon}b_{\varepsilon}) + \Phi_{\beta}(|s-t|^{\varepsilon}b_{\varepsilon}) \le 2\Phi_{\beta}(|t-r|^{\varepsilon}b_{\varepsilon})\Phi_{\beta}(|s-t|^{\varepsilon}b_{\varepsilon}).$$

The next proposition is a modification of [BGGL21, Lemma 7 and Proposition 10]. More precisely, it generalizes the inequality of Lemma 7(b)(i) giving the possibility to weaken the singularity in time by slightly reducing the regularity in space, while in relation to Proposition 10 the Hölder continuity in time is reduced to achieve a weaker singularity in time. The items (i) and (ii) in the following proposition are proven in [BGGL21, Lemma 7].

Proposition 5.5. Let Assumption 2.3 hold and put $F(s,x) := f(s,x,u(s,x),\nabla u(s,x))$.

(i) The function u belongs to $C^{0,1}([t_o, T] \times \mathbb{R})$ and, for all $(t, x) \in [t_o, T] \times \mathbb{R}$, we have,

$$Z_s^{t,x} = \nabla u(s, B_s^{t,x}) \quad \text{for a.e. } (s, \omega) \in [t, T] \times \Omega, \tag{5.13}$$

as well as

$$\nabla u(t,x) = \mathbb{E}\left(g(B_T^{t,x})\frac{B_T - B_t}{T - t}\right) + \mathbb{E}\left(\int_t^T F(s, B_s^{t,x})\frac{B_s - B_t}{s - t}ds\right). \tag{5.14}$$

Consequently, for $\mathbb{E}_r := \mathbb{E}[\cdot | \mathcal{F}_r],$

$$\nabla u(r, B_r^{t,x}) = \mathbb{E}_r \left(g(B_T^{t,x}) \frac{B_T - B_r}{T - r} \right) + \mathbb{E}_r \left(\int_r^T F(s, B_s^{t,x}) \frac{B_s - B_r}{s - r} ds \right)$$

$$a.s. \ for \ r \in [t, T]. \tag{5.15}$$

(ii) There exists a constant $c_{(5.16)} = c_{(5.16)}(T, \varepsilon, |g|_{\varepsilon}, |f|_{\varepsilon;x}, L_f, c_{f_0}) > 0$ such that

$$|\nabla u(t,x)| \le \frac{c_{(5.16)}}{(T-t)^{(1-\varepsilon)/2}} \text{ for all } (t,x) \in [t_o, T[\times \mathbb{R}.$$

$$(5.16)$$

(iii) There exists a constant $c_{(5.17)} = c_{(5.17)}(T, \varepsilon, \beta, |g|_{\varepsilon}, |f|_{\varepsilon;x}, L_f, c_{f_0}) > 0$ such that, for all $t \in [t_0, T[, x, y \in \mathbb{R} \text{ and for all } \beta > \frac{1}{2} \text{ or } \beta = 0,$

$$|\nabla u(t,x) - \nabla u(t,y)| \le c_{(5.17)} \frac{\Psi_{2\beta}(|x-y|^{2\varepsilon})^{\frac{1}{2}}}{(T-t)^{\frac{1}{2}}\Phi_{\beta}((T-t)^{\varepsilon})}.$$
(5.17)

(iv) There exists a constant $c_{(5.18)} = c_{(5.18)}(T, \varepsilon, \beta, |g|_{\varepsilon}, |f|_{\varepsilon;x}, L_f, c_{f_0}) > 0$ such that for $\beta > \frac{1}{2}$ or $\beta = 0$ and for all $x \in \mathbb{R}$,

$$|\nabla u(t,x) - \nabla u(r,x)| \le c_{(5.18)} \frac{\Psi_{2\beta}(|t-r|^{\varepsilon}b_{\varepsilon})^{\frac{1}{2}}}{(T-t)^{\frac{1}{2}}\Phi_{\beta}(|T-t|^{\varepsilon})} \quad \text{for all } t_o \le r < t < T, \quad (5.18)$$

where $b_{\varepsilon} := \mathbb{E} |B_1|^{2\varepsilon}$.

Proof. (iii) The representation (5.15) yields to

$$\|\nabla u(r, B_r^{t,x}) - \nabla u(r, B_r^{t,y})\|_{L^2} \le \left\| \mathbb{E}_r \left(\left(g(B_T^{t,x}) - g(B_T^{t,y}) \right) \frac{B_T - B_r}{T - r} \right) \right\|_{L^2} + \int_r^T \left\| \mathbb{E}_r \left(\left(F(s, B_s^{t,x}) - F(s, B_s^{t,y}) \right) \frac{B_s - B_r}{s - r} \right) \right\|_{L^2} ds.$$
(5.19)

Let us start with the g difference. Throughout the paper we will repeatedly use that one can add terms like $g(B_r^{t,x})\frac{B_T-B_r}{T-r}$ to the calculation since their conditional expectation w.r.t. \mathcal{F}_r is zero. Note that

$$\mathbb{E}_{r} \left(\left(g(B_{T}^{t,x}) - g(B_{T}^{t,y}) \right) \frac{B_{T} - B_{r}}{T - r} \right) \\
= \mathbb{E}_{r} \left(\left(g(B_{T}^{t,x}) - g(B_{T}^{t,y}) - g(B_{r}^{t,x}) + g(B_{r}^{t,y}) \right) \frac{B_{T} - B_{r}}{T - r} \right) \\
\leq \mathbb{E}_{r} \left(\underbrace{\left| g(B_{T}^{t,x}) - g(B_{T}^{t,y}) - g(B_{r}^{t,x}) + g(B_{r}^{t,y}) \right|}_{:= A} \frac{|B_{T} - B_{r}|}{T - r} \right).$$

Since g is ε -Hölder continuous we have the estimates

$$A \leq 2|g|_{\varepsilon}|x-y|^{\varepsilon}$$
 and $A \leq 2|g|_{\varepsilon}|B_T - B_r|^{\varepsilon}$,

and therefore

$$A \le 2|g|_{\varepsilon} \min\{|x-y|^{\varepsilon}, |B_T - B_r|^{\varepsilon}\}.$$

Setting $s := T - r \in (0, T]$ we are interested in the estimate of

$$M := \mathbb{E}\left(\min\{|x-y|, |B_s|\}^{\varepsilon} \frac{|B_s|}{s}\right)$$

$$= \frac{1}{s} \int_{|B_s| \le |x-y|} |B_s|^{1+\varepsilon} d\mathbb{P} + \frac{|x-y|^{\varepsilon}}{s} \int_{|B_s| > |x-y|} |B_s| d\mathbb{P}$$

$$=: T_1 + T_2.$$

For T_1 we use that $\frac{B_s}{\sqrt{s}}$ and B_1 have the same distribution and get

$$T_1 = \frac{1}{s} \int_{|z| \le \frac{|x-y|}{\sqrt{s}}} |z|^{1+\varepsilon} s^{\frac{1+\varepsilon}{2}} e^{-z^2/2} \frac{dz}{\sqrt{2\pi}}$$

$$\leq \begin{cases} \sqrt{\frac{2}{\pi}} \, s^{\frac{\varepsilon - 1}{2}} \left(\frac{|x - y|}{\sqrt{s}}\right)^{2 + \varepsilon} & \text{if } \frac{|x - y|}{\sqrt{s}} \leq 1 \\ s^{\frac{\varepsilon - 1}{2}} \mathbb{E}|B_1|^{1 + \varepsilon} & \text{if } \frac{|x - y|}{\sqrt{s}} > 1 \end{cases}$$

$$=\frac{|x-y|^{\varepsilon}}{\sqrt{s}}\left(\sqrt{\frac{2}{\pi}}\left(\frac{|x-y|}{\sqrt{s}}\right)^2\mathbf{1}_{\{|x-y|\leq\sqrt{s}\}}+\left(\frac{\sqrt{s}}{|x-y|}\right)^{\varepsilon}\mathbb{E}|B_1|^{1+\varepsilon}\mathbf{1}_{\{|x-y|>\sqrt{s}\}}\right).$$

Similarly, we have for T_2 that

$$T_{2} = \frac{|x-y|^{\varepsilon}}{s} \int_{|z| > \frac{|x-y|}{\sqrt{s}}} |z| s^{\frac{1}{2}} e^{-z^{2}/2} \frac{dz}{\sqrt{2\pi}}$$

$$\leq \frac{|x-y|^{\varepsilon}}{\sqrt{s}} \left(\mathbb{E}|B_{1}| \mathbf{1}_{\{|x-y| \leq \sqrt{s}\}} + \sqrt{\frac{2}{\pi}} e^{-|x-y|^{2}/2s} \mathbf{1}_{\{|x-y| > \sqrt{s}\}} \right).$$

Hence there exists a constant $c_{\varepsilon} > 0$ such that

$$M \le c_{\varepsilon} \frac{|x-y|^{\varepsilon}}{\sqrt{s}} \mathbf{1}_{\{|x-y| \le \sqrt{s}\}} + c_{\varepsilon} s^{\frac{\varepsilon-1}{2}} \mathbf{1}_{\{|x-y| > \sqrt{s}\}},$$

where we used that $e^{-\frac{z^2}{2}} < z^{-\varepsilon}$ for $z := \frac{|x-y|}{\sqrt{s}} > 1$.

Since Ψ_{β} is increasing on $(0, \infty)$, we get using $\Phi_{\beta}(r) = \left(\log\left(\frac{1}{r \wedge \hat{r}}\right)\right)^{\beta}$ that

$$c_{\varepsilon}s^{\frac{\varepsilon-1}{2}}\mathbf{1}_{\{|x-y|>\sqrt{s}\}} = c_{\varepsilon}\frac{1}{s^{\frac{1}{2}}\Phi_{\beta}(s^{\varepsilon})}s^{\frac{\varepsilon}{2}}\Phi_{\beta}(s^{\varepsilon})\mathbf{1}_{\{|x-y|>\sqrt{s}\}} \leq c_{\varepsilon}\frac{1}{s^{\frac{1}{2}}\Phi_{\beta}(s^{\varepsilon})}|x-y|^{\varepsilon}\Phi_{\beta}(|x-y|^{2\varepsilon}).$$

For the case $|x-y| \leq \sqrt{s}$ we use that $\Phi_{\beta}(s^{\varepsilon}) \leq \Phi_{\beta}(|x-y|^{2\varepsilon})$ and get as well

$$c_{\varepsilon} \frac{|x-y|^{\varepsilon}}{\sqrt{s}} \mathbf{1}_{\{|x-y| \le \sqrt{s}\}} \le c_{\varepsilon} \frac{1}{s^{\frac{1}{2}} \Phi_{\beta}(s^{\varepsilon})} |x-y|^{\varepsilon} \Phi_{\beta}(|x-y|^{2\varepsilon}).$$

Consequently,

$$\left| \mathbb{E}_r \left(\left(g(B_T^{t,x}) - g(B_T^{t,y}) \right) \frac{B_T - B_r}{T - r} \right) \right| \le c_\varepsilon \frac{|x - y|^\varepsilon \Phi_\beta(|x - y|^{2\varepsilon})}{(T - r)^{\frac{1}{2}} \Phi_\beta((T - r)^\varepsilon)} = c_\varepsilon \frac{\Psi_{2\beta}(|x - y|^{2\varepsilon})^{\frac{1}{2}}}{(T - r)^{\frac{1}{2}} \Phi_\beta((T - r)^\varepsilon)}.$$

We continue with the estimate of the second term on the RHS of (5.19). By the conditional Cauchy-Schwarz inequality we obtain

$$\left\| \mathbb{E}_r \left((F(s, B_s^{t,x}) - F(s, B_s^{t,y})) \frac{B_s - B_r}{s - r} \right) \right\|_{L^2} \le \left\| F(s, B_s^{t,x}) - F(s, B_s^{t,y}) \right\|_{L^2} \frac{1}{\sqrt{s - r}}.$$

Using (2.1) for f, we have

$$|F(s, B_s^{t,x}) - F(s, B_s^{t,y})|$$

$$\leq |f|_{\varepsilon:x}|x - y|^{\varepsilon} + L_f|u(s, B_s^{t,x}) - u(s, B_s^{t,y})| + L_f|\nabla u(s, B_s^{t,x}) - \nabla u(s, B_s^{t,y})|,$$
(5.20)

and the Hölder continuity of u stated in Lemma 5.1 yields

$$|F(s, B_s^{t,x}) - F(s, B_s^{t,y})| \le (|f|_{\varepsilon;x} + c_{(5.2)}L_f)|x - y|^{\varepsilon} + L_f|\nabla u(s, B_s^{t,x}) - \nabla u(s, B_s^{t,y})|. \quad (5.21)^{\varepsilon}$$

By combining the above estimates we conclude from (5.19) that

$$\|\nabla u(r, B_r^{t,x}) - \nabla u(r, B_r^{t,y})\|_{L^2} \le \frac{c_{\varepsilon} \Psi_{2\beta}(|x-y|^{2\varepsilon})^{\frac{1}{2}}}{(T-r)^{\frac{1}{2}} \Phi_{\beta}((T-r)^{\varepsilon})} + 2\left(|\mathsf{f}|_{\varepsilon;x} + c_{(5.2)} L_\mathsf{f}\right) |x-y|^{\varepsilon} \sqrt{T-r} + \int_r^T \|\nabla u(s, B_s^{t,x}) - \nabla u(s, B_s^{t,y})\|_{L^2} \frac{L_\mathsf{f}}{\sqrt{s-r}} ds.$$

By Lemma 5.2 we have

$$1 = \frac{(T-t)^{\frac{1}{2}}\Phi_{\beta}((T-t)^{\varepsilon})}{(T-t)^{\frac{1}{2}}\Phi_{\beta}((T-t)^{\varepsilon})} = \frac{(T-t)^{\frac{1-\varepsilon}{2}}\Psi_{2\beta}((T-t)^{\varepsilon})^{\frac{1}{2}}}{(T-t)^{\frac{1}{2}}\Phi_{\beta}((T-t)^{\varepsilon})} \le \frac{c_{(5.22)}}{(T-t)^{\frac{1}{2}}\Phi_{\beta}((T-t)^{\varepsilon})}$$
(5.22)

with $c_{(5.22)} = T^{\frac{1-\epsilon}{2}} \Psi_{2\beta}(\hat{r})^{\frac{1}{2}}$, implying

$$1 \le c_{(5.22)} \frac{\Phi_{\beta}(|x-y|^{2\varepsilon})}{(T-t)^{\frac{1}{2}}\Phi_{\beta}((T-t)^{\varepsilon})}$$
(5.23)

since $1 \leq \Phi_{\beta}(|x-y|^{2\varepsilon})$. This gives

$$\begin{split} &\|\nabla u(r, B_r^{t,x}) - \nabla u(r, B_r^{t,y})\|_{L^2} \\ &\leq 2C_1 \frac{\Psi_{2\beta}(|x-y|^{2\varepsilon})^{\frac{1}{2}}}{(T-r)^{\frac{1}{2}}\Phi_{\beta}((T-r)^{\varepsilon})} + \int_r^T \left\|\nabla u(s, B_s^{t,x}) - \nabla u(s, B_s^{t,y})\right\|_{L^2} \frac{L_{\mathsf{f}}}{\sqrt{s-r}} ds \end{split}$$

for $C_1 := c_{\varepsilon} + 2\sqrt{T}(|\mathsf{f}|_{\varepsilon;x} + c_{(5.2)}\,L_\mathsf{f})c_{(5.22)}$. Because of

$$|\nabla u(t,x)| \le \frac{c_{(5.16)}}{(T-t)^{(1-\varepsilon)/2}} \quad \text{ on } [t_o, T[\times \mathbb{R},$$
 (5.24)

we have an integrable bound

$$\left\| \nabla u(s, B_s^{t,x}) - \nabla u(s, B_s^{t,y}) \right\|_{L^2} \le 2 \frac{c_{(5.16)}}{(T - t)^{(1 - \varepsilon)/2}},$$

so that we may apply Gronwall's lemma (Lemma 9.2) and get

$$\|\nabla u(r, B_r^{t,x}) - \nabla u(r, B_r^{t,y})\|_{L^2} \le c_0 C_1 \frac{\Psi_{2\beta}(|x-y|^{2\varepsilon})^{\frac{1}{2}}}{(T-r)^{\frac{1}{2}} \Phi_{\beta}((T-r)^{\varepsilon})},$$

for some $c_0 = c_0(T, L_f) > 0$. Especially, for r = t this implies

$$|\nabla u(t,x) - \nabla u(t,y)| \le C \frac{\Psi_{2\beta}(|x-y|^{2\varepsilon})^{\frac{1}{2}}}{(T-t)^{\frac{1}{2}}\Phi_{\beta}((T-t)^{\varepsilon})}$$

 $\text{for some } C = C(T, \varepsilon, \beta, |g|_{\varepsilon}, |\mathsf{f}|_{\varepsilon;x}, L_\mathsf{f}, c_\mathsf{f_0}, \mathsf{f_0}) > 0.$

(iv) Recalling that $H(t_0, t_1) = \frac{B_{t_1} - B_{t_0}}{t_1 - t_0}$ for $t_0 \le t_0 < t_1 \le T$, we use (5.14) to write

$$\nabla u(r,x) - \nabla u(t,x) = \mathbb{E}\left[g\left(B_T^{r,x}\right)H(r,T) - g\left(B_T^{t,x}\right)H(t,T)\right]$$

$$+ \mathbb{E}\int_t^T F(s,B_s^{r,x})H(s,r) - F(s,B_s^{t,x})H(s,t)ds$$

$$+ \mathbb{E}\int_t^t (F(s,B_s^{r,x}) - F(s,x))H(r,s)ds.$$

Let us bound the three terms of the right hand side. By applying Lemma 5.4(i) we get for $\bar{\beta} \in]\frac{1}{2}, 1[$

$$\left| \mathbb{E} \left[g \left(B_T^{r,x} \right) H(r,T) - g \left(B_T^{t,x} \right) H(t,T) \right] \right| \leq |g|_{\varepsilon} \frac{\Psi_{2\bar{\beta}}(|t-r|^{\varepsilon})^{\frac{1}{2}}}{(T-t)^{\frac{1}{2}} \Phi_{\bar{\beta}}(|T-t|^{\varepsilon})}.$$

Let us bound the second term. Using (5.21) for s=t combined with Proposition 5.5 (iii), and (5.23) leads to $(C_F = |f|_{\varepsilon;x} + c_{(5.2)}L_f + c_{(5.17)}L_f)$

$$|F(s,x) - F(s,y)| \le C_F \left(|x - y|^{\varepsilon} + \frac{\Psi_{2\beta}(|x - y|^{2\varepsilon})^{\frac{1}{2}}}{(T - s)^{\frac{1}{2}}\Phi_{\beta}(|T - s|^{\varepsilon})} \right)$$

$$\le c_{(5.25)} \frac{\Psi_{2\beta}(|x - y|^{2\varepsilon})^{\frac{1}{2}}}{(T - s)^{\frac{1}{2}}\Phi_{\beta}(|T - s|^{\varepsilon})}, \tag{5.25}$$

where $c_{(5.25)} = C_F(c_{(5.22)} + 1)$. Hence we may apply Lemma 5.4(ii) and get

$$\begin{split} &\mathbb{E} \int_{t}^{T} |F(s,B_{s}^{r,x})H(r,s) - F(s,B_{s}^{t,x})H(t,s)|ds \\ &\leq c_{(5.25)} \,\Psi_{2\beta}(|t-r|^{\varepsilon}b_{\varepsilon})^{\frac{1}{2}} \int_{t}^{T} \frac{\Phi_{\beta}(|s-t|^{\varepsilon}b_{\varepsilon})}{(T-s)^{\frac{1}{2}}\Phi_{\beta}(|T-s|^{\varepsilon})(s-t)^{\frac{1}{2}}} ds \\ &\leq c_{(5.25)} \,\Psi_{2\beta}(|t-r|^{\varepsilon}b_{\varepsilon})^{\frac{1}{2}} \int_{t}^{T} \frac{(s-t)^{\frac{\varepsilon}{2}}\Phi_{\beta}(|s-t|^{\varepsilon}b_{\varepsilon})}{(T-s)^{\frac{1}{2}}(s-t)^{\frac{1+\varepsilon}{2}}} ds \\ &\leq C \,\Psi_{2\beta}(|t-r|^{\varepsilon}b_{\varepsilon})^{\frac{1}{2}}, \end{split}$$

where C > 0 depends on $(T, \varepsilon, \beta, |g|_{\varepsilon}, |f|_{\varepsilon;x}, L_f, c_{f_0}, f_0)$. Indeed, the integral in the last inequality is bounded: By Lemma 5.2(iii) we have

 $for \ some \ c_{(5.27)}>0 \ and \ c_{(5.28)}>0 \ depending \ at \ most \ on \ (T,\varepsilon,\alpha,|g|_{\varepsilon},|f|_{\alpha;t}^{loc},|f|_{\varepsilon;x},L_f,c_{f_0}^{(2)},\xi).$

Proof. (a) We show that there is a $c_{(5.29)} = c_{(5.29)}(T, \varepsilon, \alpha, |g|_{\varepsilon}, |f|_{\alpha;t}^{loc}, |f|_{\varepsilon;x}, L_f, c_{f_0}^{(2)}, \xi) > 0$ such that

As an immediate consequence we obtain regularity results for $u := u_f$ and $\nabla u := \nabla u_f$ related to f as well as for $u := u_{f_n}$ and $\nabla u := \nabla u_{f_n}$ related to f_n :

7 Convergence rate

In this section we establish necessary results required to deduce the main result, Theorem 1.1.

7.1 Comparing (Y, Z) and (Y_{f_n}, Z_{f_n})

We start by comparing the solution to (1.1) to the solution to (1.7).

Proposition 7.1. Under Assumption 2.2 for the solutions to (1.1) and (1.7) one has

for $n \geq n_0$ and $(t,x) \in [t_o,T] \times \mathbb{R}$, where the constants $c_{(7.1)}, c_{(7.2)} > 0$ depend at most on $(T,\varepsilon,\alpha,|g|_{\varepsilon},|f|_{\alpha;t},|f|_{\varepsilon;x},L_f,c_{f_0}^{(2)},\xi)$. Moreover, there is an absolute constant $c_{(7.3)} > 0$ such that

Proof. Inequality (7.1) is the same as (5.29). To show (7.2) we use an a priori estimate (see, for example, [GY21, Lemma 5.26]) and use (7.1) with $r = t_{n-1}$ to get, for some $c = c(T, L_f)$,

$$\leq c \left| \int_{t}^{T} \left[|f|_{\alpha;t}^{loc} \frac{|s - s \wedge t_{n-1}|^{\alpha}}{|T - s|^{\frac{1}{2}}} + L_{f} \mathcal{W}_{2}(Z_{s \wedge t_{n-1}}^{to,\xi}, Z_{s}^{to,\xi}) \right] ds \right|^{2} \\
\leq c \left| \int_{t}^{T} \left[|f|_{\alpha;t}^{loc} \frac{|s - s \wedge t_{n-1}|^{\alpha}}{|T - s|^{\frac{1}{2}}} + L_{f} c_{(7.1)} \frac{|s - t_{n-1}|^{\frac{\varepsilon}{2}}}{|T - s|^{\frac{1}{2}}} \right] ds \right|^{2} \\
\leq c' \left| \int_{t_{n-1}}^{T} \frac{|s - t_{n-1}|^{\frac{\varepsilon}{2} \wedge \alpha}}{|T - s|^{\frac{1}{2}}} ds \right|^{2} \leq c'' n^{-2(\alpha \wedge \frac{\varepsilon}{2} + \frac{1}{2})}.$$

Finally we use that $Y_t^{t,x} = u(t,x)$, $Y_{\mathsf{f}_n,t}^{t,x} = u_{\mathsf{f}_n}(t,x)$, $Z_t^{t,x} = \nabla u(t,x)$, and $Z_{\mathsf{f}_n,t}^{t,x} = \nabla u_{\mathsf{f}_n}(t,x)$. Setting $\mathbb{E}_{t,x}[\cdot] := \mathbb{E}\left[\cdot | B_t = x\right]$ we conclude

For the relation (7.3) we use (7.2) and Theorem 9.4.

7.2 Finite difference approximation - comparing (Y_{f_n}, Z_{f_n}) and $(Y_{f_n}^n, Z_{f_n}^n)$

We will use [BGGL21, Corollary 5] and reformulate it as follows:

$$\left| \mathbb{E}\left[g\left(B_{s}^{n,t,x} \right) \right] - \mathbb{E}\left[g\left(B_{s}^{t,x} \right) \right] \right| \le c_{(7.4)} |g|_{\varepsilon} n^{-\varepsilon/2}, \tag{7.4}$$

and, setting $\delta(t,s) := \max(s - t, \underline{s} - \underline{t})$,

$$\begin{split} \left| \mathbb{E} \left[g \left(B_s^{n,t,x} \right) \left(B_s^{n,t,x} - x \right) \right] - \mathbb{E} \left[g \left(B_s^{t,x} \right) \left(B_s^{t,x} - x \right) \right] \right| \\ & \leq c_{(7.4)} \left| g \right|_{\varepsilon} \frac{\delta(t,s)^{\frac{1}{2}}}{\Phi_{\beta}((s-t)^{\varepsilon})} \, n^{-\frac{\varepsilon}{2}} \Phi_{\beta} \left(\left(\frac{T}{n} \right)^{\varepsilon} \right). \end{split}$$

Proof. The first result comes from [BGGL21, Corollary 5]. To prove the second result we adapt the proof of [BGGL21, Corollary 5]. We put G(y) := (g(x+y) - g(x))y. Then $\mathbb{E}\left[g\left(B_s^{n,t,x}\right)\left(B_s^{n,t,x} - x\right)\right] - \mathbb{E}\left[g\left(B_s^{t,x}\right)\left(B_s^{t,x} - x\right)\right] = \mathbb{E}(G(B_s^n - B_t^n)) - \mathbb{E}(G(B_s - B_t))$.

In case of $\underline{s} = \underline{t}$ we have $\mathcal{W}_1(G(B_s^n - B_t^n), G(B_s - B_t)) \leq \mathbb{E}(|G(B_s - B_t)|) \leq C|g|_{\varepsilon}(s - t)^{(1+\varepsilon)/2}$. Since $(s - t)^{(1+\varepsilon)/2} = (s - t)^{\frac{1}{2}}(s - t)^{\frac{\varepsilon}{2}} \leq \delta(s, t)^{\frac{1}{2}}(s - t)^{\frac{\varepsilon}{2}}$ and $s - t \leq h$ and the function $r \mapsto r\Phi_{\beta}(r^2)$ is non-decreasing by Lemma 5.2(ii), we get

$$W_1(G(B_s^n - B_t^n), G(B_s - B_t)) \le C |g|_{\varepsilon} \frac{\delta(t, s)^{\frac{1}{2}}(s - t)^{\frac{\varepsilon}{2}} \Phi_{\beta}((s - t)^{\varepsilon})}{\Phi_{\beta}((s - t)^{\varepsilon})}$$

$$\le C |g|_{\varepsilon} \frac{\delta(t, s)^{\frac{1}{2}}}{\Phi_{\beta}((s - t)^{\varepsilon})} n^{-\frac{\varepsilon}{2}} \Phi_{\beta}\left(\left(\frac{T}{n}\right)^{\varepsilon}\right).$$

In case of $\underline{s} > \underline{t}$ we get from the proof of [BGGL21, Corollary 5] that $W_1(G(B_s^n - B_t^n), G(B_s - B_t)) \le C|g|_{\varepsilon} \left(\frac{T}{n}\right)^{\varepsilon/2} \delta(t,s)^{1/2}$. Furthermore, we have h < (s-t), which implies that $\Phi_{\beta}((s-t)^{\varepsilon}) \le \Phi_{\beta}\left(\left(\frac{T}{n}\right)^{\varepsilon}\right)$, and therefore

$$W_1(G(B_s^n - B_t^n), G(B_s - B_t)) \le C |g|_{\varepsilon} \frac{\delta(t, s)^{\frac{1}{2}}}{\Phi_{\beta}((s - t)^{\varepsilon})} n^{-\frac{\varepsilon}{2}} \Phi_{\beta}\left(\left(\frac{T}{n}\right)^{\varepsilon}\right).$$

Now we finish the proof by choosing f(x) = x in the Kantorovich-Rubinstein relation

We modify [BGGL21, Theorem 11] by introducing the function Φ_{β} with the aim to weaken the singularity in time to get square integrability at the expense of the convergence rate.

Lemma 7.3. For $n \ge n_0$, under Assumption 2.2 with f_n satisfying (5.27), there are constants $c_{(7.5)}, c_{(7.6)} > 0$ depending at most on $c_{(5.2)} = c_{(5.2)}(T, \varepsilon, \alpha, |g|_{\varepsilon}, |f|_{\alpha;t}^{loc}, |f|_{\varepsilon;x}, L_f, c_{f_0}^{(2)}, \xi) > 0$, where $c_{(7.6)} > 0$ depends additionally on β , such that

$$|u_{f_n}(t,x) - U_{f_n}^n(t,x)| \le c_{(7.5)} (1 + |x| + ||\xi||_{L^{2\varepsilon}})^{\varepsilon} n^{-\alpha \wedge \frac{\varepsilon}{2}},$$
 (7.5)

$$|\nabla u_{\mathsf{f}_n}(t,x) - \nabla^h U_{\mathsf{f}_n}^n(\underline{t}+h,x)| \le c_{(7.6)} \frac{(1+|x|+\|\xi\|_{L^{2\varepsilon}})^{\varepsilon} n^{-\alpha \wedge \frac{\varepsilon}{2}}}{(T-t)^{\frac{1-\varepsilon}{2}} (T-\underline{t})^{\frac{\varepsilon}{2}} \Phi_{\beta}((T-\underline{t})^{\varepsilon})} \Phi_{\beta}\left(\left(\frac{T}{n}\right)^{\varepsilon}\right)$$
(7.6)

for all $(t,x) \in [t_o,T] \times \mathbb{R}$, and $\beta > \frac{1}{2}$ or $\beta = 0$.

Proof. Equation (7.5) is shown in [BGGL21, Theorem 11(i)] for the setting in [BGGL21]. For the setting of this article we have to check how our local Hölder continuity in time given in (5.27) for $d = f_n$ influences the calculations done in [BGGL21]. The proof of [BGGL21, Theorem 11(i)] contains only one estimate where the Hölder continuity in time is used. We need to change it as follows: Denoting $\Theta_s^{n,t,x} := (B_{s^-}^{n,t,x}, Y_{s^-}^{n,t,x}, Z_s^{n,t,x})$ we have, by Lemma 5.6,

$$\begin{split} \left| \mathbb{E} \left[\int_{\underline{t}}^{T} \left(\mathsf{f}_{n} \left(\overline{s}, \Theta_{s}^{n,t,x} \right) - \mathsf{f}_{n} \left(s, \Theta_{s}^{n,t,x} \right) \right) ds \right] \right| \\ & \leq c_{(5.27)} \int_{\underline{t}}^{T} \left(|f|_{\alpha;t}^{loc} + \left(1 + \|\xi\|_{L^{2\varepsilon}} \right)^{\varepsilon} \right) \frac{|\overline{s} - s|^{\alpha \wedge \frac{\varepsilon}{2}}}{(T - \overline{s} \wedge t_{n-1})^{\frac{1}{2}}} ds \\ & \leq c_{(5.27)} c \left(|f|_{\alpha;t}^{loc} + \left(1 + \|\xi\|_{L^{2\varepsilon}} \right)^{\varepsilon} \right) n^{-\alpha \wedge \frac{\varepsilon}{2}} \end{split}$$

for some $c = c(\alpha, \varepsilon, T) > 0$. Item (7.6) for the case $\beta = 0$ is shown in [BGGL21, Theorem 11]. The estimate concerning the Hölder continuity in time is changed as follows:

$$|R| = \left| \int_{\underline{t}+h}^{T} \mathbb{E} \left[\left(\mathsf{f}_{n} \left(\overline{s}, \Theta_{s}^{n,t,x} \right) - \mathsf{f}_{n} \left(s, \Theta_{s}^{n,t,x} \right) \right) \frac{B_{s}^{n,t,x} - x}{\underline{s} - \underline{t}} \right] ds \right|$$

$$\leq c_{(5.27)} (|f|_{\alpha;t}^{loc} + (1 + ||\xi||_{L^{2\varepsilon}})^{\varepsilon}) \left(\frac{T}{n} \right)^{\alpha \wedge \frac{\varepsilon}{2}} \int_{\underline{t}+h}^{T} \frac{1}{(T - \overline{s} \wedge t_{n-1})^{\frac{1}{2}}} \frac{1}{\sqrt{s - (\underline{t} + h)}} ds$$

$$\leq c' c_{(5.27)} (|f|_{\alpha;t}^{loc} + (1 + ||\xi||_{L^{2\varepsilon}})^{\varepsilon}) \left(\frac{T}{n} \right)^{\alpha \wedge \frac{\varepsilon}{2}}. \tag{7.7}$$

Indeed, if $t < t_{n-2}$ we have

$$\int_{\underline{t}+h}^{t_{n-2}} \frac{1}{(T - \overline{s} \wedge t_{n-1})^{\frac{1}{2}}} \frac{1}{\sqrt{s - (\underline{t} + h)}} ds = \int_{\underline{t}+h}^{t_{n-2}} \frac{1}{(T - \overline{s})^{\frac{1}{2}}} \frac{1}{\sqrt{s - (\underline{t} + h)}} ds$$

$$\leq \sqrt{2} \int_{\underline{t}+h}^{T} \frac{1}{(T - s)^{\frac{1}{2}}} \frac{1}{\sqrt{s - (\underline{t} + h)}} ds = \sqrt{2} B(\frac{1}{2}, \frac{1}{2}),$$

where we used that $T + s = t_{n-2} + 2h + s \ge 2\overline{s}$ for $s < t_{n-2}$, implying $T - s \le 2(T - \overline{s})$. Since $t < t_{n-2}$ implies $\underline{t} + h \le t_{n-2}$ we have

To show (7.6) for $\beta > \frac{1}{2}$ we only need to make some slight changes in the proof of Theorem 11 where the statement was shown resulting in a singularity $\frac{1}{\sqrt{T-t}}$. The needed changes are as follows: As in [BGGL21, Theorem 11] we write

Using the representation (5.15) for $\nabla u_{\mathsf{f}_n}(t,x)$ with $F(s,x) = \mathsf{f}_n(s,x,u_{\mathsf{f}_n}(s,x),\nabla u_{\mathsf{f}_n}(s,x))$ and the representation

$$\nabla^h U_{\mathsf{f}_n}^n(\underline{t}+h,x) = \mathbb{E}\left[g(B_T^{n,t,x})\frac{B_T^{n,t,x}-x}{T-\underline{t}}\right] + \mathbb{E}\left[\int_{\underline{t}+h}^T \mathsf{f}_n\left(\overline{s},B_s^{n,t,x},U_{\mathsf{f}_n}^n(s,B_s^{n,t,x}),\Delta_{\mathsf{f}_n}^n(s,B_s^{n,t,x})\right)\frac{B_s^{n,t,x}-x}{\underline{s}-\underline{t}}\,ds\right],$$

given in [BGGL21, equation (33)] and recalling that $B_s^{t,x} = x + B_s - B_t$ and $B_s^{n,t,x} = x + B_s^n - B_t^n$, we split the g difference into

$$| g \text{ difference } | \leq \left| \mathbb{E} \left[g(B_T^{t,x})(B_T - B_t) \right] \left(\frac{1}{T - t} - \frac{1}{T - \underline{t}} \right) \right|$$

$$+ \left| \frac{\mathbb{E} \left[g(B_T^{t,x})(B_T - B_t) \right] - \mathbb{E} \left[g(B_T^{n,t,x})(B_T^n - B_t^n) \right]}{T - \underline{t}} \right|$$

$$=: S_1 + S_2.$$

Then for S_1 we have

$$S_1 \leq |g|_{\varepsilon} \frac{(t-\underline{t})^{\frac{\varepsilon}{2}}}{(T-t)^{\frac{1-\varepsilon}{2}}(T-\underline{t})^{\frac{\varepsilon}{2}}} \leq |g|_{\varepsilon} \frac{(t-\underline{t})^{\frac{\varepsilon}{2}} \Phi_{\beta}((\overline{t}-\underline{t})^{\varepsilon})}{(T-t)^{\frac{1-\varepsilon}{2}}(T-\underline{t})^{\frac{\varepsilon}{2}} \Phi_{\beta}((T-\underline{t})^{\varepsilon})}.$$

For the second term we use Lemma 7.2 and get

$$S_{2} \leq c_{(7.4)} |g|_{\varepsilon} \frac{\delta(t,T)^{\frac{1}{2}}}{(T-\underline{t})\Phi_{\beta}((T-\underline{t})^{\varepsilon})} n^{-\frac{\varepsilon}{2}}\Phi_{\beta} \left(\left(\frac{T}{n}\right)^{\varepsilon}\right)$$
$$= c_{(7.4)} |g|_{\varepsilon} \frac{1}{(T-\underline{t})^{\frac{1}{2}}\Phi_{\beta}((T-\underline{t})^{\varepsilon})} n^{-\frac{\varepsilon}{2}}\Phi_{\beta} \left(\left(\frac{T}{n}\right)^{\varepsilon}\right).$$

Then, since $\bar{t} - \underline{t} = T/n$, we get

$$|g| \text{ difference } | \leq \left[T^{\frac{\varepsilon}{2}} + c_{(7.4)} \right] |g|_{\varepsilon} \frac{1}{(T-t)^{\frac{1-\varepsilon}{2}} (T-\underline{t})^{\frac{\varepsilon}{2}} \Phi_{\beta} ((T-\underline{t})^{\varepsilon})} n^{-\frac{\varepsilon}{2}} \Phi_{\beta} \left(\left(\frac{T}{n} \right)^{\varepsilon} \right).$$

Analyzing the proof of [BGGL21, Theorem 11] it turns out that for

$$\beta_n(s) := \sup_{x \in \mathbb{R}} \left\{ \frac{|u_{\mathsf{f}_n} - U^n_{\mathsf{f}_n}|(s, x)}{(1 + |x| + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon}} \right\} \quad \text{and} \quad \gamma_n(s) := \sup_{x \in \mathbb{R}} \left\{ \frac{|\nabla u_{\mathsf{f}_n} - \Delta^n_{\mathsf{f}_n}|(s, x)}{(1 + |x| + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon}} \right\}$$

it holds (see [BGGL21, (43)] and [BGGL21, (44)] together with the estimates for H(t) in this proof)

$$\gamma_n(t) \le C \left(|g \text{ difference}| + \int_{(\underline{t}+h)\wedge T}^T (\beta_n(s) + \gamma_n(s)) \frac{ds}{\sqrt{\underline{s} - \underline{t}}} + n^{-\alpha \wedge \frac{\varepsilon}{2}} \right),$$

where the estimate (7.7) for |R| contributes to the last term. This implies, by the arguments in [BGGL21],

Observing that

$$\Phi_{\beta}\left(\left(\frac{T}{n}\right)^{\varepsilon}\right) \le c_{(7.9)}|\log(n+1)|^{\beta} \tag{7.9}$$

for $c_{(7.9)} = c_{(7.9)}(T, \varepsilon, \beta) > 0$, and inserting (7.8) into itself leads to

+ c_{(7.8)}^{2}c_{(7.9)} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \int_{(\underline{t}+h)\wedge T}^{T} \frac{1}{(T-s)^{\frac{1-\varepsilon}{2}}(T-\underline{s})^{\frac{\varepsilon}{2}}\Phi_{\beta}((T-\underline{s})^{\varepsilon})} \frac{ds}{\sqrt{\underline{s}-\underline{t}}} \\
+ c_{(7.8)}^{2} \int_{(t+h)\wedge T}^{T} \int_{(s+h)\wedge T}^{T} \gamma_{n}(r) \frac{dr}{\sqrt{\underline{r}-\underline{s}}} \frac{ds}{\sqrt{\underline{s}-\underline{t}}}.$$

Since $T - \underline{s} \ge T - s$ and $\Phi_{\beta}((T - \underline{s})^{\varepsilon}) \ge 1$ by Lemma 5.2, it holds that

$$(T-s)^{\frac{1-\varepsilon}{2}}(T-s)^{\frac{\varepsilon}{2}}\Phi_{\beta}((T-s)^{\varepsilon}) \ge (T-s)^{\frac{1}{2}}$$

In [BGGL21] (see the end of the proof) it is shown that

$$(7.10)$$

$$\left(\int_{t}^{T} \left| \nabla u_{\mathsf{f}_{n}}(s,\mathbf{x}(s)) - \Delta_{\mathsf{f}_{n}}^{n}(s,\mathbf{x}^{n}(s)) \right|^{2} ds \right)^{\frac{1}{2}} \leq c_{(7.11)} \left[\sup_{t \leq s \leq T} \Psi_{2\beta}(|\mathbf{x}(s) - \mathbf{x}^{n}(s)|^{2\varepsilon})^{\frac{1}{2}} + \left(1 + \sup_{t \leq s \leq T} |\mathbf{x}^{n}(s)| + \|\xi\|_{L^{2\varepsilon}} \right)^{\varepsilon} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \right],$$

$$(7.11)$$

where $c_{(7.10)}, c_{(7.11)} > 0$ depend mostly on $(T, \varepsilon, \alpha, |g|_{\varepsilon}, |f|_{\alpha;t}^{loc}, |f|_{\varepsilon;x}, L_{\mathsf{f}}, c_{(5.28)}) > 0$ and $c_{(7.11)} > 0$ depends additionally on β .

Proof. By Lemma 5.1 and Lemma 7.3 we have

$$\begin{split} \int_{t}^{T} \left[\left| \nabla u_{\mathsf{f}_{n}}(s,\mathbf{x}(s)) - \Delta_{\mathsf{f}_{n}}^{n}(s,\mathbf{x}^{n}(s)) \right|^{2} \right] \mathrm{d}s \\ &\leq 2 \int_{t}^{T} \left[\left| \nabla u_{\mathsf{f}_{n}}(s,\mathbf{x}(s)) - \nabla u_{\mathsf{f}_{n}}(s,\mathbf{x}^{n}(s)) \right|^{2} + \left| \nabla u_{\mathsf{f}_{n}}(s,\mathbf{x}^{n}(s)) - \Delta_{\mathsf{f}_{n}}^{n}(s,\mathbf{x}^{n}(s)) \right|^{2} \right] \mathrm{d}s \\ &\leq 2 \int_{t}^{T} \left[c_{(5.17)}^{2} \frac{\Psi_{2\beta}(|\mathbf{x}(s) - \mathbf{x}^{n}(s)|^{2\varepsilon})}{(T - s)\Phi_{\beta}((T - s)^{\varepsilon})^{2}} \right. \\ &\qquad \qquad + c_{(7.6)}^{2} \frac{(1 + |\mathbf{x}^{n}(s)| + \|\xi\|_{L^{2\varepsilon}})^{2\varepsilon} n^{-(2\alpha)\wedge\varepsilon} \Phi_{\beta} \left(\left(\frac{T}{n}\right)^{\varepsilon} \right)^{2}}{(T - s)^{1 - \varepsilon} (T - \underline{s})^{\varepsilon} \Phi_{\beta}((T - \underline{s})^{\varepsilon})^{2}} \right] ds \end{split}$$

$$\leq \left[2c_{(5.17)}^2 \int_t^T \frac{ds}{(T-s)\Phi_{\beta}((T-s)^{\varepsilon})^2} \right] \sup_{t \leq s \leq T} \Psi_{2\beta}(|\mathbf{x}(s) - \mathbf{x}^n(s)|^{2\varepsilon})$$

$$+ \left[2c_{(7.6)}^2 \int_t^T \frac{ds}{(T-s)^{1-\varepsilon}(T-\underline{s})^{\varepsilon}\Phi_{\beta}((T-\underline{s})^{\varepsilon})^2} \right] \times$$

$$\times \left(1 + \sup_{t \leq s \leq T} |\mathbf{x}^n(s)| + \|\xi\|_{L^{2\varepsilon}} \right)^{2\varepsilon} n^{-(2\alpha)\wedge\varepsilon}\Phi_{\beta}\left(\left(\frac{T}{n}\right)^{\varepsilon}\right)^2$$

$$\leq c \left[\sup_{t \leq s \leq T} \Psi_{2\beta}(|\mathbf{x}(s) - \mathbf{x}^n(s)|^{2\varepsilon}) + \left(1 + \sup_{t \leq s \leq T} |\mathbf{x}^n(s)| + \|\xi\|_{L^{2\varepsilon}}\right)^{2\varepsilon} n^{-(2\alpha)\wedge\varepsilon}(\log n)^{2\beta} \right].$$

7.3 Comparing (Y^n, Z^n) and $(Y_{f_n}^n, Z_{f_n}^n)$

We proceed with comparing the solutions to (1.5) and (1.8). To do so we use the following a priori estimates:

Lemma 7.5 (A priori estimates). For data $(\eta_i, f^i)_{i=1,2}$ with $\eta_i \in L^2(\Omega, \mathcal{F}, \mathbb{P})$ and the corresponding solutions $((Y_{t_k}^{n,i})_{k=j}^n, (Z_{t_k}^{n,i})_{k=j+1}^n)$ to the random walk BSDEs

where $n \geq n_0$ (and where $f = f_2$ in (i)),

(i) one has for continuous $f^i: [t_o, T] \times \mathbb{R} \times \mathbb{R} \times \mathbb{R} \to \mathbb{R}$ satisfying

$$\mathbb{E}_{k-1} \left[\sup_{k-1 \le m \le n} \left| Y_{t_m}^{n,1} - Y_{t_m}^{n,2} \right|^2 + \int_{]t_{k-1},T]} \left| Z_s^{n,1} - Z_s^{n,2} \right|^2 d\langle B^n \rangle_s \right] \\
\le c_{(7.12)} \mathbb{E}_{k-1} \left[\left| \eta_1 - \eta_2 \right|^2 \right. \\
+ \int_{]t_{k-1},T]} \left| f^1(s, B_{s^-}^n, Y_{s^-}^{n,1}, Z_s^{n,1}) - f^2(s, B_{s^-}^n, Y_{s^-}^{n,1}, Z_s^{n,1}) \right|^2 d\langle B^n \rangle_s \right], \tag{7.12}$$

where $c_{(7.12)} > 0$ depends at most on (T, L_{f^2}) .

(ii) For the special case $\eta_1 = \eta_2$,

with f satisfying (2.1) and $\mu^i, \nu^i : [t_o, T] \to \mathcal{P}_2(\mathbb{R}) : t \mapsto \mu^i_t, t \mapsto \nu^i_t$ measurable w.r.t. $(\mathcal{B}([0,T]), \mathcal{B}(\mathcal{P}_2(\mathbb{R})))$ we get

\leq c_{(7.14)}\left[\int_{]t_{k-1},T]}\mathcal{W}_{2}^{2}(Y_{s}^{n,2},\mu_{s}^{2})d\langle B^{n}\rangle_{s}+\int_{]t_{k-1},T]}\mathcal{W}_{2}^{2}(Z_{s}^{n,2},\nu_{s}^{2})d\langle B^{n}\rangle_{s}\right], \quad (7.14)$$

where $c_{(7.14)} > 0$ depends at most on (T, L_f) .

Proof. (i) We use the short notation

where we used that $|\Delta Y_{t_m}|^2 = (-hf_{t_m} + Z_{t_m}\Delta B_{t_m}^n)^2 \ge -h^2f_{t_m}^2 + \frac{1}{2}Z_{t_m}^2(\Delta B_{t_m}^n)^2$. From this we derive exploiting relations like

$$\leq \eta^2 + 2 \int_{]t_{k-1},T]} |\mathsf{Y}_{s-}||f_s|d\langle B^n\rangle_s - 2 \int_{]t_{k-1},T]} \mathsf{Y}_{s-} \mathsf{Z}_s dB_s^n \\ + \int_{]t_{k-1},T]} h|f_s|^2 d\langle B^n\rangle_s - \frac{1}{2} \int_{]t_{k-1},T]} \mathsf{Z}_s^2 d\langle B^n\rangle_s.$$

Assume $\delta > 0$. By Young's inequality we have $2|\mathsf{Y}_{s-}||f_s| \leq \frac{|\mathsf{Y}_{s-}|^2}{\delta} + \delta|f_s|^2$ which implies

From $|f_{t_k}|^2 \le 2L_{f^2}^2 |\mathsf{Z}_{t_k}|^2 + 4|f_{t_k}^{=}|^2 + 4L_{f^2}^2 |\mathsf{Y}_{t_{k-1}}|^2$ and for

we obtain

$$\begin{split} &|\mathsf{Y}_{t_{k-1}}|^2 + \frac{1}{4} \int_{]t_{k-1},T]} \mathsf{Z}_s^2 d\langle B^n \rangle_s \\ &\leq |\mathsf{Y}_{t_{k-1}}|^2 + \left(\frac{1}{2} - 2L_{f^2}^2(\delta + h)\right) \int_{]t_{k-1},T]} \mathsf{Z}_s^2 d\langle B^n \rangle_s \\ &\leq \eta^2 + \left(\frac{1}{\delta} + 4L_{f^2}^2(\delta + h)\right) \int_{]t_{k-1},T]} |\mathsf{Y}_{s-}|^2 d\langle B^n \rangle_s + 4(\delta + h) \int_{]t_{k-1},T]} |f_s^{=}|^2 d\langle B^n \rangle_s \\ &- 2 \int_{]t_{k-1},T]} \mathsf{Y}_{s-} \mathsf{Z}_s dB_s^n \\ &\leq \eta^2 + \left(\frac{1}{\delta} + 4L_{f^2}^2(\delta + h)\right) \int_{]t_{k-1},T]} |\mathsf{Y}_{s-}|^2 d\langle B^n \rangle_s + 4(\delta + h) \int_{]t_{k-1},T]} |f_s^{=}|^2 d\langle B^n \rangle_s \\ &- 2 \int_{]t_{k-1},T]} \mathsf{Y}_{s-} \mathsf{Z}_s dB_s^n. \end{split}$$

If

$$h\left(\frac{1}{\delta} + 4L_{f^2}^2(\delta + h)\right) \le \frac{1}{2} \tag{7.16}$$

we write

$$\begin{split} &\frac{1}{2}|\mathsf{Y}_{t_{k-1}}|^2 + \frac{1}{4}\int_{]t_{k-1},T]}\mathsf{Z}_s^2d\langle B^n\rangle_s\\ &\leq \eta^2 + \left(\frac{1}{\delta} + 4L_{f^2}^2(\delta+T)\right)\int_{]t_{k-1},T[}|\mathsf{Y}_s|^2d\langle B^n\rangle_s + 4(\delta+T)\int_{]t_{k-1},T]}|f_s^{=}|^2d\langle B^n\rangle_s \end{split}$$

$$-2\int_{]t_{k-1},T]} \mathsf{Y}_{s-} \mathsf{Z}_{s} dB_{s}^{n}. \tag{7.17}$$

Taking the conditional expectation we get for $j < l \le k \le n$ that

$$\begin{split} \frac{1}{2}\mathbb{E}_{l-1}|\mathsf{Y}_{t_{k-1}}|^2 + \frac{1}{4}\mathbb{E}_{l-1} \int_{]t_{k-1},T]} \mathsf{Z}_s^2 d\langle B^n \rangle_s \\ & \leq \mathbb{E}_{l-1}\eta^2 + \left(\frac{1}{\delta} + 4L_{f^2}^2(\delta + T)\right) \int_{]t_{k-1},T[} \mathbb{E}_{l-1}|\mathsf{Y}_s|^2 d\langle B^n \rangle_s \\ & + 4(\delta + T)\mathbb{E}_{l-1} \int_{]t_{l-1},T]} |f_s^-|^2 d\langle B^n \rangle_s \quad (7.18) \end{split}$$

where we enlarged the RHS by extending $]t_{k-1}, T]$ to $]t_{l-1}, T]$. Gronwall's Lemma 9.1 implies

the relations (7.18) and (7.19) imply

with $c_{(7.20)} = c_{(7.20)}(T, L_{f^2}, \delta) > 0$. Coming again back to (7.17), similarly as before we apply Gronwall's inequality, where we additionally estimate the stochastic integral by its supremum, and get

$$\leq \lambda \mathbb{E}_{k-1} \mathsf{Y}_{*}^{2} + \frac{1}{\lambda} \mathbb{E}_{k-1} \left| \int_{]t_{k-1},T]} \mathsf{Z}_{s}^{2} d\langle B^{n} \rangle_{s} \right|. \tag{7.22}$$

By (7.21), (7.22), and (7.20) we conclude

$$\mathbb{E}_{k-1} \, \mathsf{Y}_{*}^{2} \le c_{(7.21)} \mathbb{E}_{k-1} \left(K + \sup_{k \le m \le n} \left| \int_{]t_{m-1}, T]} \mathsf{Y}_{s-} \mathsf{Z}_{s} dB_{s}^{n} \right| \right)$$

$$\leq c_{(7.21)} \left(\mathbb{E}_{k-1} K + \beta_1 \lambda \mathbb{E}_{k-1} \, \mathsf{Y}_*^2 + \frac{\beta_1}{\lambda} \mathbb{E}_{k-1} \, \left| \int_{]t_{k-1},T]} \mathsf{Z}_s^2 d \langle B^n \rangle_s \right| \right) \\ \leq c_{(7.21)} \left(\mathbb{E}_{k-1} K + \beta_1 \lambda \mathbb{E}_{k-1} \, \mathsf{Y}_*^2 + \frac{\beta_1}{\lambda} c_{(7.20)} \, \mathbb{E}_{k-1} \, K \right).$$

For small enough $\lambda > 0$ we conclude

$$\mathbb{E}_{k-1} \,\mathsf{Y}_*^2 \le c_{(7,23)} \mathbb{E}_{k-1} \,K. \tag{7.23}$$

The assertion follows by (i).

(iii) We use

$$|f_s^{-}| \le L_f(\mathcal{W}_2(Y_s^{n,1}, \mu_s^2) + \mathcal{W}_2(Z_s^{n,1}, \nu_s^2) \le L_f \left[\|\mathbf{Y}_s\|_{L^2} + \|\mathbf{Z}_s\|_{L^2} + \mathcal{W}_2(Y_s^{n,2}, \mu_s^2) + \mathcal{W}_2(Z_s^{n,2}, \nu_s^2) \right],$$
(7.24)

so that, with $|f_s^{\mathcal{W}}| := \mathcal{W}_2(Y_s^{n,2}, \mu_s^2) + \mathcal{W}_2(Z_s^{n,2}, \nu_s^2)$, we have

$$|f_s^{\pm}|^2 \le 2L_f^2 \|\mathsf{Z}_s\|_{L^2}^2 + 4L_f^2 (\|\mathsf{Y}_s\|_{L^2}^2 + |f_s^{\mathcal{W}}|^2).$$

with $c_{(7.25)} = c_{(7.25)}(T, L_f, \delta) > 0$. By Gronwall's inequality

$$\mathbb{E}|\mathsf{Y}_{t_{k-1}}|^2 \le c_{(7.26)}\mathbb{E}K' \tag{7.26}$$

for $c_{(7,26)} = c_{(7,26)}(T, L_f, \delta) > 0$. Therefore we get

where $c_{(7.28)} = c_{(7.28)}(T, L_f, \delta) > 0$. Finally we choose $\delta > 0$ in (7.15) such that $L_{f^2}^2 \delta = \frac{1}{16}$ and can arrange some $n_0 = n_0(T, L_f) \in \mathbb{N}$ such that for $n \geq n_0$ the conditions (7.15) and (7.16) are satisfied.

Lemma 7.6. Assume that Assumption 2.2 holds and let $\beta > \frac{1}{2}$ or $\beta = 0$. Then there exists a constant $c = c(T, \varepsilon, \alpha, \beta, |g|_{\varepsilon}, |f|_{\alpha;t}^{loc}, |f|_{\varepsilon;x}, L_f, c_{f_0}^{(2)}, \xi) > 0$ such that for all $x \in \mathbb{R}$ and $n \geq n_0$,

 for all $t_o \le t \le s < T$.

Proof. Assertion (i) as well as (ii) for $\beta = 0$ are proved in [BGGL21, Theorem 12]. where $c_{(7.30)} = c_{(7.30)}(T, \varepsilon, \alpha, \beta, |g|_{\varepsilon}, |f|_{\alpha;t}^{loc}, |f|_{\varepsilon;x}, L_f, c_{f_0}^{(2)}, f_0, \xi) > 0$, and

\leq c_{(7.31)} (1 + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon} \frac{\left| \log(n+1) \right|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}}, \quad (7.31)$$

$$\int_{]t_{n-1},T]} \mathcal{W}_{2}^{2}(Z_{\mathsf{f}_{n},s\wedge t_{n-1}}^{n,t_{o},\xi}, Z_{\mathsf{f}_{n},s}^{n,t_{o},\xi}) d\langle B^{n} \rangle_{s} = \mathcal{W}_{2}^{2}(Z_{\mathsf{f}_{n},t_{n-1}}^{n,t_{o},\xi}, Z_{\mathsf{f}_{n},T}^{n,t_{o},\xi}) h$$

$$\leq h \left(\mathbb{E}|Z_{\mathsf{f}_{n},t_{n-1}}^{n,t_{o},\xi} - Z_{\mathsf{f}_{n},T}^{n,t_{o},\xi}|^{2} \right)$$

$$\leq 2h \left(\mathbb{E}|Z_{\mathsf{f}_{n},t_{n-1}}^{n,t_{o},\xi}|^{2} + \mathbb{E}|Z_{\mathsf{f}_{n},T}^{n,t_{o},\xi}|^{2} \right). \tag{7.38}$$

For the solution to (1.8) we use the scheme (6.3)-(6.4). Hence by (6.3) we have (denoting by \widetilde{E} the expectation w.r.t. $\widetilde{\zeta}_n$, independent of $B_{t_{n-1}}^{n,t_0,\xi}$)

$$\begin{split} |Z^{n,t_{o},\xi}_{\mathsf{f}_{n},t_{n}}| &= \left| h^{-1/2} \mathbb{E} \left[Y^{n,t_{o},\xi}_{\mathsf{f}_{\mathsf{n}},\mathsf{t}_{\mathsf{n}}} \zeta_{n} \, | \, \mathcal{F}^{n}_{t_{n-1}} \right] \right| = |h^{-1/2} \widetilde{\mathbb{E}} g(B^{n,t_{o},\xi}_{t_{n-1}} + \sqrt{h} \widetilde{\zeta}_{n}) \widetilde{\zeta}_{n}| \\ &\leq \frac{|g(B^{n,t_{o},\xi}_{t_{n-1}} + \sqrt{h}) - g(B^{n,t_{o},\xi}_{t_{n-1}} - \sqrt{h})|}{2\sqrt{h}} \leq C|g|_{\varepsilon} h^{\frac{\varepsilon - 1}{2}}. \end{split}$$

By (6.4) and (6.3)

$$\begin{split} Z_{\mathsf{f}_{n},t_{n-1}}^{n,t_{o},\xi} &= h^{-1/2}\mathbb{E}\left[Y_{\mathsf{f}_{n},\mathsf{t}_{n-1}}^{n,t_{o},\xi}\zeta_{n-1}\,|\,\mathcal{F}_{t_{n-2}}^{n}\right] \\ &= h^{-1/2}\widetilde{\mathbb{E}}\left[g(B_{t_{n-2}}^{n,t_{o},\xi}+\sqrt{h}\widetilde{\zeta}_{n-1}+\sqrt{h}\widetilde{\zeta}_{n})\widetilde{\zeta}_{n-1}\right] \\ &+ h^{1/2}\,\mathbb{E}\left[\mathsf{f}_{n}\left(t_{n-1},B_{t_{n-1}}^{n,t_{o},\xi},Y_{\mathsf{f}_{n},\mathsf{t}_{n-1}}^{n,t_{o},\xi},Z_{\mathsf{f}_{n-1},\mathsf{t}_{n}}^{n,t_{o},\xi}\right)\zeta_{n-1}\,|\,\mathcal{F}_{t_{n-2}}^{n}\right]. \end{split}$$

Like above,

$$\left| h^{-1/2} \widetilde{\mathbb{E}} \left[g(B_{t_{n-2}}^{n,t_o,\xi} + \sqrt{h} \widetilde{\zeta}_{n-1} + \sqrt{h} \widetilde{\zeta}_n) \widetilde{\zeta}_{n-1} \right] \right| \le C |g|_{\varepsilon} h^{\frac{\varepsilon - 1}{2}}.$$

For the second term we estimate the second moment. By Jensen's inequality, (2.1) and the above estimates,

$$\begin{split} & \mathbb{E} \left| h^{1/2} \, \mathbb{E} \left[\mathsf{f}_{n} \left(t_{n-1}, B_{t_{n-1}}^{n,t_{o},\xi}, Y_{\mathsf{f}_{\mathsf{n}},\mathsf{t}_{\mathsf{n}-1}}^{n,t_{o},\xi}, Z_{\mathsf{f}_{\mathsf{n}},\mathsf{t}_{\mathsf{n}}}^{n,t_{o},\xi} \right) \zeta_{n-1} \, | \, \mathcal{F}_{t_{n-2}}^{n} \right] \right|^{2} \\ & \leq h \mathbb{E} \left| f \left(t_{n-1}, B_{t_{n-1}}^{n,t_{o},\xi}, Y_{\mathsf{f}_{\mathsf{n}},\mathsf{t}_{\mathsf{n}-1}}^{n,t_{o},\xi}, Z_{\mathsf{f}_{\mathsf{n}},\mathsf{t}_{\mathsf{n}}}^{n,t_{o},\xi}, [Y_{t_{n}}^{t_{o},\xi}], [Z_{t_{n-1}}^{t_{o},\xi}] \right) \right|^{2} \\ & \leq h C \left(f_{0}^{2} + (|f|_{\alpha;t}^{loc} + (1 + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon})^{2} \, \frac{|t_{n-1}|^{(2\alpha) \wedge \varepsilon}}{(T - t_{n-1})} + (|f|_{\varepsilon;x})^{2} \mathbb{E} |B_{t_{n-1}}^{n,t_{o},\xi}|^{2\varepsilon} \right) \end{split}$$

$$\begin{split} & + L_{f}^{2} \mathbb{E}|Y_{\mathsf{f_{n}},\mathsf{t_{n-1}}}^{n,t_{o},\xi}|^{2} + L_{f}^{2} \mathbb{E}|Z_{\mathsf{f_{n}},\mathsf{t_{n}}}^{n,t_{o},\xi}|^{2} + L_{f}^{2} \mathbb{E}|Y_{t_{n}}^{t_{o},\xi}|^{2} + L_{f}^{2} \mathbb{E}|Z_{t_{n-1}}^{t_{o},\xi}|^{2} \right) \\ & \leq C(hf_{0}^{2} + (|f|_{\alpha;t}^{loc} + (1 + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon})^{2} + h(|f|_{\varepsilon;x})^{2}(1 + \|\xi\|_{L^{2\varepsilon}})^{2\varepsilon} \\ & + hL_{f}^{2} \mathbb{E}|Y_{\mathsf{f_{n}},\mathsf{t_{n-1}}}^{n,t_{o},\xi}|^{2} + hL_{f}^{2}|g|_{\varepsilon}^{2}h^{\varepsilon-1} + hL_{f}^{2} \mathbb{E}|Y_{t_{n}}^{t_{o},\xi}|^{2} + hL_{f}^{2} \mathbb{E}|Z_{t_{n-1}}^{t_{o},\xi}|^{2} \right) \\ & \leq C(T,f_{0},|f|_{\alpha;t}^{loc},|f|_{\varepsilon;x},|g|_{\varepsilon},L_{f},\varepsilon) \left[(1 + \|\xi\|_{L^{2\varepsilon}})^{2\varepsilon} + hL_{f}^{2} \mathbb{E}|Y_{t_{n-1}}^{n,t_{o},\xi}|^{2} \right] , \end{split}$$

where we used (5.1), Lemma 5.1 and Proposition 5.5 to estimate $\mathbb{E}|Y_{t_n}^{t_o,\xi}|^2$ and $|Z_{t_{n-1}}^{t_o,\xi}|^2$. The estimate for $\mathbb{E}|Y_{\mathsf{f_n,t_{n-1}}}^{n,t_o,\xi}|^2$ follows from an a priori estimate which is an immediate consequence of Lemma 7.5(i) by setting $(\xi^1, f^1) := (g(B_T^{n,t_o,\xi}), f)$ and $(\xi^2, f^2) := (0,0)$:

\leq C(L_f,T,f_0,|f|_{\alpha;t}^{loc},|f|_{\varepsilon;x},\varepsilon) (1+\|\xi\|_{L^{2\varepsilon}})^{2\varepsilon}.$$

Summarizing we may estimate (7.36) by $C(1 + ||\xi||_{L^{2\varepsilon}})^{2\varepsilon} h^{\varepsilon}$.

Consequently, collecting all terms, we get using the estimates for (7.34), (7.35), and (7.36)

$$\leq C n^{-\varepsilon} (\log n)^{2\beta} + C (1 + \|\xi\|_{L^{2\varepsilon}})^{2\varepsilon} \frac{(\log n)^{2\beta}}{n^{2(\alpha \wedge \frac{\varepsilon}{2})}} + C (1 + \|\xi\|_{L^{2\varepsilon}})^{2\varepsilon} n^{-\varepsilon}$$

$$\leq C (1 + \|\xi\|_{L^{2\varepsilon}})^{2\varepsilon} \frac{(\log n)^{2\beta}}{n^{2(\alpha \wedge \frac{\varepsilon}{2})}}.$$

Inequality (7.31): We get from Lemma 7.5(ii) that

$$\mathbb{E}_{k-1} \left[\sup_{k-1 \le m \le n} \left| Y_{\mathsf{f}_{n},t_{m}}^{n,t,x} - Y_{t_{m}}^{n,t,x} \right|^{2} + \int_{]t_{k-1},T[} \left| Z_{\mathsf{f}_{n},s}^{n,t,x} - Z_{s}^{n,t,x} \right|^{2} d\langle B^{n} \rangle_{s} \right] \\
\leq c_{(7.12)} L_{f} \left[\int_{]t_{k-1},T]} \left[\mathcal{W}_{2}(Y_{s}^{t_{o},\xi},Y_{s}^{n,t_{o},\xi}) + \mathcal{W}_{2}^{2}(Z_{s \wedge t_{n-1}}^{t_{o},\xi},Z_{s}^{n,t_{o},\xi}) \right]^{2} d\langle B^{n} \rangle_{s} \right] \\
\leq C(1 + \|\xi\|_{L^{2\varepsilon}})^{p\varepsilon} \frac{(\log n)^{p\beta}}{n^{p(\alpha \wedge \frac{\varepsilon}{2})}},$$

where we use in the last step that

$$\begin{split} \mathcal{W}_2(Y_s^{t_o,\xi},Y_s^{n,t_o,\xi}) &\leq \mathcal{W}_2(Y_s^{t_o,\xi},Y_{\mathsf{f}_n,s}^{n,t_o,\xi}) + \mathcal{W}_2(Y_{\mathsf{f}_n,s}^{n,t_o,\xi},Y_s^{n,t_o,\xi}), \\ \mathcal{W}_2(Z_{s \wedge t_{n-1}}^{t_o,\xi},Z_s^{n,t_o,\xi}) &\leq \mathcal{W}_2(Z_{s \wedge t_{n-1}}^{t_o,\xi},Z_{\mathsf{f}_n,s}^{n,t_o,\xi}) + \mathcal{W}_2(Z_{\mathsf{f}_n,s}^{n,t_o,\xi},Z_s^{n,t_o,\xi}) \end{split}$$

and apply the estimates (7.33) and (7.30). Finally, we use Theorem 9.6 to deduce from (7.31) the relation (7.32).

8 Proof of Theorem 1.1

We start with a more general version of Theorem 1.1 which holds for any coupling (B, B^n) of the Brownian motion with the random walk. For the formulation we use Banach function norms, see [GG24, Chapter 18]:

Theorem 8.1. Let $\beta > \frac{1}{2}$. For $t \in [t_o, T)$ and $x, y \in \mathbb{R}$ one has

where $c_{(8.1)} = c_{(8.1)}(T, \varepsilon, \alpha, \beta, |g|_{\varepsilon}, |f|_{\alpha;t}^{loc}, |f|_{\varepsilon;x}, L_f, c_{f_0}^{(2)}, f_0, \xi) > 0$. If $\|\cdot\|$ is a Banach function norm such that $\|\cdot\| \leq \kappa |\cdot|_{M_{\varphi_1}}$, then one has

$$\frac{1}{c_{(8.2)}} \left\| \int_{t}^{T} \left| \nabla u(s, B_{s}^{t,x}) - \Delta^{n}(s, B_{s}^{n,\underline{t},y}) \right|^{2} ds \right\|^{\frac{1}{2}} \\
\leq \left\| \sup_{t \leq s \leq T} \Psi_{2\beta}(|B_{s}^{t,x} - B_{s}^{n,\underline{t},y}|^{2\varepsilon}) \right\|^{\frac{1}{2}} + \left\| \sup_{t \leq s \leq T} |B_{s}^{n,\underline{t},y}|^{2\varepsilon} \right\|^{\frac{1}{2}} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \\
+ \sqrt{\kappa} (1 + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}}. \tag{8.2}$$

for $n \ge n_0$, where $c_{(8.2)} = c_{(8.2)}(T, \varepsilon, \alpha, \beta, |g|_{\varepsilon}, |f|_{\alpha;t}^{loc}, |f|_{\varepsilon;x}, L_f, c_{f_0}^{(2)}, f_0, \xi) > 0$.

Proof. Proof of (8.1): We have by Proposition 7.1, Proposition 7.4, and Proposition 7.7 that

$$\begin{split} |u(t,x) - U^n(t,y)| &\leq |u(t,x) - u_{\mathsf{f}_n}(t,x)| + |u_{\mathsf{f}_n}(t,x) - U^n_{\mathsf{f}_n}(t,y)| + |U^n_{\mathsf{f}_n}(t,y) - U^n(t,y)| \\ &\leq c_{(7.2)} \, n^{-((\alpha \wedge \frac{\varepsilon}{2}) + \frac{1}{2})} \\ &\quad + c_{(7.10)} \left[|x - y|^{\varepsilon} + (1 + |x| + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon} \, n^{-\alpha \wedge \frac{\varepsilon}{2}} \right] \\ &\quad + c_{(7.31)} (1 + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}}. \end{split}$$

Proof of (8.2): Again by Proposition 7.1, Proposition 7.4, and Proposition 7.7 we get

$$\begin{split} \frac{1}{3} \left\| \int_{t}^{T} \left| \nabla u(s, B_{s}^{t,x}) - \Delta^{n}(s, B_{s}^{n,\underline{t},y}) \right|^{2} \mathrm{d}s \right\| \\ & \leq \left\| \int_{t}^{T} \left| \nabla u(s, B_{s}^{t,x}) - \nabla u_{\mathbf{f}_{n}}(s, B_{s}^{t,x}) \right|^{2} \mathrm{d}s \right\| \\ & + \left\| \int_{t}^{T} \left| \nabla u_{\mathbf{f}_{n}}(s, B_{s}^{t,x}) - \Delta_{\mathbf{f}_{n}}^{n}(s, B_{s}^{n,\underline{t},y}) \right|^{2} \mathrm{d}s \right\| \\ & + \left\| \int_{t}^{T} \left| \Delta_{\mathbf{f}_{n}}^{n}(s, B_{s}^{n,\underline{t},y}) - \Delta^{n}(s, B_{s}^{n,\underline{t},y}) \right|^{2} \mathrm{d}s \right\| \\ & \leq \kappa \left[c_{(7.3)} c_{(7.2)} \, n^{-((\alpha \wedge \frac{\varepsilon}{2}) + \frac{1}{2})} \right]^{2} \\ & + 3 c_{(7.11)}^{2} \left[\left\| \sup_{t \leq s \leq T} \Psi_{2\beta}(|B_{s}^{t,x}) - B_{s}^{n,\underline{t},y}|^{2\varepsilon} \right) \right\| \\ & + \left\| \sup_{t \leq s \leq T} |B_{s}^{n,\underline{t},y}|^{2\varepsilon} \right\| \left| \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \right|^{2} \end{split}$$

$$+ (1 + \|\xi\|_{L^{2\varepsilon}})^{2\varepsilon} \left| \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \right|^{2} \right]$$

$$+ \kappa \left[c_{(7.32)} c_{(7.31)} (1 + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \right]^{2}.$$

To apply Theorem 8.1 we use the following estimate:

Lemma 8.2. Let $\beta > \frac{1}{2}$. Assume random variables such that $\sup_{p \in [1,\infty)} \sup_{n \geq 1} \frac{\|\theta_n\|_{L^p}}{p} \leq 1$ and constants $c_n > 0$. Then one has

for $p \ge 1$, where $c_{(8.3)} = c_{(8.3)}(\varepsilon, \beta) > 0$.

Proof. We recall that $\Psi_{2\beta}(r) = r \left(\log \left(\frac{1}{r \wedge \hat{r}} \right) \right)^{2\beta}$ and use for $\gamma, a, b > 0$ and $x \ge 1$ that it holds

= \mathbb{E}\left[|c_{n}\theta_{n}|^{\varepsilon p}\left(\log\left(\frac{1}{|c_{n}\theta_{n}|^{2\varepsilon}\wedge\hat{r}}\right)\right)^{\beta p}\right] \\
\leq 2^{(p\beta-1)^{+}}\left\{\mathbb{E}\left[|c_{n}\theta_{n}|^{\varepsilon p}\left(\log\left(\frac{1}{c_{n}^{2\varepsilon}\wedge\sqrt{\hat{r}}}\right)\right)^{\beta p}\right] + \mathbb{E}\left[|c_{n}\theta_{n}|^{\varepsilon p}\left(\log\left(\frac{1}{|\theta_{n}|^{2\varepsilon}\wedge\sqrt{\hat{r}}}\right)\right)^{\beta p}\right]\right\} \\
= c_{n}^{\varepsilon p}2^{(p\beta-1)^{+}}\left[\left|\log\left(\frac{1}{c_{n}^{2\varepsilon}\wedge\sqrt{\hat{r}}}\right)\right|^{\beta p}\mathbb{E}\left[|\theta_{n}|^{\varepsilon p}\right] + \mathbb{E}\left[|\theta_{n}|^{\varepsilon p}\left(\log\left(\frac{1}{|\theta_{n}|^{2\varepsilon}\wedge\sqrt{\hat{r}}}\right)\right)^{\beta p}\right]\right].$$

Now, using $\beta p \gamma = \frac{1}{2}$,

$$\begin{split} \mathbb{E}\left[|\theta_n|^{\varepsilon p}\left(\log\left(\frac{1}{|\theta_n|^{2\varepsilon}\wedge\sqrt{\hat{r}}}\right)\right)^{p\beta}\right] &\leq \mathbb{E}\left[|\theta_n|^{\varepsilon p}\frac{1}{\gamma^{\beta p}}\left|\frac{1}{|\theta_n|^{2\varepsilon}\wedge\hat{r}}\right|^{\beta p\gamma}\right] \\ &\leq \mathbb{E}\left[|\theta_n|^{\varepsilon p}\frac{1}{\gamma^{\beta p}}\left|\frac{1}{|\theta_n|^{2\varepsilon}}+\frac{1}{\hat{r}}\right|^{\beta p\gamma}\right] \\ &\leq \frac{1}{\gamma^{\beta p}}\mathbb{E}\left[|\theta_n|^{\varepsilon p}\left[\frac{1}{|\theta_n|^{\varepsilon}}+\frac{1}{\hat{r}^{1/2}}\right]\right] \\ &= (2\beta p)^{\beta p}\left[\mathbb{E}|\theta_n|^{\varepsilon(p-1)}+\mathbb{E}|\theta_n|^{\varepsilon p}\frac{1}{\hat{r}^{1/2}}\right]. \end{split}$$

Finally, we observe for $\varepsilon(p-1) \geq 1$ that

$$\left((\mathbb{E}|\theta_n|^{\varepsilon(p-1)})^{\frac{1}{\varepsilon(p-1)}} \right)^{\frac{\varepsilon(p-1)}{p}} \leq (\varepsilon(p-1))^{\frac{\varepsilon(p-1)}{p}} \leq (\varepsilon p)^{\frac{\varepsilon(p-1)}{p}}.$$

So we get for $p \ge 1 + \frac{1}{\varepsilon}$ that

$$\begin{split} & \left\| \Psi_{2\beta} (|c_n \theta_n|^{2\varepsilon})^{\frac{1}{2}} \right\|_{L^p}^p \\ & \leq c_n^{\varepsilon p} 2^{(p\beta-1)^+} \left[\left| \log \left(\frac{1}{c_n^{2\varepsilon} \wedge \sqrt{\hat{r}}} \right) \right|^{\beta p} (\varepsilon p)^{\varepsilon p} + (2\beta p)^{\beta p} \left[(\varepsilon (p-1))^{\varepsilon (p-1)} + (\varepsilon p)^{\varepsilon p} \frac{1}{\hat{r}^{1/2}} \right] \right]. \end{split}$$

Taking the p-th root the result follows (as the L^p -norm is monotone in p the range $p \ge 1 + \frac{1}{\varepsilon}$ instead of $p \ge 2$ is sufficient).

Proof of Theorem 1.1. Here we assume the coupling of the Brownian motion with the random walk such that the RHS of (4.4) is satisfied. For $p \in [2, \infty)$ and $q := p/2 \in [1, \infty)$ we have that

 i.e. $\kappa = \kappa_0 q$

for some $\kappa_0 > 0$. Then Theorem 8.1 implies that

$$\begin{split} \frac{1}{c_{(8.2)}} \left\| \left(\int_{t}^{T} \left| \nabla u(s, B_{s}^{t,x}) - \Delta^{n}(s, B_{s}^{n,\underline{t},y}) \right|^{2} \mathrm{d}s \right)^{\frac{1}{2}} \right\|_{L^{p}} \\ &= \frac{1}{c_{(8.2)}} \left\| \int_{t}^{T} \left| \nabla u(s, B_{s}^{t,x}) - \Delta^{n}(s, B_{s}^{n,\underline{t},y}) \right|^{2} \mathrm{d}s \right\|_{L^{q}}^{\frac{1}{2}} \\ &\leq \left\| \sup_{t \leq s \leq T} \Psi_{2\beta}(|B_{s}^{t,x} - B_{s}^{n,\underline{t},y}|^{2\varepsilon}) \right\|_{L^{q}}^{\frac{1}{2}} + \left\| \sup_{t \leq s \leq T} |B_{s}^{n,\underline{t},y}|^{2\varepsilon} \right\|_{L^{q}}^{\frac{1}{2}} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \\ &+ \sqrt{\kappa_{0}q} (1 + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \\ &= \left\| \sup_{t \leq s \leq T} \Psi_{2\beta}(|B_{s}^{t,x} - B_{s}^{n,\underline{t},y}|^{2\varepsilon})^{\frac{1}{2}} \right\|_{L^{p}} + \left\| \sup_{t \leq s \leq T} |B_{s}^{n,\underline{t},y}|^{\varepsilon} \right\|_{L^{p}} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \\ &+ \sqrt{p} \left[\sqrt{\frac{\kappa_{0}}{2}} (1 + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \right]. \end{split}$$

Now let

$$c_n \theta_n = \sup_{t \le s \le T} |B_s^{t,x} - B_s^{n,\underline{t},y}|$$

where $\sup_{p\in[1,\infty)}\sup_{n\geq 1}\frac{\|\theta_n\|_{L_p}}{p}\leq 1$. By Theorem 4.2 we can arrange

$$c_n := c \frac{\log(n+1)}{\sqrt{n}}$$
 for some absolute constant $c > 0$.

For x = y we deduce by Lemma 8.2 that

$$\frac{1}{c_{(8.2)}} \left\| \left(\int_t^T \left| \nabla u(s, B_s^{t,x}) - \Delta^n(s, B_s^{n,\underline{t},x}) \right|^2 \mathrm{d}s \right)^{\frac{1}{2}} \right\|_{L^p}$$

$$\leq c_{(8.3)} c_n^{\varepsilon} \left| \log \left(\frac{1}{c_n^{2\varepsilon} \wedge \sqrt{\hat{r}}} \right) \right|^{\beta} p^{\varepsilon + \beta} + \left\| \sup_{t \leq s \leq T} |B_s^{n,\underline{t},x}|^{\varepsilon} \right\|_{L^p} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}}$$

$$+ \sqrt{p} \left[\sqrt{\frac{\kappa_0}{2}} (1 + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \right].$$

Finally, we use Doob's maximal inequality and Hoeffding's inequality (3.3) to get

$$\left\| \sup_{t \le s \le T} |B_s^{n,\underline{t},x}|^{\varepsilon} \right\|_{L^p} \le |x|^{\varepsilon} + \left\| \sup_{t \le s \le T} |B_s^{n,\underline{t},0}|^{\varepsilon} \right\|_{L^p} \le |x|^{\varepsilon} + cp^{\frac{\varepsilon}{2}}$$

with $c = c(T, \varepsilon) > 0$.

Similarly, we observe that Theorem 8.1 implies that

$$\begin{split} & \left\| \sup_{s \in [t,T]} \left| u(s,B_s^{t,x}) - U^n(s,B_s^{n,t,x}) \right| \right\|_{L^p} \\ & \leq c_{(8.1)} \left\| \sup_{s \in [t,T]} \left[|B_s^{t,x} - B_s^{n,t,x}|^{\varepsilon} + (1 + |B_s^{t,x}| + \|\xi\|_{L^{2\varepsilon}})^{\varepsilon} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \right] \right\|_{L^p} \\ & \leq c_{(8.1)} \left[\left\| \sup_{s \in [t,T]} |B_s^{t,x} - B_s^{n,t,x}|^{\varepsilon} \right\|_{L^p} + \left\| \sup_{s \in [t,T]} |B_s^{t,x}|^{\varepsilon} \right\|_{L^p} \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \right. \\ & \qquad \qquad + \left[1 + \|\xi\|_{L^{2\varepsilon}}^{\varepsilon} \right] \frac{|\log(n+1)|^{\beta}}{n^{\alpha \wedge \frac{\varepsilon}{2}}} \right]. \end{split}$$

Finally we use the Theorem 4.2 (applied to εp , where we assume w.l.o.g. that $\varepsilon p \geq 1$) which gives

$$\left\|\sup_{s\in[t,T]}|B_s^{t,x}-B_s^{n,t,x}|^{\varepsilon}\right\|_{L^p} = \left\|\sup_{s\in[t,T]}|B_s^{t,x}-B_s^{n,t,x}|\right\|_{L^{\varepsilon p}}^{\varepsilon} \le c_{(4.4)}^{\varepsilon}\left\|\varepsilon p \frac{\log(n+1)}{n^{\frac{1}{2}}}\right\|^{\varepsilon},$$

and again

$$\left\| \sup_{s \in [t,T]} |B_s^{t,x}|^{\varepsilon} \right\|_{L^p} \le |x|^{\varepsilon} + c' p^{\frac{\varepsilon}{2}}$$

for some $c' = c'(T, \varepsilon) > 0$.

9 Appendix

9.1 Gronwall lemmas

Lemma 9.1. Let $\theta \in [0,1[$ and $A,B \geq 0,$ and assume that $f:[0,T] \rightarrow [0,\infty[$ is a bounded, Borel measurable function. Then

(i)
$$f(t) \leq A + B \int_t^T \frac{f(r)}{(T-r)^{\theta}} dr$$
, $t \in [0,T]$, implies that $f(t) \leq A e^{B \int_t^T (T-s)^{-\theta} ds}$, $t \in [0,T]$.

(ii)
$$f(t_{k-1}) \leq A + B \int_{]t_{k-1},T[} \frac{f(r)}{(T-r)^{\theta}} d\langle B^n \rangle_r$$
 for $k=1,...,n$ implies that

$$f(t_{k-1}) \le Ae^{B\int_{t_k}^T (T-s)^{-\theta} ds}$$

for k = 1, ..., n.

Proof. We follow [EK86, Theorem 5.1, Appendix] claiming that for a finite Borel measure μ on [0,T] the relation

$$f(t) \le A + \int_{[t,T[} f(s)d\mu(s)$$

implies

$$f(t) \leq A + \int_{]t,T[} Ad\mu(s) + \int_{]t,T[} \int_{]s,T[} f(s_1)d\mu(s_1)d\mu(s)$$

$$\leq A \sum_{n=0}^{\infty} \frac{(\mu(]t,T[))^n}{n!} = Ae^{\mu(]t,T[)},$$

where we used that

$$\int_{]t,T[} \int_{]s_1,T[} ... \int_{]s_{n-1},T[} f(s_n) d\mu(s_n) ... d\mu(s_2) d\mu(s_1) \to 0, \quad n \to \infty.$$

Then (i) follows from setting $\mu(]t,T[):=B\int_t^T(T-s)^{-\theta}ds.$

For (ii) we put $\mu(]t,T[):=B\int_{]t,T[}\frac{1}{(T-r)^{\theta}}d\langle B^{n}\rangle_{r}$ which yields to

$$f(t_{k-1}) \le Ae^{B\int_{]t_{k-1},T[\frac{1}{(T-r)\theta}}d\langle B^n\rangle_r}$$

Using the definition of $d\langle B^n\rangle_r$ we get the assertion from

$$\int_{]t_{k-1},T[} \frac{1}{(T-r)^{\theta}} d\langle B^n \rangle_r = \sum_{m=k}^{n-1} h \frac{1}{(T-t_m)^{\theta}} \le \sum_{m=k}^{n-1} \int_{t_m}^{t_{m+1}} \frac{1}{(T-r)^{\theta}} dr = \int_{t_k}^T \frac{1}{(T-r)^{\theta}} dr.$$

We formulate a Gronwall lemma of Volterra type. It can be either proved directly by a convolution argument or one can use [Hen81, Exercise 4, page 190].

Lemma 9.2. Assume a measurable $g:[0,T[\to [0,\infty[\in L_1([0,T[) \text{ and } \alpha,\beta>0 \text{ such that}$

$$g(t) \le \frac{\alpha}{(T-t)^{\alpha}} + \beta \int_{t}^{T} \frac{g(s)}{(s-t)^{\beta}} ds$$

for all $t \in [0, T[. Then g(t) \le c \frac{\alpha}{(T-t)^{\alpha}} \text{ for } t \in [0, T[\text{ for a constant } c = c(T, \alpha, \beta) > 0.$

9.2 Bounded mean oscillation

We use the following notation: If $(\Omega, \mathcal{F}, \mathbb{P})$ is a probability space and $F \in \mathcal{F}$ of positive measure, then $\mathbb{P}_F(A) := \mathbb{P}(A)/\mathbb{P}(F)$, for $A \subseteq F$ with $A \in \mathcal{F}$, is the restriction of \mathbb{P} to F equipped with the trace σ -algebra. Then, by Section 3,

$$|f|_{M_{\varphi_1}(F,\mathbb{P}_F)}:=\inf\left\{c>0:\mathbb{P}_F(|f|>\lambda)\leq e^{1-\frac{\lambda}{c}}\text{ for }\lambda\geq c\right\}.$$

We will use the following two statements, where we remark that in [Gei97] the spaces M_{φ} are denoted by M_{φ}^{0} :

Definition 9.3. For $p \in (0, \infty)$ and an adapted *continuous* process $(A_t)_{t \in [0,T)}$ with $A_0 = 0$ on a stochastic basis $(\Omega, \mathcal{F}, \mathbb{P}, (\mathcal{F}_t)_{t \in [0,T]})$ sharing the usual conditions we define

$$||A||_{\mathrm{BMO}_{p}([0,T))} := \inf c,$$

where the infimum is taken over all $c \geq 0$ such that for all $0 \leq a \leq t < T$ one has

$$\mathbb{E}[|A_t - A_a|^p | \mathcal{F}_a] \le c^p \quad a.s.$$

The John-Nirenberg theorem for *continuous* adapted processes reads as follows:

Theorem 9.4 ([DM82, p. 176]). For $p \in (0, \infty)$ there is a constant $c_{(9.1)} = c_{(9.1)}(p) > 0$ such that for all $t \in [0, T)$ and $F \in \mathcal{F}_t$ with $\mathbb{P}(F) > 0$ one has

$$||A_T - A_t||_{M_{(2)}(F, \mathbb{P}_F)} \le c_{(9.1)} ||A||_{BMO_n([0,T))}.$$
 (9.1)

Definition 9.5. For $p \in (0, \infty)$ and an adapted process $(A_n)_{n=0}^N$ with $A_0 = 0$ on a stochastic basis $(\Omega, \mathcal{F}, \mathbb{P}, (\mathcal{G}_n)_{n=0}^N)$ satisfying the usual conditions we define $||A||_{\mathrm{BMO}_p} := \inf c$ where the infimum is taken over all $c \geq 0$ such that for all $1 \leq n \leq N$ one has

$$\mathbb{E}[|A_N - A_{n-1}|^p | \mathcal{G}_n] \le c^p \quad a.s.$$

The John-Nirenberg theorem for discrete time adapted processes reads as follows:

Theorem 9.6 ([Ga73, Theorem III.1.1]). For $p \in (0, \infty)$ there is a constant $c_{(9.2)} = c_{(9.2)}(p) > 0$ such that for all $1 \le n \le N$ and $F \in \mathcal{G}_n$ with $\mathbb{P}(F) > 0$ one has

$$||A_N - A_{n-1}||_{M_{\varphi_1}(F, \mathbb{P}_F)} \le c_{(9.2)} ||A||_{BMO_p([0,T))}.$$
 (9.2)
