# Calculation appendix

Gas exchanges in hyperbaric environments: towards a physiological model

This appendix serves various purposes : it gives the required mathematical tools needed for the computations made in the corpus of the article, it demonstrates the existence of solutions to the differential systems presented in the article and it presents the results of another implementation of a numerical solution of those systems.

# **1 Study of the function** *f*

In this section, some basic properties of the  $\frac{H(x)}{x} = \frac{1}{f^3}$   $\frac{x^3 + bx}{f^4}$  the article are given. The function *H* is defined over  $\mathbb{R}$  by  $\longrightarrow$  1. By denoting  $\lambda = O_{xc}Hb$  and  $\alpha = \alpha_{O_2}$ , *f* can be written :  $=\frac{x^3 + bx}{63 + x^2}$ *x* <sup>3</sup> + *bx* + *a*

$$
f(x) = \lambda H(x) + \alpha x
$$

*H* and *f* are differentiable over **R**

$$
H'(x) = \frac{(3x^2 + b)(x^3 + bx + a) - (3x^2 + b)(x^3 + bx)}{(x^3 + bx + a)^2}
$$
  
= 
$$
\frac{a(3x^2 + b)}{(x^3 + bx + a)^2}
$$

so

$$
f'(x) = \frac{a\,\lambda(3x^2 + b)}{(x^3 + bx + a)^2} + \alpha\tag{1}
$$

and from this definition, the following property can be written :

**Property 1** *f* 0 *is continuous, differentiable and bounded over* **R** *and satisfies*

$$
f'(x) \underset{x \to +\infty}{\to} \alpha
$$
 and  $f'(x) \underset{x \to -\infty}{\to} \alpha$ 

Please note also that, as  $a > 0$ ,  $\alpha > 0$  and  $\lambda > 0$ , we have that

$$
\forall x \in \mathbb{R}, \qquad f'(x) > 0 \tag{2}
$$

### **2 Notations and hypothesis**

#### **2.1 Notations and derivatives**

The following notations are adopted, to simplify the equations

 $\Diamond$  1 : inspired air

- $\Diamond$  2 : airways
- $\Diamond$  3 : alveolar gas
- $\diamondsuit$  4 : alveolar blood
- $\lozenge$  5 : arterial blood
- $\Diamond$  6 : capillary blood
- $\Diamond$  7 : veinous blood
- $\Diamond$  8 : tissue

Besides, the following vector is defined :

$$
\forall t \in \mathbb{R} \qquad X(t) = (P_2(t), ..., P_8(t))^T
$$

When the perfect gas law is satisfied, one can write  $P_iV_i = Q_iRT$ . Hence

$$
\frac{dQ_i}{dt} = \frac{1}{RT} V_i \frac{dP_i}{dt} + \frac{1}{RT} P_i \frac{dV_i}{dt}
$$

When  $C_i = f(P_i)$ , as  $Q_i = V_i C_i$  for  $i = 4, ..., 8$ ,  $Q_i$  time derivative can be expressed as follows :

$$
\frac{dQ_i}{dt} = V_i \frac{dP_i}{dt} f'(P_i) + f(P_i) \frac{dV_i}{dt}
$$

#### **2.2 Hypothesis**

The following hypothesis are made on the input parameters.  $P_1$  is given by, with  $M$  the considered gas

$$
P_1(t) = f_r(M)(AP(t) - P_{H_2O})
$$

**Hypothesis 1** *The function AP is differentiable over* **R** *and its derivative is continuous over* **R***. Hence, the* property is also true for  $P_1$ , so  $P_1\, \in \mathcal{C}^1(\mathbb{R}).$  AP is a known input parameter.

**Hypothesis 2** The volumes and their derivatives are continuous over  $\mathbb{R}$ , so  $\forall i = 1, ..., 7$ ,  $V_i \in C^1(\mathbb{R})$ . They are *known input parameters.*

# **3 Oxygen differential system**

#### **3.1 General case**

The assumption 2 holds. In the following equations, *K<sup>i</sup>* , *α<sup>i</sup>* , . *Q* and . *MO*<sup>2</sup> are known constants defined in the article.

$$

The previous system, well defined thanks to (2) can be written under the form

$$
\dot{X} = F(t, X) \tag{3}
$$

*F* belonging to  $C^1(\mathbb{R} \times \mathbb{R}^7)$ , the Cauchy-Lipschitz theorem can be applied to this system, leading to the following theorem :

**Theorem 1** *Under the assumptions* 1 *and* 2, for every  $t_0 \in \mathbb{R}$  *and for every*  $X_0 \in \mathbb{R}^7$ , the system (3) has a *unique solution satisfying*  $X(t_0) = X_0$ *.* 

**Remark 1** *Please note that the source term is actually coming from*  $P_1(t)$ 

#### **3.2 Steady volumes**

The assumption of steady volumes is made, leading to

$$
\frac{dV_i}{dt} = 0
$$

and one obtains the following simplified system :

The theorem 1 holds for this particular case, and implies existence and uniqueness of a solution to this system for a given initial value.

#### **3.3 Numerical implementation**

The system defined in 3.2 has been implemented in Scilab, separately and independently from the implementation that produced the figures presented in the article, in order to check the values and to verify that no mistake has been made. The implementation was made by a different co-author. The 2 codes lead to the same numerical results, and the Scilab representations are given below :

# **4 Nitrogen differential case**

#### **4.1 General case**

The assumption is made that the time derivatives of the volumes are known, and that the equations for nitrogen can be derived from the oxygen ones

\frac{dP_2}{dt} = \frac{\dot{V}}{V_2} P_1 - \frac{P_2}{V_2} \left( \frac{dV_2}{dt} + \dot{V} + K_1 RT \right) + \frac{K_1 RT}{V_2} P_3
$$
\n

\frac{dP_3}{dt} = -\frac{P_3}{V_3} \left[ \frac{dV_3}{dt} + RT(K_1 + K_2) \right] + \frac{RT}{V_3} [K_1 P_2 + K_2 P_4]

This system is exactly similar to the system (3) and by the same type of proof, one gets existence and uniqueness of a solution.

### **4.2 Steady volumes**

If the volumes are constant over time, the system for the nitrogen writes

This system is linear and can be simply written

$$
\dot{X}(t) = AX(t) + U(t) \qquad A \in \mathcal{M}_7(\mathbb{R})
$$

with

U(t) = \left(\frac{\dot{V}}{V_2} P_1(t), 0, 0, 0, 0, 0, 0\right)^T
$$
\n(5)

**Theorem 2** For every vector  $X_0 \in \mathbb{R}^7$  and for every  $t_0 \in \mathbb{R}$  the system (4), with (5) has a unique solution *satisfying*  $X(t_0) = X_0$ *, which is* 

$$
X(t) = \exp(tA)\left[X_0 + \int_0^t \exp(-sA)U(s) ds\right]
$$

*Proof :* One has to consider the equation with no right hand side,  $\dot{Z} = AZ$ , whose solution is  $Z(t) =$  $\exp(tA)Z(0)$ , and then use a varying constant method, writing  $X(t) = \exp(tA)\Lambda(t)$ , and derive this expression to find the explicit expression of  $\Lambda$ .  $\square$ 

**Remark 2** *Even if this elegant exact solution was found, it would require the diagonalization of the matrix A in order to be properly implemented. Hence, a Runge-Kutta 4 method was preferred, and implemented by 2 different persons, with no exchanges apart from the sharing of the input data, and the final comparison.*

#### **4.3 Numerical implementation of the** *N*<sup>2</sup> **model**

The *N*<sup>2</sup> model with steady volumes described in the previous paragraph has been implemented by 2 different persons with a Runge-Kutta 4 method, and the 2 codes converge towards values that are very similar. The table 4 shows the initial values and the table values obtained after a 100-minute simulation. In order to see the stability of the 2 codes even with drastic changes, the assumption was made that all the compartments were free of  $N_2$  at the initial time. The table 5 shows the comparison between the 2 codes : *Computed* corresponds to an Excel computation, while *Implemented* refers to a VBA code. One can see that the 2 different codes are very close one from another.

And 6 is a caption of the evolution of the different *N*<sub>2</sub> pressures in all the different compartments.

## **5 Various functions for the** *CO*<sup>2</sup> **model**

In this part, we describe several functions needed for the *CO*<sup>2</sup> model. As some of them appear in the denominators of the equations, we have to show that they do not vanish. As we could not succeed to show it theoretically, we checked their numerical values.

#### **5.1** *g* **function**

**Notations** In the article, the carbon dioxyde pressure relates to the pH through the following function

$$
P(CO_2) = g(pH) = \frac{1}{\alpha_{CO_2}} (a pH + b) 10^{pK - pH}
$$

Please note that the coefficient *a* and *b* used there are not the ones used previously. We use the following notation for the study of *g* :

$$
\lambda = \frac{10^{pK}}{\alpha_{\rm CO_2}}
$$

which then writes

$$
g(x) = \lambda(a x + b) 10^{-x}
$$

Please note the following assumption

**Hypothesis 3** *The coefficient a satisfies a* < 0*.*

**Study of** *g* As we need to find the *pH* as a function of the carbon dioxyde pressure, we have see if *g* is a bijection, and for this to study it.

$$
g'(x) = \lambda \left[ a - (ax + b) \ln(10) \right] 10^{-x}
$$

$$
x_0 = \frac{1}{\ln(10)} - \frac{b}{a}
$$

$$
g(x) \underset{x \to -\infty}{\to} +\infty \quad \text{and} \quad g(x) \underset{x \to +\infty}{\to} 0^-
$$

and we have that

which vanishes on

$$
g'(x) \underset{x \to -\infty}{\to} -\infty
$$
 and  $g'(x) \underset{x \to +\infty}{\to} 0^+$   
and from this we get that *g* is strictly decreasing on  $]-\infty$ ;  $x_0$  and strictly increasing on  $[x_0; +\infty[$ . Hence,  
it is a bijection on each of those intervals, but we will have to make sure that we look for its reverse func-  
tion on one or the other intervals. We note  $h = g^{-1}$  in what follows. Here is a graphical representation  
of *g* on a reduced interval



FIGURE 7 – Function *g* on a reduced interval

**Numerical application** An explicit and general expression of the reverse function of *g* cannot be found as it uses the Lambert function, but some softwares can provide approximate values. With the following values

$$
a = -21.6 \t b = 183.84 \t \alpha_{CO_2} = 2.250210^{-4} \t pK = 6.1 \t(7)
$$

one gets  $x_0$ 

This is a very high value for the blood pH, hence one can reverse *g* on  $|-\infty; x_0|$ , and with a software for approaching  $h$ , we get an approximate function  $\hat{h}$  defined by

 $x_0 \approx 8.94$ 

$$
\hat{h}(x) = c_0 + c_1 \ln x + c_2 (\ln x)^2 + c_3 (\ln x)^3 + c_4 (\ln x)^4
$$
\n(8)

As the pH can only be positive, we can decide to study and define *g* only on a smaller interval. But similarly, as the *CO*<sup>2</sup> pressure is supposed to be positive, we can restrict again the interval and study *g* only where she is positive. Finding the value for which *g* vanishes gives :

$$
g(\tilde{x}) = 0 \qquad \Longleftrightarrow \qquad \tilde{x} = \frac{-b}{a} \approx 8.51
$$

and note that  $\tilde{x} < x_0$  by construction.

**Definition of** *h* We decide to study and reverse *g* on the interval  $I = [0; \tilde{x}]$ . The reverse function *h* of *g* is defined on  $J = g(I) = [0; g(0)]$  with  $g(0) = \lambda b > 0$ . From this we get the following definitions for the intervals

$$
I = \left[0; \frac{-b}{a}\right] \quad \text{and} \quad J = \left[0; \lambda b\right] \tag{9}
$$

Numerical application gives that  $g(0) \approx 1.029\,10^{12}.$ 

**Derivative of the reverse** *h* Even if we found an approximative function close enough from *h*, nothing guarantees that its derivative will be close from *h*<sup>7</sup>. Hence, it appears safer to use a simple trick, by deriving the relation  $g(h(x)) = x$ 

$$
h'(x) g'(h(x)) = 1
$$

one gets

$$
h'(x) = \frac{10^{h(x)}}{\lambda [a - (ah(x) + b) \ln (10)]}
$$
(10)

As we do not have the explicit expression of  $h$ , we will use  $\hat{h}$  in (10) but it will be less risky than deriving (8), as we do not know the closeness between  $\hat{h}'$  and  $h'$ . From the definition of  $h$ , please note that one can use

$$
\forall x \in J, \qquad 0 < h(x) < \frac{-b}{a}
$$

to establish the following inequality for its derivative

$$
\frac{10^{h(x)}}{\lambda a} < h'(x) < \frac{10^{h(x)}}{\lambda (a - b \ln 10)} < 0 \tag{11}
$$

#### **5.2** *R* **function**

This function is defined on *J* by

$$
R(x) = \alpha_{CO_2} x (1 + 10^{h(x) - pK})
$$
\n(12)

as a composition of  $\mathcal{C}^1$  function on the intervals on which they are defined,  $R$  is of class  $\mathcal{C}^1$ .

$$
\frac{R'(x)}{\alpha_{CO_2}} = 1 + [1 + x h'(x) \ln(10)] 10^{h(x) - pK}
$$
\n(13)

So far, even if we established the inequality (11), we did not succeed in proving that *R'* will not vanish on the considered interval, so we decided to study its values on a pressure interval relevant for our study, namely considering a minimum pressure of 4,000 and a maximum pressure of 15,000.

As one can see, even if *R'* does not vanish, its values are quite small, indicating that the system may present some numerical instabilities.



FIGURE 8 – R' on a relevant pressure interval

#### **5.3** *M* **function**

This function is defined by

$$
M(x) = R(x) \left[ 1 + \frac{0.0289 \left[ Hb \right]}{(3.352 - 0.456 \, Sat)(h(x) - 8.142)} \right]
$$

The terms on the lower part of the fraction cannot vanish, as the pH blood can never reach a value as high as 8.142 and as the saturation *Sat* is comprised between 0 and 1. We note

$$
\zeta = 8.142 \quad \text{and} \quad \mu = \frac{0.0289[Hb]}{(3.352 - 0.456 \text{ S}at)} \tag{14}
$$

which enables to write

$$
M(x) = R(x) \left[ 1 + \frac{\mu}{h(x) - \zeta} \right] \tag{15}
$$

As for *R*, *M* can be derived on the proper interval, and one gets

$$
M'(x) = R'(x) \left[ 1 + \frac{\mu}{h(x) - \zeta} \right] - \mu R(x) \frac{h'(x)}{(h(x) - \zeta)^2}
$$
(16)

Now, for what follows, we need to see if M' can vanish or not. The values for *Hb* and *Sat* are the following

$$
Hb = 2.19117647058824 \quad mmol/L
$$
 and  $Sat = 0.99$ 

We proceed as for *R'* and study the numerical values of *M'*, whose values are very close from the *R*''s ones.

### **6 Carbon dioxyde model**

#### **6.1 Equations**

The assumption 2 still holds, leading to the following system for the carbon dioxyde *CO*<sup>2</sup>

$$
\frac{dP_2}{dt} = \frac{\dot{V}}{V_2} P_1 - \frac{\dot{V} + K_1 RT}{V_2} P_2 + \frac{K_1 RT}{V_2} P_3
$$
\n

\frac{dP_3}{dt} = -\frac{RT}{V_3} (K_1 + K_2) P_3 + \frac{RT}{V_3} [K_1 P_2 + K_2 P_4]
$$

\frac{dP_4}{dt} = \frac{1}{V_4 M'(P_4)} [K_2 (P_3 - P_4) + \dot{Q} (M(P_7) - M(P_4))]
$$

\frac{dP_5}{dt} = \frac{\dot{Q}}{V_5 M'(P_5)} [M(P_4) - M(P_5)]

**Remark 3** *Be careful, RQ is a variable itself, and has no link whatsoever with the constant R.*

#### **6.2 Steady state**

If one considers an input pressure  $P_1$  constant over time, the system is supposed to stabilize for an infinite time towards a limit steady state. This state would be characterized by null time derivatives, leading to the following set of equations, in which we keep for the moment the same notations than before

$$
VP_1 - (V + K_1RT)P_2 + K_1RTP_3 = 0 \tag{17}
$$

-RT(K_1 + K_2)P_3 + RT[K_1P_2 + K_2P_4] = 0
$$

K_2(P_3 - P_4) + Q(M(P_7) - M(P_4)) = 0
$$

M(P_4) - M(P_5) = 0 \tag{20}
$$

$$

#### **6.3 Numerical implementation**

The system has been implemented with 2 different numerical methods, and, with no exterior variations, the 2 models converge towards values that are approximately the ones obtained from the steady state. The following table 10 shows how the 2 codes reach the same value what can be computed from the steady state. The column titled *computed value* corresponds to an implementation with Excel, while the column titled *Implemented value* gives the value obtained with a VBA code.
