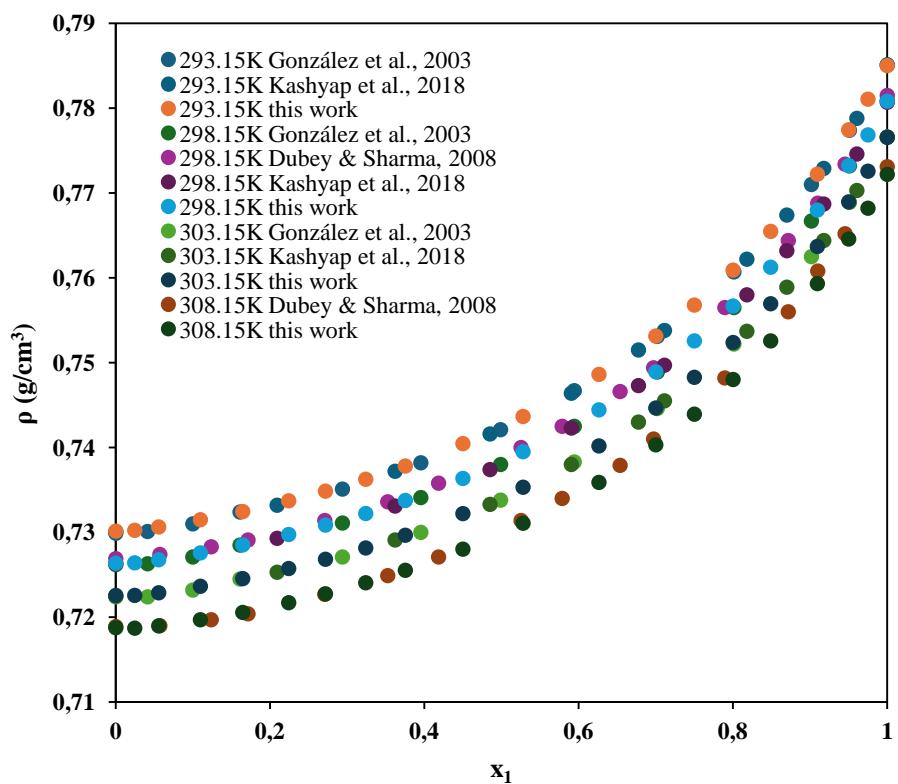
#### **1. Literature comparison**

We have compared our measured density data with literature data [1–3] for 2-propanol and n-decane binary system. Figure S1 shows the literature comparison with the experimental data. The measured densities were correlated using a second order polynomial expression.

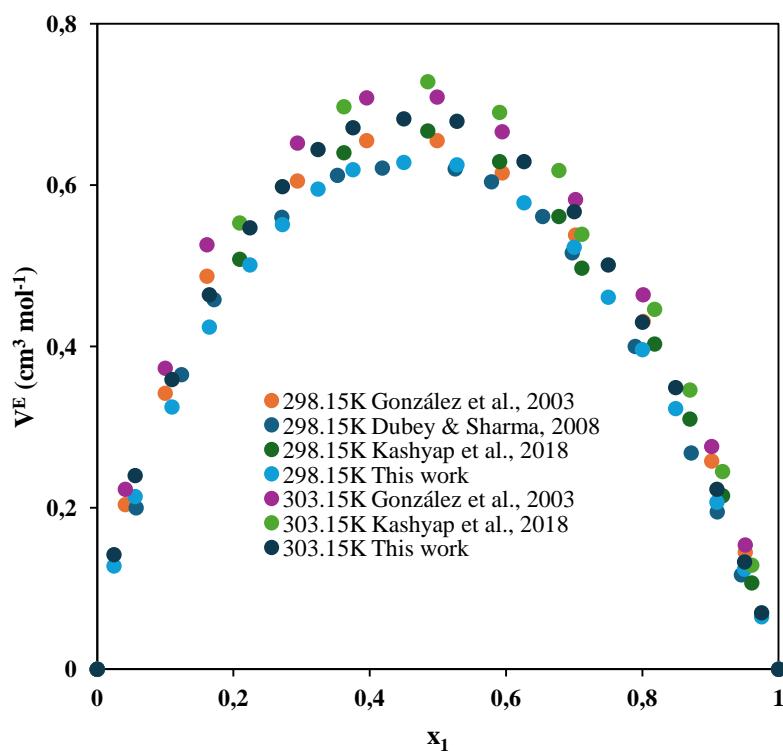
$$\rho = AT^2 + BT + C \quad (\text{S1})$$

With parameters A, B, and C, and  $\rho$  the density in g/cm<sup>3</sup>. Table S1 shows the density parameters for each composition with their corresponding uncertainties.

We compared our excess molar volume with literature data, as shown in Figure S2, and detailed the deviations in Table S3. These comparisons were conducted at specific 2-propanol compositions and three temperatures: 298.15 K, 303.15 K, and 308.15 K. Although a visual discrepancy is noticeable in the graph, the average absolute relative deviation (AARD%) between our experimental data and the literature data is consistently below 5% across all analyzed datasets.

## 2. Molar volume correlation

The density data was used to calculate molar volume. We used this data to adjust the coefficient of the molar volume by the least squared method.

$$v = aT^2 + bT + c \quad (S2)$$

Table S2 presents the molar volume parameter for each composition

### 3. Partial Molar Volume

The molar volume is calculated from the partial molar volume (Eq. (S3)).

$$n\mathbf{v} = n_1\mathbf{v}_1 + (n - n_1)\mathbf{v}_2 \quad (\text{S3})$$

Consequently, partial volume is obtained from Eq. (S4).

$$\mathbf{v}_i = \left( \frac{\partial n\mathbf{v}}{\partial n_i} \right)_{T,p,n_{j \neq i}} \quad (\text{S4})$$

Combining Eq. (S3) and Eq. (S4) we can calculate the two partial molar volume using Eq. (S5) and (S6).

$$\mathbf{v}_1 = \mathbf{v} + n \left( \frac{\partial \mathbf{v}}{\partial n_1} \right)_{T,p,n_{j \neq i}} \quad (\text{S5})$$

$$\mathbf{v}_2 = \mathbf{v} + n \left( \frac{\partial \mathbf{v}}{\partial n_2} \right)_{T,p,n_{j \neq i}} \quad (\text{S6})$$

The calculated molar volume data were correlated using a second order polynomial expression (Eq. (S7)).

$$\mathbf{v} = ax_1^2 + bx_1 + c \quad (\text{S7})$$

Figure S3 shows the molar volume of the binary mixture as a function 2-propanol molar composition at 303.15K as an example. Using Eq. (S7), the partial molar volume of each component for the system of 2-propanol and n-Decane can be expressed considering Eq. (S8) and (S9).

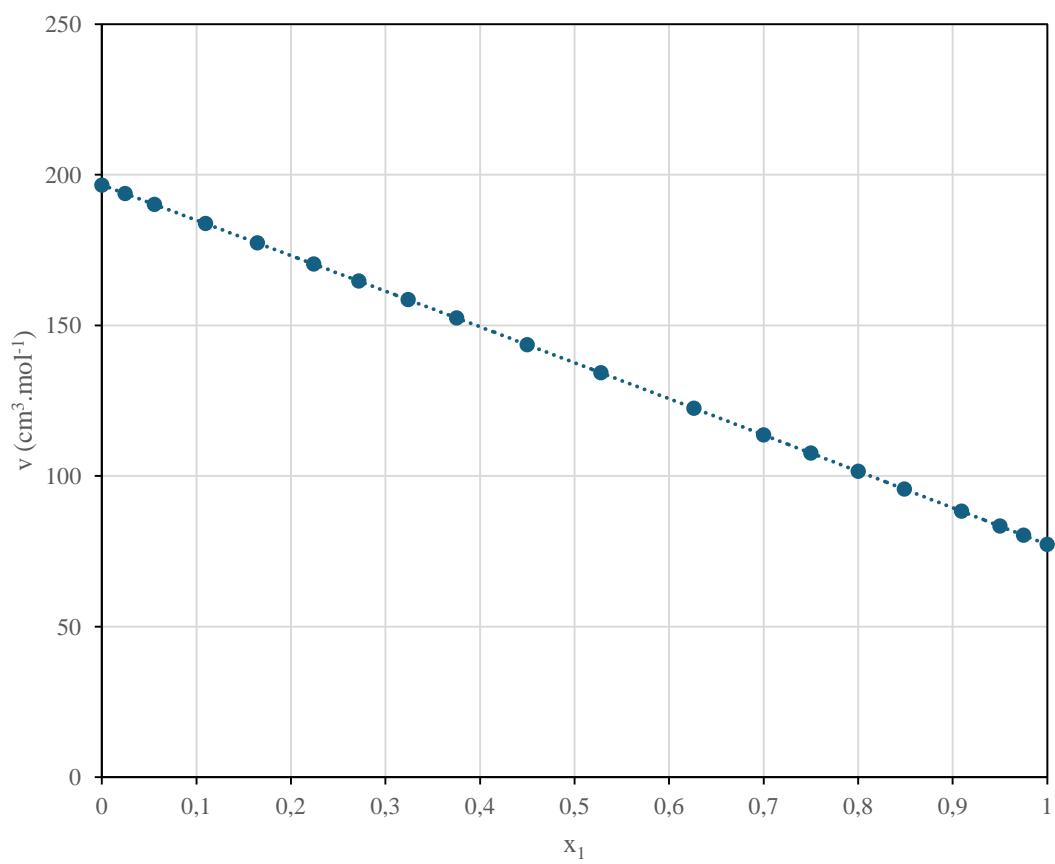
$$\mathbf{v}_1 = \mathbf{v} + (1 - x_1) \left( \frac{\partial \mathbf{v}}{\partial x_1} \right)_{T,p,x_2} \quad (\text{S8})$$

$$\mathbf{v}_2 = \mathbf{v} + x_1 \left( \frac{\partial \mathbf{v}}{\partial x_2} \right)_{T,p,x_1} = \mathbf{v} - x_1 \left( \frac{\partial \mathbf{v}}{\partial x_1} \right)_{T,p,x_2} \quad (\text{S9})$$

For each temperature, we have determined the parameters of the second order polynomial expression (Eq. (S7)). The results are presented in Table S4. Table S5 gives the values of the calculated partial molar volume for each temperature and composition.

#### 4. Thermal expansion

The density data measured at various compositions and temperatures are utilized to calculate thermal expansion coefficients. A second order polynomial expression is applied to determine the molar volume for each composition, with parameters provided in Table S4. By considering the definition of thermal expansion and taking the derivative of the molar volume equation with respect to temperature for each composition, the thermal expansion is then computed. Additionally, the excess molar thermal expansion  $\alpha^E$  (Figure S4) was calculated using Eq. **Erreur ! Source du renvoi introuvable..**

$$\alpha^E = \alpha - \phi_1 \alpha_1^* - \phi_2 \alpha_2^* \quad (\text{S10})$$

where  $\phi_i = \frac{x_i v_i^*}{\sum_i x_i v_i^*}$  is the volume fraction of component i and  $\alpha_1^*$  and  $\alpha_2^*$  are the molar thermal expansion coefficient of pure components 1 and 2, respectively. Analysing excess thermal expansion coefficients is important as it accounts for how temperature affects changes in molar volume. The accuracy of these coefficients depends on several factors, including the uncertainty in density measurements, the accuracy of temperature derivative calculations, and the uncertainty in molar fraction (Eq. S11).

$$u_{am} = \sqrt{u_\alpha^2 + u_x^2} \quad (\text{S11})$$

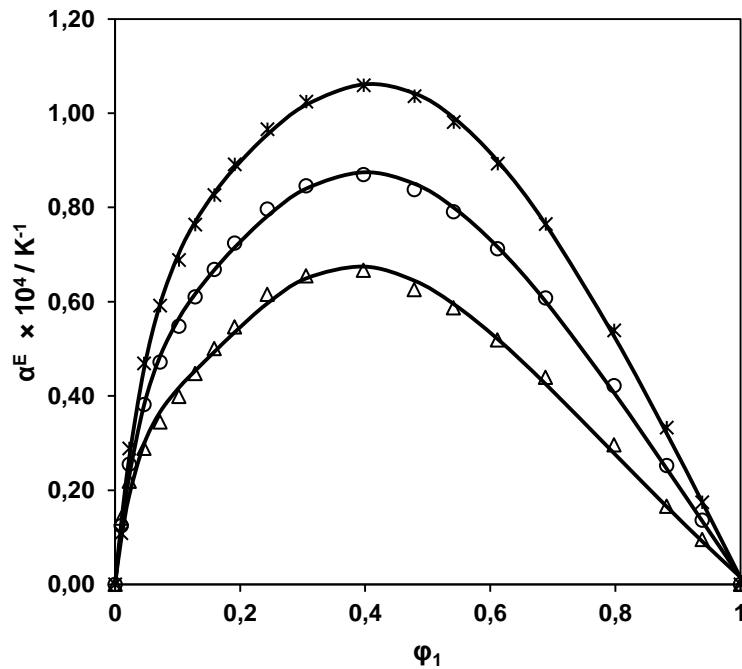
The uncertainty in composition is given by Eq. (8) of the main paper. For the thermal expansion, uncertainty is given by Eq. **Erreur ! Source du renvoi introuvable..**

$$u_\alpha = \sqrt{\left(\frac{\partial \alpha}{\partial \rho}\right)^2 u_\rho^2 + \left(\frac{\partial \alpha}{\partial T}\right)^2 u_T^2} \quad (\text{S12})$$

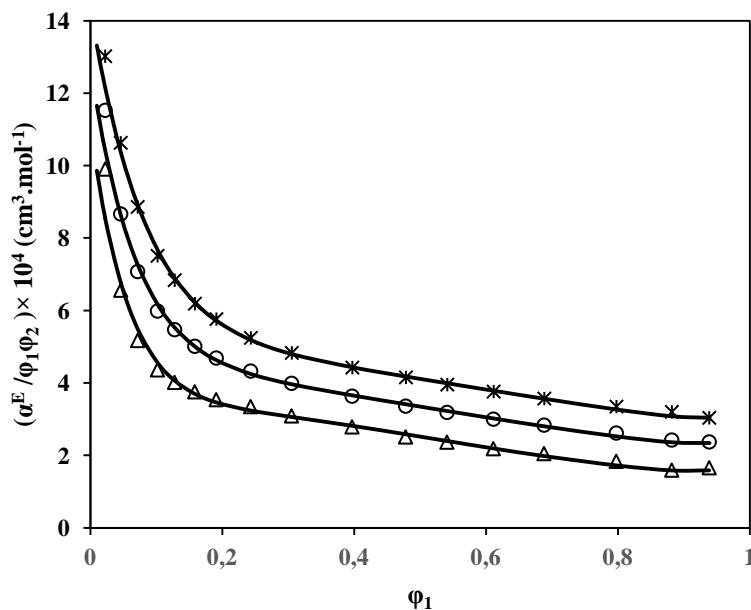
The value of  $u_\alpha$  is  $1 \times 10^{-5} \text{ K}^{-1}$ . The uncertainty in the excess thermal expansion coefficient, as calculated by Eq. (S13), closely approximates  $1.5 \times 10^{-5} \text{ K}^{-1}$ .

$$u_{\alpha^E} = \sqrt{(1 + x_1^2 + x_2^2) u_\alpha^2 + (\alpha_1^2 + \alpha_2^2) u_x^2} \quad (\text{S133})$$

The dependence of  $\frac{\alpha^E}{\varphi_1 \varphi_2}$  on volumetric fraction and temperature, as depicted in Figure S5, demonstrates that the Redlich-Kister (RK) equation effectively represents the excess thermal expansion.

## 5. Speed of sound

The excess speed of sound  $u^E$  (figure S6) was calculated using Eq. (S14). The results of the speed of sound measurement can be found in Table S5. Figure S6 shows how the relationship between  $u^E$  and the mole fraction of 2-propanol changes at three different temperatures: 293.15 K, 298.15 K, and 303.15 K.

$$u^E = u - x_1 u_1 - x_2 u_2 \quad (\text{S14})$$

where  $x_1$  and  $x_2$  represent mole fractions and  $u_1$  and  $u_2$  are the molar volumes of components 1 and 2, respectively. In the mixture of 2-propanol and n-decane, the  $u^E$  values are initially negative at lower  $x_1$  values of 2-propanol, but they exhibit a positive trend at higher  $x_1$  values. The negative  $u$  values indicate the importance of alkane molecules fitting between alcohol aggregates. Conversely, the positive  $u$  values for 2-propanol and n-decane suggest that as the size of the alkane molecule increases, the mixing component molecules have difficulty accommodating easily.

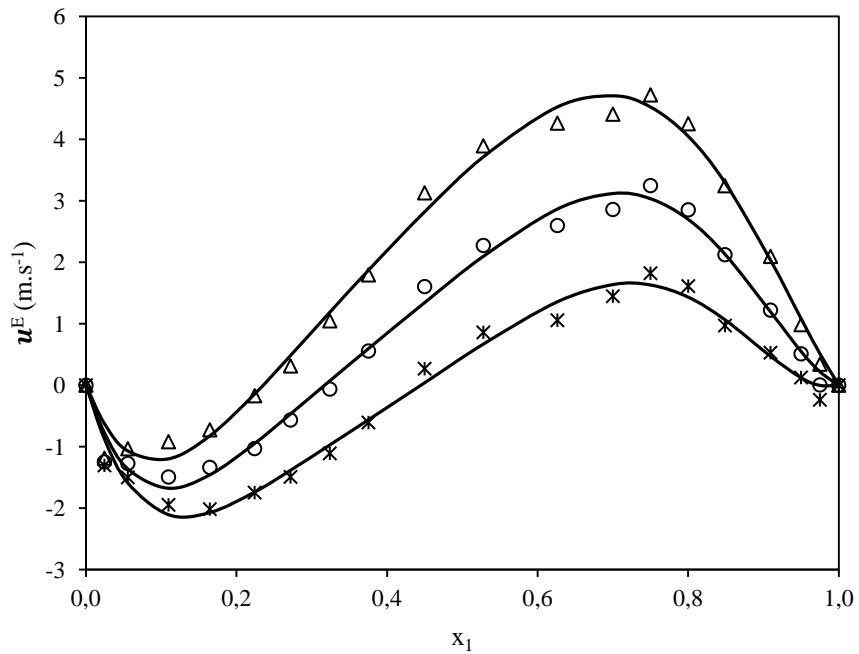
Using the experimental data for density and speed of sound, we calculated the relative association ( $R_A$ ) using Eq. (S15) [4].

$$R_A = \left( \frac{\rho}{\rho_o} \right) \left( \frac{u_o}{u} \right)^{1/3} \quad (\text{S145})$$

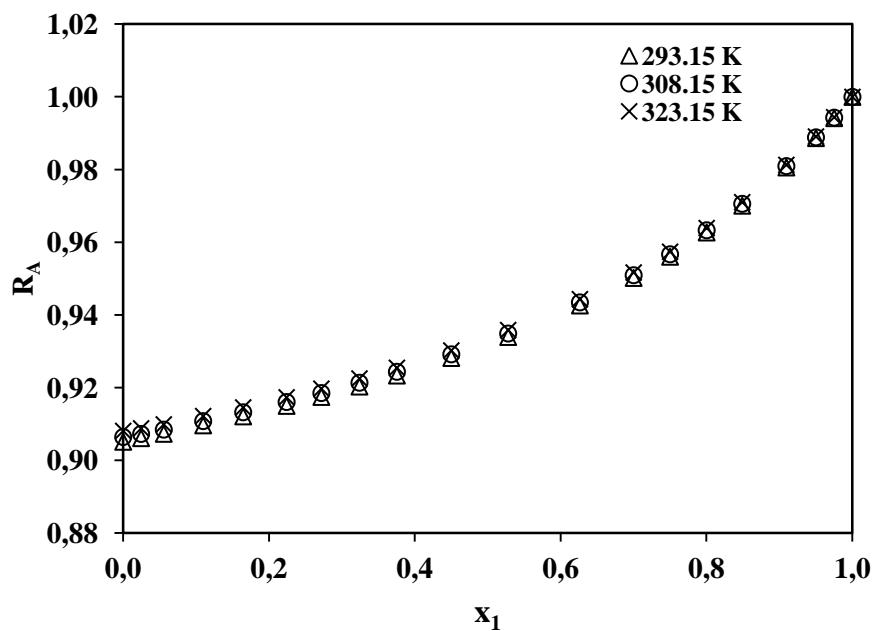
where  $\rho$  and  $\rho_o$  are the densities, and  $u$  and  $u_o$  are the speeds of sound for the mixture and the

pure solvents, respectively.

Figure S7 displays the results of the relative association ( $R_A$ ). The figure shows that  $R_A$  increases linearly with the concentration of 2-propanol, indicating a breakdown of solvent-solvent interactions. Additionally, the  $R_A$  values remain constant across different temperatures for the binary mixtures.

## 6. Isentropic compressibility

The speed of sound and density data measured at various compositions and temperatures are utilized to calculate the isentropic compressibility ( $\kappa_s$ ) using Eq. (S16).

$$\kappa_s = (\rho u^2)^{-1} \quad (\text{S16})$$

Like excess molar thermal expansion, the excess molar isentropic compressibility ( $\kappa_s^E$ ) was calculated using Eq (S17) and plotted on Figure S8.

$$\kappa_s^E = \kappa_s - (\varphi_1 \kappa_{s,1} + \varphi_2 \kappa_{s,2}) \quad (\text{S17})$$

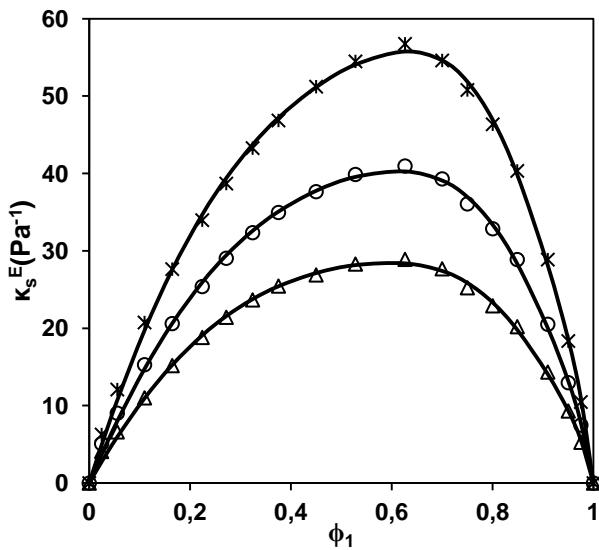
Where  $\varphi_i = \frac{x_i v_i^*}{\sum_i x_i v_i^*}$  is the volume fraction of component i and  $\kappa_{s,1}$  and  $\kappa_{s,2}$  are the isentropic compressibility pure components 1 and 2, respectively. Analysing excess isentropic compressibility is important as it accounts for how pressure affects changes in molar volume. The accuracy of these coefficients depends on several factors, including the uncertainty in density and speed of sound measurements, the accuracy of pressure calculations, and the uncertainty in molar fraction (Eq. (S18)).

$$u_{\kappa_s,m} = \sqrt{u_{\kappa_s}^2 + u_x^2} \quad (\text{S18})$$

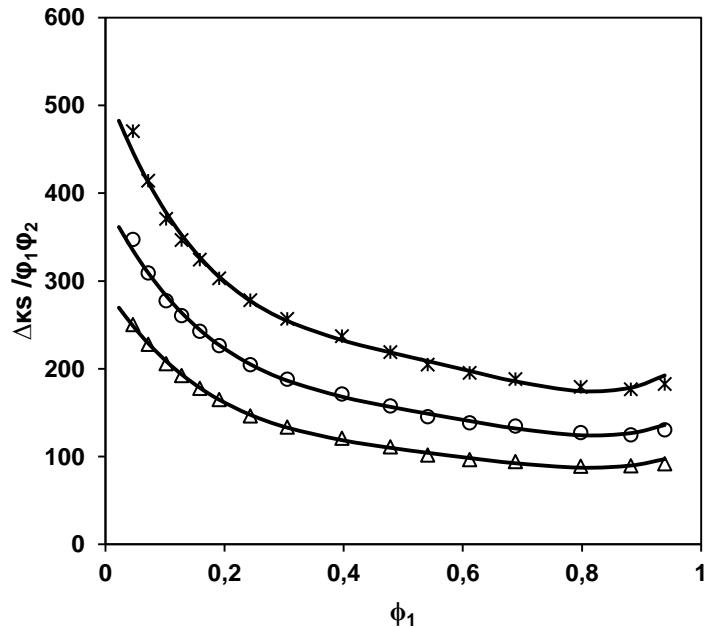
The value of  $u_{\kappa_s}$  is  $2 \text{ Pa}^{-1}$ . The uncertainty in the excess isentropic compressibility, as calculated by Eq. (S19), closely approximates  $2.5 \text{ Pa}^{-1}$ .

$$u_{\kappa_s^E} = \sqrt{(1 + x_1^2 + x_2^2) u_{\kappa_s}^2 + (\kappa_{s,1}^2 + \kappa_{s,2}^2) u_x^2} \quad (\text{S19})$$

The volumetric fraction and temperature dependence of  $\frac{\kappa_s^E}{\varphi_1 \varphi_2}$  for the binary mixture in Figure S9 shows the utilization of RK equation is well adapted for the representation of the excess isentropic compressibility (Table S8).

## 7. Refractive index

Reis et al. [5] stated that the refractive index squared ( $n^2$ ) is approximately equal to the relative permittivity ( $\epsilon_r$ ), also known as the dielectric constant. This property characterizes the ability of the solvent to form electrolytes and stabilize them [6–9]. The refractive index is connected to the molar volume through the Lorentz-Lorenz equation Eq. (S20) as presented by Iglesias-Otero et al. [10]:

$$\left(\frac{n^2 - 1}{n^2 + 2}\right)v = \frac{N_A \alpha_p}{3\epsilon_0} \quad (\text{S15})$$

In this equation,  $n$  represents the refractive index,  $v$  represents the molar volume,  $N_A$  represents Avogadro's number,  $\epsilon_0$  represents the permittivity of vacuum, and  $\alpha$  represents the mean molecular polarizability.

To estimate the excess squared refractive index ( $(n^2)^E$ ), Eq. (S21) is applied, considering volume fractions instead of mole fractions. This equation is used for the calculation of the excess squared refractive index:

$$(n^2)^E = n^2 - \varphi_1 n_1^2 - \varphi_2 n_2^2 \quad (\text{S16})$$

Where  $\varphi_i = \frac{x_i v_i^*}{\sum_i x_i v_i^*}$  is the volume fraction of component i and  $n_i^2$  the squared refractive index of component i. The uncertainty in the refractive index is related to the uncertainty in the measured refractive index and the uncertainty in the molar fraction. Eq. (S22) provides the expression for this uncertainty:

$$u_{(n^2)m} = \sqrt{u_{n^2}^2 + u_x^2} \quad (\text{S17})$$

The uncertainty in composition is given by Eq. (26) of the main paper. The value of  $u_{n^2}$  is equal to  $6 \times 10^{-5}$ . The uncertainty of the excess squared refractive index is given by Eq (S23). The obtained value was close to  $2 \times 10^{-4}$ .

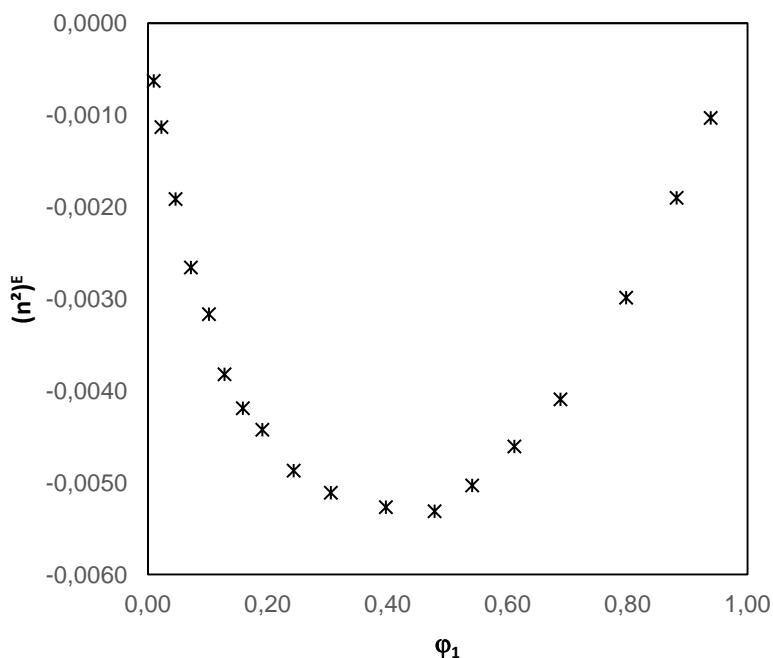
$$u_{(n^2)^E} = \sqrt{(1 + x_1^2 + x_2^2)u_{n^2}^2 + ((n^2)_1^2 + (n^2)_2^2)u_x^2} \quad (\text{S18})$$

The refractive index at 293.15 K are presented in Table S9 and Figure S10. Redlich-Kister treatment was not administered. The excess squared refractive index presents a minimum, indicating that the intermolecular forces between 2-propanol and n-decane are weaker than those between pure 2-propanol or pure n-decane. This results in a less efficient packing of the molecules, leading to a decrease in the refractive index.

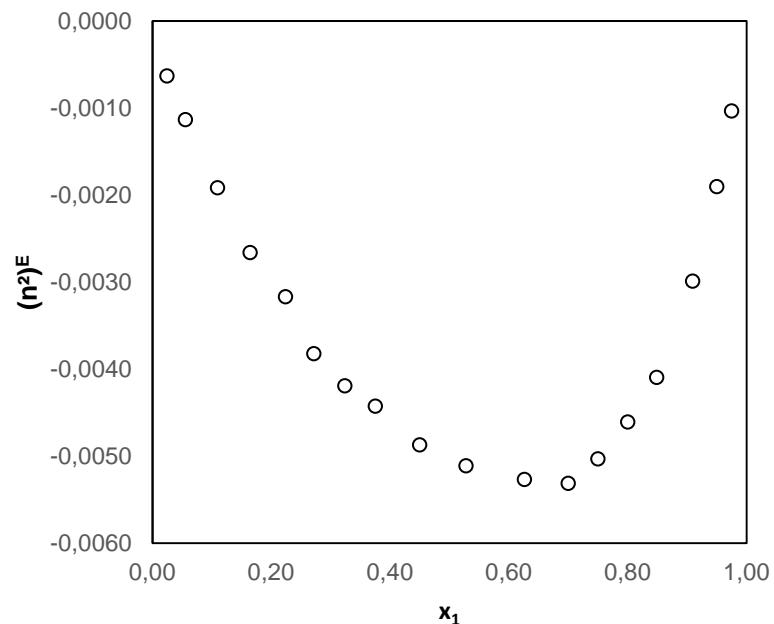

## 8. Optimal Numbers of RK parameters and $\chi^2$ test

To validate the data treatment and the number of parameters used for each correlation, a  $\chi^2$  goodness-of-fit test was applied. The test statistic is given by Eq. (S24):

$$\chi^2 = \sum_k \left( \frac{U_k - f(T_R, \vec{X})}{\sigma_k} \right)^2 \quad (\text{S24})$$

The selected level of significance is  $p=0.05$ . We considered six correlations, each with five parameters. A total of 18 data points were used, giving a degree of freedom of 13. According to the  $\chi^2$  table, the critical  $\chi^2$  value for  $p=0.05$  is 22.362. The null hypothesis ( $H_0$ ) concerns the quality of the data treatment and the accuracy of the correlation in representing the data. The test is validated if the  $\chi^2$  value is lower than the critical value.

Table S13 presents the results, showing that the test was validated for all correlations except for  $\Delta G^{E*}$ . A careful analysis revealed that this discrepancy is due to incorrect calculations for the data point with  $x_1=0.9750$  in the correlation.
