4 **Abstract**

5 Global warming is changing plant communities due to the arrival of new species from warmer 6 regions and declining abundance of cold-adapted species. However, experimentally testing 7 predictions about trajectories and rates of community change is challenging because we 8 normally lack an expectation for future community composition, and most warming experiments

9 fail to incorporate colonization by novel species. To address these issues, we analyzed data 10 from 44 whole-community transplant experiments along 22 elevational gradients across the

11 Northern Hemisphere. In these experiments, high-elevation communities were transplanted to

12 lower elevations to simulate warming, while also removing dispersal barriers for lower-elevation

13 species to establish. We quantified the extent and pace at which warmed high-elevation

14 communities shifted towards the taxonomic composition of lower elevation communities.

16 High-elevation plant communities converged towards the composition of low-elevation

17 communities, with higher rates under stronger experimental warming. Strong community shifts

18 occurred in the first year after transplantation then slowed over time, such that communities

19 remained distinct from both origin and destination control by the end of the experimental periods

20 (3-9 years). Changes were driven to a similar extent by both new species colonization and

21 abundance shifts of high-elevation species, but with substantial variation across experiments

22 that could be partly explained by the magnitude and duration of experimental warming, plot size

23 and functional traits.

25 Our macroecological approach reveals that while warmed high-elevation communities

26 increasingly resemble communities at lower elevations today, the slow pace of taxonomic shifts

27 implies considerable colonization and extinction lags, where a novel taxonomic composition of

29 contribution of the colonizing species to community change also indicates that once dispersal

30 barriers are overcome, warmed high-elevation communities are vulnerable to encroachment

31 from lower elevation species.

32 **Introduction**

33 Changes in the composition of vegetation along steep elevation gradients reveal the role of

34 climate as a powerful force in structuring plant communities [\(Giaccone et al. 2019, Chauvier et](https://paperpile.com/c/pDL3XE/2J4i9+TRAex)

35 [al. 2021\),](https://paperpile.com/c/pDL3XE/2J4i9+TRAex) and now, climate warming is restructuring plant communities [\(Harrison 2020, IPBES](https://paperpile.com/c/pDL3XE/8JCdl+iwT3D)

36 [2023\)](https://paperpile.com/c/pDL3XE/8JCdl+iwT3D). Climate change effects are especially prominent at higher elevations in mountains,

37 where temperatures are rising faster than the global average [\(Pepin et al. 2022\).](https://paperpile.com/c/pDL3XE/kmpl0) The

38 abundance and species composition of mountain plant communities are changing as extant

39 populations respond to new environmental conditions and as species migrate upslope to track

40 their preferred climate (Fig. 1B) [\(Lenoir et al. 2008, Rumpf et al. 2018\).](https://paperpile.com/c/pDL3XE/MHqA+WWJmY) However, vegetation

41 changes are strongly lagging behind expectations based on the pace of climate warming, due to

42 lags in both local extinction [\(Rumpf et al. 2019\)](https://paperpile.com/c/pDL3XE/EaeK) and colonization events [\(Zu et al. 2021\)](https://paperpile.com/c/pDL3XE/3aLH). One

43 expectation is that over time, these lags will be overcome and high-elevation plant communities

44 will increasingly resemble communities that are currently found at lower elevation [\(Jurasinski](https://paperpile.com/c/pDL3XE/XuLc+TKDl)

- 45 [and Kreyling 2007, Savage and Vellend 2015\)](https://paperpile.com/c/pDL3XE/XuLc+TKDl). Alternatively, priority effects and novel plant-
- 46 plant-climate interactions might set communities on alternative trajectories, yielding "no-analog"
- 47 communities, as has occurred under past climatic changes [\(Overpeck et al. 1992, Leopold et al.](https://paperpile.com/c/pDL3XE/cM0E5+notl0+t2GWp)
- 48 [2015, Staples et al. 2022\)](https://paperpile.com/c/pDL3XE/cM0E5+notl0+t2GWp) as well as during current climate warming [\(Roth et al. 2014\)](https://paperpile.com/c/pDL3XE/dxVPI). Insight 49 into the trajectory and pace of changes in plant community composition will therefore be
- 50 important to accurately forecast the impacts of climate change on biodiversity in mountainous
- 51 regions.

ey are poorly adapted to war 53 Since both the trajectory and pace of changes in community composition depend on the 54 combined effects of colonization rates, local extinctions, and abundance shifts, we can gain 55 insights into the relative importance of these processes by explicitly examining the response to 56 warming of three distinct species pools [\(Lynn et al. 2021\).](https://paperpile.com/c/pDL3XE/FMLt) Firstly, species that are restricted to 57 high elevation (hereafter, "strictly high-elevation species") are generally expected to respond 58 negatively to warming and eventually become locally extinct [\(Geppert et al. 2023\).](https://paperpile.com/c/pDL3XE/yMwY) This could 59 happen either because they are poorly adapted to warmer conditions, or because they are 60 poorer competitors for resources, such as light, that become increasingly limiting as warm-61 adapted, lower-elevation species arrive and increase in abundance [\(Alexander et al. 2015,](https://paperpile.com/c/pDL3XE/dHgu+dK2U) 62 [Olsen et al. 2016\).](https://paperpile.com/c/pDL3XE/dHgu+dK2U) Secondly, species that occur in both high and low-elevation communities 63 (hereafter, "overlapping species"), and thus that are adapted to a wider range of climatic and 64 biotic conditions, might benefit from climate warming and increase in abundance [\(Lynn et al.](https://paperpile.com/c/pDL3XE/FMLt) 65 [2021\)](https://paperpile.com/c/pDL3XE/FMLt). Finally, new species that migrate upslope from low elevation will establish in high-66 elevation communities and increase in abundance (hereafter, "colonizing species"). The relative 67 contribution of these three local species pools – strictly high-elevation, overlapping, and 68 colonizing species – to community shifts in response to climate change will depend on their 69 reaction time (e.g., dispersal, establishment and extinction lags; Alexander et al. 2018) and the 70 magnitude of warming. Disentangling responses of these different species pools can help 71 anticipate the trajectory and rate of changes in high-elevation vegetation and the consequences 72 for species' range shifts under future climate. 73

- 74 Manipulative experiments are key to studying possible long-term changes in community 75 composition in response to climate warming. *In situ* warming experiments, for example using 76 passive warming chambers, have been most commonly employed to reveal shifts in mountain 77 plant communities towards assemblages more typical of lower elevations [\(Henry et al. 2022\).](https://paperpile.com/c/pDL3XE/bWib) 78 However, *in situ* experiments do not capture the contribution of all species pools to community 79 change, most notably that of colonizing species. This is because the pool of potential colonists 80 is typically absent due to dispersal lags, unless this aspect is intentionally manipulated. Whole-81 community transplant experiments, which simulate climate change by moving plant communities 82 with their soils to a new location representing possible future climate conditions, overcome this 83 problem by simultaneously exposing communities to a change in climate and potential 84 colonization by species from the destination transplant site (Fig. 1A). They thus offer a powerful 85 way to examine the trajectory of mountain plant communities under future climate change, and 86 how these trajectories are underlain by different species pools once dispersal barriers are lifted.

Collectively, these studies 92 suggest that under experimental climate change, transplanted high-elevation communities can 93 restructure quickly and resemble lower-elevation communities. While the magnitude and pace of 94 these shifts remain unknown, species pools driving changes in community composition can be 95 region and experiment-dependent. For example, in a transplant experiment in Norway, 96 transplanted turfs were rapidly colonized by low-elevation species, which negatively impacted 97 high-elevation species within the community through novel competitive interactions [\(Vandvik et](https://paperpile.com/c/pDL3XE/v4Do) 98 [al. 2020\)](https://paperpile.com/c/pDL3XE/v4Do) In contrast, an experiment in France, shifts in relative abundances within the existing 99 communities drove the community reassembly (Bektaş [et al. 2023\).](https://paperpile.com/c/pDL3XE/y0Ay) Furthermore, the functional 100 strategies of individual plant species that benefit from climate change exhibit both general and 101 region-specific responses. For example, taller species become more abundant under 102 experimental warming in experiments from Switzerland [\(Visakorpi et al. 2022\)](https://paperpile.com/c/pDL3XE/6L09) and Norway 103 [\(Guittar et al. 2016\),](https://paperpile.com/c/pDL3XE/Kgz1) where taller species have also lower extinction rates [\(Lynn et al. 2023\)](https://paperpile.com/c/pDL3XE/KbEix). In 104 addition, while species with slow resource acquisition were favored under warming in 105 Switzerland [\(Visakorpi et al. 2022\),](https://paperpile.com/c/pDL3XE/6L09) species with fast resource acquisition strategies coming 106 from warmer habitats colonized and increased their abundance more in colder sites in Norway 107 [\(Lynn et al. 2023\).](https://paperpile.com/c/pDL3XE/KbEix) These regional differences might arise from variations in limiting resources 108 and how they are impacted by climate change, as well as from differences in the magnitude or 109 duration of the experimental warming (Elmendorf et al. 2012). Consequently, it remains unclear 110 whether we can make general predictions about the trajectory and pace of taxonomic responses 111 to warming, and to what extent context-dependencies can be attributed to regional climatic or 112 ecological or experimental differences.

114 A macroecological experimental approach (Box 1) can allow us to identify general patterns in 115 community composition change under climate change, while quantifying regional and 116 experimental differences (Alexander et al. 2016). Here, we combine, for the first time, vegetation 117 surveys spanning 2-9 years from a network of 44 whole-community downslope transplant 118 experiments along 22 elevation gradients across the Northern Hemisphere to ask: i) To what 119 extent does the species composition of warmed high-elevation communities diverge from the 120 non-warmed high-elevation communities and converge towards that of low-elevation 121 communities over time? ii) How do different species pools (strictly high-elevation, overlapping, 122 or low-elevation colonizing species) contribute to divergence or convergence in plant community 123 composition associated with climate change? iii) Is variation in overall rates of community 124 change across experiments, as well as the average contribution of different pools to divergence 125 or convergence, influenced by experimental design, the climate context of the study site, or 126 plant functional trait composition? 127

W 133 134 TransPlant is a network of 22 elevation gradients, distributed across 20 different mountainous 135 regions of the Northern Hemisphere, where whole plant communities have been transplanted to 136 lower elevations to simulate climate change **(Fig. 1-2, Table S1-2)**. The basic design of the 137 transplant experiments involve the transplantation of vegetation turfs (or "monoliths") of whole 138 plant communities with their soil from a higher (cooler) to a lower (warmer) elevation site to 139 simulate climate warming ("warmed" treatment) **(Fig. 1A)**. Moving plant communities to lower 140 elevation in this way allows plants from the lower elevation site to quickly colonize transplanted 141 turfs, also simulating the arrival of the novel species into high elevation communities that we 142 expect to arrive following climate warming **(Fig. 1A).** For any given set of warmed turfs, there 143 are "origin controls" (high-elevation turfs locally transplanted at their high-elevation site of origin) 144 and "destination controls" (low-elevation turfs locally transplanted at the low-elevation site of 145 destination) **(Fig.1A)**. Thus, these controls make it possible to disentangle potential 146 transplantation artifacts from the effects of experimental climate change. Along some 147 TransPlant gradients, multiple experiments are conducted by transplanting the turfs from high to 148 mid, mid to low, high to low elevations **(Fig. S1A)**. We refer to a set of warmed, origin and 149 destination control turfs within each gradient as an "experiment" **(Fig. 1A)**, yielding a total of 40 150 experiments because 12 gradients were composed of more than two sites (Table S1-2). The 151 experiments were established between 2007 and 2017. Each experiment had 3-10 replicates of 152 transplant and control turfs, and in total there were 668 turfs varying in sizes between 0.02 $m²$ 153 and 1 m^2 with a mean size of 0.3 m^2 across the 40 experiments.  Fig. 1: Overview of experimental designs in the TransPlant network, illustrating the ecological processes simulated through whole-community transplantation and the analytical framework used to study community shifts post-transplantation. **A)** Transplant experiments aim to simulate climate change by transplanting whole plant communities to putative future climates at lower elevation. This approach also lifts the dispersal barrier for colonizing species, thereby allowing colonization into the transplanted communities from the low-elevation site (colonizing species). We refer to the turfs transplanted from origin to destination sites as "warmed" communities (red circle), and to turfs locally replanted at origin and destination sites as "origin" (blue circle) and "destination" (orange circle) controls, respectively. **B)** Our expectation is that the warmed communities (red circle) will diverge in taxonomic composition from the origin controls (blue circle) and increasingly resemble the destination controls (orange circle), following the shortest distance between the controls over the years after transplantation. However, communities might deviate from this expected trajectory of resembling destination controls (red lines), showing deviating responses (pink lines). To quantify the degree of divergence from origin controls (solid lines) or convergence towards destination controls (dotted lines), we calculate the taxonomic distances of warmed

196 communities to either origin or destination controls, respectively. **C)** Over the experimental years, we

- 197 expect that taxonomic distances between warmed and control communities change. If warmed
- 198 communities follow the expected trajectory (red lines), the distance between warmed and origin control 199 communities will increase (red solid line) and the distance between warmed and destination control
- 200 communities will decrease (red dotted line). If the distance between warmed communities and origin
- 201 controls reaches the maximum divergence determined by the distance between the controls, and if the
- 202 distance to destination controls reduces to zero, indicating maximum convergence, then no lags remain in
- 203 community shifts. However, warmed communities might deviate from this expected trajectory, increasing
- 204 the taxonomic distances to both controls (pink lines), thereby maintaining lags in community shifts. Given
- 205 that distances in warmed communities are constrained between zero and the shortest distance between
- 206 controls for the expected trajectory, and between zero and one for the deviating trajectory, a logarithmic 207 relationship is expected between experimental years and taxonomic distances. Note that the taxonomic
- 208 distance between controls is expected to remain constant (gray line).

riment to calculate the ori 211 We extracted monthly mean daily air temperature (°C) and potential evapotranspiration (PET) 212 (mm) data from the ~1 km resolution CHELSA database [\(Karger et al. 2021\)](https://paperpile.com/c/pDL3XE/vH6MN) for each site. We 213 calculated the average summer (June, July, August) temperature and annual PET for each site 214 for each year of the experiment. We averaged the summer temperature and annual PET across 215 all years for each experiment to calculate the origin and destination climates. To estimate the 216 experimental climate warming experienced by warmed turfs, we calculated the average 217 difference between destination and origin sites' summer temperature over the experimental 218 years. Transplantation of turfs from high to low elevation simulated 0.5-11.1 °C (average of 3.0 219 °C) of experimental warming across all experiments, covering a range of climate change 220 scenarios generated by the IPCC for the next 50 years (IPCC 2022a). The experiments aimed 221 to simulate warming but other environmental changes, such as in PET, are also imposed by 222 downward transplantation (Fig. 2B). However, due to the high spatio-temporal variability of 223 precipitation, especially in mountainous regions, CHELSA model spatial projections convey 224 more uncertainty than temperature projections (Prein and Gobiet 2017). This uncertainty may 225 prevent us from accurately calculating the differences in PET between closely located origin and 226 destination sites. Therefore, we only analyze the effect of PET at the destination sites rather 227 than the difference between sites.

229 *Plant relative abundances*

230 Vegetation surveys varied in timing, temporal resolution, and duration. Survey methodologies 231 were also diverse, including percent cover estimates of all species in the turfs, point-intercept 232 counts, or species-specific sorting of above-ground biomass. Some surveys did not record non-233 vascular plant categories, rock or bare soil. Thus, we removed inconsistent cover categories 234 from the dataset and converted vascular plant species cover or count data into relative plant 235 abundances to ensure comparability across experiments. The compiled data ranges from 1 to 9 236 years, for 60635 observations of 967 identified species and 92 taxa identified only at genus 237 level. We decomposed these species pools into strictly high-elevation, overlapping, or 238 colonizing low-elevation species based on their presence/absence in the control communities 239 for each experiment (Table S3, Fig. S3). By definition, strictly high-elevation species were only

240 found in the higher-elevation origin controls for each experiment, including high-elevation 241 species relative to the experiment. We note that these are not necessarily alpine plants in a 242 biogeographic sense (i.e., species found mainly above the treeline). The colonizing low-243 elevation species pool includes species that occur in destination controls but not in origin

- 244 controls. Overlapping species are found both in origin and destination controls. Species that
- 245 occur in warmed communities only but are absent from both sets of controls (i.e., on average,
- 246 5% across all experiments, Fig. S3, Fig. S9) were excluded from the analysis. We limited our 247 analysis to experiments with over two years of data, thus excluding US Colorado and
- 248 IN Kashmir. We also excluded US Arizona due to its small high-elevation species pool of four 249 species. Additionally, we excluded species found only once in a single turf to eliminate potential 250 botanical identification errors. We square-root transformed species relative abundances in the 251 analyses described below.

nal traits from the TRY database: vegetative haven and traits from the TRY database: vegetative haven are alleven and resource use strategies that are relevant of their ability to compete for light, [w](https://paperpile.com/c/pDL3XE/MHECl)ater and Ve used a pre 254 We compiled five functional traits from the TRY database: vegetative height, leaf area (LA), 255 seed mass, specific leaf area (SLA), and leaf nitrogen percentage [\(Kattge et al. 2020\).](https://paperpile.com/c/pDL3XE/m3hvM) These 256 traits relate to plant size and resource use strategies that are relevant for plant responses to 257 environmental change and their ability to compete for light, water and nutrients [\(Violle et al.](https://paperpile.com/c/pDL3XE/8A8I8+1teIH) 258 [2007, Díaz et al. 2016\)](https://paperpile.com/c/pDL3XE/8A8I8+1teIH). We used a pre-processed version of the TRY dataset by [\(Walker et al.](https://paperpile.com/c/pDL3XE/Q1ecO) 259 [2023\)](https://paperpile.com/c/pDL3XE/Q1ecO), filtered for trait values with an error risk < 4 according to the TRY database criterion 260 (which measures the deviation from mean trait values within species, genus, family, or the entire 261 dataset in standard deviation) and gap-filled using Bayesian hierarchical probabilistic matrix 262 factorization imputation. This pre-processed dataset still had missing focal traits for certain 263 species (vegetative height: 22%, SLA: 15%, LA: 31%, N-percent: 23%, seed mass: 29%) that 264 we additionally gap-filled with miceRanger algorithm (Wilson in press). From these functional 265 traits, we built a principal component analysis (PCA) with all the species from the TransPlant 266 network (Fig. S2). Horn's parallel analysis retained two principal components (PC) to represent 267 the variation in the trait space. LA (33%), vegetative height (26%), seed mass (23%) contributed 268 primarily to PC1 followed by N-percent (9%) and SLA (8%). SLA (42%) and N-percent (38%) 269 contributed the most to PC2 followed by vegetative height (9%), seed mass (9%) and LA (1%). 270 Thus, we defined the first two PCs as denoting plant-size and resource acquisition-related traits, 271 respectively, representing the two main axes of the global plant functional trait spectrum [\(Díaz](https://paperpile.com/c/pDL3XE/1teIH) 272 [et al. 2016\)](https://paperpile.com/c/pDL3XE/1teIH). We calculated community-weighted means (CWMs) of PC1 and PC2 scores for 273 each control community, reflecting plant size and resource acquisition strategies, respectively.

275 *Quantifying plant community taxonomic divergence or convergence*

276 To quantify the plant community taxonomic change over time, we built principal response curves 277 (PRC) [\(Van den Brink and Braak 1999\).](https://paperpile.com/c/pDL3XE/1Bfv) PRC, developed from redundancy analysis (RDA), is 278 an ordination technique that quantifies the impact over time of several treatments on species 279 relative abundances in experimental communities, relative to a reference community. It 280 accounts specifically for the interaction between experimental years and treatment while 281 controlling for the overall temporal trend in community composition. PRC allows for extracting i) 282 taxonomic distances between the treatments and the reference over time as canonical

283 coefficients of the treatments and ii) species weights that quantify species' contributions to 284 overall community taxonomic changes [\(Vandvik et al. 2014\)](https://paperpile.com/c/pDL3XE/ERLFH).

m canonical coefficients of the warmed c 286 We quantified the taxonomic distances of the warmed communities relative to the controls by 287 constructing two PRCs for each experiment. The first PRC used the origin control as the 288 reference community, with the warmed and destination control as treatments to quantify their 289 taxonomic distance from the origin control. The second PRC used the destination control as the 290 reference, with the warmed and origin control as treatments to quantify their taxonomic distance 291 from the destination control (Table S4). Canonical coefficients (C_t) from PRC axis 1 (hereafter, 292 "PRC1") capture the most important taxonomic variation in differences between warmed and 293 control communities for a given year t, quantifying warmed communities' divergence from the 294 origin control and convergence towards the destination control. Canonical coefficients from PRC 295 axis 2 (hereafter, "PRC2") capture the second most important variation, and most important 296 deviation from the PRC1 (van den Brink et al. 2009). In PRCs, taxonomic distances between the 297 origin and destination controls indicate the maximum expected divergence of warmed 298 communities from origin controls and their maximum expected convergence towards destination 299 controls (Fig. 1B-C). When canonical coefficients of the warmed communities exceed the 300 canonical coefficients of the control communities in a given PRC, this can be interpreted as the 301 communities deviating from the shortest trajectory between warmed communities and displaying 302 a "deviating" response (Fig. 1B-C). We expect to see these responses mainly in PRC2 with 303 higher values in PRC2 indicating stronger deviating responses.

304

305 **Quantifying species' contributions to taxonomic divergence or convergence**

306 To assess the species' contributions to the community taxonomic shifts, we calculated 307 proportional relative abundance differences in warmed communities in comparison to the mean 308 relative abundance in control communities following the expression $b_k * c_t - 1$ for each species 309 K, with species weights b_k and canonical coefficient c_t of warmed communities at year t from 310 both PRCs per experiment. Here, species weights b_k (i.e., constant over the years) allow us to 311 obtain the fitted response curves for species k and quantifies the affinity of species k with the 312 overall trajectory of the community (i.e., the higher the species' weights, the more likely it is that 313 the species is aligned with the pattern of community change as quantified by PRC) [\(Van den](https://paperpile.com/c/pDL3XE/1Bfv) 314 [Brink and Braak 1999\)](https://paperpile.com/c/pDL3XE/1Bfv). Interpreting this outcome as the species' contribution to a communities' 315 taxonomic divergence and convergence provides several advantages to using raw relative

- 316 abundance differences: i) disentangling species contributions to the most important variation
- 317 (PRC1) from the second most important variation (PRC2, i.e., deviations from PRC1)
- 318 community change, while ii) taking into account the noise in the data.
- 319

320 *Statistical analyses*

321 To address our first question, we assessed the rate of composition change in warmed

- 322 communities along two primary axes: 1) divergence or convergence along PRC1, quantified by
- 323 canonical coefficients, and 2) deviation from these trajectories along PRC2. We developed
- 324 linear mixed effects models for each axis, considering both the warmed (red lines in Fig.1B-C)
- 325 and control communities (gray lines in Fig.1B-C) relative to a reference community. These
- 326 models used canonical coefficients as the response variable and included log-transformed

327 experimental year, distance type (to origin or destination control), experiment identity, and their 328 three-way interactions as fixed effects. A random effect for gradient was included to adjust for 329 non-independence across experiments due to regional variations like soil and habitat 330 differences. We log-transformed the experimental year to fit a logarithmic regression because 331 the distances between communities cannot surpass the maximum expected distance in the 332 case of the divergence, or zero in the case of convergence. This transformation improved model 333 fit, reducing AIC values by 121.39 and 153.20 for PRC1 and PRC2, respectively (df = 162). The 334 slopes from these models provide estimates of the rates of divergence from origin controls, 335 convergence towards destination controls, and deviations in composition across all experiments 336 over the years.

rences in relative abundances in w 338 To answer our second question, we estimated i) the proportional differences in relative 339 abundances in warmed communities calculated from both PRC axes per species pool (strictly 340 high-elevation, overlapping and colonizing) at the start (year = 1) and end (year = 9, projected 341 for the short experiments) of experiments, and ii) the rate of changes in these proportional 342 differences over time. We built linear mixed effects models for each axis and species pool with 343 species' proportional differences in relative abundances in warmed communities as the 344 response variable with experimental year (log-transformed), comparison type (to origin or 345 destination control), experiment identity, and their three-way interactions as fixed effects. We 346 included species nested in gradients as random effects. Here, we present the estimated 347 proportional differences in relative abundances in warmed communities per species pool at the 348 start and end of experiments, and the slopes (as rate of changes in relative abundances) from 349 these species pool-level models for all experiments combined. When compared to origin 350 controls, higher proportional relative abundance differences in warmed communities indicate 351 greater climate change effects on relative abundances of that experiment and/or species pool. 352 Also compared to origin controls, greater magnitudes of the slopes (absolute values) indicate 353 faster changes in relative abundances. More precisely, higher positive rates indicate faster 354 species gains, lower negative rates indicate faster losses. When compared to destination 355 controls, i) higher proportional relative abundance differences in warmed communities indicate 356 greater lags in relative abundances, while ii) larger magnitudes of the slopes (absolute values) 357 indicate faster realization of the experimental climate change response and thus, declines in 358 lags. More precisely, higher positive rates indicate faster decline in colonization lags (i.e., 359 realization of colonization events), lower negative rates indicate faster decline in extinction lags 360 (i.e., realization of extinction events). Overall, changes in a species pool reflect overall changes 361 in species' relative abundances in a given experimental community belonging to the species 362 pool in question.

363

364 To answer our third question, we first extracted the slopes (i.e., rate of changes in distances 365 between warmed and both control communities) and their standard errors for each experiment 366 from the first-mentioned (community-level) model. Second, we extracted the initial and final 367 proportional differences in relative abundances and slopes (i.e., rate of change in proportional 368 differences in relative abundances) and their standard errors for each experiment from the 369 second-mentioned (species pool-level) model. At community-level, we built two separate meta-370 regression models to accommodate each of the two distance types (to origin or destination

371 control) with slopes as response variable. At species pool-level, we built 18 separate meta-372 regression models to accommodate each of the two comparison types (to origin or destination 373 control) and three species pools with three response variables: i) slopes at species pool-level, 374 iii) initial and iii) final proportional differences in species-pool relative abundances. In these 375 models, experimental (turf size, experimental warming, duration), and climate factors (summer 376 temperature and annual PET of destination sites) and functional traits (CWM of plant size and 377 resource acquisition traits) were included as explanatory variables. Meta regression models 378 take into account the uncertainty in the response variables [\(Viechtbauer 2010\)](https://paperpile.com/c/pDL3XE/Nq96). All explanatory 379 variables were standardized (i.e., z-score normalization). 380 381 We conducted the statistical analysis with R version 4.4.0 [\(R Core Team 2024\)](https://paperpile.com/c/pDL3XE/1oP7) using the

onverge 422 Warmed communities taxonomically diverged from the high-elevation origin control communities 423 (Fig. 3A red-solid lines; Table S5) and converged towards low-elevation destination control 424 communities across all experiments **(Fig. 3A, red-dotted lines).** As expected, the distance 425 between the two control communities remained constant on both PRC axes, indicating no 426 significant directional change in composition in the controls **(Fig. 3 A-B, gray lines).** In the first 427 year, warmed communities had already diverged on PRC1 by on average 14 %, and converged 428 by on average 13 %, of the maximum expected distance (i.e., the distance between the two 429 controls). If communities maintained this pace they would have reached zero taxonomic 430 distance with destination controls at around 7 years, however, rates of divergence and 431 convergence slowed down considerably over time. On average, (i.e., based on projections), 432 48% and 54 % of taxonomic distance on PRC1 still remained, after 9 years, for communities to 433 reach maximum divergence and convergence, respectively.

434

435 However, variation in rates of composition change was observed across the 40 experiments

436 (Fig. S5). First, warming led to divergence from origin controls only in 33 experiments.

437 Conversely, in 7 experiments, warmed communities diverged from origin controls in the first

438 year but they started to converge back towards origin controls over the years (Fig.3A, Fig. S5).

439 The rates of change in taxonomic distances between warmed and origin control communities

440 ranged from -0.053 to 0.215 (i.e., unitless change in taxonomic distance over the years scaled

441 between -1 and 1, Fig. S5). Second, warming led to convergence with destination controls only

442 in 36 experiments. Whereas in 4 experiments, warmed communities tended to diverge from the 443 destination controls. The rates of change in taxonomic distances between warmed and

444 destination controls ranged from -0.283 to 0.0584. In addition, taxonomic distances between

445 warmed and control communities generally **(Fig. 3B solid and dotted red lines)** exceeded the 446 distances between the controls **(Fig. 3B gray lines)** along PRC2. This indicates that warmed

447 communities deviated from the expected trajectory of convergence. These deviations 448 significantly increased over time **(Fig. 3B&D).**

463 **How do different species pools contribute to divergence or convergence in plant** 464 **community composition?**

481 The divergence of warmed communities from origin controls was similarly driven by both the 482 decrease in relative abundances of strictly high-elevation species and the increase in colonizing 483 species. (Fig. 4A-B). However, both colonization and extinction lags remained after the 9-year

484 experimental period: On average, strictly high-elevation species remained more abundant and

485 colonizing species less abundant in warmed communities compared to destination controls (Fig.

486 4A-B). Besides having equal contributions to the overall shifts in warmed communities, rates of

487 species gains and losses over the years were similar, thus contributing equally to the rates of

- 488 divergence from the origin controls and convergence towards destination controls (Fig. 4C).
- 489 However, beyond these general trends, there was substantial variation across experiments (Fig.
- 490 5A, thin lines, Fig. S5). In fact, the relative abundances of overlapping species across
- 491 experiments showed both increasing and decreasing trends, which canceled each other out,
- 492 resulting in no clear general trend.
- 493

494 Taxonomic shifts away from the shortest trajectory between origin and destination controls in 495 warmed communities were mainly driven by the colonizing species (Fig. S4). Interestingly, when 496 predicted by PRC2, relative abundances of the colonizing species were increasingly higher in 497 warmed communities in comparison to destination controls, indicating that some colonizing 498 species were increasing their abundances more than expected (i.e., given their relative 499 abundances in destination controls), contributing to the community-level deviating responses 500 (Fig. S4).

502 **What influences the variation in overall rates of community change across experiments, as** 503 **well as the contribution of different pools to divergence or convergence?**

Also, 507 communities exposed to stronger warming over longer periods converged faster towards 508 destination controls (i.e., decreasing taxonomic distances between warmed and destination 509 control communities over time) (Fig. S6; Table S7).
- 510

511 Species pools' relative abundance differences in warmed communities compared to controls 512 varied between the beginning and end of experiments (Fig. 5; Table S8). At the beginning of the

513 experiments, species losses (i.e., decreases in the relative abundances of the strictly high-

- 514 elevation species) in warmed communities were higher in experiments with smaller plots and
- 515 when destination communities were dominated by smaller-sized plants. Similarly, extinction lags
- 516 were greater in smaller plots, under stronger warming, in shorter experiments, when
- 517 transplanted to cooler destinations where destination communities were dominated with taller-
- 518 sized plants. Parallely, species gains (i.e., increases in the relative abundances of the colonizing 519 species) in warmed communities were higher in smaller plots. Finally, overlapping species had
- 520 higher relative abundances in warmed communities in comparison to destination controls when
- 521 transplanted to a wetter destination (among other destination sites) and when they originated
- 522 from smaller-sized and more resource-acquisitive communities.
- 523

524 At the end of the experiments, species losses and gains were higher (Fig. 5) and faster (Fig. S7; 525 Table S8) in smaller plots and under stronger warming. Whereas, extinction lags were higher in 526 shorter experiments and when communities were transplanted to wetter conditions. Meanwhile, 527 colonization lags were higher when the origin communities were dominated by more resource-528 acquisitive strategies. Finally, overlapping species had higher relative abundances in warmed 529 communities than in origin controls when they originated from more conservative and taller-

530 sized communities.

Discussion

High-elevation plant community trajectories under climate warming

551 Ecologists are trying to understand the reconfigurations of plant communities due to abundance

- 552 and distribution shifts triggered by climate change. A "null hypothesis" is that when dispersal
- 553 limitations of warm-adapted species are overcome, the future composition of cool-adapted plant
- 554 communities converge on the composition of warm-adapted communities of today. Alternatively,

555 altered ecological interactions within warming communities might cause them to exhibit lagged 556 responses or even follow alternative trajectories leading to novel community compositions. A 557 network of transplant experiments provided us with the unique opportunity to examine the initial 558 years of these trajectories under climate warming. As expected, the taxonomic composition of 559 warmed communities shifted, converging towards their lower-elevation communities. 560 Nonetheless, communities under warming did not fully converge on the low-elevation 561 community composition, even up to nine years after transplantation. In addition, we found that 562 warmed communities deviated significantly from the shortest trajectory of community shift 563 between high- and low-elevation sites and rates of taxonomic convergence slowed over time. 564 Together, these results suggest that even if high-elevation communities do eventually converge 565 on today's low-elevation community composition, this will be a slow process characterized by 566 significant colonization and extinction lags and transient dynamics leading to a prolonged period 567 of novel community structures [\(Hastings et al. 2018\).](https://paperpile.com/c/pDL3XE/xIJ2f) Such transient dynamics could be due to 568 demographic lags (Alexander et al. 2018), feedbacks in plant-plant interactions [\(Alexander et al.](https://paperpile.com/c/pDL3XE/dHgu+v4Do+y0Ay) 569 [2015, Vandvik et al. 2020,](https://paperpile.com/c/pDL3XE/dHgu+v4Do+y0Ay) Bektaş et al. 2023), plant-soil nutrient pools [\(Khedim et al. 2022\)](https://paperpile.com/c/pDL3XE/nFkZ8), or 570 plant-microbial interactions (Zhang et al. 2014).

is (Zhang et 572 Taxonomic changes were already large in the first year after transplantation. This might be an 573 effect of the transplantation method, whereby the communities are exposed to an abrupt 574 environmental change. Indeed, community responses to gradual warming might differ from 575 those of abrupt climate manipulations, partly because individual species differ in their 576 demographic responses to fast vs. slow warming altering the network of plant-plant interactions 577 [\(Block et al. 2022\).](https://paperpile.com/c/pDL3XE/3UCEZ) Nonetheless, the rapid responses to more intense warming and drying 578 emphasize the crucial role of extreme events in driving community changes, triggering the loss 579 of less resilient high-elevation species and facilitating swift colonizations by warm-adapted taxa. 580 Even as taxonomic shifts appear to slow down over time, and warmed high-elevation 581 communities stabilize, their vulnerability to extreme climatic events could further accelerate the 582 rate of taxonomic changes, inducing a second wave of abrupt shifts. In fact, in transplant 583 experiments in Switzerland and Austria, colonization of the low-elevation species started only 584 three years after the transplantation, specifically after the drought in 2018, which led to 585 significant species losses in transplanted high-elevation communities [\(Schuchardt et al. 2023b\).](https://paperpile.com/c/pDL3XE/e1JC) 586 With intense heatwaves and droughts becoming more common in mountainous areas [\(IPCC](https://paperpile.com/c/pDL3XE/Nyo7T) 587 [2022b\)](https://paperpile.com/c/pDL3XE/Nyo7T), high-elevation communities may undergo multiple swift taxonomic changes, as 588 evidenced by landscape-scale alterations following recent extreme events in the European Alps 589 [\(Choler 2023\)](https://paperpile.com/c/pDL3XE/9Alr).

590

591 **Contributions of different species pools to changes in community composition**

592 Changes in community composition under warming were influenced both by colonizing species from the 593 destination site, and abundance shifts, including local extinctions, of strictly high-elevation species. On 594 average, species gains from colonizing pools and losses from strictly high-elevation species pools, along

595 with the rates of these changes, were of similar magnitude, albeit in opposite directions. This suggests that

- 596 these two species pools contributed similarly to community changes. The large contributions of the
- 597 strictly high-elevation species pool to the divergence of warmed communities from the high-elevation
- 598 communities indicate that even after the first year of transplantation, decreasing relative abundances and

 local extinction events of cold-adapted species under warming were important. Interestingly, a minority 600 of experiments ($n = 5$) displayed increasing relative abundance of this species pool over the years, which might be explained by a few species initially tolerating (or even benefiting from) climate change and/or altered plant-plant interactions under warming [\(Nomoto and Alexander 2021\)](https://paperpile.com/c/pDL3XE/5fsk). Fewer losses from this species pool were detected in studies with shorter experimental durations. In longer-term experiments, despite overall losses, the strictly high-elevation species maintained enough abundance to significantly differentiate the warmed community from the destination controls even after nearly a decade. . In other words, many of these species appear able to persist for considerable periods of time under significant future warming. This is consistent with estimates of substantial extinction lags in alpine plant communities, especially when species continue to coexist with their original plant community via competition [\(Rumpf et al. 2019\)](https://paperpile.com/c/pDL3XE/EaeK).

 Colonizing species also made large contributions to the difference in community composition between warmed and high-elevation communities over time, even though with substantial delays. This clearly

demonstrates that under climate change, low-elevation species can colonize high-elevation plant

- communities if dispersal limitations are removed. This gives a first indication that the lags in range shifts
- observed in mountain floras (Rumpf et al. 2018, 2019) are at least partly explained by dispersal limitation,
- and that novel plant establishment should be expected once these limitations are overcome. Moreover,
- increasing colonizations in smaller plots, which have more exposure to the surrounding colonizing
- 618 community at the edges due to a larger edge length ratio (e.g., 16 and 4 for 0.0625 and 1 m^2 plots, respectively), contradicts the expectation of colonist establishment from seeds, where larger plots should

accommodate a higher probability of dispersal events. This implies that clonal growth may be a key factor

This does not imply that species in this pool were unaffected by warming. Instead, it suggests a spectrum of positive and negative responses across and within experiments: the overlapping species pool in each experiment contained a mixture of "winner" and "loser" species. Given that overlapping species demonstrate a larger niche in tolerating a broader range of environmental and biotic conditions at across elevations, their abundance change in the beginning of experiments may be stochastic. However, if originating from more resource-conservative communities, relative abundances of overlapping species increased more. Moreover, when in drier conditions than all other destinations, their relative abundances were lower than in destination controls. This indicates that responses to drought play a major role in mountain plant population dynamics and drought-tolerant species can be the winners of climate change in the mountains [\(Visakorpi et al. 2022\)](https://paperpile.com/c/pDL3XE/6L09).

synamic Only partly related to experimental design choices (e.g, plot size, duration, and climate context), much of the variation in species responses could be explained by destination or origin communities' functional traits. These traits, which indicate competitive abilities for acquiring light, water, and nutrients, suggest that plant-plant interactions and their temporal dynamics may play a role in the observed variation in population dynamics [\(Lynn et al. 2019, Meineri et al. 2020\)](https://paperpile.com/c/pDL3XE/8QU3+h8zS). For example, colonization lags persisted in warmed communities where resource-acquisitive plants were originally dominating. Perhaps, when high- elevation communities are competitive for resources such as soil nutrients and water, colonizers fail to establish. Moreover, we expected that warmed communities suffering competitive exclusion due to taller surrounding destination communities (Fig. S8). Yet, in destination sites dominated by taller-sized plants, species losses were lower and extinction lags were higher. This might suggest that biotic interactions between destination communities and strictly high-elevation species influence the population dynamics of the latter, possibly through tall and wide-leaved destination-species creating shade and thus, cooler microhabitats for intensely warmed high-elevation species. Finally, effects of functional traits were not consistent across the experimental period and they do not determine the rates of changes in communities and species contributions. This could indicate, on the one hand, initial stochastic losses and gains, on the other hand, plant-plant interactions needing time to adjust, being transient and leading to inconsistencies through feedback between them.

Conclusions & Perspectives

Our study underscores the dynamic shifts in high-elevation plant communities due to experimental

climate warming, suggesting the formation and persistence of novel communities that complicate future

predictions. While community taxonomic convergence towards lower elevations hints at a predictable

trajectory under climate change, significant uncertainties due to local factors like climate and initial

community composition highlight the need for localized studies. Future research should focus on the

variability in temporal and spatial dynamics, investigate the causes of shifts in populations and

communities, including the changes in biotic interactions. We encourage expanded collaborative

macroecological experiments across diverse ecosystems to better understand plant community responses

to climate change.

1 **Title:** Colonization and extinction lags drive non-linear responses to warming in mountain plant

- 2 communities across the Northern Hemisphere

34 **Abstract**

- 5 Global warming is changing plant communities due to the arrival of new species from warmer
- 6 regions and declining abundance of cold-adapted species. However, experimentally testing
- 7 predictions about trajectories and rates of community change is challenging because we
- 8 normally lack an expectation for future community composition, and most warming experiments
- 9 fail to incorporate colonization by novel species. To address these issues, we analyzed data
- 10 from 44 whole-community transplant experiments along 22 elevational gradients across the
- 11 Northern Hemisphere, where. In these experiments, high-elevation communities were
- 12 transplanted to lower elevations to simulate warming, while also removing dispersal barriers to
- 13 establishment byfor lower--elevation species to establish. We quantified the extent and pace at 14 which warmed high-elevation communities shifted towards the taxonomic composition of lower
- 15 elevation communities.

- 20 remained distinct from eitherboth origin orand destination control by the end of the experimental
- 21 periods (3-9 years). Changes were driven to a similar extent by both new species colonization
- 22 and abundance shifts of high-elevation species, but with substantial variation across
- 23 experiments that could be partly explained by the magnitude and duration of experimental
- 24 warming, plot size and functional traits.

- 26 Our macroecological approach reveals that while warmed high-elevation communities
- 27 increasingly resemble communities at lower elevations today, the slow pace of taxonomic shifts
- 28 implies considerable colonization and extinction lags, where a novel taxonomic composition of
- 29 both low- and high-elevation species could coexist for long periods of time. The important
- 30 contribution of the colonizing species to community change also indicates that once dispersal
- 31 barriers are overcome, warmed high-elevation communities are vulnerable to encroachment
- 32 from lower elevation species.

33 **Introduction**

- 34 Changes in the composition of vegetation along steep elevation gradients reveal the role of
- 35 climate as a powerful force in structuring plant communities [\(Giaccone et al. 2019, Chauvier et](https://paperpile.com/c/pDL3XE/2J4i9+TRAex)
- 36 [al. 2021\),](https://paperpile.com/c/pDL3XE/2J4i9+TRAex) and now, climate warming is restructuring plant communities [\(Harrison 2020, IPBES](https://paperpile.com/c/pDL3XE/8JCdl+iwT3D)
- 37 [2023\)](https://paperpile.com/c/pDL3XE/8JCdl+iwT3D). Climate change effects are especially prominent at higher elevations in mountains,
- 38 where temperatures are rising faster than the global average [\(Pepin et al. 2022\).](https://paperpile.com/c/pDL3XE/kmpl0) The
- 39 abundance and species composition of mountain plant communities are changing as extant
- 40 populations respond to new environmental conditions and as species migrate upslope to track
- 41 their preferred climate (Fig. 1B) [\(Lenoir et al. 2008, Rumpf et al. 2018\).](https://paperpile.com/c/pDL3XE/MHqA+WWJmY) However, vegetation
- 42 changes are strongly lagging behind expectations based on the pace of climate warming, due to

Alternatively, priority effects and novel plant-47 plant-climate interactions might set communities on alternative trajectories, yielding "no-analog" 48 communities, as has occurred under past climatic changes [\(Overpeck et al. 1992, Leopold et al.](https://paperpile.com/c/pDL3XE/cM0E5+notl0+t2GWp) 49 [2015, Staples et al. 2022\)](https://paperpile.com/c/pDL3XE/cM0E5+notl0+t2GWp) as well as during current climate warming [\(Roth et al. 2014\)](https://paperpile.com/c/pDL3XE/dxVPI). Insight 50 into the trajectory and pace of changes in plant community composition will therefore be 51 important to accurately forecast the impacts of climate change on biodiversity in mountainous 52 regions. 53 54 Since both the trajectory and pace of changes in community composition depend on the 55 combined effects of colonization rates, local extinctions, and abundance shifts, we can gain 56 insights into the relative importance of these processes by explicitly examining the response to 57 warming of three distinct species pools (Lynn et al. 2021). Firstly, species that are restricted to 58 high elevation (hereafter, "strictly high-elevation species") are generally expected to respond 59 negatively to warming and eventually become locally extinct [\(Geppert et al. 2023\).](https://paperpile.com/c/pDL3XE/yMwY) This could 60 happen either because they are poorly adapted to warmer conditions, or because they are 61 poorer competitors for resources, such as light, that become increasingly limiting as warm-62 adapted, lower-elevation species arrive and increase in abundance [\(Alexander et al. 2015,](https://paperpile.com/c/pDL3XE/dHgu+dK2U) 63 [Olsen et al. 2016\).](https://paperpile.com/c/pDL3XE/dHgu+dK2U) Secondly, species that occur in both high and low-elevation communities 64 (hereafter, "overlapping species"), and thus that are adapted to a wider range of climatic and 65 biotic conditions, might benefit from climate warming and increase in abundance [\(Lynn et al.](https://paperpile.com/c/pDL3XE/FMLt) 66 [2021\)](https://paperpile.com/c/pDL3XE/FMLt). Finally, new species that migrate upslope from low elevation will establish in high-67 elevation communities and increase in abundance (hereafter, "colonizing species"). The relative 68 contribution of these three local species pools – strictly high-elevation, overlapping, and 69 colonizing species – to community shifts in response to climate change will depend on their 70 reaction time (e.g., dispersal, establishment and extinction lags; Alexander et al. 2018) and the 71 magnitude of warming. Disentangling responses of these different species pools can help 72 anticipate the trajectory and rate of changes in high-elevation vegetation and the consequences 73 for species' range shifts under future climate. 74

75 Manipulative experiments are key to studying possible long-term changes in community 76 composition in response to climate warming. *In situ* warming experiments, for example using 77 passive warming chambers, have been most commonly employed to reveal shifts in mountain 78 plant communities towards assemblages more typical of lower elevations [\(Henry et al. 2022\).](https://paperpile.com/c/pDL3XE/bWib) 79 However, *in situ* experiments do not capture the contribution of all species pools to community 80 change, most notably that of colonizing species. This is because the pool of potential colonists 81 is typically absent due to dispersal lags, unless this aspect is intentionally manipulated. Whole-82 community transplant experiments, which simulate climate change by moving plant communities 83 with their soils to a new location representing possible future climate conditions, overcome this 84 problem by simultaneously exposing communities to a change in climate and potential 85 colonization by species from the destination transplant site (Fig. 1A). They thus offer a powerful 86 way to examine the trajectory of mountain plant communities under future climate change, and 87 how these trajectories are underlain by different species pools once dispersal barriers are lifted.

Collectively, these studies 93 suggest that under experimental climate change, transplanted high-elevation communities can 94 restructure quickly and resemble lower-elevation communities. While the magnitude and pace of 95 these shifts remain unknown, species pools driving changes in community composition can be 96 region and experiment-dependent. For example, in a transplant experiment in Norway, 97 transplanted turfs were rapidly colonized by low-elevation species, which negatively impacted 98 high-elevation species within the community through novel competitive interactions [\(Vandvik et](https://paperpile.com/c/pDL3XE/v4Do) 99 [al. 2020\)](https://paperpile.com/c/pDL3XE/v4Do) In contrast, an experiment in France, shifts in relative abundances within the existing 100 communities drove the community reassembly (Bektaş [et al. 2023\).](https://paperpile.com/c/pDL3XE/y0Ay) Furthermore, the functional 101 strategies of individual plant species that benefit from climate change exhibit both general and 102 region-specific responses. For example, taller species become more abundant under 103 experimental warming in experiments from Switzerland [\(Visakorpi et al. 2022\)](https://paperpile.com/c/pDL3XE/6L09) and Norway 104 [\(Guittar et al. 2016\),](https://paperpile.com/c/pDL3XE/Kgz1) where taller species have also lower extinction rates [\(Lynn et al. 2023\)](https://paperpile.com/c/pDL3XE/KbEix). 105 HoweverIn addition, while species with slow resource acquisition were favored under warming 106 in Switzerland [\(Visakorpi et al. 2022\),](https://paperpile.com/c/pDL3XE/6L09) species with fast resource acquisition strategies coming 107 from warmer habitats colonized and increased their abundance more in colder sites in Norway 108 [\(Lynn et al. 2023\).](https://paperpile.com/c/pDL3XE/KbEix) These regional differences might arise from variations in limiting resources 109 and how they are impacted by climate change, as well as from differences in the magnitude or 110 duration of the experimental warming (Elmendorf et al. 2012). Consequently, it remains unclear 111 whether we can make general predictions about the trajectory and pace of taxonomic responses 112 to warming, and to what extent context-dependencies can be attributed to regional climatic or 113 ecological or experimental differences. 114

- 115 A macroecological experimental approach (Box 1) can allow us to identify general patterns in 116 community composition change under climate change, while quantifying regional and
- 117 experimental differences (Alexander et al. 2016). Here, we combine, for the first time, vegetation
- 118 surveys spanning 2-9 years from a network of 44 whole-community downslope transplant
- 119 experiments along 22 elevation gradients across the Northern Hemisphere to ask: i) To what
- 120 extent does the species composition of warmed high-elevation communities diverge from the
- 121 non-warmed high-elevation communities and converge towards that of low-elevation
- 122 communities over time? ii) How do different species pools (strictly high-elevation, overlapping,
- 123 or low-elevation colonizing species) contribute to divergence or convergence in plant community
- 124 composition associated with climate change? iii) Is variation in overall rates of community 125 change across experiments, as well as the average contribution of different pools to divergence
- 126 or convergence, influenced by experimental design, the climate context of the study site, or
- 127 plant functional trait composition?

com the effects of exp 136 TransPlant is a network of 22 elevation gradients, distributed across 20 different mountainous 137 regions of the Northern Hemisphere, where whole plant communities have been transplanted to 138 lower elevations to simulate climate change **(Fig. 1-2, Table S1-2)**. The basic design of the 139 transplant experiments involve the transplantation of vegetation turfs (or "monoliths") of whole 140 plant communities with their soil from a higher (cooler) to a lower (warmer) elevation site to 141 simulate climate warming ("warmed" treatment) **(Fig. 1A)**. Moving plant communities to lower 142 elevation in this way allows plants from the lower elevation site to quickly colonize transplanted 143 turfs, also simulating the arrival of the novel species into high elevation communities that we 144 expect to arrive following climate warming **(Fig. 1A).** For any given set of warmed turfs, there 145 are "origin controls" (high-elevation turfs locally transplanted at their high-elevation site of origin) 146 and "destination controls" (low-elevation turfs locally transplanted at the low-elevation site of 147 destination) **(Fig.1A)**. Thus, these controls make it possible to disentangle potential 148 transplantation artifacts from the effects of experimental climate change. Along some 149 TransPlant gradients, multiple experiments are conducted by transplanting the turfs from high to 150 mid, mid to low, high to low elevations **(Fig. S1A)**. We refer to a set of warmed, origin and 151 destination control turfs within each gradient as an "experiment" **(Fig. 1A)**, yielding a total of 40 152 experiments because 12 gradients were composed of more than two sites (Table S1-2). The 153 experiments were established between 2007 and 2017. Each experiment had 3-10 replicates of 154 transplant and control turfs, and in total there were 668 turfs varying in sizes between 0.02 m² 155 and 1 m^2 with a mean size of 0.3 m^2 across the 40 experiments.  Fig. 1: Overview of experimental designs in the TransPlant network, illustrating the ecological processes simulated through whole-community transplantation and the analytical framework used to study

- community shifts post-transplantation. **A)** Transplant experiments aim to simulate climate change by
- 211 transplanting whole plant communities to putative future climates at lower elevation. This approach also
- lifts the dispersal barrier for colonizing species, thereby allowing colonization into the transplanted
- communities from the low-elevation site (colonizing species). We refer to the turfs transplanted from origin
- to destination sites as "warmed" communities (red circle), and to turfs locally replanted at origin and

 destination sites as "origin" (blue circle) and "destination" (orange circle) controls, respectively. **B)** Our expectation is that the warmed communities (red circle) will diverge in taxonomic composition from the origin controls (blue circle) and increasingly resemble the destination controls (orange circle), following the shortest distance between the controls over the years after transplantation. However, communities might deviate from this expected trajectory of resembling destination controls (red lines), showing deviating responses (pink lines). To quantify the degree of divergence from origin controls (solid lines) or convergence towards destination controls (dotted lines), we calculate the taxonomic distances of warmed communities to either origin or destination controls, respectively. **C)** Over the experimental years, we expect that taxonomic distances between warmed and control communities change. If warmed communities follow the expected trajectory (red lines), the distance between warmed and origin control communities will increase (red solid line) and the distance between warmed and destination control communities will decrease (red dotted line). If the distance between warmed communities and origin controls reaches the maximum divergence determined by the distance between the controls, and if the distance to destination controls reduces to zero, indicating maximum convergence, then no lags remain in community shifts. However, warmed communities might deviate from this expected trajectory, increasing the taxonomic distances to both controls (pink lines), thereby maintaining lags in community shifts. Given that distances in warmed communities are constrained between zero and the shortest distance between controls for the expected trajectory, and between zero and one for the deviating trajectory, a logarithmic relationship is expected between experimental years and taxonomic distances. Note that the taxonomic

ijectory, and between zer 237 We extracted monthly mean daily air temperature (°C) and potential evapotranspiration (PET) 238 (mm) data from the ~1 km resolution CHELSA database [\(Karger et al. 2021\)](https://paperpile.com/c/pDL3XE/vH6MN) for each site. We 239 calculated the average summer (June, July, August) temperature and annual PET for each site 240 for each year of the experiment. We averaged the summer temperature and annual PET across 241 all years for each experiment to calculate the origin and destination climates. To estimate the 242 experimental climate warming experienced by warmed turfs, we calculated the average 243 difference between destination and origin sites' summer temperature over the experimental 244 years. Transplantation of turfs from high to low elevation simulated 0.5-11.1 °C (average of 3.0 245 °C) of experimental warming across all experiments, covering a range of climate change 246 scenarios generated by the IPCC for the next 50 years (IPCC 2022a). The experiments aimed 247 to simulate warming but other environmental changes, such as in PET, are also imposed by 248 downward transplantation (Fig. 2B). However, due to the high spatio-temporal variability of 249 precipitation, especially in mountainous regions, CHELSA model spatial projections convey 250 more uncertainty than temperature projections [\(Prein and Gobiet 2017\)](https://paperpile.com/c/pDL3XE/PJvG). This uncertainty may 251 prevent us from accurately calculating the differences in PET between closely located origin and 252 destination sites. Therefore, we only analyze the effect of PET at the destination sites rather 253 than the difference between sites.

255 *Plant relative abundances*

256 Vegetation surveys varied in timing, temporal resolution, and duration. Survey methodologies 257 were also diverse, including percent cover estimates of all species in the turfs, point-intercept 258 counts, or species-specific sorting of above-ground biomass. Some surveys did not record non-259 vascular plant categories, rock or bare soil. Thus, we removed inconsistent cover categories

260 from the dataset and converted vascular plant species cover or count data into relative plant 261 abundances to ensure comparability across experiments. The compiled data ranges from 1 to 9 262 years, for 60635 observations of 967 identified species and 92 taxa identified only at genus 263 level. We decomposed these species pools into strictly high-elevation, overlapping, or 264 colonizing low-elevation species based on their presence/absence in the control communities 265 for each experiment (Table S3, Fig. S3). By definition, strictly high-elevation species were only 266 found in the higher-elevation origin controls for each experiment, including high-elevation 267 species relative to the experiment. We note that these are not necessarily alpine plants in a 268 biogeographic sense (i.e., species found mainly above the treeline). The colonizing low-269 elevation species pool includes species that occur in destination controls but not in origin 270 controls. Overlapping species are found both in origin and destination controls. Species that 271 occur in warmed communities only but are absent from both sets of controls (i.e., on average, 272 5% across all experiments, Fig. S3, Fig. S9) were excluded from the analysis. We limited our 273 analysis to experiments with over two years of data, thus excluding US_Colorado and 274 IN Kashmir. We also excluded US Arizona due to its small high-elevation species pool of four 275 species. Additionally, we excluded species found only once in a single turf to eliminate potential 276 botanical identification errors. We square-root transformed species relative abundances in the 277 analyses described below.

We square-root transformed specie 280 We compiled five functional traits from the TRY database: vegetative height, leaf area (LA), 281 seed mass, specific leaf area (SLA), and leaf nitrogen percentage [\(Kattge et al. 2020\).](https://paperpile.com/c/pDL3XE/m3hvM) These 282 traits relate to plant size and resource use strategies that are relevant for plant responses to 283 environmental change and their ability to compete for light, water and nutrients [\(Violle et al.](https://paperpile.com/c/pDL3XE/8A8I8+1teIH) 284 [2007, Díaz et al. 2016\)](https://paperpile.com/c/pDL3XE/8A8I8+1teIH). We used a pre-processed version of the TRY dataset by [\(Walker et al.](https://paperpile.com/c/pDL3XE/Q1ecO) 285 [2023\)](https://paperpile.com/c/pDL3XE/Q1ecO), filtered for trait values with an error risk < 4 according to the TRY database criterion 286 (which measures the deviation from mean trait values within species, genus, family, or the entire 287 dataset in standard deviation) and gap-filled using Bayesian hierarchical probabilistic matrix 288 factorization imputation. This pre-processed dataset still had missing focal traits for certain 289 species (vegetative height: 22%, SLA: 15%, LA: 31%, N-percent: 23%, seed mass: 29%) that 290 we additionally gap-filled with miceRanger algorithm (Wilson in press). From these functional 291 traits, we built a principal component analysis (PCA) with all the species from the TransPlant 292 network (Fig. S2). Horn's parallel analysis retained two principal components (PC) to represent 293 the variation in the trait space. LA (33%), vegetative height (26%), seed mass (23%) contributed 294 primarily to PC1 followed by N-percent (9%) and SLA (8%). SLA (42%) and N-percent (38%) 295 contributed the most to PC2 followed by vegetative height (9%), seed mass (9%) and LA (1%). 296 Thus, we defined the first two PCs as denoting plant-size and resource acquisition-related traits, 297 respectively, representing the two main axes of the global plant functional trait spectrum [\(Díaz](https://paperpile.com/c/pDL3XE/1teIH) 298 [et al. 2016\)](https://paperpile.com/c/pDL3XE/1teIH). We calculated community-weighted means (CWMs) of PC1 and PC2 scores for 299 each control community, reflecting plant size and resource acquisition strategies, respectively.

301 *Quantifying plant community taxonomic divergence or convergence*

302 To quantify the plant community taxonomic change over time, we built principal response curves

303 (PRC) [\(Van den Brink and Braak 1999\).](https://paperpile.com/c/pDL3XE/1Bfv) PRC, developed from redundancy analysis (RDA), is

304 an ordination technique that quantifies the impact over time of several treatments on species

- 305 relative abundances in experimental communities, relative to a reference community. It
- 306 accounts specifically for the interaction between experimental years and treatment while
- 307 controlling for the overall temporal trend in community composition. PRC allows for extracting i)
- 308 taxonomic distances between the treatments and the reference over time as canonical
- 309 coefficients of the treatments and ii) species weights that quantify species' contributions to 310 overall community taxonomic changes [\(Vandvik et al. 2014\)](https://paperpile.com/c/pDL3XE/ERLFH).

312 We quantified the taxonomic distances of the warmed communities relative to the controls by

Canonical coefficients from PRC axis 2 (hereafter, 322 "PRC2") capture the second most important variation, and most important deviation from the 323 PRC1 [\(van den Brink et al. 2009\)](https://paperpile.com/c/pDL3XE/KPvO). In PRCs, taxonomic distances between the origin and 324 destination controls indicate the maximum expected divergence of warmed communities from
- 325 origin controls and their maximum expected convergence towards destination controls (Fig. 1B-
- 326 C). When canonical coefficients of the warmed communities exceed the canonical coefficients
- 327 of the control communities in a given PRC, this can be interpreted as the communities deviating 328 from the shortest trajectory between warmed communities and displaying a "deviating" response
- 329 (Fig. 1B-C). We expect to see these responses mainly in PRC2 with higher values in PRC2
- 330 indicating stronger deviating responses.

332 **Quantifying species' contributions to taxonomic divergence or convergence**

- 333 To assess the species' contributions to the community taxonomic shifts, we calculated
- 334 proportional relative abundance differences in warmed communities in comparison to the mean
- 335 relative abundance in control communities following the expression $b_k * c_t 1$ for each species
- 336 b k , with species weights b_k and canonical coefficient c_t of warmed communities at year t from
- 337 both PRCs per experiment. Here, species weights b_k (i.e., constant over the years) allow us to
- 338 obtain the fitted response curves for species k and quantifies the affinity of species k with the

- 342 taxonomic divergence and convergence provides several advantages to using raw relative
- 343 abundance differences: i) disentangling species contributions to the most important variation
- 344 (PRC1) from the second most important variation (PRC2, i.e., deviations from PRC1)
- 345 community change, while ii) taking into account the noise in the data.

347 *Statistical analyses*

348 To address our first question, we assessed the rate of composition change in warmed 349 communities along two primary axes: 1) divergence or convergence along PRC1, quantified by 350 canonical coefficients, and 2) deviation from these trajectories along PRC2. We developed 351 linear mixed effects models for each axis, considering both the warmed (red lines in Fig.1B-C) 352 and control communities (gray lines in Fig.1B-C) relative to a reference community. These 353 models used canonical coefficients as the response variable and included log-transformed 354 experimental year, distance type (to origin or destination control), experiment identity, and their 355 three-way interactions as fixed effects. A random effect for gradient was included to adjust for 356 non-independence across experiments due to regional variations like soil and habitat 357 differences. We log-transformed the experimental year to fit a logarithmic regression because 358 the distances between communities cannot surpass the maximum expected distance in the 359 case of the divergence, or zero in the case of convergence. This transformation improved model 360 fit, reducing AIC values by 121.39 and 153.20 for PRC1 and PRC2, respectively (df = 162). The 361 slopes from these models provide estimates of the rates of divergence from origin controls, 362 convergence towards destination controls, and deviations in composition across all experiments 363 over the years.

stination, we estimated i) the prop 365 To answer our second question, we estimated i) the proportional differences in relative 366 abundances in warmed communities calculated from both PRC axes per species pool (strictly 367 high-elevation, overlapping and colonizing) at the start (year = 1) and end (year = 9, projected 368 for the short experiments) of experiments, and ii) the rate of changes in these proportional 369 differences over time. We built linear mixed effects models for each axis and species pool with 370 species' proportional differences in relative abundances in warmed communities as the 371 response variable with experimental year (log-transformed), comparison type (to origin or 372 destination control), experiment identity, and their three-way interactions as fixed effects. We 373 included species nested in gradients as random effects. Here, we present the estimated 374 proportional differences in relative abundances in warmed communities per species pool at the 375 start and end of experiments, and the slopes (as rate of changes in relative abundances) from 376 these species pool-level models for all experiments combined. When compared to origin 377 controls, higher proportional relative abundance differences in warmed communities indicate 378 greater climate change effects on relative abundances of that experiment and/or species pool. 379 Also compared to origin controls, greater magnitudes of the slopes (absolute values) indicate 380 faster changes in relative abundances. More precisely, higher positive rates indicate faster 381 species gains, lower negative rates indicate faster losses. When compared to destination 382 controls, i) higher proportional relative abundance differences in warmed communities indicate 383 greater lags in relative abundances, while ii) larger magnitudes of the slopes (absolute values) 384 indicate faster realization of the experimental climate change response and thus, declines in 385 lags. More precisely, higher positive rates indicate faster decline in colonization lags (i.e., 386 realization of colonization events), lower negative rates indicate faster decline in extinction lags 387 (i.e., realization of extinction events). Overall, changes in a species pool reflect overall changes 388 in species' relative abundances in a given experimental community belonging to the species 389 pool in question.

391 To answer our third question, we first extracted the slopes (i.e., rate of changes in distances 392 between warmed and both control communities) and their standard errors for each experiment 393 from the first-mentioned (community-level) model. Second, we extracted the initial and final 394 proportional differences in relative abundances and slopes (i.e., rate of change in proportional 395 differences in relative abundances) and their standard errors for each experiment from the 396 second-mentioned (species pool-level) model. At community-level, we built two separate meta-397 regression models to accommodate each of the two distance types (to origin or destination 398 control) with slopes as response variable. At species pool-level, we built 18 separate meta-399 regression models to accommodate each of the two comparison types (to origin or destination 400 control) and three species pools with three response variables: i) slopes at species pool-level, 401 iii) initial and iii) final proportional differences in species-pool relative abundances. In these 402 models, experimental (turf size, experimental warming, duration), and climate factors (summer 403 temperature and annual PET of destination sites) and functional traits (CWM of plant size and 404 resource acquisition traits) were included as explanatory variables. Meta regression models 405 take into account the uncertainty in the response variables [\(Viechtbauer 2010\)](https://paperpile.com/c/pDL3XE/Nq96). All explanatory 406 variables were standardized (i.e., z-score normalization). 407

408 We conducted the statistical analysis with R version 4.4.0 [\(R Core Team 2024\)](https://paperpile.com/c/pDL3XE/1oP7) using the

To what extent does the species composition of warmed communities shift over time?

onverge 462 Warmed communities taxonomically diverged from the high-elevation origin control communities 463 (Fig. 3A red-solid lines; Table S5) and converged towards low-elevation destination control 464 communities across all experiments **(Fig. 3A, red-dotted lines).** As expected, the distance 465 between the two control communities remained constant on both PRC axes, indicating no 466 significant directional change in composition in the controls **(Fig. 3 A-B, gray lines).** In the first 467 year, warmed communities had already diverged on PRC1 by on average 14 %, and converged 468 by on average 13 %, of the maximum expected distance (i.e., the distance between the two 469 controls). If communities maintained this pace they would have reached zero taxonomic 470 distance with destination controls at around 7 years, however, rates of divergence and 471 convergence slowed down considerably over time. On average, (i.e., based on projections), 472 48% and 54 % of taxonomic distance on PRC1 still remained, after 9 years, for communities to 473 reach maximum divergence and convergence, respectively. 474

475 However, variation in rates of composition change was observed across the 40 experiments

476 (Fig. S5). First, warming led to divergence from origin controls only in 33 experiments.

477 Conversely, in 7 experiments, warmed communities diverged from origin controls in the first

478 year but they started to converge back towards origin controls over the years (Fig.3A, Fig. S5).

479 The rates of change in taxonomic distances between warmed and origin control communities

480 ranged from -0.053 to 0.215 (i.e., unitless change in taxonomic distance over the years scaled

481 between -1 and 1, Fig. S5). Second, warming led to convergence with destination controls only 482 in 36 experiments. Whereas in 4 experiments, warmed communities tended to diverge from the

483 destination controls. The rates of change in taxonomic distances between warmed and

484 destination controls ranged from -0.283 to 0.0584. In addition, taxonomic distances between 485 warmed and control communities generally **(Fig. 3B solid and dotted red lines)** exceeded the

486 distances between the controls **(Fig. 3B gray lines)** along PRC2. This indicates that warmed 487 communities deviated from the expected trajectory of convergence. These deviations

488 significantly increased over time **(Fig. 3B&D).**

521 The divergence of warmed communities from origin controls was similarly driven by both the 522 decrease in relative abundances of strictly high-elevation species and the increase in colonizing 523 species. (Fig. 4A-B). However, both colonization and extinction lags remained after the 9-year 524 experimental period: On average, strictly high-elevation species remained more abundant and 525 colonizing species less abundant in warmed communities compared to destination controls (Fig.

526 4A-B). Besides having equal contributions to the overall shifts in warmed communities, rates of

527 species gains and losses over the years were similar, thus contributing equally to the rates of

- 528 divergence from the origin controls and convergence towards destination controls (Fig. 4C).
- 529 However, beyond these general trends, there was substantial variation across experiments (Fig.
- 530 5A, thin lines, Fig. S5). In fact, the relative abundances of overlapping species across 531 experiments showed both increasing and decreasing trends, which canceled each other out,
- 532 resulting in no clear general trend.
- 533

534 Taxonomic shifts away from the shortest trajectory between origin and destination controls in 535 warmed communities were mainly driven by the colonizing species (Fig. S4). Interestingly, when 536 predicted by PRC2, relative abundances of the colonizing species were increasingly higher in 537 warmed communities in comparison to destination controls, indicating that some colonizing 538 species were increasing their abundances more than expected (i.e., given their relative 539 abundances in destination controls), contributing to the community-level deviating responses 540 (Fig. S4).

541

542 **What influences the variation in overall rates of community change across experiments, as** 543 **well as the contribution of different pools to divergence or convergence?**

- 544 Communities exposed to stronger warming, over longer periods, in smaller plots and 545 transplanted to drier conditions diverged faster from origin controls (i.e., increasing taxonomic 546 distances between warmed and origin control communities over time) (Fig. S6; Table S7). Also, 547 communities exposed to stronger warming over longer periods converged faster towards 548 destination controls (i.e., decreasing taxonomic distances between warmed and destination 549 control communities over time) (Fig. S6; Table S7).

ilitions diverged faster from ori 551 Species pools' relative abundance differences in warmed communities compared to controls 552 varied between the beginning and end of experiments (Fig. 5; Table S8). At the beginning of the 553 experiments, species losses (i.e., decreases in the relative abundances of the strictly high-554 elevation species) in warmed communities were higher in experiments with smaller plots and 555 when destination communities were dominated by smaller-sized plants. Similarly, extinction lags 556 were greater in smaller plots, under stronger warming, in shorter experiments, when 557 transplanted to cooler destinations where destination communities were dominated with taller-558 sized plants. Parallely, species gains (i.e., increases in the relative abundances of the colonizing 559 species) in warmed communities were higher in smaller plots. Finally, overlapping species had 560 higher relative abundances in warmed communities in comparison to destination controls when 561 transplanted to a wetter destination (among other destination sites) and when they originated

- 562 from smaller-sized and more resource-acquisitive communities.
- 563

564 At the end of the experiments, species losses and gains were higher (Fig. 5) and faster (Fig. S7; 565 Table S8) in smaller plots and under stronger warming. Whereas, extinction lags were higher in 566 shorter experiments and when communities were transplanted to wetter conditions. Meanwhile, 567 colonization lags were higher when the origin communities were dominated by more resource-568 acquisitive strategies. Finally, overlapping species had higher relative abundances in warmed 569 communities than in origin controls when they originated from more conservative and taller-

570 sized communities.

Discussion

High-elevation plant community trajectories under climate warming

591 Ecologists are trying to understand the reconfigurations of plant communities due to abundance

- 592 and distribution shifts triggered by climate change. A "null hypothesis" is that when dispersal
- 593 limitations of warm-adapted species are overcome, the future composition of cool-adapted plant
- 594 communities converge on the composition of warm-adapted communities of today. Alternatively,

595 altered ecological interactions within warming communities might cause them to exhibit lagged 596 responses or even follow alternative trajectories leading to novel community compositions. A 597 network of transplant experiments provided us with the unique opportunity to examine the initial 598 years of these trajectories under climate warming. As expected, the taxonomic composition of 599 warmed communities shifted, converging towards their lower-elevation communities. 600 Nonetheless, communities under warming did not fully converge on the low-elevation 601 community composition, even up to nine years after transplantation. In addition, we found that 602 warmed communities deviated significantly from the shortest trajectory of community shift 603 between high- and low-elevation sites and rates of taxonomic convergence slowed over time. 604 Together, these results suggest that even if high-elevation communities do eventually converge 605 on today's low-elevation community composition, this will be a slow process characterized by 606 significant colonization and extinction lags and transient dynamics leading to a prolonged period 607 of novel community structures [\(Hastings et al. 2018\).](https://paperpile.com/c/pDL3XE/xIJ2f) Such transient dynamics could be due to 608 demographic lags (Alexander et al. 2018), feedbacks in plant-plant interactions [\(Alexander et al.](https://paperpile.com/c/pDL3XE/dHgu+v4Do+y0Ay) 609 [2015, Vandvik et al. 2020,](https://paperpile.com/c/pDL3XE/dHgu+v4Do+y0Ay) Bektaş et al. 2023), plant-soil nutrient pools [\(Khedim et al. 2022\)](https://paperpile.com/c/pDL3XE/nFkZ8), or 610 plant-microbial interactions (Zhang et al. 2014).

s (Zhang et al. 612 Taxonomic changes were already large in the first year after transplantation. This might be an 613 effect of the transplantation method, whereby the communities are exposed to an abrupt 614 environmental change. Indeed, community responses to gradual warming might differ from 615 those of abrupt climate manipulations, partly because individual species differ in their 616 demographic responses to fast vs. slow warming altering the network of plant-plant interactions 617 [\(Block et al. 2022\).](https://paperpile.com/c/pDL3XE/3UCEZ) Nonetheless, the rapid responses to more intense warming and drying 618 emphasize the crucial role of extreme events in driving community changes, triggering the loss 619 of less resilient high-elevation species and facilitating swift colonizations by warm-adapted taxa. 620 Even as taxonomic shifts appear to slow down over time, and warmed high-elevation 621 communities stabilize, their vulnerability to extreme climatic events could further accelerate the 622 rate of taxonomic changes, inducing a second wave of abrupt shifts. In fact, in transplant 623 experiments in Switzerland and Austria, colonization of the low-elevation species started only 624 three years after the transplantation, specifically after the drought in 2018, which led to 625 significant species losses in transplanted high-elevation communities [\(Schuchardt et al. 2023b\).](https://paperpile.com/c/pDL3XE/e1JC) 626 With intense heatwaves and droughts becoming more common in mountainous areas [\(IPCC](https://paperpile.com/c/pDL3XE/Nyo7T) 627 [2022b\)](https://paperpile.com/c/pDL3XE/Nyo7T), high-elevation communities may undergo multiple swift taxonomic changes, as 628 evidenced by landscape-scale alterations following recent extreme events in the European Alps 629 [\(Choler 2023\)](https://paperpile.com/c/pDL3XE/9Alr).

631 **Contributions of different species pools to changes in community composition**

- 632 Changes in community composition under warming were influenced both by colonizing species
- 633 from the destination site, and decrease in relative abundancesabundance shifts, including local
- 634 extinctions, of strictly high-elevation species. On average, species gains from colonizing pools
- 635 and losses from strictly high-elevation species pools, along with the rates of these changes,

onsistent with estimates of substantial ex pools contributed similarly to community changes. The large contributions of the strictly high- elevation species pool to the divergence of warmed communities from the high-elevation communities indicate that even after the first year of transplantation, decreasing relative abundances and local extinction events of cold-adapted species under warming were important. 641 Interestingly, a minority of experiments ($n = 5$) displayed increasing relative abundance of this species pool over the years, which might be explained by a few species initially tolerating (or even benefiting from) climate change and/or altered plant-plant interactions under warming [\(Nomoto and Alexander 2021\)](https://paperpile.com/c/pDL3XE/5fsk). Fewer losses from this species pool were detected in studies with shorter experimental durations. In longer-term experiments, despite overall losses, the strictly high-elevation species maintained enough abundance to significantly differentiate the warmed community from the destination controls even after nearly a decade. . In other words, many of these species appear able to persist for considerable periods of time under significant future warming. This is consistent with estimates of substantial extinction lags in alpine plant communities, especially when species continue to coexist with their original plant community via competition [\(Rumpf et al. 2019\)](https://paperpile.com/c/pDL3XE/EaeK).

 Colonizing species also made large contributions to the difference in community composition between warmed and high-elevation communities over time, even though with substantial delays. This clearly demonstrates that under climate change, low-elevation species can colonize high-elevation plant communities if dispersal limitations are removed. This gives a first indication that the lags in range shifts observed in mountain floras [\(Rumpf et al. 2018, 2019\)](https://paperpile.com/c/pDL3XE/MHqA+EaeK) are at least partly explained by dispersal limitation, and that novel plant establishment should be expected once these limitations are overcome. Moreover, increasing colonizations in smaller plots, which have more exposure to the surrounding colonizing community at the edges due to a larger edge 661 length ratio (e.g., 16 and 4 for 0.0625 and 1 m^2 plots, respectively), contradicts the expectation of colonist establishment from seeds, where larger plots should accommodate a higher probability of dispersal events. This implies that clonal growth may be a key factor facilitating the local expansion of low-elevation species once dispersal lags are overcome [\(Guittar et al. 2016,](https://paperpile.com/c/pDL3XE/Kgz1+dY2F) [Töpper et al. 2018\).](https://paperpile.com/c/pDL3XE/Kgz1+dY2F) However, persisting colonization lags in our experiments even after almost

This does not imply that species in this pool were unaffected by warming. Instead, it suggests a spectrum of positive and negative responses across and within experiments: the overlapping species pool in each experiment contained a mixture of "winner" and "loser" species. Given that overlapping species demonstrate a larger niche in tolerating a broader range of environmental and biotic conditions at across elevations, their abundance change in the beginning of experiments may be stochastic. However, if originating from more resource- conservative communities, relative abundances of overlapping species increased more. Moreover, when in drier conditions than all other destinations, their relative abundances were lower than in destination controls. This indicates that responses to drought play a major role in mountain plant population dynamics and drought-tolerant species can be the winners of climate

change in the mountains (Visakorpi et al. 2022).

Variation in responses across and within experiments due to biotic interactions?

 The large variation in magnitude and direction of species relative abundance changes, even within the same pool is typical for species-level responses to climate change [\(Rumpf et al. 2018,](https://paperpile.com/c/pDL3XE/MHqA+dY2F) [Töpper et al. 2018\).](https://paperpile.com/c/pDL3XE/MHqA+dY2F) Only partly related to experimental design choices (e.g, plot size, duration, and climate context), much of the variation in species responses could be explained by 689 destination or origin communities' functional traits. Moreover, we expected that warmed communities suffering competitive exclusion due to taller surrounding destination communities (Fig. S8). Yet, in destination sites dominated by taller-sized plants, species losses were lower and extinction lags were higher. This might suggest that biotic interactions between destination communities and strictly high-elevation species influence the population dynamics of the latter, possibly through tall and wide-leaved destination-species creating shade and thus, cooler microhabitats for intensely warmed high-elevation species. Finally, effects of functional traits were not consistent across the experimental period and they do not determine the rates of changes in communities and species contributions. This could indicate, on the one hand, initial stochastic losses and gains, on the other hand, plant-plant interactions needing time to adjust, being transient and leading to inconsistencies through feedback between them.

Conclusions & Perspectives

Our study underscores the dynamic shifts in high-elevation plant communities due to

experimental climate warming, suggesting the formation and persistence of novel communities

that complicate future predictions. While community taxonomic convergence towards lower

elevations hints at a predictable trajectory under climate change, significant uncertainties due to

- local factors like climate and initial community composition highlight the need for localized
- studies. Future research should focus on the variability in temporal and spatial dynamics,
- investigate the causes of shifts in populations and communities, including the changes in biotic
- interactions. We encourage expanded collaborative macroecological experiments across
- diverse ecosystems to better understand plant community responses to climate change.

As these PRC comparison are key for the majority of the results in the manuscript I think the specific comparisons need to be laid out as two separate sentences (Ie., The first PCR compares X and Y. The second PCR compares X and Z). Or at least resolve the sentence to modify ' and the other control as treatments'. It is especially difficult to follow which comparisons are being made in this part of the sentence.

We clarified at L286-291 as follows: "We quantified the taxonomic distances of the warmed communities relative to the controls by constructing two PRCs for each experiment. The first PRC used the origin control as the reference community, with the warmed and destination control as treatments to quantify their taxonomic distance from the origin control. The second PRC used the destination control as the reference, with the warmed and origin control as treatments to quantify their taxonomic distance from the destination control (Table S4)."

L337 It may be useful to remind readers what the three species pools are, perhaps in parenthetical.

L346-353 In the explanation of how to interpret this analysis the focus is largely on relative abundance changes and the lags in those changes of relative abundance. However in the results (e.x., Fig. 4 caption L478 - 481) the rates (and lags) of extinction and colonization is also discussed. To me, the difference in interpretation is dependent on which species pools is being focused on. I think this point about how interpretation changes for the different species pool results needs to be made clear in the section on how to interpret this specific analysis. To clarify we added "More precisely, higher positive rates indicate faster species gains, lower negative rates indicate faster losses." at L353 and "More precisely, higher positive rates indicate faster decline in colonization lags (i.e., realization of colonization events), lower negative rates indicate faster decline in extinction lags (i.e., realization of extinction events)." at L358.
