Finally, their interest regarding questions of playability is 25 discussed. 26

## 29 1 Introduction

 Musical instruments are complex dynamical systems. 31 Some of them are self-sustained oscillators, meaning that 32 a continuous energy supply can make them oscillate. Wind a continuous energy supply can make them oscillate. Wind instruments and bowed string instruments belong to this category. These instruments admit a wide variety of regimes, which sometimes coexist for certain values of control parameters. This is known as multistability. Multistability is a common phenomenon in self-sustained oscillators. It has been observed experimentally, theoreti- cally and numerically on a wide variety of instruments, e.g., single and double reed instruments [1–3], flutes [4], brass instruments [5], vocal folds [6] and bowed string instruments [7]. There are multiple works focusing on map- ping the operating regimes of these instruments [8]. We find in [9, 10] among the first curves representing the evolution of the amplitude of a solution as a function of a control parameter. The stability of these solutions is also studied few years later [11]. A seminal work of Dalmont et al. [12] represents bifurcation diagrams of self-sustained musical instruments. These diagrams show the evolution of known 49<br>solution properties as a function of one or more control 50 solution properties as a function of one or more control parameters. The stability of these solutions is given, as well 51<br>as some key features, such as amplitude and fundamental 52 as some key features, such as amplitude and fundamental frequency for periodic solutions. Thanks to these diagrams, 53 one can predict the behavior of an instrument whose control 54 parameters vary in a quasi-static manner  $-$  i.e., slowly in  $55$ relation to the system's rate of evolution. In the case of 56 multistability, bifurcation diagrams predict hysteretic 57 behaviors, such as those of reed and brass instruments 58 [13] or flute-like instruments [14]. Some unexpected regimes 59 are also predicted with this method, such as the ghost note 60 in brass instruments  $[15]$  or the wolf tone of the cello  $[16]$ . 61 Nevertheless, it is much more difficult to predict the regime 62 of a multistable instrument when the control parameters 63 vary rapidly. In particular, the blowing pressure dynamics 64 are shown to have an influence over the regime selection 65 in flute-like instruments [17]. Similar results are shown in  $66$  [18] for the saxophone.  $67$  $[18]$  for the saxophone.

Similarly, once the control parameters are fixed, the 68 time required to reach the steady state depends on the 69<br>previous evolution of the control parameters. The<br>5 duration of the transients that gives rise to a sound is thus 5 duration of the transients that gives rise to a sound is thus<br>6 studied on multiple self-sustained instruments, from the 6 studied on multiple self-sustained instruments, from the trombone  $[24]$  to the cristal Baschet  $[25]$ , using linear stabiltrombone  $[24]$  to the cristal Baschet  $[25]$ , using linear stabil- ity analysis. Like the prediction of the playing regime, the duration of the transient is estimated for control parameters varying in a quasi-static manner. Linear stability analysis cannot predict dynamic phenomena such as those observed by [19, 20]. Finally, despite their high efficiency in the quasi- static regime, current methods for analyzing self-oscillating instruments are limited when considering rapidly varying control parameters. By taking these rapid variations into account, the dimensionality of the problem becomes infinite since the parameters can follow any time series. Conse- quently, it motivates researchers to limit their studies to specific transient scenarios. For example, several authors consider pressure ramps of variable slope and study the influence of the pressure rise rate on the selected regime [26, 27] or the transient duration [20]. In this article, we study rapid variations in control parameters through stochastic initial conditions, in cases of multistability 25 between an equilibrium and a periodic regime. We are<br>26 interested in situations where the musician moves quickly 26 interested in situations where the musician moves quickly<br>27 from one quasi-static configuration to another, as is the case 27 from one quasi-static configuration to another, as is the case<br>28 during an attack  $[21, 28]$  a break or a change of note during an attack  $[21, 28]$ , a break or a change of note [22, 29, 30]. Quasi-statistical analysis is not valid during this transition and the new quasi-static configuration is studied under unknown initial conditions. With this in mind, we study the statistical influence of initial conditions on the selected regime and on the duration of the transient. The probability of obtaining each regime is estimated with an already existing method called basin stability [31], and an 36 original approach is proposed to determine the probability<br>37 of obtaining each transient duration. Finally, the distribu- of obtaining each transient duration. Finally, the distribu- tions of initial conditions considered for these statistical methods are discussed. In particular, initial conditions generated by specific transient control scenarios are studied.

 The remainder of the document is organized as follows. The system chosen to introduce the methods is given in Section 2. Section 3.1 focuses on the basin stability metric and its use for musical instruments. The transient duration is investigated in Section 3.2 and the influence of the distribution of initial conditions is explored in Section 4. To highlight the interest of the methods on more sophisti- cated and high dimensional systems, an application to a physical model of trumpet is presented in Section 5. Differ- ent methods and results are discussed in Section 6. Perspec-tives and conclusions are drawn in Section 7.

#### 52 2 Minimal multistable system

 Most physical models of self-sustained musical instru- ments have no exact analytical solutions for transient or steady-state regimes. Therefore, numerical methods are often used to study them, such as finite differences [32] or harmonic balance method [33]. A number of authors have 57 proposed less detailed models with exact analytical solu- 58 tions and only few state variables. These simplified models help to investigate the mechanisms behind self-oscillations 60 [34]. In order to compare our statistical approach with exact 61 analytical results, we have chosen to illustrate our methods 62 on such a system. In this article, we focus on a Van der Pol 63 oscillator with fifth-order nonlinearity, as described in [35]. 64 This oscillator is characterized by a region of multistability, 65 where both an equilibrium and a periodic solution are 66 stable. This feature can also be observed on several musical 67 instruments, such as saxophones [27] or brass instruments 68 [5]. Its phase space is of dimension two and can therefore 69 be displayed simply, enabling more detailed dynamic 70 analysis. A technical publication [36] presents the musical 71 interest of this system and provides a demonstrator solving 72 interest of this system and provides a demonstrator solving 72 it in real time (<https://zenodo.org/records/8413627>). Note 73 that even though the global behavior of musical instru- 74 ments is varied and rich, the system studied here can be 75 obtained by change of variables and polynomial expansions 76 from any system presenting this type of multistable behav- 77 ior. It is only used to illustrate the interest of a statistical 78 approach to predict the behavior of a multistable system 79 under transient excitations. 80

The motion of the considered oscillator is given by the 81 following equation: 82

We impose  $\sigma = -1.5$  and  $v = 0.1$  in order to obtain a 87 multistable saxophone-like or brass-like behavior. The 88 parameter  $\mu$  is the control parameter of this simple "musical 89 instrument" and its effect is analogous to the blowing pres-<br>sure for wind instruments [36]. A harmonic balance method 91 sure for wind instruments  $[36]$ . A harmonic balance method with only one harmonic gives the amplitude X of solutions 92<br>of the form:  $x = X \cos(t + \varphi)$ . with  $\mu_{\rm H} = 0$  and  $\mu_{\rm SN} = -\frac{\sigma^2}{4v}$ . These solutions consist of 102 an equilibrium  $(X_{\text{Eq}})$  and two  $2\pi$ -periodic solutions 103<br> $(X_{\text{Eq}})$  and  $X_{\text{Eq}}$ ) which are represented on a bifurcation 104  $(X_{2\pi+}$  and  $X_{2\pi-}$ ), which are represented on a bifurcation 104<br>diagram in Figure 1. This oscillator shows an inverse Hopf 105 diagram in Figure 1. This oscillator shows an inverse Hopf 105 bifurcation at  $\mu = \mu_H$  and a saddle-node bifurcation at 106  $\mu = \mu_{SN}$ . Between these two bifurcations, the system is 107  $\mu = \mu_{SN}$ . Between these two bifurcations, the system is 107 multistable: both the equilibrium  $X_{Eq}$  and the largest perimultistable: both the equilibrium  $X_{\text{Eq}}$  and the largest peri-<br>odic solution  $X_{2\pi+}$  are stable. Saxophones [27] and brass 109 odic solution  $X_{2n+}$  are stable. Saxophones [27] and brass 109 instruments [5] are likely to present this bifurcation 110  $in$ struments  $[5]$  are likely to present this bifurcation sequence and therefore this multistability behavior. 111

A traditional bifurcation diagram only depicts the 112 steady state solutions. The influence of initial conditions 113 on the transient and the steady-state behavior is concealed. 114

 This influence can be seen on a phase plane for a given value of the control parameters. In Figure 2, we show the phase 3 plane of the fifth order Van der Pol oscillator for  $\mu = -3$ , which is a situation of multistability. For the remainder 5 of the paper, we use this value each time we need to choose<br>6 a specific  $\mu$  for illustration. The equation of motion equation a specific  $\mu$  for illustration. The equation of motion equation (1) is numerically integrated with the function ode45 of Matlab [37], for three initial states very close to one another. In that case, the slight change in initial conditions leads the system either to the equilibrium (in blue) or to the stable limit cycle (in red). The two oscillating trajectories have different transient durations: one is almost instanta-neous while the other lasts approximately one period.



Figure 3. Basins of attraction of the fifth order Van der Pol oscillator ( $\mu = -3$ ). Initial conditions taken in the red shaded area give rise to the periodic solution whereas initial conditions taken in the blue shaded area give rise to the equilibrium solution.

In short, Figures 1 and 2 illustrate that the steady state 14 and the transient duration of this minimal self-sustained 15 musical instrument are sensitive to the initial conditions 16 and to the control parameter value around a bifurcation. 17 This sensitivity is merely a mark of non linearity and is 18 shared by most non linear dynamical systems. In the 19 Sections 3.1 and 3.2, we present two statistical approaches 20 to predict the selected regime and the transient duration for 21 such a system. 22

## 3 Methods 23

#### 3.1 Basin stability 24

Some self-sustained musical instruments are multi- 25 stable. In such a case, once their control parameters are 26 settled, their steady state depends exclusively on their 27 initial state. The subset of initial conditions leading to a 28 specific attractor is called its basin of attraction [38, 39]. 29 In Figure 3, we depict the basins of attraction of the fifth 30 order Van der Pol oscillator, for  $\mu = -3$ . The basin of the 31 equilibrium is shaded in blue and the basin of the periodic 32 solution is shaded in red. In that case, the two basins are 33 separated by the unstable limit cycle of amplitude  $X_{2n-}$ , , 34 plotted in broken line and given in equations (1) and (3). 35 In the general case, however, the geometry of a basin of 36 attraction can be more complex and its boundaries difficult 37 to find. We discuss this problem in Section 6. Moreover, in 38 the scope of this article, we consider that the initial condi-<br>tions resulting from a quick change in the control parame-<br>40 tions resulting from a quick change in the control parameters are unknown. They are randomly taken within a 41 subset of the initial state space. 48 In practice,  $S_B$  is unknown so it is replaced by its estimation  $S_B$  in equation (7). This error only accounts for sub-sam-<br>50 pling. It is interesting to notice that the error does not pling. It is interesting to notice that the error does not depend on the dimension of the state space. As a result, the basin stability is a metric suitable for low dimension problems as well as for high dimension ones. In general, for more complex systems, the basin boundaries are 55 unknown and the classification method would consist in 56 time integrating the system and observing toward which 56 time integrating the system and observing toward which<br>57 attractor it would converge. Such strategy is illustrated in attractor it would converge. Such strategy is illustrated in Figure 4. However, for this minimal multistable system, the basin boundary is analytically known: the boundary is 60 the unstable periodic solution whose  $\mathcal{L}_2$ -norm  $X_{2\pi-}$  is given

in equation  $(3)$ . As a result, it is much faster to classify the 61 samples with this analytical expression rather than with 62 time integrations. 63

Figure 5 gives the basin stability of the Van der Pol 64 oscillator. To compute it, we arbitrarily choose a subset of 65 the phase space  $Q$  which includes all the attractors and 66 which is independent of  $\mu$ . For  $\mu \in [-7, 1]$  as in Figure 1, 67 the subset  $Q = ([-4, 4] \times [-4, 4])$  meets these condi- 68 tions. To uniformly sample  $Q$ , we use a Latin Hypercube 69 Sampling of 100 samples. The basin stability of the equilib- 70 rium is plotted in blue and the one corresponding to the 71 periodic solution in red. The error bars correspond to the 72

This validates the error esti-11 mation of the sample-based method given in equation (7). 12 Outside the multistability area, the only stable solution 13 has a basin stability equal to 1 whereas the other one has 14 a basin stability equal to 0. Regarding this metric, non 15 existing solutions and unstable solutions are identical and 16 have a zero basin stability. Inside the multistability area, 17 both solutions have a non zero basin stability. The stability 18 of the periodic solution increases with  $\mu$  whereas the stabil-19 ity of the equilibrium decreases. One can observe that  $S_B$  is<br>20 continuous at the Hoof bifurcation but discontinuous at the 20 continuous at the Hopf bifurcation but discontinuous at the 21 saddle-node bifurcation. Indeed, in the first case, the basin 22 of attraction of the equilibrium shrinks progressively until it 23 becomes a dot in the phase space for  $\mu = \mu_H$ . In the second 24 case, the periodic solution suddenly disappears at  $\mu_{\text{SM}}$ , even 24 case, the periodic solution suddenly disappears at  $\mu_{SN}$ , even<br>25 though its basin of attraction had previously occupied a 25 though its basin of attraction had previously occupied a 26 large part of  $Q$ . The value of  $S_B$  corresponds to the proba-<br>27 bility to obtain the related solution, given a random initial 27 bility to obtain the related solution, given a random initial 28 state inside Q. If a musician were to impose uniformly ran-29 dom initial conditions in  $Q = ([-4, 4] \times [-4, 4])$ , Figure 5 30 indicates that he/she would have at least a 60% chance of 31 reaching the periodic regime in the steady state. However, 32 the assumption of a musician peeking a random initial 33 condition uniformly seems oversimplified. This topic is discussed in Sections 4 and 6. discussed in Sections 4 and 6.

35 Overall, the basin stability indicates which values of the 36 parameters (here, the only parameter is  $\mu$ ) fosters one solu-37 tion or another. It gives the probability to produce a specific<br>38 regime, considering a subset  $Q$  of the phase space and a regime, considering a subset  $Q$  of the phase space and a 39 probability density function  $\rho$  of  $\mathcal{Q}$ . The result depends 40 greatly on the choice of  $\mathcal{Q}$  and  $\rho$ . The standard error of this 40 greatly on the choice of  $Q$  and  $\rho$ . The standard error of this 41 metric depends on the number of samples and on the relametric depends on the number of samples and on the rela-42 tive size of the studied basin of attraction. It does not 43 depend on the phase space dimension however and thus is 44 very well adapted to high but finite dimensional systems.

#### 45 3.2 Transient duration

 In music, transient phenomena play a crucial role in sound and instrument discrimination [42–44]. Musicians may also have expectations concerning the characteristics of these transients, and in particular concerning their duration. For example, Guettler and Askenfelt [23] high-51 light the importance of the type and duration of violin<br>52 attacks on their quality as perceived by professional string attacks on their quality as perceived by professional string players. Several authors [21, 22, 25, 45] assume that musi-54 cians and instrument makers look for short transitions,<br>55 whether for the onset or for sequences of linked notes. whether for the onset or for sequences of linked notes. In this paper, we thus consider the reaction time of an

instrument – i.e., its tendency to produce short transients –  $57$ as a playability criterion. In self-sustained instruments, the 58 transient depends on the parameters of the system but also 59 on the initial conditions, as can be seen on Figure 6. In this  $60$ figure, the evolution of the fifth order Van der Pol oscillator 61 has been computed for a large number of random initial 62 states, all other things being equal. In Figure 6a, the trajec- 63 tories are represented in the phase plane whereas in 64 Figure 6b, the same trajectories are represented with respect 65 to time. The transient part of a trajectory is defined between 66 its initial state and the moment it reaches the neighborhood 67 of an attractor. The transient duration is denoted  $\tau$  here-<br>after. The neighborhoods of the two attractors are shaded 69 after. The neighborhoods of the two attractors are shaded in grey and are defined at a distance  $\varepsilon$  in  $\mathcal{L}_2$ -norm from 70<br>the attractor. Although the size of these neighborhoods 71 the attractor. Although the size of these neighborhoods has an impact on the transient duration results, for now 72 it is arbitrarily set to  $\varepsilon = 0.1$ . Figure 6b highlights the 73<br>diversity of transient durations that can be obtained only 74 diversity of transient durations that can be obtained only

These tendencies stand out when the distributions of the transient durations are represented graphically. Infor- mation on a distribution can be displayed as in Figure 7. The upper panel gives the cumulative distribution function, i.e., the proportion of trajectories with a transient duration 10 shorter than the value  $\tau_i$  represented in abscissa. The two 11 lower panels depict the corresponding violin plots [46, 47]. lower panels depict the corresponding violin plots  $[46, 47]$ , where the box plots give the extreme values (tips of the whiskers), the median and the two quartiles, and the shaded curves represent the probability density function of the distributions. To compute the latter, we used the kernel density estimator of Matlab (ksdensity). This statis- tic information is calculated for each attractor separately. As in Section 3.1, we use a Latin Hypercube Sampling to uniformly explore the space of initial states. With this sampling, we do not control the exact number of samples in each basin of attraction, but it can be estimated with 22 the basin stability  $S_B$  previously computed. As a result,<br>23 for lowest values of  $S_B$ , the statistical transient analysis 23 for lowest values of  $S_B$ , the statistical transient analysis 24 relies on only few samples and may not be very representarelies on only few samples and may not be very representa- tive. It should be remembered that such misrepresentations occur only on highly improbable regimes. If a specific

case calls for in-depth study of these regimes, the region 27 of interest  $Q$  can be adapted, leaving the method otherwise 28 unchanged. The cumulative distribution function lends 29 itself well to interpretation in musical context, where one 30 could define a longest acceptable transient duration. The 31 probability of the transient being shorter than this upper 32 limit can be read directly on the cumulative distribution 33 function, under the hypothesis of random initial conditions 34 following a uniform law.  $35$ 

We use the violin plot representation in Figure 8 to 36 depict the evolution of the transient duration distribution 37 with respect to the control parameter  $\mu$ . Plotting the 38 probability density function over the boxplot is particularly 39 interesting when there are multiple maxima in the distribu- 40 tion since multiple maxima are not visible on a box plot. 41 For instance, some examples of bi-modal distributions can 42 be observed around the saddle-node bifurcation (for 43  $\mu \approx \mu_{\rm SN}$ . 44

Figure 8 shows that most transients leading to the 45 periodic solution are very short compared with its period 46  $(T = 2\pi)$ . Indeed, the violin plots are centered around 47<br>low values of  $\tau$  (a magnified view for  $u = -3$  is visible in 48 low values of  $\tau$  (a magnified view for  $\mu = -3$  is visible in 48 Fig. 9). However, the maximum transient durations are 49 markedly larger than the median duration, up to 800 times 50 longer for  $\mu = -0.26$ . This indicates that, for most values of 51  $\mu$ , a few initial conditions have extremely long transients. 52

1 In fact, these particular initial states are very close to the 2 unstable limit cycle. In that case, the trajectory follows 3 the unstable limit cycle for some time while slowly diverging<br>4 from it, which lengthens the transient duration. These rare 4 from it, which lengthens the transient duration. These rare<br>5 and very long durations have particularly large values in 5 and very long durations have particularly large values in 6 the vicinity of the Hopf bifurcation. For the equilibrium, 7 transient durations are longer and distributed more uni-8 formly for all the values of  $\mu$ . Outside the vicinity of the two bifurcations, the transient durations leading to both two bifurcations, the transient durations leading to both 10 solutions statistically decrease as  $\mu$  increases. This is coher-11 ent with the fact that  $-\mu$  is the linear part of the damping. 12 As  $\mu$  increases, the system becomes less and less damped 13 until  $\mu$  eventually becomes positive and energy is added until  $\mu$  eventually becomes positive and energy is added 14 to the system. Near the saddle-node bifurcation, this trend 15 does not apply. The equilibrium becomes the only stable 16 solution but its transient duration globally increases around 17  $\mu_{SN}$ . This is a usual phenomenon around a saddle-node<br>18 bifurcation. It is interpreted by Strogatz in [38] as the bifurcation. It is interpreted by Strogatz in [38] as the 19 remaining *ghost* of a nearby attractor that does not exist<br>20 anymore. Around the Hopf bifurcation, the periodic soluanymore. Around the Hopf bifurcation, the periodic solu-21 tion becomes the only stable solution but its maximum 22 transient duration significantly increases. However, apart 23 from these very few long transients, Figure 8b shows that 24 the overall trend does not change significantly for the peri-25 odic solution around the Hopf bifurcation. Considering ini-26 tial conditions chosen from a uniform distribution, these 27 long transients are highly improbable.

## <sup>28</sup> 4 Influence of the distribution of initial 29 conditions

 In order to provide a more meaningful analysis in a con- text of musical performance, we consider another distribu- tion for the initial conditions, informed by temporal evolutions of the control parameter. More precisely, we now consider initial conditions resulting from a transient

variation of the control parameter  $\mu$ , just before it reaches 35 a constant target value. Our goal is therefore to consider 36 what we call hereafter a "transient-informed" distribution 37 what we call hereafter a "transient-informed" distribution and to analyze how it affects the basin stability results. 38 To obtain a transient-informed distribution, we compute 39 the time evolution of the system under several transient 40 variations of  $\mu$ . These transient-informed distributions 41 could also be used to compute the transient duration statis- 42 tics, but we only focus on the basin stability here, since the 43 results are more remarkable. 44

## 4.1 Control scenarios 45

Systems such as the fifth order Van der Pol oscillator 46 presenting an inverse Hopf bifurcation followed by a 47 saddle-node bifurcation produce a sound of non-zero ampli- 48 tude when the control parameter exceeds the Hopf bifurca- 49 tion (this is the case for the trumpet and the saxophone for 50<br>certain sets of parameters). Nevertheless, it is possible to 51 certain sets of parameters). Nevertheless, it is possible to reduce the sound amplitude afterward by decreasing the 52 control parameter under the Hopf bifurcation value, into 53<br>the multistability region. To produce a low-volume sound 54 the multistability region. To produce a low-volume sound at the onset, one can attempt to realize this gesture quickly 55 by reducing the control parameter, and move the system 56 into the multistable region before the limit cycle is attained. 57 However, this strategy may fail if the system remains too 58 close to the equilibrium during the transient. It would 59 become trapped in the equilibrium's basin of attraction 60 when the parameter stops varying, which would result in 61 no stable sound being produced. We consider piecewise 62 linear control scenarios, as depicted in Figure 9. These 63 scenarios are defined by four parameters: their initial 64 value  $\mu_0$ , their maximal value  $\mu_{\text{max}}$  that corresponds to 65 what can be called the overshoot value, their final value  $\mu_{end}$  66 at which the basin stability is computed and their duration 67 at which the basin stability is computed and their duration  $\tau_{\text{att}}$  that corresponds to the "attack duration". For simplic-<br>ity, we choose the same slope (in absolute value) for 69 ity, we choose the same slope (in absolute value) for the increasing and the decreasing phases (before and after 70 the overshoot). 71<br>The order of magnitude of  $\mu_0$  is based on the bifurcation 72

We arbitrarily choose  $\mu_{\text{max}} \in [1, 10]$  and  $\tau_{\text{att}} \in [1, 20]$  85<br>(dimensionless values). In [21], Ernoult and Fabre measured 86 (dimensionless values). In  $[21]$ , Ernoult and Fabre measured pressure rise times going approximately from 5 to 150 ms, 87 for all fingerings between C5 (1046.5 Hz) and C6 88 (2093 Hz). Therefore, by choosing  $\tau_{\text{att}} \in [1, 20]$ , we keep a 89<br>ratio between the longest and the shortest attacks with 90 ratio between the longest and the shortest attacks with the same order of magnitude as in  $[21]$ . 91

Firstly, it can be observed that this depicted in Figure 10. Firstly, it can be observed that this 10 distribution is far from being uniform; most transient-11 informed initial conditions are very close to either the 12 equilibrium or the periodic solution. It is expected for such 13 a system to leave an unstable equilibrium through its fast 14 eigendirection (i.e., associated with the eigenvalue of high-15 est modulus) and to converge towards a stable equilibrium 16 through its slow eigendirection (i.e., associated with the 17 eigenvalue of smallest modulus). Such behavior is explained 18 by Strogatz in example 5.2.3, p.133 of [38]. Precisely, 19 around the equilibrium in Figure 10, the states of the 20 system at  $\mu = \mu_{end}$  are gathered along a specific direction<br>21 whereas the states of the system at  $\mu = \mu_{max}$  are regrouping 21 whereas the states of the system at  $\mu = \mu_{\text{max}}$  are regrouping<br>22 along another direction. In addition, we plot on the same along another direction. In addition, we plot on the same 23 figure the fast eigendirection of the equilibrium at  $\mu = \mu_{\text{max}}$ <br>24 and its slow eigendirection at  $\mu = \mu_{\text{end}}$ . At the overshoot,<br>25 the system clearly leaves the equilibrium through its 25 the system clearly leaves the equilibrium through its 26 fast eigendirection. At the end of the attack, some of the 27 trajectories converge toward the equilibrium. If the simula-28 tion was performed over a longer duration, they would<br>29 eventually gather along the slow eigendirection of the eventually gather along the slow eigendirection of the 30 equilibrium.

## 4.3 Basin stability with transient-informed 31 distribution 32

The basin stability is then computed using these tran- 33 sient-informed distributions. The results are shown in 34 Figure 11 for three different overshootvalues. For the sake 35 of readability, only the basin stability of the periodic solu-36 of readability, only the basin stability of the periodic solution is represented (we recall that the basin stability of 37 the equilibrium is the complementary to one). 38

The result computed with the uniform distribution is 39 represented in black. Firstly, this Figure 11 highlights that 40 the basin stability depends greatly on the considered distri- 41 bution, even though some features are preserved:  $S_B(\mu)$  is 42<br>discontinuous at  $\mu = \mu_{SN}$ , continuous at  $\mu = \mu_H$  and mono-43 discontinuous at  $\mu = \mu_{SN}$ , continuous at  $\mu = \mu_H$  and mono-<br>tonously increasing for the cases where  $\mu_{max} = 3$  and 4. In tonously increasing for the cases where  $\mu_{\text{max}} = 3$  and 4. In 44<br>the case where  $\mu_{\text{max}} = 2$ , the overshoot scenario does not 45 the case where  $\mu_{\text{max}} = 2$ , the overshoot scenario does not suffice to leave the basin of the equilibrium and no oscilla- 46 tions are observed in the multistable region. Secondly, for 47 the situation considered, this Figure 11 shows that the 48 large-overshoot attacks are more likely to make the system 49 end up on the periodic solution. Moreover, the basin stabil- 50 ity increases faster when  $\mu_{\text{end}}$  gets closer to  $\mu_{\text{H}}$ . In terms of 51<br>playability, a slowly varying  $S_R$  can be interpreted as a 52 playability, a slowly varying  $S_B$  can be interpreted as a region where the difficulty to produce a sound does not 53 depend much on the final value of the control parameter. 54 For the situation under study, this means that for a given 55 value of  $\mu_{\text{max}}$ , all the attacks with  $\mu_{\text{end}}$  in this region of slow 56<br>varying  $S_R$  have almost the same probability to converge 57 varying  $S_B$  have almost the same probability to converge towards the periodic solution. As a result, if we ignore the 58 difficulty for a musician to maintain  $\mu > \mu_{SN}$ , there is no 59<br>additional difficulty to reducing the sound amplitude to 60 additional difficulty to reducing the sound amplitude to its minimal value. 61

## 5 Application to a trumpet model 62

In order to evaluate the interest of the methods intro- 63 duced in previous sections to a more advanced and high 64

1 dimensional model of musical instrument, the analysis of 2 basin stability and transient durations is applied in this 3 section to a physical model of  $B<sub>b</sub>$  trumpet.

#### 4 5.1 Presentation of the model

 The model used is identical to the one considered in [5]. It is detailed in Appendix A. The lips are represented by a one-degree-of-freedom oscillator. The air column inside the body of the instrument, also known as the resonator, is modeled by a modal truncation of its input impedance. These two elements are coupled by a nonlinear function that models the air jet through the lip channel. In this arti- cle, we consider an 11-mode truncation of the resonator and fix the resonance frequency of the lips around the second 14 impedance peak  $(f_L = 200 \text{ Hz and } f_2 = 232.7 \text{ Hz})$ . This peak corresponds to the lowest note of the instrument, in corresponds to the lowest note of the instrument, in "normal" playing conditions (the first peak being associated with the "pedal note"). The variables of this model are the 18 position and velocity of the lip as well as the real and<br>19 imaginary parts of the 11 modal pressures. This results in imaginary parts of the 11 modal pressures. This results in a system of dimensionality 24. The parameter values used in this article are given in Appendix A.

#### 22 5.2 Bifurcation diagram

 Unlike the fifth-order Van der Pol oscillator, this 24 trumpet model has no analytical solutions. To determine<br>25 its solutions. numerical continuation can be used. Here. its solutions, numerical continuation can be used. Here, we use the Manlab software [33]. The bifurcation diagram of the model is shown in Figure B1. The amplitude of the 28 mouthpiece pressure  $p$  and the frequency of the sound pro-<br>29 duced  $f_{\text{obs}}$  are plotted with respect to the blowing pressure 29 duced  $f_{\text{play}}$  are plotted with respect to the blowing pressure 30  $p_0$ . In this zone, the system exhibits an inverse Hopf bifur- p<sub>0</sub>. In this zone, the system exhibits an inverse Hopf bifur-<br>31 cation followed by a saddle-node bifurcation, like the Van cation followed by a saddle-node bifurcation, like the Van der Pol oscillator presented in previous sections. The periodic regime is associated with the second mode of the resonator, represented on the bottom panel of Figure B1 by a horizontal dotted line.

## 36 5.3 Basin stability and transient durations computed 37 with bSTAB

 To calculate the system's basin stability and transient durations, we use the bSTAB toolbox [48]. For our applica- tion, we have made a number of modifications to this tool- box, which are detailed in Appendix B. These modifications rely on convergence criteria in order to identify when the system has reached steady state. The numerical integration lasts until these criteria are met, rather than for an arbi- trary time which would be identical for all trajectories. These modifications allow us both to reduce the duration of the time integrations required to compute basin stability, and to calculate the duration of transients (which is not provided in the original toolbox). These criteria must be defined carefully, in order to avoid samples missclassifica- tion, leading to errors in the estimation of basin stability and transient durations.

#### 5.3.1 Initial conditions from a uniform distribution 53

As for the Van der Pol oscillator, we first consider a 54 uniform random distribution of initial conditions  $Q_u$  55<br>selected inside a hyper-rectangle. This hyper-rectangle is 56 selected inside a hyper-rectangle. This hyper-rectangle is chosen large enough to contain all the solutions, whatever 57 the value of  $p_0$ . The basin stability calculated with  $Q_u$  for  $N = 300$  61 order is given in Figure 13a, the transient duration distrisamples is given in Figure  $13a$ , the transient duration distributions are given in Figure 13b and a zoomed-in view is 63 given in Figure  $13c$ . The basin stability shares some features 64 with the Van der Pol oscillator. Indeed, it is discontinuous 65 at the saddle-node bifurcation and remains continuous at 66 the Hopf bifurcation. The observations and comments 67 made about this feature on the simple Van der Pol oscilla- 68 tor translate directly to this more complicated system. In 69 addition,  $S_B$  is monotonous. However, unlike the Van der 70 Pol oscillator, for dynamical systems of dimensionality 71 three or more, the basins' boundaries are different than <sup>72</sup> the unstable periodic solutions. These objects even have 73 different dimensionalities (the basins' boundaries are hyper- 74 surfaces and the limit cycles are hyperlines). Consequently, 75 the basin stability of the equilibrium cannot be inferred 76 from a size estimate of the unstable periodic solution and 77 the sampling approach is then required.  $78$ 

Concerning transient durations, the Hopf bifurcation 79 induces a few long transients in its vicinity, leading both 80 to the equilibrium and to the periodic solution. This is prob- 81 ably related to the increasing timescale of the slowest 82 eigendirection whose stability is reversed at the Hopf 83

On the contrary, in a phase space of 10 higher dimensionality, these trajectories can pass away 11 from this region. Moreover, the median and the interquar- 12 tile range of both solutions increase around the Hopf bifur- 13 cation (even though it is hardly noticeable for the periodic 14 solution with that scale). 15

Finally, this trumpet model sometimes exhibits 16 transients of more than several seconds, which is extremely 17 long compared to usual musical timescales. Beyond a 18 certain duration, these asymptotic regimes can be consid- 19 ered unplayable or at least difficult to play. However, the 20 regime that is heard during one of these extremely long 21 transients can be treated as a playable regime by the 22 musician, even if it is unstable. In this respect, one could 23 see a percussion instrument as a dynamic system with only 24 one asymptotic solution, the equilibrium, but whose tran- 25 sients are long enough to be used to make music. We could 26<br>then consider a "transient" category for samples with a tran-27 then consider a "transient" category for samples with a tran-<br>sient duration exceeding a certain "musical duration". 28 sient duration exceeding a certain "musical duration", rather than classifying them according to their asymptotic 29 solution. 30 solution.

#### 5.3.2 Initial conditions from a distribution based on 31 archetypal time variations of  $p_{\theta}$  $\mathbf{0}$  32

In the following, we study the influence of attack tran- 33 sients on basin stability. We apply the same method as in 34 Section 4 to generate distributions  $\mathcal{Q}_{tb}$  based on transient 35 evolutions of  $p_0$ . Again, we consider pressure rises with 36 overshoot (see Fig. 9), in the manner of a strong tonguing 37 overshoot (see Fig.  $9$ ), in the manner of a strong tonguing attack or a sforzando, as can be found in [49]. The configu- 38 ration and the parameters chosen here differ from [49]. 39 Consequently, we consider slightly different control 40 transients than those measured in that article, so that 41  $p_{0,\text{max}} \in [1, 10]$  kPa and  $\tau_{\text{att}} \in [10, 500]$  ms. Ten attack 42<br>transients are applied to each sample of a uniform dis-43 transients are applied to each sample of a uniform distribution of  $N_0 = 100$  pre-initial conditions. This leads to 44 a final distribution of  $N = 1000$  initial conditions. Each 45 a final distribution of  $N = 1000$  initial conditions. Each 45 variable of the pre-initial distribution is selected in ranges 46 variable of the pre-initial distribution is selected in ranges 0.3 times smaller than in Section 5.3.1. These ranges are 47 chosen arbitrarily and have a significant influence on the 48 results. 49

In Figure 14a, we present the influence of the attack 50 duration  $\tau_{\text{att}}$  on the behavior of the system. Each curve 51<br>has a fixed value of  $\tau_{\text{att}}$  and 10 different values of 52 has a fixed value of  $\tau_{\text{att}}$  and 10 different values of 52<br> $p_{0,\text{max}} \in [1, 10]$  kPa. Indeed, one would expect that the longer the system stays in the 55 region of monostability of the periodic solution, the higher 56 the chances it has to end up in its basin of attraction. 57

This closeness is the result of the time 9 spent by the system below the bifurcation but also of the 10 number of significant digits used in the simulation (numer-11 ical noise is therefore inevitable). This makes direct inter-12 pretation not straightforward. In Figure 14b, we study 13 instead the influence of the overshoot amplitude  $p_{0,\text{max}}$  for various attack durations  $\tau_{\text{att}} \in [10, 500]$  ms. In that case, 14 various attack durations  $\tau_{\text{att}} \in [10, 500]$  ms. In that case,<br>15 S<sub>B</sub> increases with the overshoot value, until it reaches its  $S_B$  increases with the overshoot value, until it reaches its 16 maximal value for  $p_{0,\text{max}} \in [5, 7]$  kPa. Hence, it seems that 17 there are optimal values of transient control parameters to there are optimal values of transient control parameters to 18 maximize  $S_B$ . Further study would be needed to under-<br>19 stand the dynamical reasons leading to this non trivial stand the dynamical reasons leading to this non trivial 20 behavior.

## 6 Discussion 21

## 6.1 Computational cost 22

The methods presented in this paper allow to compute 23 the basin stability and the transient duration distributions 24 of a system. These metrics describe the global, statistical 25 behavior of a system and could be very useful to study 26 musical instruments, notably their playability. However, 27 in order to take into account all the potential behaviors of 28 a system, their computation can be costly. As a result, 29 the computation cost limits the possible applications of 30 these methods, for parametric studies for example. 31

Initially, [31] proposed to use Monte-Carlo techniques to 32 numerically estimate the basin stability. Some limitations of 33 these techniques have been drawn [40] when applied on 34 strange basins of attraction (e.g., fractal and riddled/ 35 intermingled). However, such basins remain to be exhibited 36 on self-sustained musical instruments. Some authors also 37 proposed enrichment to the metric, to take into account 38 uncertainties and variations of the parameters [51, 52]. 39 Additionally, improvements on classical Monte Carlo 40 approaches, notably using machine learning tools, show 41 promise to accelerate basin stability computation. This 42 could be interesting for more complex musical instrument 43 models. For example, [41] proposed a method based on 44 support vector machines. The idea is to find the basins' <sup>45</sup> boundaries with a limited number of samples. Work still 46 needs to be done to determine which method should be used 47 depending on the situation and on the classification cost of 48 a single sample. Indeed, if the classification of each sample is 49 fast, it may be slower to find basins' boundaries rather than <sup>50</sup> to apply a simple Monte-Carlo size estimation. For 51 instance, it is the case for the Van der Pol oscillator 52 presented in this article. 53

If the transient duration statistics and the basin stabil- 54 ity are both studied, the two metrics can be computed 55 simultaneously, using the same time integrations (as in 56 Sect. 5). The cost needed to compute the basin stability 57 with Monte-Carlo methods only depends on the size of 58 the basin as indicated by the absolute standard error given 59 by equation  $(7)$ . For systems with higher dimensions, that 60 cost could increase if the classification cost does. Moreover, 61 the relative standard error, which writes  $err_{rel}(\hat{S}_B) = 62$ 63  $1/\mathcal{S}_{\mathcal{B}}-1$  $\sqrt{\frac{1/S_B-1}{N}}$ , increases as  $S_B$  decreases. Higher dimension systems may have more stable solutions which lead to smaller basin stability values. More samples would thus be 65 ler basin stability values. More samples would thus be 65 needed to keep the relative standard error low. This standard error formula stands for independent trials with only 67 two outcomes – the sample is either inside or outside the <sup>68</sup> studied basin of attraction. The calculation of the transient 69 duration distributions does not enter into this category 70 since the outcome is a continuous random variable: a trans since the outcome is a continuous random variable: a transient duration. With a sparse sampling, some transient 72<br>behaviors that appear for specific initial conditions might 73 behaviors that appear for specific initial conditions might 73<br>be missed. Consequently, it could be interesting to estimate 74 be missed. Consequently, it could be interesting to estimate 74<br>the convergence of the probability density functions in 75 the convergence of the probability density functions in order to chose an adequate number of samples.  $76$

Indeed, non-linear systems sometimes evolve with very varied dynamics, making it dif- ficult to distinguish between a steady state and a transient regime with slow dynamics. This kind of behavior leads to significant differences in transient duration between differ- ent initial conditions, especially at a bifurcation, where one eigendirection becomes infinitely slow. These discrepan- cies in transient durations are particularly visible in Figure 13b, around the Hopf bifurcation. In this regard, the Manlab solutions were very helpful to define efficient classification and convergence criteria (see Appendix B). For systems with a wide range of transient durations, we would strongly recommend to set a convergence criteria rather than to use a fixed integration time, as this is the case in the version of bSTAB currently online. This would improve performances and limit missclassification.

## 24 6.2 Initial conditions and musical gestures

 In Section 3, the presented statistical approach is based 26 on a uniform distribution of initial conditions. This is a general distribution and it allows different instrument configu- eral distribution and it allows different instrument configu- rations to be compared. However, the resulting probabilities probably fail to translate the musician's playing experience. As a first attempt to tackle this issue, we study in Section 4 initial conditions resulting from an archetypal control gesture. This approach highlights the importance of the considered distribution of initial conditions and it can be interpreted in musical terms more directly than random initial conditions. We would like to draw the reader's atten- tion to the fact that the results obtained with this transient- based approach not only depend on the transient control parameters, but also on the choice of the pre-initial condi- tions. Overall, applicative studies on playability would 40 greatly benefit from a preliminary description of the control<br>41 scenarios and, where relevant, initial conditions distribu-41 scenarios and, where relevant, initial conditions distribu-<br>42 tions. In that perspective, it could be of great interest to tions. In that perspective, it could be of great interest to measure transient blowing scenarios provided by humans (musicians and non-musicians) in an experimental study. Moreover, as illustrated by Figure 10, dynamical systems are more likely to cross specific regions of their phase space during transients. Choosing distributions of initial condi- tions based on the slow and fast eigendirections (depending on the solutions that exist during the transient) could also be an interesting idea.

 In this paper, we focus on initial conditions induced by the fast evolution of one control parameter. However, musi- cians may also impact the initial conditions by acting directly on a state variable. One example among many others is the use of the tongue in reed instruments to impose initial reed positions and velocities. Measurements of ton-gue-induced reed positions in a clarinet are presented in

[53] for example. To improve the statistical approaches, 58 these initial conditions should also be taken into account. 59 these initial conditions should also be taken into account.

#### 6.3 Stability, transient duration and playability 60

Other studies were interested in predicting the transient 61 duration of a self-sustained musical instrument [24, 25]. 62 A common approach is to linearize the system around an 63 unstable equilibrium and to consider the exponential 64 growth of a perturbation. This exponential growth depends 65 on the positive real part of the eigenvalues of the matrix of  $66$ derivatives (i.e., the jacobian matrix). This method is better 67 adapted for studying initial conditions close to an equilib-68 adapted for studying initial conditions close to an equilibrium solution. The Floquet theory might be used in the 69 same way for initial conditions next to a periodic solution. 70 same way for initial conditions next to a periodic solution, 70<br>although it has vet to be applied in that manner to a musi-<br>71 although it has yet to be applied in that manner to a musical instrument model (for more details on the Floquet the-  $72$  ory, refer to  $[54, 55]$ ). In this article, we consider initial  $73$ ory, refer to  $\begin{bmatrix} 54, 55 \end{bmatrix}$ . In this article, we consider initial 73 conditions not necessarily close to any solution. Hence, 74 conditions not necessarily close to any solution. Hence, 74<br>these linear analyses might not be valid for every sample. 75 these linear analyses might not be valid for every sample. On more complex systems with several competing multi-<br>stable solutions, its local nature prevents it from giving a stable solutions, its local nature prevents it from giving a 77 complete analysis of the transients. However, the system 78 complete analysis of the transients. However, the systematic and fast nature of linear analysis makes it a good 79 candidate to bolster certain sections of a complete statisti- 80 cal study.

Finally, the statistical study of the trumpet model pre- 82 sented in Section 5 highlights several interests of the meth- 83 ods. The long transients observed in Figure 13 raise the 84 question of the playability of a regime as a function of its 85 transient duration. In a standard musical context, we argue 86 that a regime that takes several seconds to establish cannot 87 really be considered playable. Therefore, certain stable 88 regimes could actually be unplayable due to transient 89 behaviors, which shows the relevance of nuancing the 90 notion of stability using transients when studying playabil- 91 ity. The transient-based analysis of Section 5.3.2 also indi- 92 cates that the transient control parameters of a musical 93 gesture may have nontrivial optimal values. Future works 94 could analyze these types of transient control scenarios into more details, relying on the statistical approaches as playa- 96 bility guidelines. 97

## **7 Conclusion and perspectives 12 Conclusion and perspectives**

In this article, we present a sample-based approach that 99 can be used to enrich a bifurcation diagram. In this study 100 we use it to investigate two playability issues: the prediction 101 of the steady state in multistable situations and the predic- 102 tion of the transient duration. The method used for the first 103 issue is called the basin stability [31], whereas the method 104 proposed for describing the responsiveness of a dynamical 105 system is new, to the authors' knowledge. These two <sup>106</sup> methods rely on distributions of initial conditions that 107 represent the transient action of a musician. The results 108 strongly depend on this choice of distribution and we 109 proposed a method based on time integration to generate 110 transient-informed distributions. 111

 The methods are then applied to a physical model of trumpet with the aim to evaluate their interest in a more practical case. The transient-based basin stability of this model present non trivial tendencies regarding some tran- sient control parameters. Moreover, very long transients 6 are highlighted, which raises the question of the playability<br>7 of such asymptotic regime. Overall, these statistical methods of such asymptotic regime. Overall, these statistical methods 8 show interest for the analysis of musical instruments, but<br>9 they can also be extended to a large variety of systems. they can also be extended to a large variety of systems.

 Future works will focus on two aspects. First, these methods will be applied on musical instrument models in configurations showing multiple oscillating regimes and rich transients. Then, measurements on musicians will be con-ducted to evaluate the initial conditions that they induce,

15 depending on the desired musical effect.
