## **Gallium-catalyzed Boron-assisted Recycling of Any Silicone Waste: Depolymerization to produce Chlorosilanes as key industrial commodities**

Silicone polymers and networks are wonder hybrid materials with a robust inorganic backbone and tunable organic substituents tailored for various daily life applications. However, their recycling, including mechanical and chemical processes, remains at its infancy. 25 We present a generalized method to depolymerize, at ambient temperatures, any silicone waste;

30 *a.k.a.* key intermediates from the Müller-Rochow process, at the cornerstone of the Si industry.

#### **One-Sentence Summary:**

Chemical recycling of any silicone waste harnessing  $BCl<sub>3</sub>$  and Ga catalysis produces key industrial chlorosilanes.

including a very wide range of silicone-based materials and post-consumer waste *a.k.a*. end-oflife crosslinked polydimethysiloxane-based networks within formulated materials. The reaction harnesses an efficient gallium catalyst, with a 30-million-fold rate enhancement, and boron trichloride as source of chloride to produce nearly quantitative yields of (methyl)chlorosilanes

#### **CONTEXT/RATIONALE**

Silicone polymers are ubiquitous materials in our daily lives owing to their exceptional mechanical and thermal stability, chemical resistance and low toxicity that are advantageous in various applications such as household, automotive, medicinal care, etc (*1*). In 2022, the world 5 production of silicone polymers reached  $>8$  million tons, representing a market value at  $\sim$  20 billion USD (*2*). Due to its upstream hydrometallurgical process step, the production of silicones is energy intensive. The metallurgy to reach Si metal (relying on the mining of quartz) and to a lesser extent the Müller-Rochow process to yield chlorosilanes both represent  $>70\%$  of CO<sub>2</sub> footprint of silicones. They are the most energy-intensive steps of the silicone industry and circumventing them 10 is appealing. Silicones recycling thus appears as a key solution to conserve already depleting resources (such as quartz) and minimize energy consumption.

The current solution for discarding silicone waste (oils + elastomers with and without fillers) is mostly to either incinerate or landfill. Although silicone wastes have so far been considered mostly benign for our environment (eventual degradation in soil to CO2, H2O and SiO2), *do nothing* 15 *and let it accumulate and slowly degrade over the next thousand years* would be an unsatisfactory and inefficient solution for the end-of-life of these materials. In addition, some silicone-based compounds have recently come under scrutiny, fostering novel strategies such as eco-design for silicones (*3*) and biocatalytic pathways to deal with volatile methylsiloxanes (*4*). Addressing silicone waste is thus crucial to a sustainable future for our environment and society, aiming at 20 circularity for polymers. Unlike some specific thermoplastics such as PET or Polyolefins (*5-8*), whose recycling are widely developed **—** mechanical in particular (*9*), but more recently chemical (*10-14*) — the recycling of silicone-based polymers is underexploited and few examples exist (*15*). Chemical recycling could prove particularly efficient for silicones since it sidesteps the powerhungry metallurgy and Müller-Rochow processes. According to the studies from Elkem 25 Silicones©, the chemical recycling of silicone wastes can reduce 65% of energy consumption and 75% in greenhouse emission (*16,17*). Developing novel processes toward recycling and circularity of silicone polymers is thus highly desirable.

A main reason for the difficult chemical recycling of silicone materials and particularly elastomers (crosslinked networks) is their sophisticated multi-component silicone-based 30 formulations. Those elastomers/rubbers often exist as a mixture of crosslinked polysiloxanes, inorganic and organic fillers, technical additives, and catalysts (*15*). Since they are cured or crosslinked in the presence of catalyst, they can no longer be melted or reshaped. Therefore, mechanical recycling will warrant downcycling as rubber powder or crumbs and thus has rather limited applications. Consequently, chemical upcycling to recover key industrial intermediates 35 (*15,16*) appears as a seducing and likely alternative for complex silicone waste.

The chemical recycling of waste silicones has nonetheless been studied for a long time, yet mainly focusing on the conversion of silicone polymers to cyclosiloxanes (**method 1**, cyclic monomers, *see Fig. 1*). Very rarely has "upcycling" to halogenated organosilanes been considered as efficient strategy for chemical recycling (**method 2**, Cl-based monomers, *see Fig. 1*). Both 40 cyclosiloxanes and halogenated organosilanes are key intermediates of the silicone industry (*see Fig. 1*).

On the one hand (**method 1**), a strong alkaline base/complex or fluorine derivatives could be used as the efficient catalyst (generation of propagating silanolate) for the deconstruction of silicone polydimethylsiloxane (PDMS) chains to cyclosiloxanes through back-biting successive 45 nucleophilic attacks (*16, 18-20*). This is a desirable short recycling loop: "back-to-cyclic

monomers". We recently provided a straightforward strategy for several silicone wastes: a "backto-cyclics" methodology with a very efficient, readily available and recyclable catalyst (*16*). However, the strategy lacks universality and tolerance towards high contents of moieties supporting Si-H bonds. More detrimentally, it cannot properly handle formulated elastomers and 5 highly crosslinked resins which account for a large fraction of all silicone waste (> 40%), especially present in post-consumer waste.

On the other hand, analogue to **method 2** but for fluorosilanes, the conversion of silicone polymer to Si-F products is a thermodynamically favored chemical route. Enthaler *et al.* have presented a new synthetic method for the depolymerization of silicone oils/elastomers to produce 10 the corresponding fluorosilanes (*21*). An excess of benzoyl fluoride was used as the fluorine sources and the reaction often proceeds in the presence of a Zinc catalyst at elevated temperatures (120-190°C). However, the drawback of this method is twofold: it involves the price/availability/lack of atom-economy of fluorine/fluoride sources and the release of some volatile and hazardous fluorosilanes during "recycling". Moreover, utilization of those 15 fluorosilanes is rather limited industrially and is "outside the loop" of silicon/silicone main industrial train.

Chlorosilanes (**method 2**) are the most important intermediates in silicone industrial production. They are conventionally produced through Müller-Rochow process that involves a copper-catalyzed reaction of methyl chloride and metallurgic silicon in a fluidized bed reaction 20 (300°C, 2-5 bar) (*22*). However, the chemical recycling of silicone polymers to (methyl)chlorosilanes is seldom reported due to unfavored thermodynamic of Si-Cl bond in comparison to Si-O featured in silicone backbones (*23*). There is only one report by Enthaler *et al.*, mentioning the conversion of silicone oils to chlorosilanes (*24*). However, reaction conditions (high catalyst loading [Fe], excess of unsustainable acyl chloride, high temperature ~ 190°C) and 25 narrow scope with waning reactivity have limited its application in silicone recycling. Alternatively, we provide a *chew-all-waste* chemical recycling strategy based on an inorganic chloride source, boron trichloride, whose side-product boron oxide  $B_2O_3$  can be used by the borosilicate glass industry or looped back into boron trichloride (*25,26*).

Herein, we present an effective method for depolymerization of any silicone polymers – 30 including functional oils, block copolymers or end-of-life/industrial elastomers and filled crosslinked materials waste – to produce (methyl)chlorosilanes as key commodities of the silicone industry. The reaction is performed at ambient temperature in the presence of low metal catalysts (typically 0.5 mol% down to 0.02 mol%, *i.e.* from 0.005 equiv. down to 0.0002 equiv. of Si-O bonds) using boron trichloride as a depolymerizing reagent. The heterobimetallic ion pairs 35 resulting from Si-O-Si bond, and  $BCl<sub>3</sub>$  (as Lewis acid and source of Cl) and  $GaCl<sub>3</sub>$  (as a catalyst) promoted Si-O and B-Cl scrambling from BCl<sub>3</sub> and Si-O-Si silicone backbone. Among various Lewis acids, GaCl<sub>3</sub> exhibited superior performances as a catalyst, but not as a chloride source when compared to far superior  $BCl<sub>3</sub>$  (see below). The  $[BCl<sub>3</sub>•GaCl<sub>3</sub>]$  combination in the presence of Si-O-Si based backbone can yield up to 99% chlorosilanes. Even if this type of Lewis acidic 40 behavior is not extensively documented (see dedicated section in ESI: "Precedent literatures on homo/hetero-bimetallic reactivity"), multi-nuclear NMR spectra of the active species elucidate and confirm prior findings. With the support of molecular modelling performed at the DFT level, we unveil the atypical mechanism of this depolymerization reaction.

### **RESULTS & DISCUSSION**

5 The depolymerization of silicone polymers was first studied at 40°C during 24 hours using a solution of boron chloride in dichloromethane  $(1M)$  as a source of chloride. BCl<sub>3</sub> was selected to counterbalance the thermodynamically disfavored formation of Si-Cl bonds from Si-O bonds. Silicone oil 1 (MD<sub>70</sub>M,  $M_n = 5340$  g mol<sup>-1</sup>, viscosity 100 cSt) was used as a model substrate. First, the Si-O-Si backbone cleavage was evidenced using BCl<sup>3</sup> in the absence of catalyst (*see* entry 1, 10 *Table 1*). Some Si-O bond cleavage was observed along with the formation of Si-Cl bonds through the formation of products **4**, but no volatile (methyl)chlorosilanes **2** and **3** could be evidenced. To favor the chlorination process, catalysis by a Lewis acid was then evaluated. Combination of BCl<sup>3</sup> with another Lewis acid seemed promising to enhance reactivity and Si-O bond cleavage.

Heterobimetallic reactivity was first discovered decades ago but its application through the 15 combination of two Lewis acidic molecules is scarcely reported. One key example was reported by Sugasawa, using stoichiometric amount of BCl3 and GaCl3, to realize a specific *ortho*substitution acylation of aniline derivatives (*27*). This concept was later exploited by Negishi to understand what governs or induces the ate complexation, transmetallation or dynamic polarization (*see Fig. S6* and more generally the "Precedent literatures on homo/hetero-bimetallic 20 reactivity" discussion in ESI), concluding that the new metal center in the putative heterobimetallic complex must be more electrophilic than the original "non-activated" one (*28*). Recently, Schindler *et al.* have found that the hetero-bimetallic species, harnessing Fe and Al Lewis acid character, could be used as excellent catalyst for carbonyl-olefin ring-closing metathesis (*29,30*). Interestingly, these reports reinforce the idea that the super-electrophilic 25 character arising from such species can unlock some unconventional reactions. Although the experimental data were meticulously interpreted by a computed mechanism, spectroscopy studies did not reveal any conclusive evidence of active species. More recently, Klare, Oestreich *et al.*  reported a new halodealkylation of alkylsilanes, harnessing the super-electrophilic character of arenium cations and corresponding chlorenium/silylium intermediates (*31,32*). The main goal here

is to unlock a valuable, yet thermodynamically unfavorable, formation Si-Cl bond from Si-O bonds. We tried to capitalize on the hetero-bimetallic [BCl3•Lewis acidic catalyst] combination to induce chlorosilanes formation from Si-O-Si backbones.

To that effect, a wide range of *Lewis acids* (MCl<sub>x</sub>, 0.5 mol% of siloxane unit) were tested as 5 catalysts for the depolymerization reaction (*see Table 1*, entries 2 to 9). On the one hand, no reactivity was observed using  $ZnCl_2$ ,  $MnCl_2$ ,  $CoCl_2$  whereas dichlorodimethylsilane 2 was obtained in low yield  $(12%)$  in the presence of FeCl<sub>2</sub>. Interestingly, the depolymerization with FeCl<sup>3</sup> gave an excellent yield of **2** (up to 97%), albeit after 24 hours. On the other hand, the reaction using AlCl<sub>3</sub> or GaCl<sub>3</sub> provided an excellent reactivity in a shorter timeframe. The chlorosilane 2 10 was obtained in 85% and 98% yield respectively, after only 30 minutes. We hypothesized that the increased chlorophilicity of these Lewis acids leads to the formation of super-electrophile reagent [O-BCl<sub>2</sub><sup>+</sup>] from BCl<sub>3</sub> with coordination of Si-O-Si behaving as the Lewis base and GaCl<sub>3</sub> harvesting the Cl<sup>-</sup> to generate the favorable [GaCl<sub>4</sub><sup>-</sup>] anion, thus promoting the cleavage of Si-O-Si bonds (*see* discussion about the mechanism in a following dedicated section). Moreover, 15 (Me3SiO)-functionalized chain-ends could for instance be recovered with this process as corresponding functionalized chlorosilanes (Me3SiCl, 99% yields). Furthermore, other gallium pre-catalyst species were also evaluated for depolymerization reaction. The reactions with GaBr<sup>3</sup> and  $Ga(OTf)_3$  gave 95% and 70% of 2 while no desired product was observed when  $Ga_2O_3$  was employed as a catalyst precursor, likely due to immiscibility issues. In the Ga-based series, GaCl<sub>3</sub> 20 was thus selected for further investigation, including temperature effect and catalyst loading on the performances of the depolymerization reaction (*Table S1*). Lowering the temperature down to 0°C or 25°C resulted in a good but non-quantitative yield of **2** obtained in 67-70% along with the formation of silyl ether product **3** (10-11% yield). When the catalyst loading was decreased further down to 0.02 mol%, the reaction time had to be consequently increased to achieve complete 25 depolymerization reaction. Considering all these factors,  $GaCl<sub>3</sub>$  (0.5 mol%, 40<sup>o</sup>C) was chosen for further investigation, in particular, concerning the choice of solvent or diluent (swelling in the case of crosslinked materials).

*Solvent.* We verified that our depolymerizing strategy did not rely on the use of dichloromethane (DCM) as a solvent. Alternative valuable solvents, either for the dilution (linear 30 PDMS waste) or for the necessary swelling of any silicone waste (including mixed elastomers), such as toluene and heptane, have been investigated (*see* entries 10 & 11, **Table 1**). Since BCl<sub>3</sub> has a low boiling point (12°C) and it is hard to handle in a neat state, its solution in different solvent (CH2Cl2, heptane or toluene) was first evaluated for this reaction. When the reaction was performed at 40°C for 30 minutes, the depolymerization in DCM yielded 98% of **2,** while utilizing 35 BCl<sup>3</sup> in *n*-heptane or toluene solutions provided yields of **2** at 60% and 62%, respectively. More interestingly, when the reaction's time was increased, a better conversion of **1** was also observed. After 2 hours, the depolymerization in toluene gave an excellent dichlorosilane yield (95%) while the depolymerization in *n*-heptane provided 75% yield of **2** after 5 hours. Furthermore, the temperature could also be increased when higher boiling-point toluene was used. After 1 hour at 40 90°C, nearly quantitative yield of **2** was obtained with very little percentage of silyl ether **3**. Thus, both more sustainable and friendly solvents provided good to excellent yields of desired (methyl)chlorosilanes, albeit using slightly longer reaction times (*see* entries 10 & 11, *Table 1*).

Since the  $BCI<sub>3</sub>/GaCl<sub>3</sub>$  proved to be a powerful combination for the transformation, we wanted to verify that other potentially industry-compliant chloride sources could be utilized.

5 *Source of chloride.* AlCl<sup>3</sup> was tested as an alternative chloride source for the depolymerization as previously reported by Mair *et al.* (33) (**Table S2**). Of note: AlCl<sub>3</sub> is a byproduct of the Si industry (after the Müller-Rochow & subsequent hydrolysis processes). The reaction was carried out at different temperatures (40 $^{\circ}$ C for CH<sub>2</sub>Cl<sub>2</sub>, 90 $^{\circ}$ C for ClCH<sub>2</sub>CH<sub>2</sub>Cl as solvents/swelling agents) for 24 hours. However, only low yield of chlorosilane **2** (10-12%) was 10 observed. We suspect that if the first Al-Cl bond of AlCl<sub>3</sub> is reactive, the subsequent  $-O-AlCl<sub>2</sub>$  and further oxygenated counterparts are far less efficient chlorinating reagents. Additionally, GaCl<sub>3</sub> was ruled out as the chlorinating reagents, due to its favored transmethylation (*34*). Finally, other metallic or metalloid-based chloride sources such as TiCl<sub>4</sub>, SiCl<sub>4</sub>, CuCl<sub>2</sub> or even a solution of HCl in dioxane (4M) were also used as alternative chloride sources but no reactivity was detected in all 15 these cases (*Table S2*), highlighting the advantageous role of boron chloride as a source of chloride.

*Recycling functional waste oils.* After optimization with PDMS oil **1** with viscosity of 100 cSt, the conditions for the depolymerization of other silicone waste were selected as follow: BCl<sup>3</sup> as Cl source (2.2 eq. of Cl per Si atom to convert, mainly targeting  $Me<sub>2</sub>SiCl<sub>2</sub>$  as product, which 20 corresponds to 1.1 eq. of B-Cl bond per Si-O bond, cat: GaCl<sub>3</sub> (0.5 mol%), 40<sup>o</sup>C for 30 min. We applied these conditions to a series of silicone oils with different chain-end functionalities (*Fig. 2* and *Table S3*). First, several trimethylsilyl end-capped polysiloxanes with higher viscosities **7** and **8** (respectively 1000 cSt and 10<sup>6</sup> cSt) were examined. Interestingly, all of them gave an excellent

yield of chlorosilane **2** (95-97%) upon recycling, indicating that the molar masses of the linear PDMS or silicone gum (very high molar-mass linear PDMS) do not affect the efficiency of the depolymerization method. Then, the vinyl-terminated silicone oils **9** and **10** were also tested under standard conditions. A good yield of **2** (93-96%) was also afforded. Additionally, silanol-5 terminated polysiloxanes **11** and **12** were also investigated, giving the desired product **2** in very good yields (93-97%). Moreover, the resin **13**, which consists of 75% of D moieties, 20% of T moieties and 4% of M moieties, was tested under reaction condition (*35*). Interestingly, 90% of **2** and 10% of **3** were obtained after the deconstruction. Besides, some advantageous depolymerization products of T fraction such as  $\text{MeSiCl}_3$  and  $(\text{MeSiCl}_2)_2$ O were detected for the 10 first time in 10% and 50% yield respectively. T moieties are particularly challenging for silicone recycling since their accumulation in many "back-to-cyclics" depolymerization strategies often yields a crosslinked insoluble fraction that requires process discontinuity and extensive cleaning (*15, and see discussion on demethylation in ref.16 in particular*).

Furthermore, and to showcase the robustness and universality of the method, waste silicone block copolymers **14** which has phenyl content (5 mol%) and a viscosity of 60000 cSt, was also investigated under optimized depolymerization conditions. After 30 minutes, chlorosilane **2** could be afforded in a yield of 97% based on D moieties (*36*). Eventually, silicone oil **15** containing 5 numerous Si-H moieties, extremely challenging to recycle compared to fully methylated silicone oils regarding both safety and chemical instability, was evaluated for the depolymerization. Excellent yields of methyldichlorosilane (Me(H)SiCl<sub>2</sub>) ( $> 95\%$ ) and minor silyl ether  $(Me(H)SiCl)<sub>2</sub>O$  (< 5%) were observed. In all examples, chain-end-derived chlorosilanes (M) moieties) were recovered almost quantitatively (see grey column for product **5**, separated with 10 doubled line in Table S3, ESI), except for silanol-terminated substrates depolymerization, logically lost during chlorination. These chain blockers are particularly valuable to the *Si* industry.

*Scale-up.* Finally, a scale-up of the method was conducted using first 2 g of silicone oil **1** and then ~ 80 g of **1** (see scale-up section in ESI) in a dedicated semi-batch process. A distillation setup was applied to separate the volatile fraction (containing  $Me<sub>2</sub>SiCl<sub>2</sub>$  and  $CH<sub>2</sub>Cl<sub>2</sub>$ ) and solid co-15 product  $(B_2O_3)$ . The side-product was analyzed by solid-state <sup>11</sup>B NMR spectroscopy and is mainly comprised of the boron oxide with some B-Cl residual bonds. Interestingly, chlorosilane **2** was observed in a high yield of 97% whereas boron oxide was also isolated as a white solid (95% yield) for the 2 g scale, and in 95-97% (D moieties in liquid distillate plus leftovers in boiler) and ~99% respectively for the promising 80 g-scale experiment (see ESI for details). This latter experiment 20 allowed for a monitoring of the depolymerization reaction (see ESI section dedicated to scale-up), which is exploited in the mechanism investigation following section. Additionally, we could achieve a more precise characterization of the  $B_2O_3$  co-product from this larger scale, showing minimal contamination by B-Cl bonds, likely due to the slight excess used to warrant full transformation to chlorosilanes (ESI, *Fig. S54 & S55*). This side product of chemical recycling 25 could therefore be recycled in another industrial loop (*37*) or reused by the borosilicate glass industry.

These scale-up experiments confirm the first selective and scalable method to convert silicone oils into valuable chlorosilanes, paving the way towards industrialization. The remaining hurdle was the mixture of silicone waste: could our method handle this ultimate challenge?

30 *Waste elastomers, Industrial waste and waste Consumer Products.* Silicone elastomers are more challenging substrates for depolymerization processes because they often exist in a complex formulated mixture comprised of fillers/additives, crosslinked silicone elastomers and catalysts. They are even more challenging at their end-of-life with lifespan pollution including many organic/inorganic contaminants, rendering their formulation even more complex. Polysiloxanes 35 often account for 60-70% wt% while fillers (inorganics often based on silica or chemically modified  $SiO<sub>2</sub>$ ), pigments and catalyst often contribute in a range of 30-40 wt%. Considering the abundant of silicone elastomers in our society, several post-consumer silicone waste from our daily lives – such as nipple pads, cupcake molds, silicone sheets or water/liquid tubing were used as starting materials for the depolymerization process (*Fig. 3* **and** *Table S4*). Interestingly, desired 40 product **2** was obtained in high yields (90-99%, based on theoretical Si-O-containing moieties) (*Table S4*, entries 1-4). Then, industrial wastes, supplied by our industrial partner Elkem Silicone©, were also tested under optimized conditions (*Table S4*, entries 5-8). First, RTV1 and RTV2 formulated elastomers (room-temperature vulcanizates, with fillers) that are obtained through crosslinked using Tin (Sn) or Platinum (Pt) catalysts, were subjected to the 45 depolymerization conditions. Interestingly, desired product **2** was obtained in an excellent yield (95%). Moreover, high-temperature vulcanization elastomer (HTV, with fillers) that was

crosslinked at elevated temperature in the presence of peroxide catalyst, was also evaluated. After 0.5 hour, chlorosilane **2** was again obtained in a quantitative yield. This protocol was extended to a more challenging HTV elastomer (formulation with additives and fillers densely crosslinked by peroxide and hydrosilylation at 170°C rather than ~120°C for classical HTV). Respectively 80% 5 of **2** and 20% of **3** were recovered after depolymerization, even for this densely crosslinked silicone material. More interestingly, the chlorination of crosslinking knots was also detected in the crude mixture as the appearance of characteristic signals in  ${}^{1}$ H-NMR spectra at 0.66 and 0.62 ppm (characteristic of Cl2MeSi-CH2CH2-SiMeCl2). Finally, a mixture of *all elastomers without sorting* (3 g) was subjected to these recycling conditions. After 2 hours, the crude mixture was distillated 10 under reduced pressure (40°C, 200 mbar) to yield chlorosilane **2** and silyl ether **3** at 83% and 6%, respectively. A mixture of  $B_2O_3$  and  $SiO_2$  (2.2 g) and minimal silicone residues were also isolated after the distillation as a grey fine solid (*see Fig. S56 & S57*). This mixture could be used as base material in the production of borosilicate glass, boron nitride or boron carbide (*25*). These positive results demonstrate that this chemistry is highly selective and robust. No matter what fillers or 15 catalyst residues are present in the silicone waste, the depolymerization of silicone backbones produces chlorosilane **2**, cornerstone of the silicone industry in almost quantitative yields based on D moieties. Chain-end functionalities could be recovered once again as valuable chain-capping agents for regeneration of catalogue oils for the Si industry.

### **MECHANISM INVESTIGATION**

To enhance our understanding and potentially tackle future challenges in silicon chemistry, 25 the species resulting from the combination of chlorinated Lewis acids and GaCl<sub>3</sub> that allows the efficient formation of Si-Cl bonds from the Si-O bonds were examined using multi-nuclear NMR spectroscopy (*Fig.* 4). First, the mixture of BCl<sub>3</sub> & GaCl<sub>3</sub> (1:1 ratio) was analyzed in CD<sub>2</sub>Cl<sub>2</sub> but the evidence of an anticipated Cl-bridged dimer was hard to detect (see ESI for detailed analysis, pp.S33-35). We beneficially added PPh<sub>3</sub> to the mixture in  $CD_2Cl_2$  in a molar ratio of 1:1:2  $(BCI<sub>3</sub>/GaCl<sub>3</sub>/PPh<sub>3</sub>)$  and the *in situ* NMR analyses  $(^{11}B, ^{31}P$  and  $^{71}Ga)$  were recorded at room

temperature. The significant difference between the initial BCl<sub>3</sub> signal at 46.5 ppm and the new resonance at 3.91 ppm (d,  $J = 154.6$  Hz for the  $J^1$ {<sup>11</sup>B-<sup>31</sup>P} coupling) (*Fig. 4A*) was attributed to the signal of stabilized electrophile  $[BCl_2(PPh_3)_2]^+$ . This reveals the likely halide abstraction using 1 equiv. of GaCl<sub>3</sub> and 2 equiv. of PPh<sub>3</sub>, which agrees with tetracoordinate boronium species in solution (38). Moreover, the main resonance at -1.03 ppm (q, 154.6 Hz for the  $J^1\{^{31}P - ^{11}B\}$ coupling) was observed in the  ${}^{31}P\text{-NMR}$  (*Fig. 4B*), indicating the interaction of triphenyl phosphine with BCl<sub>2</sub><sup>+</sup>. Additionally, one can identify the overlap of the characteristic quadruplet of  $J^1\{^{31}P^{-11}B\}$  and minor septuplet of  $J^1\{^{31}P^{-10}B\}$ . The anionization of the gallium center was also confirmed by <sup>71</sup>Ga-NMR spectroscopy (*Fig. 4C*). The <sup>71</sup>Ga-NMR spectrum of active species 10 exhibited a broad feature with two maxima at 250 and 270 ppm, consistent with analogous species [GaCl<sub>4</sub>] and  $[Ga_xCl_{3x+1}]$  to those identified for the P-donors (39,40). For the <sup>71</sup>Ga-NMR reference, [bmim<sup>+</sup>GaCl<sub>4</sub><sup>-</sup>] was synthesized. Its main resonance was observed at  $\sim$  250 ppm as a narrow signal, which corresponds to a nearly centrosymmetric tetracoordinate anion [GaCl4]. Similar species can also be identified with  $AICI_3$  instead of  $GaCl_3$ ; which comforted us in our assignment 15 (centrosymmetric tetracoordinate anion [AlCl<sub>4</sub>] and polymeric analogues, see Fig. S53). In agreement with our spectroscopic study, we postulate a first cycle in the mechanism of the unusual electrophile depolymerization as below (*Fig. 4D*).

To raise our understanding of the key steps of the depolymerization mechanism, the "selective" cleavages of hexamethyl disiloxane (HMDS) and hexamethylcyclotriloxanes (D3) have been investigated using various stoichiometric amounts of BCl<sub>3</sub> and/or GaCl<sub>3</sub> as chlorinating reagents in  $CD_2Cl_2$ . HDMS and  $D_3$  were selected to best represent the chain ends and main 5 moieties (D) of the silicone waste to recycle, while retaining a manageable molecular dimension for the DFT calculation. The reactions were performed in 5-mm NMR tube under inert atmosphere and the corresponding multi-nuclear NMR analyses performed to detect some key intermediate species. BCl<sub>3</sub> can efficiently produce TMSCl from HMDS  $(50\%$  yield using 1 eq. BCl<sub>3</sub> with concomitant formation of TMS-O-BCl2). Initially, boron trichloride was also able to cleave the D 10 moieties of D<sup>3</sup> (Si-O-Si bond) to yield Si-Cl and Si-O-B bonds (see ESI, Figure S58-S61). Moreover, it favored the redistribution between mono-, di- and tri-alkoxy borate derivatives (**B1a**, **B2a**, **B3a**). However, it was not possible to cleave and chlorinate the corresponding O-Si-Cl bond to give Me2SiCl2. In order to obtain the dimethyl dichlorosilane **2**, another metal chlorides such as GaCl<sub>3</sub> (Fe/ Al-based analogues can be utilized as well, see Table 1) must be involved in the 15 catalytic cycle to break  $Cl-(Me<sub>2</sub>SiO)<sub>x</sub>-BCl<sub>2</sub>$  derivatives into  $Me<sub>2</sub>SiCl<sub>2</sub>$  and correspond Cl-B-O derivatives that could further yield  $B_2O_3$  with the help of catalysis (see dedicated section in ESI). Interestingly, GaCl<sub>3</sub> can also cleave HMDS to yield  $\frac{1}{2}$  equiv. of TMSCl and full conversion when using 2equiv. with respect to HMDS. However,  $GaCl<sub>3</sub>$  is unable to cleave  $D<sub>3</sub>$ . Only with the help of the mixture of HMDS/2equiv. GaCl<sub>3</sub> can we observe the formation of desired product 2, albeit 20 not quantitatively. These model reactions already suggest the need for a prerequisite complexation of a Lewis base to allow the formation of  $[-LB-BCl<sub>2</sub><sup>+</sup>GaCl<sub>4</sub><sup>-</sup>]$  type species with Si-O-Si bond enacting as the *in situ* Lewis base.

As a first approach, we estimated the thermochemical driving force for these transformations 25 by using tabulated bond dissociation energies. In particular, enthalpies of formation for Si-Cl/B-O formation and B-Cl/Si-O cleavage. (*41-43*). To our surprise, the tabulated values suggested an endothermic value of 17 kcal/mol  $\left(\frac{2}{2}$  kJ/mol), which is not what we would have expected for our system.

30 Performing calculations at the DFT level (*see* details in ESI section), we were able to rationalize and propose mechanisms that rationalize the reactivity of  $GaCl<sub>3</sub>$  and/or  $BCI<sub>3</sub>$  with  $D<sub>3</sub>$ (*Fig. 5*), thus unveiling the depolymerization mechanism. On first instance, the lack of reactivity of GaCl<sup>3</sup> alone is explained by the high Gibbs energy barrier required for the Si-O / Si-Cl bond metathesis ( $TS_1$ **-Ga** ~31 kcal/mol) and its endergonicity (*Fig. 5a*). In the case of BCl<sub>3</sub>, boron 35 oxophilicity weakens the Si-O bond enough to halve the activation energy of the Si-O / Si-Cl bond metathesis to 15 kcal/mol (**TS1-B**, *Fig. 5b*) and to thermodynamically favor Si-Cl and O-BCl<sup>2</sup> formations as detected by NMR. Of note, the following O-B-O cyclization *via* **TS2-B** is endergonic by *ca*. 6 kcal/mol and the subsequent chlorination / second Si-O cleavage (**TS3-B**) is kinetically prevented relative to the experimental conditions. The energetics of these two steps thus hinder the 40 reaction to proceed further, in line with experimental results. For both Lewis acids, when used independently, Si-O / Si-Cl bond metathesis transition states **TS1-Ga** and **TS1-B** feature distorted square-pyramidal geometries at Si (*Fig. 5c*), a pattern that differs when both GaCl<sub>3</sub> and BCl<sub>3</sub> are combined (*vide infra*).

In addition, we calculated bond dissociation energies (BDE) on an opened  $D_3$  molecule by 45 BCl<sup>3</sup> (see ESI, **Table S5** and **Figure S62**) and we obtained an exothermic value of -15 kcal/mol for the transformation of B-Cl/Si-O to B-O/Si-Cl bonds. A very different value from the  $\Delta H$ calculated from tabulated ones and in better agreement with the experimental results.

When  $D_3$  reacts with both  $BCl_3$  and  $GaCl_3$ , the formation of  $GaCl_4$ <sup>-</sup> by Cl transfer from B to Cl upon O-B bond formation is virtually barrierless and thermodynamically favored  $\sim 2 \text{ kcal/mol}$ 10 *via* **TS0-GaB**) with a gain of ~ 4 kcal/mol over the Lewis-adduct. This exchange reaction is driven by boron's preference to form B-O over B-Cl bonds, weakening consequently the (B)O-Si bond and raising the cationic character of the vicinal silicon atoms (*32*). This boron to gallium Cl transfer reaction also impacts the geometry at Si that evolves from tetrahedral to distorted trigonal pyramid.

From this geometry, the Si can undergo an O to Cl exchange mediated by an attack of GaCl4 at both Si apical positions of a transient and hypervalent trigonal bipyramid (**TS1-GaBsyn** and **TS1- GaBanti***, Fig. 5d* & *5e*). The Gibbs energy barrier for the O to Cl exchange is lowered by 6 kcal/mol when Cl and O are *trans* to each other. In contrast to the BCl<sub>3</sub> case, the formation of new B-O 5 bonds continues (**TS<sub>2</sub>-GaB**) at expenses of Cl release by B and transiently captured by GaCl<sub>3</sub>, which weakens again the adjacent O-Si bonds to yield Me<sub>2</sub>SiCl<sub>2</sub> (TS<sub>3</sub>**-GaB**<sub>anti</sub>). Lowering this barrier almost 10 kcal/mol, in comparison to BCl3.

#### **CONCLUSION**

We present a universal chemical depolymerization for all silicone waste, including elastomers with fillers, which represent a substantial fraction (>40%) of post-consumer waste. This strategy advantageously uses the thermodynamic lever of B-Cl / B-O bonds exchange that offsets the supposedly unfavorable Si-O/B-Cl to Si-Cl/B-O conversion by -15 kcal/mol. The side-product of 15 recycling is thus boron oxide  $B_2O_3$ , a raw material oxide for borosilicate glass. Ga catalysis favors the transformation by lowering the activation energy  $\sim$ 10 kcal/mol, which corresponds to a  $\sim$  36million-fold  $(3.6x10<sup>7</sup>)$  kinetic enhancement. The recovered (methyl)chlorosilanes, key industrial intermediates known as MCS in the silicon industry, are then recovered by straightforward distillation. Our method sidesteps the energy-intensive metallurgy and Müller-Rochow process, 20 lowering significantly the carbon footprint of silicone materials when compared to starting anew from native quartz. NMR spectroscopy (observed nuclei:  $^{11}B$ ,  $^{29}Si$ ,  $^{71}Ga$  and  $^{31}P$  to spy the intermediates) analyses allowed us to pinpoint very favorable Ga-catalyzed intermediates (such as [-LB-BCl<sub>2</sub><sup>+</sup>GaCl<sub>4</sub><sup>-</sup>], with LB being a Si-O-Si moiety) and propose a mechanism for the transformation as unveiled by modeling at the DFT level. This work paves the road for the circular 25 economy of silicon.
