Advancing Responsible Genomic Analyses of Ancient Mollusc Shells

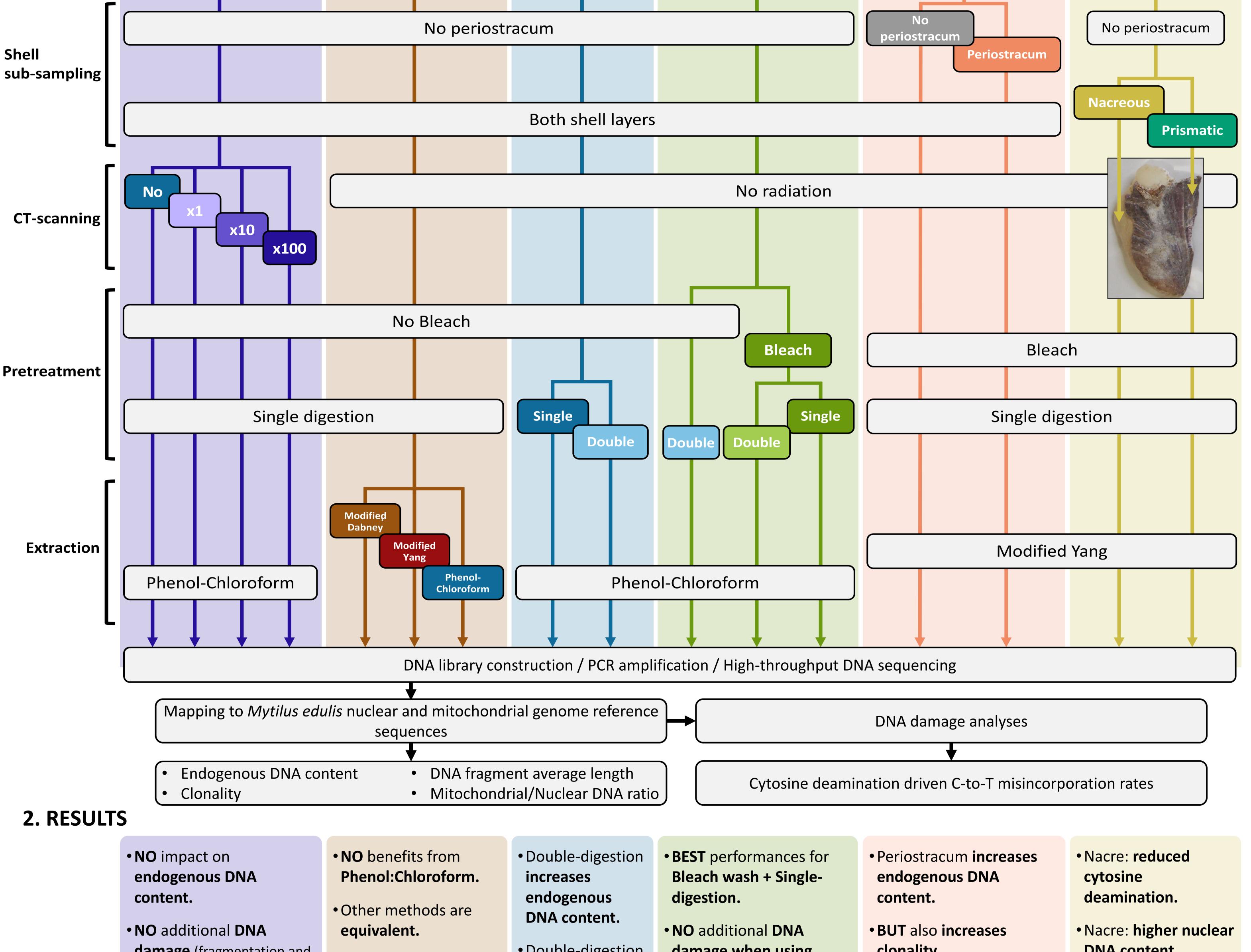

The DNA entrapped in ancient mollusc shells has the potential to shed light on the evolution and ecology of this diverse phylum. It could help reconstruct responses to past climate, aquaculture practices, pollution and extinction events at unprecedented time resolution. Such studies are lacking partly due to our limited knowledge of DNA preservation in calcium carbonate shells and the need for optimizing methods for genomic data generation from ancient shells. Here, we applied high-throughput DNA sequencing to 27 mollusc shells dated to 111-6,500 years Before Present to investigate the impact of micro computed tomography (micro-CT) scanning on ancient shell DNA to preserve morphological information, the performance of commonly used silica-based DNA extraction methods and predigestion treatments, and DNA recovery from the organic (periostracum) and carbonated (aragonite, calcite) mollusc shell layers. We propose recommendations for efficient and responsible genomic analyses of ancient mollusc shells. Micro-CT scans can be used without harming their DNA. Ancient shells' DNA is protected in preservation niches and its recovery was improved by double-digestion and predigestion bleach wash of shell powder. The periostracum, the calcite and the aragonite layers are good DNA reservoirs, the latter appearing as the best substrate for genomic analyses. Our results also give insight on long-term molecular preservation in biominerals.

3. CONCLUSIONS and RECOMMENDATIONS

1. Acquire high-resolution 3D images of ancient mollusc shells prior to destructive DNA analyses. Molluscs shells can be scanned without significant impact on DNA molecules. Document scanning history/parameters to avoid unnecessary scanning. Micro-CT scans are better suited than photogrammetry/surface scans for the preservation of the 3D morphological information of shells. 2. Use silica-based methods for ancient mollusc shell DNA extraction. No differences in performance were observed between protocols. However, 'modified Dabney' protocol is cheaper per sample. 3. Consider pre-digestion treatments for ancient mollusc shell DNA extraction. All pretreatments allowed for increased endogenous DNA recovery from preservation niches within ancient mollusc' shell biominerals. Bleach wash followed by a single digestion step showed the best performance and is a cost effective way to reduce contamination. 4. Use the periostracum as an indicator of good DNA preservation in ancient mollusc shells. Mollusc shell DNA extraction keeping the periostracum layer yielded higher endogenous DNA content. 5. Prefer well-preserved aragonite rather than calcite shell layers for ancient mollusc genomics. The nacreous layer offers better protection to nuclear DNA, likely due to its microsctructure organisation (densely packed aragonite crystals) compared to the prismatic layer (elongated calcite crystals).
