



Not all images are necessarily visual.

Images can also be taken metaphorically.

The transformation and alteration brought about by an image is often consciously, even deliberately, oriented; it is often dictated by ideological preoccupations, thereby acknowledging the particular power of the image, whatever the literal or metaphorical meaning of the word. Produced within an ideological system that necessarily reorients their meaning, images always distort or give a new shape to their sources. This possibility of giving a new form to a reality is what motivates their production.

Introduction

It's also worth noting that there is considerable porosity between the realm of images in the figurative sense, i.e. textual images, and images in the literal sense, i.e. graphic images. A text that results from the projection of a previous text can perfectly well give rise to graphic images that visually confirm the transformation that has taken place.

Images can also be taken metaphorically.

The "real" images discussed in this workshop can be seen as a form of rewriting, as another "text" in relation to a first text.

In the other direction, rewritings, rewritten texts, can be seen as images of another textual reality; in relation to a first text, they can be seen as refractions, or projections.

Each time one or other of these transfers occurs, transformations, modifications and deformations follow.

An image is rarely a "faithful" reproduction of its model.

In the field of text, the question of the image concerns par excellence the question of rewriting.

Translation is a field that has been the subject of a major theoretical effort over the past few decades.

In the wealth of theoretical references, one book deserves particular attention: André Lefevere, *Translation, Rewriting and the Manipulation of Literary Fame*, 1992. What does André Lefevere, 1992, say?

Theoretical references

To conclude these theoretical considerations: my contribution aims to use the concept of image in a figurative, metaphorical sense, that of the projection of a reality onto something that is its double, its reproduction, but which nevertheless differs from it, thus creating an intersemiotic distance.

In the field of text, the question of the image concerns par excellence the question of rewriting.

Our starting point is a seemingly simple question: why does something that has already been written need to be rewritten?


No less simple an answer: because its rewriting says something else.

Rewriting is very close to another paradigm, that of translation; in

fact, rewriting is nothing other than a form of translation.

Translation is a field that has been the subject of a major theoretical effort over the past few decades.

We can refer to a well-known text considered to be at the foundation of translation theory (Translation



We can refer to a well-known text considered to be at the foundation of translation theory (Translation Studies): Roman Jakobson "On Linguistic Aspects of Translation" (1959), in which he says that there are "Three kinds of translation or ways of interpreting a verbal sign"

- Intersemiotic translation or transmutation is an

 - This third type is of particular interest to the theme that brings us together in this workshop,
- as it relates especially to the "translation" of texts into images, paintings, films, stage performances and the like.

In the wealth of theoretical references, one book deserves particular attention: André Lefevere, *Translation, Rewriting and the Manipulation of Literary Fame*, 1992. What does André Lefevere, 1992, say?

"André Lefevere takes up the seminal work of Even-Zohar and Toury [related to polysystems] and redefines their concepts of literary system and norm. Lefevere treats translation, criticism, editing, and historiography as forms of "refraction" or "rewriting." Refractions "carry a work of literature over from one system into another," and they are determined by such factors as "patronage," "poetics," and "ideology."" (Lawrence Venuti 2004, 217).

He makes extensive use of the notion of image, which he borrows from Walter Benjamin ("The Task of the Translator", 1923), to refer to the production of a text on the basis of a previous text, whether in translation or rewriting; he insists that this product, this image, always takes on its meaning in an ideological environment different from the previous one.

He notes the efficiency of these images; the efficiency of an image is often greater than the original, and it is for this very reason that so much effort has gone into creating this image.

"Rewriters—and this includes translators—create "Images of a writer, a work, a period, a genre, sometimes a whole literature. These images existed side by side with the realities they competed with, but the images always tended to reach more people than the corresponding realities did." ... "the power wielded by these images, and therefore by their makers, is enormous." ... "translation is the most obviously recognizable type of rewriting, and... it is potentially the most influential because it is able to project the image of an author and/or a (series of) work(s) in another culture, lifting that author and/or those works beyond the boundaries of their culture of origin." (Lefevere 1992, 8–9).

Concerning the phenomena of rewriting within the same culture, Lefevere speaks of the tendency to update the past in a "modernized" form: once a culture has arrived at a canonized image of its past, it tends to edit out those figures and features of that past that do not fit that image.

We need to pay attention here to the notion of "another culture": André Lefevere is referring in particular to the projection of one language onto another, but this is not exclusive to foreign cultures and different languages.

Lefevere also talks about rewritings that shape the image and reception of a work, author, literature, society in their own culture.

This can be perfectly applied to other types of transculturality, in particular that of one social group towards another group.

And here many things of this type can be observed in the history of Chinese literature, specifically in the vernacular: for example, when knowledge is conveyed from the literate class to new audiences; this is the very justification, in the discourse of the literati, for the desire to write in the vernacular, through modern genres such as the novel or drama.

Lefevere speaks of an "intended audience of the translation" (and of the rewriting), vis-à-vis which the author of a translation or rewriting reshapes the original.

Let's take a very simple example here: the way in which the impact of Xixiang ji 西廂記 has far outstripped that of the text from which it originated, Yuan Zhen's 元稹 (779-831) tale in literary Chinese (chuanqi 傳奇) "Yingying zhuan" 鶯鶯傳 ("The Story of Yingying", aka

"Huizhen ji" 會真記, "Story of an Encounter with an Immortal"); Wang Shifu's 王實甫 play is the product of a succession/conjugation of multiple stages of rewriting. Each rewrite, each reading even, changes the image of a text and its characters: Dong Jieyuan 董解元's Cui Yingying 崔鶯鶯 is not the same as Wang's Shifu 王實甫, which is not the same as Jin Shengtan's 金聖嘆.

This reality is observed in Chinese literary texts, in the numerous cases of interaction (rewriting) between source texts classical (literary) language and target texts in vernacular

Research area: 17th century novels and plays on current events, shishi xiaoshuo 時事小說, shishi (xi)qu 時事(戲)曲

Numerous novels and plays have conveyed knowledge of political facts to new audiences eager to know more about what goes on in ruling circles, in the capital, at court, in high administration, including at the provincial level.

This applies in particular to the late Ming and dynastic transition periods; a number of dominant themes are the subject of narrative texts on "current events"; principally:

This literature has made a major contribution to disseminating knowledge of current events and shaping awareness of the period in a lasting way.

This is also true for future generations: it has formed judgments about people and events, which are often those that remain in the collective memory even today.

This literature does not contradict full-fledged historical sources.

This applies in particular to the late Ming and dynastic transition periods; a number of dominant themes are the subject of narrative texts on "current events"; principally:

- End of the Wanli 萬曆 reign (1573-1620).
- ✓ Issues surrounding the Wanli Taichang 泰昌 (1620)
 Tianqi 天啓 (1620-1627) transition.
- The influence of Donglin 東林.
- Tianqi's reign and grip on state power by Wei

 ✓ Zhongxian 魏忠賢 (1568-1627); victims (mainly Donglin) of the Great Eunuch.
- The Manchu conquest and subsequent establishment of the Qing 清 rule.
- ✓ Wu Sangui 吳三桂 (1612-1678).
- The reign of Hongguang 弘光 in Nanjing (1644-1645), and
 ✓ other Southern Ming 南明 events; reigns of Longwu 隆武 (1645-1646), Yongli (永曆 (1646-1662).
 - The saga of the Zheng 鄭 family, "Coxinga" -
- ✓ Zheng Chenggong 鄭成功 (1624-1662), the coastal/maritime world and Taiwan.

This literature does not contradict full-fledged historical sources.

- Historical and administrative documents : shilu
- ✓ 實錄 (veritable records), dibao 邸報 (official gazettes), shengzhi 聖旨 (imperial edicts).

yeshi 野史

- (privately-initiated history publications).
- Cross-borrowing, constant interaction.
- The desire to rewrite history and influence judgment and posterity.

Numerous novels and plays devoted in whole or in part to him.

Great abundance of sources and "by-products" that rewrite its history and reorient it.

A marked desire to pass judgment on this historic moment and what made it possible.

Methodology: in his case, as in many others, a comparison between historical or para-historical sources and the novelistic narrative reveals the direction the author of the vernacular story wanted to take in order to create a lasting impression on the public.

These novels and plays were often written very soon after the death of Tianqi, the accession of Chongzhen and the death of Wei Zhongxian (as early as 1628).

They contribute to shaping the portrait of Wei Zhongxian.

We often observe a shift from the collective (historical) to the individual (motivations, personal choices, conduct, ethics, etc.).

Case study: stories about Wei Zhongxian 魏忠賢

The formation of a portrayal of Wei Zhongxian

Two related texts:

- Yujing xintan 玉鏡新譚 (before April 1628) by Zhu Changzuo 朱長祚
- Jingshi yinyang meng 警世陰陽夢 (before July 1628) by Chang'an daoren guoqing 長安道人國清

They are probably by the same author.

- The first text is a *yeshi* 野史, a story written in classical language, due to an insider who was undoubtedly very close to the court or even to Wei Zhongxian.
- The second text is a novel, which also purports to present Wei Zhongxian's fate, including his afterlife.

With these two books, we have a very unique case: that of an author successively writing two works, one in literary Chinese, the other in vernacular language, on the same subject.

Many episodes and anecdotes from Wei Zhongxian's life are common to both books.

Yet the way in which the source is used is diverse.

This is without even considering the last 25% of the novel, which deals with the fate of Wei Zhongxian and his accomplices (Cui Chengxiu 崔逞秀, Ke-shi 客氏) after their death.

Situations of convergence between the source and the novel version

Numerous converging narrative situations, including the vernacular transposition of the original text.

Examples: the dream that Wei Zhongxian receives from the local deity as he takes refuge in a temple, the premonitory words of a Taoist as he is about to voluntarily castrate himself.

Example: the episode in which Wei Zhongxian has the audacity to mount a horse in front of the emperor to perform a feat of

horsemanship; in the cavalcade, Wei loses control of his horse and the emperor is frightened; the latter kills the horse with his own arrow and consents not to punish Wei.

Example: the episode in which Wei Zhongxian entertains the emperor with a demonstration of naval maneuvers on a lake; at the end of the day, while disembarking, the emperor falls into the water.

The two examples above, always combined, of the cavalcade and the nautical maneuvers show Wei Zhongxian's hold over the Tianqi emperor, his transgressive character, as well as the system of protection he has been able to put in place, which puts him above everyone else and makes him untouchable.


I wrote above: a text that is the result of the projection of a previous text can perfectly well give rise to graphic images that visually confirm the transformation that has taken place; the images thus

emphasize the episodes or anecdotes considered important; this scene will often remain narrated and represented from one novel or play to the next.





Strangely, there is a wide divergence in the use of historical documents and official sources.

For example *Yujing xintan* 玉鏡新譚 quotes verbatim from imperial decisions/edicts (*shengzhi* 聖旨) 95 times.

Jingshi yijnyang meng 警世陰陽夢 quotes shengzhi's verbatim only twice.

In the novel version, the quotation is edited, and accompanied by developments absent from the original text.

In other situations, certain historical documents are not quoted verbatim in Yujing suntan 玉鏡新譚 whereas they are in Jingshi yinyang meng 警世陰陽夢, but again edited.

Situations of divergence between the source and the novel version

Example: the memoir by censor Yang Lian 楊漣 (1572-1625) accusing Wei Zhongxian of 24 crimes is simply mentioned but not cited in the source; in the novel it is quoted in extenso, but translated into the vernacular, summarized, synthesized, and clearly edited, sometimes with groupings of items (e.g. the fate of imperial concubines murdered or driven to suicide); even censorship effects (he prefers to avoid mentioning the empress's voluntarily induced abortion). What can we learn from these observations?

Rewriting in the vernacular is both a process of disseminating knowledge and a selection of information that amounts to at least partial censorship.

The near-disappearance of official documents such as edicts in the classical source probably reflects, among other reasons, a desire to spare the figure of the emperor (the problem of "fabricated edicts" 矯旨).

At the same time, every effort is made to individualize Wei Zhongxian and decontextualize him from the compromises of others.

By making the details of Wei Zhongxian's journey familiar to the reader, the possibility of identification is opened up: he becomes an individual responsible for his choices, a fearsome counter-example to be pondered on an individual basis.


He is placed in parallel/opposition with other individuals faced with personal ethical choices: the members of Donglin who try to oppose him.

The point is to create a figure of disorder without upsetting the social order by denouncing too much of what made it possible.

The novel (警世陰陽夢, chap. 32) actually lists them, with all the details of their identity, in a synthetic way that is not present in the source in literary language; this is then to reverse the balance of power and place them as judges (in the afterlife) of Wei Zhongxian, whose moral, individual responsibility is asserted.

The pair of texts mentioned here is just one part of a debate that, it is striking to note, has been rapid and intense right from the advent of the Chongzhen emperor, ie, as soon as 1628.

Clearly, there is strong competition between authors to define Wei Zhongxian's image for posterity, based on the information and documents available.

Two main trends.

Between these two trends, debate was intense throughout Chongzhen's reign; then interest in the character began to wane, as other events at the end of the dynasty came to the fore.



Between these two trends, debate was intense throughout Chongzhen's reign; then interest in the character began to wane, as other events at the end of the dynasty came to the fore.

The number of publications from 1628 onwards demonstrates both the competition and the urgency of building a discourse on Wei Zhongxian.

Their rivalry often revolves around the claimed reliability of their sources.

For example Lu Yunlong 陸雲龍, author of Wei Zhongxian xiaoshuo chijianshu 魏忠賢小說斥奸書 claims to draw on numerous *dibao* 邸報 gazettes (in his *fanli* 凡例, he says he has read all those produced since the end of Wanli) and expressly criticizes *Jingshi yinyang Meng*'s 警世陰陽夢 tendencies to introduce supernatural elements.

Example: Lu Yunlong criticizes the inclusion in 玉鏡新譚 and

● 警世陰陽夢 of the tale about the Daoist at the banquet (魏忠賢小說斥奸書, end-of-chapter comment, ch. 27).

Taowu xianping 檮杌閒評 is partly a rewriting of Wei Zhongxian xiaoshuo chijian shu 魏忠賢小說斥奸書, but also its refutation.

The interactions are such that the dividing line between the more or less historical and the more or less supernatural is not at all clear.

Taowu xianping 檮杌閒評, though known for his highly supernatural components/religious fantasy, is remarkably well documented and partly based on rewriting of official documents.

Example: the way he takes from a 邸報 many accurate details

given of the explosion of the gunpowder reserve at the Wanggongchang 王恭廠 (Anminchang 安民廠) arsenal in May 1626.

Gideon Toury, *Descriptive Translation Studies and Beyond*, 1995, says that translation processes (which include rewriting) never go in a single direction, but present a helicoidal progression: there is always a moment when we go backwards, when the projection of an image comes to affect the whole of the knowledge produced by the translation/rewriting process.

Toury borrows the notion of "bi-text" from Brian Harris: a text never comes alone, but is inevitably accompanied by other texts (preceded by, or followed by)

Image and truth (before concluding)

This vision is very much in line with the Chinese tradition of commentary, which has the retrospective effect of affecting every reading: a commentary produces a truth which itself spreads and is in its turn commented upon, encompassing the preceding fields of knowledge; with each new "helicoidal" progression, the image, i.e. the new interpretation of the facts, takes on a little more authority.

This is perhaps, at least in part, an effect of censorship and the scarcity of sources from which to talk about recent/contemporary events, in the context of the conquest of the empire by the new Qing dynasty: there is then a lack of official sources, or a lack of availability of such sources, from which to discuss recent history (think, for example, that the *Ming shi* 明史 would only be completed under Qianlong 乾隆, in 1739!).

Vernacular texts take control of the dissemination of knowledge; their status increases as they evolve from interpretations and images of sources to sources in their own right, themselves debated downstream.

Novels begin to imitate the historical chronicle, and take its place; this can be seen, for example, in one detail: the way events are listed with precise dates: in Wei Zhongxian xiaoshuo chijianshu 魏忠賢小說斥奸書, Qiaoshi yanyi 樵史演義, Taohua shan 桃花扇 for example. (f)

A little later *Taiwan waiji* 臺灣外紀 by Jiang Risheng 江日昇 (舉人 1713) would become (and has remained to this day) the main historical source on Taiwan in the 17th century; its 章回 form is that of the novel; its linguistic form a "light" literary Chinese; its discourse a hagiographic intent vis-à-vis Coxinga and his clan.

A good example is the great historical novel *Qiaoshi tongsu yanyi* 樵史通俗演義 (Vernacular Romance of the Historian Woodcutter, in 40 chapters), by Jiangzuo Qiaozi 江左樵子.

Ji Liuqi reproduces entire passages from the novel, translates it into classical language, includes vernacular passages, and uses it as a source of quotations from official documents such as imperial edicts.



His novelistic/theatrical image has taken precedence over historicity.

There is no connection between the use of historical sources and the greater or lesser "truth" of a work of fiction.

In the field presented here (時事小說/時事戲曲) there is a close interweaving between historical or para-historical sources and novelistic rewritings

But borrowings, quotations and influences go both ways.

As the last case cited, that of Ruan Dacheng, shows, we can certainly confirm André Lefevere's assertion that "Images of a writer, a work, a period, a genre, sometimes a whole literature. These images existed side by side with the realities they competed with, but the images always tended to reach more people than the corresponding realities did.".

Conclusion

It is the destiny of the image to continually refract itself; this is part of the logic of comments calling up other comments in a continuous chain.

With a qualitative change here: the involvement of vernacular culture and expression; this undoubtedly profoundly alters previous commentary habits, because of the new audience that is included as the recipient of the "images" thus formed.

Charles Sanders Peirce (1839-1914): "the meaning of any linguistic sign is its translation into some further, alternative sign" + "a sign is not a sign" — in the linguistic sense — unless it translates itself into another sign in which it is more fully developed" (cf. his influence on Jakobson, quoted above).

The notion of image differs from that of historical document and historical truth:

Intersemiotic distance is also social distance and ideological distancing, with interaction between different sociolects.

The notion of image differs from that of historical document and historical truth:

It enables appropriation and positive or negative identification.

The change in linguistic register brought about by the vernacular opens up even more effective ways of appropriating historical figures.

Thanks to this transformation, we can compare ourselves with images; an ethical issue.
