A Preconditioned Inverse Scattering Scheme for High-Contrast Bone Imaging at Microwave Frequencies

Abstract—This work presents a combined quasi-Helmholtz preconditioning strategy for the contrast source volume integral equation (J-VIE) with a Newton-Kantorovich method allowing 2D microwave imaging for high-contrast scatterers. We show that the preconditioning improves the convergence of the J-VIE, reducing the number of iterations required, even for highly inhomogeneous objects. We demonstrate the practical significance of this preconditioned inverse scattering scheme on a realistic human bone and thigh imaging problem.

I. INTRODUCTION

Microwave imaging (MWI) is a promising technique for imaging biological tissues and offers a low-cost alternative to standard imaging procedures such as magnetic resonance imaging (MRI) and X-ray. When the background medium is already known, a formulation employing volume integral equations (VIE) is advantageous since it allows for the reconstruction of inhomogeneous scatterers without discretizing the background. Among VIE formulations, the contrast source VIE (J-VIE) is the most adopted one since it vields a data equation in the form of an inverse source problem. However, the high permittivity of biological tissues with respect to the background introduces a severe ill-conditioning of the J-VIE and causes a slowdown of iterative solvers, which is often referred to as the high-contrast (HC) breakdown. A regularization technique based on quasi-Helmholtz projectors has been introduced in [1] to rescale the permittivity dependent spectrum of the J-VIE. In this work, we adapt these projectors to a 2D setting with the transverse electric J-VIE (TE J-VIE) and we apply this preconditioner to a Newton-Kantorovich method (NKM) [2] derived for the TE J-VIE. Numerical results will show that these projectors enable handling highcontrast settings and we additionally demonstrate the effectiveness of this novel preconditioned inverse scattering scheme in a realistic bone and thigh imaging problem.

II. NOTATION AND BACKGROUND

Consider a scattering problem in which a transverse electric (TE) time-harmonic incident wave with electric field E_i and the angular frequency ω is scattered in a nonmagnetic inhomogeneous scatterer with arbitrary cross-sectional shape $\Omega \subset \mathbb{R}^2$ and complex permittivity $\epsilon(\mathbf{r})$ ($\mathbf{r} \in \mathbb{R}^2$) embedded in free-space of permittivity ϵ_0 and permeability μ_0 . The TE contrast source volume integral equation relates the inplane contrast source J and E_i as $J - \chi(\nabla \nabla + k_0^2)$.

 $\mathcal{S}(\boldsymbol{J}) = -i\omega\epsilon_0\chi \boldsymbol{E}_{\boldsymbol{i}}$ where $\mathcal{S}(\boldsymbol{F})(\boldsymbol{r}) = \int_{\Omega} G_2(\boldsymbol{r}, \boldsymbol{r}') \boldsymbol{F}(\boldsymbol{r}') \, ds'$, $G_2(\boldsymbol{r}, \boldsymbol{r}') = i/4H_0^1(\boldsymbol{r}, \boldsymbol{r}')$, and k_0 is the wavenumber of $\boldsymbol{E}_{\boldsymbol{i}}$.

We can numerically solve the TE J-VIE by discretizing Ω with N_T triangles having a constant permittivity and expanding the contrast current $\boldsymbol{J} = \boldsymbol{J}^{\boldsymbol{x}} + \boldsymbol{J}^{\boldsymbol{y}}$ as $\boldsymbol{J}^{\boldsymbol{\alpha}}(\boldsymbol{r}) \approx \sum_{m=1}^{N_T} [\boldsymbol{J}]_m^{\alpha} \boldsymbol{f}_m^{\alpha}(\boldsymbol{r})$ in which $\hat{\boldsymbol{\alpha}} = \hat{\boldsymbol{x}}, \hat{\boldsymbol{y}}$. The basis function $\boldsymbol{f}_m^{\alpha}$, which lives in $L^2(\Omega)^2$, is defined as $\boldsymbol{f}_m^{\alpha}(\boldsymbol{r}) = \hat{\boldsymbol{\alpha}} P_m(\boldsymbol{r})$ with $P_m \in L^2(\Omega)$ being a patch defined on triangle T_m . Following a Galerkin procedure as in [1], the continuous TE J-VIE is discretized as $(\boldsymbol{I} - \boldsymbol{\chi} \boldsymbol{G}_S) \boldsymbol{J} = -i\omega\epsilon_0 \boldsymbol{\chi} \boldsymbol{\mathsf{E}}_i$, where $\boldsymbol{\mathsf{G}}_S \in \mathbb{C}^{2N_T \times 2N_T}$, $\boldsymbol{\mathsf{I}} \in \mathbb{R}^{2N_T \times 2N_T}$, $\boldsymbol{\mathsf{J}} \in \mathbb{C}^{2N_T \times 1}, \boldsymbol{\chi} \in \mathbb{C}^{2N_T \times 2N_T}$, and $\boldsymbol{\mathsf{E}}_i \in \mathbb{C}^{2N_T \times 1}$.

We then define the inverse scattering problem based on the discretized state and data equations

$$(\mathbf{I} - \boldsymbol{\chi} \mathbf{G}_{\mathbf{S}}) \mathbf{J} = -\mathrm{i}\omega\epsilon_0 \boldsymbol{\chi} \mathbf{E}_{\mathbf{i}}$$

$$\mathbf{G}_{\mathbf{D}}\mathbf{J} = -\mathrm{i}\omega\epsilon_0\mathbf{E}_{\mathbf{s}},\tag{2}$$

where $\mathbf{G}_{\mathbf{D}} \in \mathbb{C}^{N_A \times 2N_T}$ is the discretized radiation operator and $\mathbf{E}_{\mathbf{s}} \in \mathbb{C}^{N_A \times 1}$ is the measured scattered field with N_A being the number of independent measurements. The aim of this scattering problem is to estimate $\boldsymbol{\chi}$ from the knowledge of $\mathbf{E}_{\mathbf{i}}$ and $\mathbf{E}_{\mathbf{s}}$.

III. NEWTON-KANTOROVICH METHOD FOR THE PRECONDITIONED J-VIE

The first step of this contribution is the preconditioning of the forward problem. Following a similar approach as in [1], we define projection operators to the solenoidal, irrotational and harmonic subspaces as $\mathbf{P}_{\Lambda} = \mathbf{\Lambda}(\mathbf{\Lambda}^T\mathbf{\Lambda})^+\mathbf{\Lambda}^T$, $\mathbf{P}_{\Sigma} = \mathbf{\Sigma}(\mathbf{\Sigma}^T\mathbf{\Sigma})^+\mathbf{\Sigma}^T$, and $\mathbf{P}_H = \mathbf{I} - \mathbf{P}_{\Lambda} - \mathbf{P}_{\Sigma}$, respectively, where ⁺ denotes the Moore-Penrose pseudoinverse. The transformation matrices $\mathbf{\Sigma}$ and $\mathbf{\Lambda}$ are constructed from $[\mathbf{\Sigma}^{\alpha}]_{mn} = \langle f_m^{\alpha}, \nabla b_n \rangle$, with b_n a pyramid function and $\langle f, g \rangle = \int_{\Omega} f(r) \cdot g(r) \, ds$, and $[\mathbf{\Lambda}^{\alpha}]_{mn} = \langle f_m^{\alpha}, \hat{z} \times \nabla b_n \rangle$, which are the transformation matrices from irrotational and solenoidal functions to the piecewise constant basis functions $f_m^{\alpha}(r)$.

In the framework of the inverse scattering problems the imaging object is in general inhomogeneous and the details of its internal structure are unkown. Therefore we build a preconditioning operator as in [1], using instead the average relative permittivity $\tilde{\epsilon}$

$$\mathbf{P} = \mathbf{P}_{\Lambda} + \mathbf{P}_{\Sigma}\tilde{\epsilon}^{-1} + \mathbf{P}_{H}2(\tilde{\epsilon}+1)^{-1}, \qquad (3)$$

yielding the preconditioned equation

$$\mathbf{P}\left(\mathbf{I} - \boldsymbol{\chi}\mathbf{G}_{\mathbf{S}}\right)\mathbf{P}\mathbf{Y} = -\mathrm{i}\omega\epsilon_{0}\mathbf{P}\boldsymbol{\chi}\mathbf{E}_{\mathbf{i}},\tag{4}$$

where $\mathbf{PY} = \mathbf{J}$. The reduction of the condition number enforced by this preconditioning operation allows for a faster convergence of the iterative method employed to solve (1), as shown in Fig.2 where the forward problem is solved on an inhomogeneous disk with ϵ_r randomly distributed in an interval $\Delta \epsilon = |\epsilon_{max} - \epsilon_{min}|$.

A. The Preconditioned Newton-Kantorovich Method

We then employ the NKM to solve the data and preconditioned state equations. This method is based on the minimization of a residual cost functional derived by applying a first order perturbation to the contrast χ . The equations that describe the preconditioned NKM are

$$\boldsymbol{\chi}_{n+1} = \boldsymbol{\chi}_n + \boldsymbol{\delta}\boldsymbol{\chi} \tag{5}$$

$$\delta \chi = \arg \min \| \boldsymbol{\rho}_n - \mathbf{G}_{\mathsf{S}} \mathsf{P} \mathbf{L}_n^{-1} \mathsf{P} \delta \chi \mathsf{P} \tilde{\boldsymbol{L}}_n^{-1} \mathsf{P} \mathsf{E}_{\mathsf{i}} \|^2, \quad (6)$$

where χ_n is the contrast at the n-*th* step, χ_0 is the initial guess, ρ_n is the difference between \mathbf{E}_s and the computed scattered field at iteration n, $\mathbf{L}_n = \mathbf{P}(\mathbf{I} - \chi_n \mathbf{G}_{\mathbf{D}})\mathbf{P}$, and $\tilde{\mathbf{L}}_n = \mathbf{P}(\mathbf{I} - \mathbf{G}_{\mathbf{D}}\chi_n)\mathbf{P}$. The preconditioning operator \mathbf{P} is computed using the initial homogeneous guess χ_0 . To reduce the ill-posedness of the problem, we further regularize it using a Tikhonov regularization, which adds an extra term proportional to $\|\delta\chi\|^2$ to (6), hence enforcing the minimization of the norm of $\delta\chi$.

IV. APPLICATION TO BONE IMAGING

In this final section we use our method on a realistic biomedical imaging problem in which the geometry is obtained from an MRI of a human thigh (Fig. 1a). The scattered field used as measured data is computed on a circle around the object ($N_A = 60$) using an incident field oscillating at 0.5 GHz from 10 independent sources and a mesh with three layers corresponding to the skin/fat, the muscle, and the bone with $\epsilon_r = \{30 - 25i, 50 - 29i, 10 - 4i\}$ (from the outer layer to the inner one), depicted in Fig. 1b. Subsequently,

the reconstruction of the image is performed using the homogeneous coarser mesh shown in Fig.1c. We obtain a good reconstruction of the image both in shape and values of ϵ_r , as shown in Fig.1d. Moreover, the preconditioner reduces the total computational time by a factor of almost 4 with respect to the non-preconditioned case, showing the benefit of HC regularization in this realistic scenario.
