Homological smoothness of Hopf-Galois extensions

Abstract

We show that if H is a Hopf algebra with bijective antipode and $B \subset A$ is a faithfully flat H-Galois extension, then A is homologically smooth if H and B are.

1 Introduction

An algebra A is said to be homologically smooth if A admits, as an A-bimodule, a finite length resolution by finitely generated projective A-bimodules. Homological smoothness is an appropriate analogue of regularity for (noncommutative) algebras, and is the basic condition involved in homological duality questions for algebras, see [3, 17, 18, 8]. The aim of this paper is to provide a result that produces new examples of homologically smooth algebras, in the setting of Hopf-Galois extensions, the analogue of principal bundles in noncommutative algebra.

Recall [10] that if H is a Hopf algebra and A is a H-comodule algebra, the algebra extension $A^{\operatorname{co} H} \subset A$ is said to be an H-Galois extension if a certain canonical map $\beta : A \otimes_B A \to A \otimes H$ is bijective, see Section 3. This framework includes examples of various nature such as Hopf crossed products [12] or exact sequences of Hopf algebras [1] (in particular exact sequences of groups).

In this setting, our main result is as follows:

Theorem 1.1. Let H be a Hopf algebra with bijective antipode and let $B \subset A$ be an H-Galois extension such that A is faithfully flat as left and right B-module. If H and B are homologically smooth algebras, then A is homologically smooth as well.

Similar results were known to be true in some particular cases, notably in the setting of twisted Calabi-Yau algebras: the case of Galois objects (i.e. for B = k) was done by Yu [21] and smash products of algebras by Hopf algebras were studied by Le Meur [11].

The main ingredients to prove Theorem 1.1 are

- 1. Stefan's spectral sequences [16] for Hopf-Galois extensions;
- 2. a smoothness criterion using Tor due to Bieri-Eckmann [2], which seems to have been slightly forgotten in the recent literature.

The paper is organized as follows. Section 2 consists of preliminaries about homological finiteness of modules and reminders about Hochschild cohomology. In section 3 we recall the definition of Hopf-Galois extensions and we introduce Stefan's spectral sequences. Section 4 is devoted to the proof of Theorem 1.1 and in the final Section 5, we present an illustrating example of Theorem 1.1.

Notations. Throughout the paper, we work over a field k, and all algebras are (unital) k-algebras. If A is an algebra, the opposite algebra is denoted A^{op} and the enveloping algebra $A \otimes A^{op}$ is denoted A^e . The category of right (resp. left) A-modules is denoted \mathcal{M}_A (resp. $_A\mathcal{M}$). We have $\mathcal{M}_A = _{A^{op}}\mathcal{M}$, hence any definition we give for left modules has an obvious analogue for right modules, that we will not necessarily give. An A-bimodule structure is equivalent to a left (or right) A^e -module structure. Indeed, if M is an A-bimodule, a left (resp. right) A^e -module structure on M is defined by

$$(a \otimes b) \cdot m = amb$$
 (resp. $m \cdot (a \otimes b) = bma$) for $a, b \in A$ and $m \in M$.

The category of A-bimodule is thus identified with the category \mathcal{M}_{A^e} , or with the category $_{A^e}\mathcal{M}$.

If M and N are left A-modules, Ext spaces ([20]) are denoted $\operatorname{Ext}_{A}^{\bullet}(M, N)$ and if P is a right A-module Tor spaces are denoted $\operatorname{Tor}_{\bullet}^{A}(P, M)$. We will also need to consider Ext spaces in categories of right modules, which we denote $\operatorname{Ext}_{A^{op}}^{\bullet}(-, -)$.

If H is a Hopf algebra, its comultiplication, counit and antipode are denoted Δ , ε and S and we will use Sweedler notation in the usual way, i.e. for $h \in H$, we write $\Delta(h) = h_{(1)} \otimes h_{(2)}$. See [12].

2 Homological preliminaries

In this section we recall the various homological ingredients needed in the paper.

Definition 2.1. Let A be an algebra. The projective dimension of an A-module M is defined by

 $\operatorname{pdim}_A(M) := \min \{ n \in \mathbb{N}, M \text{ admits a length } n \text{ resolution by projective } A \text{-modules} \} \in \mathbb{N} \cup \{\infty\}.$

The projective dimension can as well be characterized by

$$pdim_A(M) = \min \left\{ n \in \mathbb{N}, \ \text{Ext}_A^{n+1}(M, N) = \{0\} \text{ for any } A\text{-module } N \right\}$$
$$= \max \left\{ n \in \mathbb{N}, \ \text{Ext}_A^n(M, N) \neq \{0\} \text{ for some } A\text{-module } N. \right\}$$

We now recall various finiteness conditions on modules.

Definition 2.2. Let A be an algebra and let M be an A-module.

- 1. The A-module M is said to be of type FP_{∞} if it admits a projective resolution $P_{\bullet} \to M$ with P_i finitely generated for all *i*.
- 2. The A-module M is said to be of type FP if it admits a finitely generated projective resolution of finite length.

The following result characterizes modules of type FP among those of type FP_{∞} , see e.g [5, Chapter VIII].

Proposition 2.3. Let A be an algebra. An A-module M is of type FP if and only if it is of type FP_{∞} and $pdim_A(M)$ is finite. In this case we have

$$\operatorname{pdim}_{A}(M) = \max \left\{ n \in \mathbb{N}, \operatorname{Ext}_{A}^{n}(M, A) \neq \{0\} \right\}$$

The following result is [2, Corollary 1.6]. The implication (iii) \Rightarrow (i) is due to Bieri-Eckmann [4], and gives an effective condition to check that a module is of type FP_{∞} and will be useful in section 4.

Proposition 2.4. Let A be an algebra and M a left (resp. right) A-module. The following conditions are equivalent:

- (i) The left (resp. right) A-module M is of type FP_{∞} ;
- (ii) For any direct product $\prod_{i \in I} N_i$ of right (resp. left) A-modules, the natural map $\operatorname{Tor}_k^A(\prod_{i \in I} N_i, M) \to \prod_{i \in I} \operatorname{Tor}_k^A(N_i, M)$ (resp. $\operatorname{Tor}_k^A(M, \prod_{i \in I} N_i) \to \prod_{i \in I} \operatorname{Tor}_k^A(M, N_i)$ is an isomorphism for all $k \geq 0$;
- (iii) For any direct product $\prod A$ of arbitrary many copies of A, we have $\operatorname{Tor}_{i}^{A}(\prod A, M) = 0$ (resp. $\operatorname{Tor}_{i}^{A}(N, \prod A) = 0$) for $i \geq 1$ and the natural map $(\prod A) \otimes_{A} M \to \prod M$ (resp. $M \otimes_{A} (\prod A) \to \prod M$) is an isomorphism.

There are similar results for Ext functors, but will only use the following particular instance.

Proposition 2.5. Let A be an algebra and M a right (resp. left) A-module, if M is of type FP_{∞} then $\operatorname{Ext}_{A^{op}}(M, -)$ (resp. $\operatorname{Ext}_{A}(M, -)$) commutes with direct sums.

Those above general homological finiteness notions specify to the case of bimodules which is our case of interest when considering Hochschild (co)homology.

Definition 2.6. Let A be an algebra.

- 1. The cohomological dimension of A is defined to be $cd(A) := pdim_{A^e}(A)$.
- 2. The algebra A is said to be homologically smooth if A is of type FP as a left A^e -module.
- 3. Let M an A-bimodule. The Hochschild cohomology spaces of A with coefficients in M are the vector spaces $\operatorname{HH}^{\bullet}(A, M) := \operatorname{Ext}_{A^{e}}^{\bullet}(A, M)$. The Hochschild homology spaces of A with coefficients in M are the vector spaces $\operatorname{HH}_{\bullet}(A, M) := \operatorname{Tor}_{\bullet}^{A^{e}}(M, A)$.

Notice that if A is a homologically smooth algebra, then $cd(A) = \max\{n \in \mathbb{N}, HH^n(A, A^e) \neq 0\}$, by Proposition 2.3.

We finally record that if A = H is a Hopf algebra, homological smoothness can be expressed using *H*-modules rather than *H*-bimodules.

Theorem 2.7. [19, Proposition A.2] Let H be a Hopf algebra. The following assertions are equivalent:

- (i) The algebra H is homologically smooth;
- (ii) The right H-module k_{ε} is of type FP;
- (iii) The left H-module εk is of type FP.

3 Hopf-Galois extensions

3.1 Definitions and examples

Recall that if H is a Hopf algebra, an H-comodule algebra is an algebra A together with an algebra map $\rho: A \to A \otimes H$ making it into an H-comodule.

Definition 3.1. Let *H* be a Hopf algebra. An *H*-comodule algebra *A* is said to be an *H*-Galois extension of $B := A^{\text{co}H} = \{a \in A, a_{(0)} \otimes a_{(1)} = a \otimes 1\}$ if the (canonical) map

$$\begin{array}{ccc} \beta : & A \otimes_B A \longrightarrow A \otimes H \\ & a \otimes_B b \longmapsto ab_{(0)} \otimes b_{(1)} \end{array}$$

is bijective. An H-Galois extension of the base field k is called an H-Galois object.

An overview of the theory of Hopf-Galois extensions can be found in [13]. We now list a number of important examples.

Example 3.2. Let H be a Hopf algebra. Then H is an H-Galois object, with the right H-comodule structure given by the comultiplication.

Example 3.3. Let G be a group and let A a G-graded algebra, i.e. an algebra with a decomposition $A = \bigoplus_{g \in G} A_g$ such that $A_g A_h \subset A_{gh}$ for any $g, h \in G$ and $1 \in A_e$, where e denotes the neutral element of G. The G-grading makes A into a kG-comodule algebra, and $A_e \subset A$ is a kG-Galois extension if

and only if A is G-strongly graded, which means that $A_g A_h = A_{gh}$ for any $g, h \in G$.

In that case, the inverse of β is given by

$$\beta^{-1}(a \otimes g) = \sum_{i} ac_i \otimes_{A_e} d_i \text{ for } a \in A, g \in G$$

where $c_i \in A_{g^{-1}}$ and $d_i \in A_g$ are elements such that $\sum_i c_i d_i = 1$.

Example 3.4. Let H be a Hopf algebra and let B be a left H-module algebra, i.e. B is a left H-module with $h \cdot (ab) = (h_{(1)} \cdot a)(h_{(2)} \cdot b)$ and $h.1 = \varepsilon(h)1$ for any $h \in H$, $a, b \in B$. Let A be the smash product algebra $B \ddagger H$. Then A is an H-Galois extension of B where the H-comodule structure on A is given by

$$a \sharp h \mapsto (a \sharp h_{(1)}) \otimes h_{(2)}$$

and the inverse of β is

$$\beta^{-1}: (B\#H) \otimes H \longrightarrow (B\#H) \otimes_B (B\#H)$$
$$(a\#h) \otimes k \longmapsto (a\#hS(k_{(1))}) \otimes_B (1\#k_{(2)})$$

Example 3.5. Let $p: A \to H$ be a surjective Hopf algebra map. Then p induces a right H-comodule algebra structure on A, given by $a \mapsto a_{(1)} \otimes p(a_{(2)})$. Let $B = A^{\operatorname{co} H}$. If $B^+A = \operatorname{Ker}(p)$, then $B \subset A$ is an H-Galois extension, with the inverse of the canonical map β being given by

$$\beta^{-1}: A \otimes H \longrightarrow A \otimes_B A$$
$$a \otimes p(a') \longmapsto aS(a'_{(1)}) \otimes_B a'_{(2)}$$

Recall [1] that a sequence of Hopf algebra maps

$$k \longrightarrow B \xrightarrow{i} A \xrightarrow{p} H \longrightarrow k$$

is said to be exact if the following conditions hold:

- (1) i is injective and p is surjective,
- (2) $\operatorname{Ker}(p) = i(B)^+ A = Ai(B)^+,$

 $(3) \quad i(B) = A^{coH} = {}^{coH}A,$

where $A^{coH} = \{a \in A, a_{(1)} \otimes p(a_{(2)}) = a \otimes 1\}$ and ${}^{coH}A = \{a \in A, p(a_{(1)}) \otimes a_{(2)} = 1 \otimes a\}$. Exact sequences of groups correspond to exact sequences of their group algebras.

Hence, if $k \longrightarrow B \xrightarrow{i} A \xrightarrow{p} H \longrightarrow k$ is an exact sequence of Hopf algebras, then by the previous consideration we have that A is an H-Galois extension of i(B) where the H-comodule structure on A is given by $a \mapsto a_{(1)} \otimes p(a_{(2)})$.

Remark 3.6. Let $B \subset A$ be an *H*-Galois extension. Since the canonical map is left *A*-linear, its inverse is uniquely determined by $\kappa : H \to A \otimes_B A$ defined by $\kappa(h) = \beta^{-1}(1 \otimes h)$. Denoting $\kappa(h) = h^{\langle 1 \rangle} \otimes_B h^{\langle 2 \rangle}$, the following identities, which we will not use directly but are essential for some constructions in the next subsection, are [15, Remark 3.4]:

$$bh^{\langle 1 \rangle} \otimes_B h^{\langle 2 \rangle} = h^{\langle 1 \rangle} \otimes_B h^{\langle 2 \rangle} b, \quad a_{(0)} a_{(1)}^{\langle 1 \rangle} \otimes_B a_{(1)}^{\langle 2 \rangle} = 1 \otimes_B a, \quad h^{\langle 1 \rangle} h^{\langle 2 \rangle} = \varepsilon(h)$$

$$h^{\langle 1 \rangle} \otimes_B (h^{\langle 2 \rangle})_{(0)} \otimes (h^{\langle 2 \rangle})_{(1)} = h_{(1)}^{\langle 1 \rangle} \otimes_B h_{(1)}^{\langle 2 \rangle} \otimes h_{(2)},$$

$$(h^{\langle 1 \rangle})_{(0)} \otimes_B h^{\langle 2 \rangle} \otimes (h^{\langle 1 \rangle})_{(1)} = h_{(2)}^{\langle 1 \rangle} \otimes_B h_{(2)}^{\langle 2 \rangle} \otimes S(h_{(1)})$$

$$(hk)^{\langle 1 \rangle} \otimes_B (hk)^{\langle 2 \rangle} = k^{\langle 1 \rangle} h^{\langle 1 \rangle} \otimes_B h^{\langle 2 \rangle} k^{\langle 2 \rangle}$$

3.2 The Stefan spectral sequences

The fundamental tool that we will use in the proof of Theorem 1.1 is the Stefan spectral sequence, constructed in [16] by using the Grothendieck spectral sequence.

It involves a right (resp. left) *H*-module structures on the cohomology spaces $\operatorname{HH}^q(B, M)$ (resp. on the homology spaces $\operatorname{HH}_q(B, M)$) for $q \ge 0$ and any *A*-bimodule *M* defined in [16]. For q = 0, the *H*-action on $\operatorname{HH}^0(B, M) \simeq M^B$ is given by $m \cdot h = h^{\langle 1 \rangle} m h^{\langle 2 \rangle}$ for $m \in M^B$ and $h \in H$ and it is extended to $q \ge 0$ using the machinery of cohomological functors [5, Theorem 7.5]. In [7], explicit formulas are given for $q \ge 0$ in the case of a smash product.

For q = 0, the *H*-action on $HH_0(B, M) \simeq M/[M, B]$ is given by $h \cdot \pi_M(m) = \pi_M \left(h^{\langle 2 \rangle} m h^{\langle 1 \rangle} \right)$ for $m \in M$ and $h \in H$, where π_M denotes the natural projection of M onto M/[M, B].

Theorem 3.7 ([16]). Let H be a Hopf algebra, let $B \subset A$ be an H-Galois extension and let M be an A-bimodule.

(i) Assume that A is flat as left and right B-module. Then there is a spectral sequence

$$E_2^{p,q} = \operatorname{Ext}_{H^{op}}^p(k_{\varepsilon}, \operatorname{HH}^q(B, M)) \implies \operatorname{HH}^{p+q}(A, M)$$

which is natural in M.

(ii) Assume that A is projective as left and right B-module. Then there is a spectral sequence

$$E_{p,q}^2 = \operatorname{Tor}_p^H(k_{\varepsilon}, \operatorname{HH}_q(B, M)) \implies \operatorname{HH}_{p+q}(A, M)$$

which is natural in M.

As explained in [16], the above spectral sequences are natural generalizations of the usual Lyndon-Hochschild-Serre spectral sequences in group or Lie algebra (co)homology. Remark 3.8. It is shown in [14, Theorem 4.10] that if H is a Hopf algebra with bijective antipode, and $B \subset A$ an H-Galois extension with A faithfully flat as a left and right B-module, then A is projective as a left and right B-module. Thus, in order to invoke one of the above spectral sequences, we can indifferently assume projectivity or faithful flatness for an H-Galois extension $B \subset A$.

Remark 3.9. In [16], the homology spaces $\operatorname{HH}_{\bullet}(A, M)$ are defined as the spaces $\operatorname{Tor}_{\bullet}^{A^{e}}(A, M)$ for A an algebra and M an A-bimodule. This is equivalent to Definition 2.6, indeed, if P is an A-bimodule, we have $M \otimes_{A^{e}} P \simeq P \otimes_{A^{e}} M$ hence, the complexes defining $\operatorname{Tor}_{\bullet}^{A^{e}}(M, A)$ and $\operatorname{Tor}_{\bullet}^{A^{e}}(A, M)$ are isomorphic, hence their homology are and $\operatorname{Tor}_{\bullet}^{A^{e}}(M, A) \simeq \operatorname{Tor}_{\bullet}^{A^{e}}(A, M)$.

4 Smoothness of Hopf-Galois extensions

This section is dedicated to the proof of our main theorem. We begin with a result on finiteness of the cohomological dimension.

Proposition 4.1. Let H be a Hopf algebra with bijective antipode and let $B \subset A$ be an H-Galois extension such that A is flat as left and right B-module. We have $cd(A) \leq cd(B) + cd(H)$, and hence if cd(B) and cd(H) are finite, so is cd(A).

Proof. Under those assumptions, we can use Theorem 3.7. Thus, for every A-bimodule M, we get a spectral sequence

$$E_2^{pq} = \operatorname{Ext}_{H^{op}}^p(k_{\varepsilon}, \operatorname{HH}^q(B, M)) \implies \operatorname{HH}^{p+q}(A, M).$$

If $\operatorname{cd}(B)$ or $\operatorname{cd}(H)$ is infinite, there is nothing to show, so we assume that these are finite. For $p > \operatorname{cd}(H)$ or $q > \operatorname{cd}(B)$, we have $E_2^{pq} = \{0\}$. Now, if we denote $d_2^{p,q} : E_2^{pq} \to E_2^{p+2,q-1}$ the differential on the second page of the spectral sequence, we get that for $p > \operatorname{cd}(H)$ or $q > \operatorname{cd}(B)$ the maps $d_2^{p,q} : E_2^{p,q} \to E_2^{p+2,q-1}$ and $d_2^{p-2,q+1} : E_2^{p-2,q+1} \to E_2^{p,q}$ are both 0 hence $\{0\} = E_2^{p,q} \simeq E_3^{p,q} \simeq .. \simeq \operatorname{HH}^{p+q}(A, M)$. We obtain that $\operatorname{HH}^n(A, M) = \{0\}$ for $n > \operatorname{cd}(B) + \operatorname{cd}(H)$, and hence $\operatorname{cd}(A) \leq \operatorname{cd}(H) + \operatorname{cd}(B)$.

Proof of Theorem 1.1. Let H be a Hopf algebra with bijective antipode and let $B \subset A$ be an H-Galois extension. We assume that A is faithfully flat as left and right B-module and that H and B are homologically smooth algebras. We know from Proposition 4.1 that A has finite cohomological dimension, hence to prove that A is homologically smooth, it remains to prove, by Proposition 2.3, that A is of type FP_{∞} as an A-bimodule.

To prove that A is of type FP_{∞} as an A-bimodule, we will use the characterization of Proposition 2.4, and hence we consider the A-bimodule $M = \prod A^e$ where \prod is an arbitrary direct product. We have to show that for $n \geq 1$, one has $HH_n(A, M) = 0$ and that $HH_0(A, M) \simeq \operatorname{Tor}_0^{A^e}(M, A) \simeq (\prod A^e) \otimes_{A^e} A \simeq \prod A \simeq \prod \operatorname{Tor}_0^{A^e}(A^e, A) \simeq \prod HH_0(A, A^e).$

Under the hypothesis that A is faithfully flat as a right and left B-module and regarding Remark 3.8, we can use Theorem 3.7 (ii). Thus, for every A-bimodule M we get a spectral sequence

$$E_{pq}^2 = \operatorname{Tor}_p^H(k_{\varepsilon}, \operatorname{HH}_q(B, M)) \implies \operatorname{HH}_{p+q}(A, M).$$

The algebra B is of type FP_{∞} as a left B^e -module hence $\operatorname{HH}_q(B, -) = \operatorname{Tor}_q^{B^e}(-, B)$ commutes with direct products. Moreover, A^e is flat as a left and right B^e -module [16, Lemma 2.1] thus for $q \ge 1$, we get that

$$\operatorname{HH}_q(B, \prod A^e) \simeq \prod \operatorname{HH}_q(B, A^e) = \{0\}.$$

Hence we have $E_{pq}^2 = \{0\}$ for q > 0.

If π_M (resp. π_{A^e}) denotes the natural projection of M (resp. A^e) onto $\operatorname{HH}_0(B, M) \simeq M/[M, B]$ (resp. $\operatorname{HH}_0(B, A^e) \simeq A^e/[A^e, B]$), the natural isomorphism $\mu : \operatorname{HH}_0(B, M) \to \prod \operatorname{HH}_0(B, A^e)$ is given by $\mu(\pi_M((x_i \otimes y_i)_i)) = (\pi_{A^e}(x_i \otimes y_i))_i$ for any $x_i, y_i \in A$. Hence, for $h \in H$, we have

$$\mu(h \cdot \pi_M((x_i \otimes y_i)_i)) = \mu(\pi_M((h^{\langle 2 \rangle} x_i \otimes y_i h^{\langle 1 \rangle})_i)) = (\pi_{A^e}(h^{\langle 2 \rangle} x_i \otimes y_i h^{\langle 1 \rangle}))_i = h \cdot \left(\left(\pi_{A^e}(x_i \otimes y_i) \right)_i \right).$$

The natural isomorphism $HH_0(B, M) \simeq \prod HH_0(B, A^e)$ is thus an isomorphism of *H*-modules. Therefore, since the algebras *B* and *H* are homologically smooth, we get, using Proposition 2.4, for $p \ge 0$

$$E_{p0}^{2} = \operatorname{Tor}_{p}^{H}(k_{\varepsilon}, \operatorname{HH}_{0}(B, M)) \simeq \operatorname{Tor}_{p}^{H}(k_{\varepsilon}, \prod \operatorname{HH}_{0}(B, A^{e})) \simeq \prod \operatorname{Tor}_{p}^{H}(k_{\varepsilon}, \operatorname{HH}_{0}(B, A^{e})).$$

The A^e -module A^e is projective, hence [16, Proposition 4.4] ensures that

$$\operatorname{Tor}_p^H(k_{\varepsilon}, \operatorname{HH}_0(B, A^e)) = \{0\} \text{ for } p \ge 1.$$

Hence for $p \ge 1$ we have

$$E_{p,0}^2 = \operatorname{Tor}_p^H(k_{\varepsilon}, \operatorname{HH}_0(B, M)) \simeq \prod \operatorname{Tor}_p^H(k_{\varepsilon}, \operatorname{HH}_0(B, A^e)) = \{0\}$$

We get that $E_{p,q}^2 = \operatorname{Tor}_p^H(k_{\varepsilon}, \operatorname{HH}_q(B, M)) = \{0\}$ for $(p,q) \neq (0,0)$, and hence the spectral sequence ensures that $\operatorname{HH}_n(A, M) = \{0\}$ for n > 0.

Finally, using [16, Proposition 4.2], that k_{ε} is of type FP_{∞} as a right *H*-module and that *B* is smooth, we obtain

$$\operatorname{HH}_{0}(A, \prod A^{e}) \simeq \operatorname{Tor}_{0}^{H}(k_{\varepsilon}, \operatorname{HH}_{0}(B, \prod A^{e}))$$
$$\simeq \operatorname{Tor}_{0}^{H}(k_{\varepsilon}, \prod \operatorname{HH}_{0}(B, A^{e}))$$
$$\simeq \prod \operatorname{Tor}_{0}^{H}(k_{\varepsilon}, \operatorname{HH}_{0}(B, A^{e}))$$
$$\simeq \prod \operatorname{HH}_{0}(A, A^{e}).$$

It is not difficult to check that the above isomorphism is the natural map μ in the third item of Proposition 2.4, the first an last isomorphism being explicit from [16, Proposition 4.2], and the second and third one being obtained from the natural respective maps μ as well. We thus conclude from Proposition 2.4 that A is homologically smooth.

Remark 4.2. In the situation of Theorem 1.1, we have seen that $cd(A) \leq cd(B) + cd(H)$. We have not been able to show that the equality cd(A) = cd(B) + cd(H) holds in general, although we suspect it does. It holds in the case of Galois objects [21], of smash products [11], and in the case of exact sequences of Hopf algebras, as we will show in a forthcoming paper.

5 An example

We finish the paper by presenting an illustrative example.

Definition 5.1. Let B be a commutative k-algebra, let $b \in B$ and let $q \in k^{\times}$ with $q^2 \neq 1$. The k-algebra $U_q^{B,b}$ is defined by

$$U_q^{B,b} = B\left\langle g, \ g^{-1}, \ e, \ f \ \Big| \ eg = q^{-2}ge, \ gf = q^{-2}fg, \ ef - fe = bg - \frac{1}{q - q^{-1}}g^{-1}\right\rangle$$

When B = k and $b = (q + q^{-1})^{-1}$, the algebra $U_q^{B,b}$ is the quantized enveloping algebra $U_q(\mathfrak{sl}_2)$.

Proposition 5.2. If B is an homologically smooth commutative algebra, then $U_q^{B,b}$ is as well homologically smooth, with $\operatorname{cd}(U_q^{B,b}) \leq \operatorname{cd}(B) + 3$.

Proof. Recall that denoting E = e, K = g and F = f, the algebra $U_q(\mathfrak{sl}_2)$ has a Hopf algebra structure defined by

$$\Delta(E) = 1 \otimes E + E \otimes K, \ \Delta(F) = K^{-1} \otimes F + F \otimes 1, \ \Delta(K) = K \otimes K,$$
$$S(E) = -EK^{-1}, \ S(F) = -KK, \ S(K) = K^{-1}, \ \varepsilon(E) = \varepsilon(F) = 0, \ \varepsilon(K) = 1$$

More generally, $U_q^{B,b}$ is a right $U_q(\mathfrak{sl}_2)$ -comodule algebra with $\rho(a) = a \otimes 1$ for any $a \in B$, $\rho(g) = g \otimes K$, $\rho(e) = e \otimes K + 1 \otimes E$, $\rho(f) = f \otimes 1 + g^{-1} \otimes F$. It is shown in [9, Lemma 16] that $B \subset U_q^{B,b}$ is a cleft (hence in particular free) $U_q(\mathfrak{sl}_2)$ -Galois extension. Hence combining [6, Proposition 3.2.1] (for $\mathfrak{g} = \mathfrak{sl}_2$), Proposition 4.1 and Theorem 1.1, we obtain the announced result.
