## A SIR epidemic model on a refining spatial grid II-Central limit theorem

#### Abstract

A stochastic SIR epidemic model taking into account the heterogeneity of the spatial environment is constructed. The deterministic model is given by a partial differential equation and the stochastic one by a space-time jump Markov process. The consistency of the two models is given by a law of large numbers. In this paper, we study the deviation of the spatial stochastic model from the deterministic model by a functional central limit theorem. The limit is a distribution-valued Ornstein-Uhlenbeck Gaussian process, which is the mild solution of a stochastic partial differential equation.

## 1 Introduction

A stochastic spatial model of epidemic has been described by N'zi et al. (2021) to study the oubreak of infectious diseases in a bounded domain. Such a model takes into account heterogeneity, spatial connectivity and movement of individuals, which play an important role in the spread of the infectious diseases. It is based on the compartmental SIR model of Kermack and Mckendrick (1927). Let us summarize the results in N'zi et al. (2021) in the case of one dimensional space.

Consider a deterministic and a stochastic SIR model on a grid  $D_{\varepsilon}$  of the torus  $\mathbb{T}^1 = [0,1)$  with migration between neighboring sites (two neighboring sites are at distance  $\varepsilon$  apart,  $\varepsilon^{-1} \in \mathbb{N}^*$ ). Let  $S_{\varepsilon}(t, x_i)$  (resp.  $I_{\varepsilon}(t, x_i)$ , resp.  $R_{\varepsilon}(t, x_i)$ ) be the proportion of the total population which is both susceptible (resp. infectious, resp. removed) and located at site  $x_i$  at time  $t$ . The dynamics of susceptible , infected and removed individuals at each site can be expressed as

 $\Delta_{\varepsilon}$  is the discrete Laplace operator defined as follows

The rates  $\beta : [0,1] \longrightarrow \mathbb{R}_+$  and  $\alpha : [0,1] \longrightarrow \mathbb{R}_+$  are continuous periodic functions, and  $\mu_S$ ,  $\mu$ *I* and  $\mu$ <sup>*R*</sup> are positive diffusion coefficients for the susceptible, infectious and removed subpopulations, respectively.  $\Delta$ 

In what follows, we use the notations

where  $\Delta = \frac{\partial^2}{\partial x^2}$  $\frac{\partial}{\partial x^2}$ . In the sequel, we set **X** := (**s**, **i**, **r**)<sup>T</sup>. Let  $N$  be the total population size. The stochastic version of  $(1)$  is given by the following

where all the P<sub>j</sub>'s are standard Poisson processes, which are mutually independent. For each given site, these processes count the number of new infectious, recoveries and the migrations between sites.  $y_i \sim x_i$  means that  $y_i \in \{x_i + \varepsilon, x_i - \varepsilon\}.$  $\mathcal{L}$

The authors show the consistency of the two models by a law of large numbers. More precisely, the following two results were proved in N'zi et al. (2021).

#### Theorem 1.1 (Law of Large Numbers:  $N \rightarrow \infty$ ,  $\varepsilon$  being fixed).

We devote this paper to study the deviation of the stochastic model from the deterministic one as the mesh size of the grid goes to zero. In this work, we focus our attention to the periodic boundary conditions on the unit interval [0, 1], which we denote by  $\mathbb{T}^1$ . Let us mention that Blount (1993) and Kotelenez (1986) described similar spatial model for chemical reactions. The resulting process has one component and is compared with the corresponding deterministic model. They proved a functional central limit theorem under some restriction on the respective speeds of convergence of the initial number of particles in each cell and the number of cells. The rest of this paper is organized as follows. In section 2, we give some notations and preliminaries which will be useful in the sequel of this paper. In section 3, we establish a functional central limit theorem, the main result of this paper, by letting the mesh size  $\varepsilon$  of the grid go to zero. The fluctuation limit is a distribution valued generalized Ornstein-Uhlenbeck Gaussian process and can be represented as the solution of a linear stochastic partial differential equation, whose driving terms are Gaussian martingales.

## 2 Notations and Preliminaries

In this section, we give some notations and collect some standard facts on the Sobolev spaces  $H^{\gamma}(\mathbb{T}^1)$ ,  $\gamma \in \mathbb{R}$ . First of all, let us describe some of the properties of the (discrete)-Laplace operator. Let  $H_{\varepsilon} \subset L^2(\mathbb{T}^1)$  denote the space of real valued step functions that are constant on each cell *V*<sub>*i*</sub>. For  $f \in H_{\varepsilon}$ , let us define

Basic computations show that there exists a constant *c*, such that for each *m* and  $\varepsilon$ ,  $\varepsilon^{-2} (1 - \cos(\pi m \varepsilon)) > cm^2$ . Let us set  $n_{\varepsilon} = \frac{\varepsilon^{-1} - 1}{2}$ .  $\Delta_{\varepsilon}$  generates a contraction semigroup  $T_{\varepsilon}(t) := \exp(\Delta_{\varepsilon} t)$  whose action on each  $f \in H_{\varepsilon}$  is given by

$$
\mathsf{T}_{\varepsilon}(t)f = \sum_{k=0}^{n_{\varepsilon}} \exp(-\lambda_{2k}^{\varepsilon}t) \left[ \langle f, \varphi_{2k}^{\varepsilon} \rangle \varphi_{2k}^{\varepsilon} + \langle f, \psi_{2k}^{\varepsilon} \rangle \psi_{2k}^{\varepsilon} \right]. \tag{7}
$$

Note that both  $\Delta_{\varepsilon}$  and  $T_{\varepsilon}(t)$  are self-adjoint and that  $T_{\varepsilon}(t)\Delta_{\varepsilon}\varphi = \Delta_{\varepsilon}T_{\varepsilon}(t)\varphi$ . For any  $J \in \{S, I, R\}$ , the semigroup generated by  $\mu_J \Delta$  is  $\mathsf{T}(\mu_J t)$ . In the sequel, we will use the notation  $T_J(t) := T(\mu_J t)$  and similarly, in the discrete case, we will use the notation  $\mathcal{T}_{\varepsilon,J}(t) := \mathcal{T}_{\varepsilon}(\mu_J t)$ . Also, for any  $J \in \{S, I, R\}$ , we set  $\lambda_{m,J} := \mu_J \lambda_m$  and  $\lambda_{m,J}^{\varepsilon} := \mu_J \lambda_m^{\varepsilon}$ . For  $\gamma \in \mathbb{R}_+$ , we define the Hilbert space  $H^{\gamma}(\mathbb{T}^1)$  as follows.

$$
\mathrm{H}^\gamma(\mathbb{T}^1):=\big\{\,f\in L^2\left(\mathbb{T}^1\right),\|f\|_{\mathrm{H}^\gamma}^2:=\sum_{m\,\mathrm{even}}\big[\langle\,f,\varphi_m\,\rangle^2+\langle\,f,\psi_m\,\rangle^2\big](1+\lambda_m)^\gamma<\infty\,\big\}.
$$

We shall use the notations  $H^{\gamma} := H^{\gamma}(\mathbb{T}^1)$  and  $L^2 := L^2(\mathbb{T}^1)$ . Note that  $\|\varphi\|_{H^{\gamma}} = \|(\mathbf{I} - \Delta)^{\gamma/2}\varphi\|_{L^2}$ , where **I** is the identity operator on  $L^2(\mathbb{T}^1)$ . For any

three-dimensional vector-valued function  $\Phi = (\Phi_1, \Phi_2, \Phi_3)^T$ , we use the notation  $\|\Phi\|_{H^{\gamma}} :=$  $\left( \|\Phi_1\|_{H^{\gamma}}^2 + \|\Phi_2\|_{H^{\gamma}}^2 + \|\Phi_3\|_{H^{\gamma}}^2 \right.$ Hγ  $\big)^{1/2}.$ For  $\gamma \in \mathbb{R}$ , we also define

$$
||f||_{\mathrm{H}^{\gamma,\varepsilon}}:=\Bigg[\sum_{m\text{ even}}\big(\langle f,\varphi_m^\varepsilon\rangle^2+\langle f,\psi_m^\varepsilon\rangle^2\big)(1+\lambda_m^\varepsilon)^\gamma\Bigg]^{1/2},\ f\in\mathrm{H}_{\varepsilon}.
$$

For  $f$ ,  $g \in H_{\varepsilon}$ , we have

$$
\left| \langle f, g \rangle \right| \leq \| f \|_{H^{-\gamma \varepsilon}} \| g \|_{H^{\gamma \varepsilon}}, \quad \gamma \geq 0. \tag{8}
$$

Elementary calculation shows that for  $f \in H_{\varepsilon}$ , and  $\gamma > 0$  there exist positive constants  $c_1(\gamma)$ and  $c_2(\gamma)$  such that for all  $\varepsilon > 0$ 

$$
c_1(\gamma) \|f\|_{H^{-\gamma,\varepsilon}} \le \|f\|_{H^{-\gamma}} \le c_2(\gamma) \|f\|_{H^{-\gamma,\varepsilon}}.
$$
\n<sup>(9)</sup>

 $f' := \frac{\partial f}{\partial x}$  $\frac{\partial f}{\partial x}$  will denote the derivative of *f*.

In the sequel of this paper we may use the same notation for different constants (we use the generic notation *C* for a positive constant). These constants can depend upon some parameters of the model, as long as these are independent of  $\varepsilon$  and  $N$ , we will not necessarily mention this dependence explicitly. However, we use  $C(\gamma, T)$  to denote a constant which depends on  $\gamma$  and *T* (and possibly on some unimportant constants). The exact value may change from line to line.

Let us now consider the deviation of the stochastic model around its determinsitc law of large numbers limit. To this end we introduce the rescaled difference between  $Z_{N,\varepsilon}(t)$  and  $Z_{\varepsilon}$ , namely

$$
\Psi_{\mathbf{N},\varepsilon}(t):=\left(\begin{array}{c} U_{\mathbf{N},\varepsilon}(t)\\ V_{\mathbf{N},\varepsilon}(t)\\ W_{\mathbf{N},\varepsilon}(t)\end{array}\right),
$$

where

$$
U_{\mathbf{N},\varepsilon}(t) := \left(\frac{\sqrt{\mathbf{N}}\Big(S_{\mathbf{N},\varepsilon}(t,x_1) - S_{\varepsilon}(t,x_1)\Big)}{\vdots} \right), V_{\mathbf{N},\varepsilon}(t) := \left(\frac{\sqrt{\mathbf{N}}\Big(I_{\mathbf{N},\varepsilon}(t,x_1) - I_{\varepsilon}(t,x_1)\Big)}{\vdots}_{\sqrt{\mathbf{N}}\Big(I_{\mathbf{N},\varepsilon}(t,x_{\ell}) - I_{\varepsilon}(t,x_{\ell})\Big)}\right)
$$

and

$$
W_{\mathbf{N},\varepsilon}(t) := \begin{pmatrix} \sqrt{\mathbf{N}} \Big( R_{\mathbf{N},\varepsilon}(t,x_1) - R_{\varepsilon}(t,x_1) \Big) \\ \vdots \\ \sqrt{\mathbf{N}} \Big( R_{\mathbf{N},\varepsilon}(t,x_{\ell}) - R_{\varepsilon}(t,x_{\ell}) \Big) \end{pmatrix}.
$$

In the sequel, we denote by " $\implies$ " weak convergence. By fixing the mesh size  $\varepsilon$  of the grid and letting N go to infinity, we obtain the following theorem.

Theorem 2.1 (Central Limit Theorem :  $N \rightarrow \infty$ ,  $\varepsilon$  being fixed). *Assume that*  $\sqrt{N}(Z_{N,\varepsilon}(0) - Z_{\varepsilon}(0)) \longrightarrow 0$ , as  $N \to \infty$ . Then, as  $N \to +\infty$  ,  $\big\{\Psi_{N,\varepsilon}(t),\, t\ge 0\,\big\}$   $\Longrightarrow$   $\big\{\Psi_\varepsilon(t),\, t\ge 0\,\big\}$  , for the topology of locally uniform

*convergence, where the limit process*  $\Psi_{\varepsilon}(t)$  :=  $\sqrt{ }$  $\overline{1}$  $U_{\varepsilon}(t)$  $V_{\varepsilon}(t)$  $W_{\varepsilon}(t)$  $\setminus$ *satisfies*

$$
\Psi_{\varepsilon}(t) = \int_0^t \nabla_z b_{\varepsilon}(r, Z_{\varepsilon}(r)) \Psi_{\varepsilon}(r) dr + \sum_{j=1}^K \int_0^t \sqrt{\beta_j(r, Z_{\varepsilon}(r))} dB_j(r), \quad t \ge 0,

*and*  ${B_1(t), B_2(t), \cdots, B_K(t)}$  *are mutually independent standard Brownian motions. More precisely, by setting*  $A_\varepsilon = S_\varepsilon + I_\varepsilon + R_\varepsilon$ , *for any site*  $x_i$ , *the limit*  $(U_\varepsilon, V_\varepsilon, W_\varepsilon)^\text{T}$  *satisfies the following system*

$$
U_{\varepsilon}(t,x_{i}) = \mu_{S} \int_{0}^{t} \Delta_{\varepsilon} U_{\varepsilon}(r,x_{i}) dr - \int_{0}^{t} \beta(x_{i}) \frac{I_{\varepsilon}(r,x_{i}) (I_{\varepsilon}(r,x_{i}) + R_{\varepsilon}(r,x_{i})) V_{\varepsilon}(r,x_{i})}{A_{\varepsilon}^{2}(r,x_{i})} dr - \int_{0}^{t} \beta(x_{i}) \frac{S_{\varepsilon}(r,x_{i}) (S_{\varepsilon}(r,x_{i}) + R_{\varepsilon}(r,x_{i})) U_{\varepsilon}(r,x_{i})}{A_{\varepsilon}^{2}(r,x_{i})} dr + \int_{0}^{t} \sqrt{\beta(x_{i}) \frac{S_{\varepsilon}(r,x_{i}) I_{\varepsilon}(r,x_{i})}{A_{\varepsilon}(r,x_{i})}} dB^{inf}_{x_{i}}(r) - \sum_{y_{i} \sim x_{i}} \int_{0}^{t} \sqrt{\frac{\mu_{S}}{\varepsilon^{2}} S_{\varepsilon}(r,x_{i})} dB^{S}_{x_{i}y_{i}}(r) + \sum_{y_{i} \sim x_{i}} \int_{0}^{t} \sqrt{\frac{\mu_{S}}{\varepsilon^{2}} S_{\varepsilon}(r,y_{i})} dB^{S}_{y_{i}x_{i}}(r)

$$
V_{\varepsilon}(t,x_{i}) = \mu_{I} \int_{0}^{t} \Delta_{\varepsilon} V_{\varepsilon}(r,x_{i}) dr + \int_{0}^{t} \beta(x_{i}) \frac{I_{\varepsilon}(r,x_{i}) (I_{\varepsilon}(r,x_{i}) + R_{\varepsilon}(r,x_{i})) V_{\varepsilon}(r,x_{i})}{A_{\varepsilon}^{2}(r,x_{i})} dr + \int_{0}^{t} \beta(x_{i}) \frac{S_{\varepsilon}(r,x_{i}) (S_{\varepsilon}(r,x_{i}) + R_{\varepsilon}(r,x_{i})) U_{\varepsilon}(r,x_{i})}{A_{\varepsilon}^{2}(r,x_{i})} dr - \int_{0}^{t} \alpha(x_{i}) V_{\varepsilon}(r,x_{i}) dr - \int_{0}^{t} \sqrt{\beta(x_{i}) \frac{S_{\varepsilon}(r,x_{i}) I_{\varepsilon}(r,x_{i})}{A_{\varepsilon}^{2}(r,x_{i})}} dB_{x_{i}}^{inf}(r) + \int_{0}^{t} \sqrt{\alpha(x_{i}) I_{\varepsilon}(r,x_{i})} dB_{x_{i}}^{rec}(r) - \sum_{y_{i} \sim x_{i}} \int_{0}^{t} \sqrt{\frac{\mu_{I}}{\varepsilon^{2}} I_{\varepsilon}(r,x_{i})} dB_{x_{i}y_{i}}^{I}(r) + \sum_{y_{i} \sim x_{i}} \int_{0}^{t} \sqrt{\frac{\mu_{I}}{\varepsilon^{2}} I_{\varepsilon}(r,y_{i})} dB_{y_{i}x_{i}}^{I}(r)
$$

$$
W_{\varepsilon}(t,x_i) = \mu_R \int_0^t \Delta_{\varepsilon} W_{\varepsilon}(r,x_i) dr + \int_0^t \alpha(x_i) V_{\varepsilon}(r,x_i) dr - \int_0^t \sqrt{\alpha(x_i) I_{\varepsilon}(r,x_i)} dB_{x_i}^{rec}(r)
$$

$$
- \sum_{y_i \sim x_i} \int_0^t \sqrt{\frac{\mu_R}{\varepsilon^2} R_{\varepsilon}(r,x_i)} dB_{x_i y_i}^R(r) + \sum_{y_i \sim x_i} \int_0^t \sqrt{\frac{\mu_R}{\varepsilon^2} R_{\varepsilon}(r,y_i)} dB_{y_i x_i}^R(r),
$$

where  $\{B_{x_i}^{inf}: x_i \in D_{\varepsilon}\}\$ ,  $\{B_{x_i}^{rec}: x_i \in D_{\varepsilon}\}\$ ,  $\{B_{x_iy_i}^S: y_i \sim x_i \in D_{\varepsilon}\}\$ ,  $\{B_{x_iy_i}^I: y_i \sim x_i \in D_{\varepsilon}\}\$ and  ${B_{x_iy_i}^R}$ :  $y_i \sim x_i \in D_{\varepsilon}$  *are families of independent Brownian motions.* 

Theorem 2.1 is a special case of Theorem 3.5 of Kurtz (1971) (see also Theorem 2.3.2 in Britton and Pardoux (2019) ). Then, here, we do not give the proof and refer the reader to those references for a complete proof.  $\square$ 

Let  $X = (s, i, r)^T$  satisfying the system (2) on [0, 1]. Thanks to Proposition 1.1 of Taylor (1991) (chapter 15, section 1) we have the following lemma.

**Lemma 2.1.** Let  $\gamma \ge 0$  and assume that the initial data  $\mathbf{X}(0)$  bebong to  $(\mathrm{H}^{\gamma})^3$ , then the *parabolic system* (2) has a unique solution  $\mathbf{X} \in C([0, T]; (H^{\gamma})^3)$ .

The rest of this section is devoted to the proof of some estimates for the solution of the system of equations (1). We first note that  $S_{\varepsilon}(t, x_i) \geq 0, I_{\varepsilon}(t, x_i) \geq 0, R_{\varepsilon}(t, x_i) \geq 0$  for all  $t \geq 0, x_i \in D_{\varepsilon}$ and  $\varepsilon > 0$ . Moreover for any  $T > 0$ , there exists a contant  $C_T$  such that

$$
\sup_{0\leq t\leq T} (\|S_{\varepsilon}(t)\|_{\infty} \vee \|I_{\varepsilon}(t)\|_{\infty} \vee \|R_{\varepsilon}(t)\|_{\infty}) \leq C_T, \ \forall \varepsilon > 0. \tag{11}
$$

Indeed we first note that  $||S_{\varepsilon}(t)||_{\infty} \leq M$ , since  $S_{\varepsilon}$  is upper bounded by the solution of the ODE

$$
\frac{dX_{\varepsilon}}{dt}(t,x_i) = \mu_S \Delta_{\varepsilon} X_{\varepsilon}(t,x_i), \quad X_{\varepsilon}(0,x_i) = M.
$$
\n(12)

Next  $I_{\varepsilon}(t, x_i)$  is upper bounded by the solution of the ODE (with  $\bar{\beta} := \sup_{x} \beta(x)$ )

$$
\frac{dY_{\varepsilon}}{dt}(t,x_i)=\mu_I\Delta_{\varepsilon}Y_{\varepsilon}(t,x_i)+\bar{\beta}Y_{\varepsilon}(t,x_i),\quad Y_{\varepsilon}(0,x_i)=M.
$$

The result for  $R_{\varepsilon}$  is now easy.

Let us set  $A_{\varepsilon} := S_{\varepsilon} + \mathcal{I}_{\varepsilon} + \mathcal{R}_{\varepsilon}$ . We have the

**Lemma 2.2.** *For any T*  $> 0$ *, there exists a positive constant c<sub>T</sub> such that* 

$$
\mathcal{A}_{\varepsilon}(t,x) \geq c_T, \quad \text{for any } \varepsilon > 0, \ 0 \leq t \leq T, \ x \in \mathbb{T}^1.
$$

Proof: We consider the ODE

$$
\frac{dS_{\varepsilon}}{dt}(t,x) = \mu_S \Delta_{\varepsilon} S_{\varepsilon}(t,x) - \frac{\beta(x)S_{\varepsilon}(t,x)\mathcal{I}_{\varepsilon}(t,x)}{S_{\varepsilon}(t,x) + \mathcal{I}_{\varepsilon}(t,x) + \mathcal{R}_{\varepsilon}(t,x)}.
$$

Since  $S_{\epsilon}(t, x) + \mathcal{R}_{\epsilon}(t, x) \ge 0$  and  $\mathcal{I}_{\epsilon}(t, x) \ge 0$ , it is plain that

$$
0 \leq \frac{\beta(x)\mathcal{I}_{\varepsilon}(t,x)}{\mathcal{S}_{\varepsilon}(t,x) + \mathcal{I}_{\varepsilon}(t,x) + \mathcal{R}_{\varepsilon}(t,x)} \leq \overline{\beta}, \quad \text{where } \overline{\beta} := \sup_{x \in \mathbb{T}^1} |\beta(x)|.
$$

Define  $\overline{S}_{\varepsilon}(t,x) = e^{\beta t} S_{\varepsilon}(t,x)$ . We have

$$
\frac{d\overline{S}_{\varepsilon}}{dt}(t,x) = \mu_S \Delta_{\varepsilon} \overline{S}_{\varepsilon}(t,x) + \left(\overline{\beta} - \frac{\beta(x)\mathcal{I}_{\varepsilon}(t,x)}{S_{\varepsilon}(t,x) + \mathcal{I}_{\varepsilon}(t,x) + \mathcal{R}_{\varepsilon}(t,x)}\right) \overline{S}_{\varepsilon}(t,x).
$$

Combining this with the last inequality, we deduce that

$$
\overline{S}_{\varepsilon}(t,x) \geq [e^{t\mu_S\Delta_{\varepsilon}}\overline{S}_{\varepsilon}(0,\cdot)](x) \geq c,
$$



from Assumption 1.2.

Going back to  $S_{\varepsilon}$ , we note that we have proved that

$$
\mathcal{S}_{\varepsilon}(t,x) \geq c e^{-\overline{\beta}t}.
$$

In other words, for any *T* > 0, there exists a constant  $c_T := ce^{-\overline{\beta}T}$  which is such that

$$
\mathcal{S}_{\varepsilon}(t,x) \geq c_T, \quad \text{ for any } \varepsilon > 0, \ 0 \leq t \leq T, \ x \in \mathbb{T}^1.
$$

And since  $I_{\varepsilon}(t, x_i) + R_{\varepsilon}(t, x_i) \geq 0$ ,  $\mathcal{A}_{\varepsilon}(t, x)$  satisfies the same lower bound.

$$
\Box
$$

**Lemma 2.3.** *For any T*  $> 0$ *, there exists a constant C such that for each*  $\varepsilon$   $> 0$ 

$$
\sup_{0 \le t \le T} \left( \left\| \mathcal{S}_{\varepsilon}(t) \right\|_{L^2}^2 + \left\| \mathcal{I}_{\varepsilon}(t) \right\|_{L^2}^2 + \left\| \mathcal{R}_{\varepsilon}(t) \right\|_{L^2}^2 \right) + 2 \int_0^T \left( \mu_S \left\| \nabla_{\varepsilon}^+ \mathcal{S}_{\varepsilon}(r) \right\|_{L^2}^2 + \mu_I \left\| \nabla_{\varepsilon}^+ \mathcal{I}_{\varepsilon}(r) \right\|_{L^2}^2 + \mu_R \left\| \nabla_{\varepsilon}^+ \mathcal{R}_{\varepsilon}(r) \right\|_{L^2}^2 \right) dr \le C. \quad (13)
$$

**Proof:** For all  $(t, x) \in [0, T] \times [0, 1]$ , we have

$$
\frac{dS_{\varepsilon}}{dt}(t,x) = \mu_S \Delta_{\varepsilon} S_{\varepsilon}(t,x) - \frac{\beta(x) S_{\varepsilon}(t,x) \mathcal{I}_{\varepsilon}(t,x)}{\mathcal{A}_{\varepsilon}(t,x)},
$$

which implies

$$
2\langle \mathcal{S}_{\varepsilon}(t), \frac{d\mathcal{S}_{\varepsilon}}{dt}(t) \rangle = 2\mu_{S} \langle \Delta_{\varepsilon} \mathcal{S}_{\varepsilon}(t), \mathcal{S}_{\varepsilon}(t) \rangle - 2 \langle \frac{\beta(.)\mathcal{S}_{\varepsilon}(t)\mathcal{I}_{\varepsilon}(t)}{\mathcal{A}_{\varepsilon}(t)}, \mathcal{S}_{\varepsilon}(t) \rangle
$$
  
= 
$$
-2\mu_{S} \langle \nabla_{\varepsilon}^{+} \mathcal{S}_{\varepsilon}(t), \nabla_{\varepsilon}^{+} \mathcal{S}_{\varepsilon}(t) \rangle - 2 \langle \frac{\beta(.)\mathcal{S}_{\varepsilon}(t)\mathcal{I}_{\varepsilon}(t)}{\mathcal{A}_{\varepsilon}(t)}, \mathcal{S}_{\varepsilon}(t) \rangle.
$$

Then,  $\forall t \in [0, T]$ ,

$$
\left\|\mathcal{S}_{\varepsilon}(t)\right\|_{L^{2}}^{2}+2\mu_{S}\int_{0}^{t}\left\|\nabla_{\varepsilon}^{+}\mathcal{S}_{\varepsilon}(r)\right\|_{L^{2}}^{2}dr=\left\|\mathcal{S}_{\varepsilon}(0)\right\|_{L^{2}}^{2}-2\int_{0}^{t}\left\langle\frac{\beta(.)\mathcal{S}_{\varepsilon}(r)\mathcal{I}_{\varepsilon}(r)}{\mathcal{A}_{\varepsilon}(r)},\mathcal{S}_{\varepsilon}(r)\right\rangle dr
$$

In the same way, we obtain

$$
\|\mathcal{I}_{\varepsilon}(t)\|_{L^{2}}^{2}+2\mu_{I}\int_{0}^{t}\|\nabla_{\varepsilon}^{+}\mathcal{I}_{\varepsilon}(r)\|_{L^{2}}^{2}dr=\|\mathcal{I}_{\varepsilon}(0)\|_{L^{2}}^{2}+2\int_{0}^{t}\langle\frac{\beta(.)\mathcal{S}_{\varepsilon}(r)\mathcal{I}_{\varepsilon}(r)}{\mathcal{A}_{\varepsilon}(r)},\mathcal{I}_{\varepsilon}(r)\rangle dr\\-2\int_{0}^{t}\langle\alpha(.)\mathcal{I}_{\varepsilon}(r),\mathcal{I}_{\varepsilon}(r)\rangle dr,
$$

and

$$
\left\|\mathcal{R}_{\varepsilon}(t)\right\|_{L^{2}}^{2}+2\mu_{R}\int_{0}^{t}\left\|\nabla_{\varepsilon}^{+}\mathcal{R}_{\varepsilon}(r)\right\|_{L^{2}}^{2}dr=\left\|\mathcal{R}_{\varepsilon}(0)\right\|_{L^{2}}^{2}+2\int_{0}^{t}\left\langle \alpha(.)\mathcal{I}_{\varepsilon}(r),\mathcal{R}_{\varepsilon}(r)\right\rangle dr
$$

Then, we deduce that

$$
\begin{split} \left\| \mathcal{S}_{\varepsilon}(t) \right\|^{2}_{L^{2}} &+ \left\| \mathcal{I}_{\varepsilon}(t) \right\|^{2}_{L^{2}} + \left\| \mathcal{R}_{\varepsilon}(t) \right\|^{2}_{L^{2}} + 2 \int_{0}^{t} \left( \mu_{S} \left\| \nabla_{\varepsilon}^{+} \mathcal{S}_{\varepsilon}(r) \right\|^{2}_{L^{2}} + \mu_{I} \left\| \nabla_{\varepsilon}^{+} \mathcal{I}_{\varepsilon}(r) \right\|^{2}_{L^{2}} + \mu_{R} \left\| \nabla_{\varepsilon}^{+} \mathcal{R}_{\varepsilon}(r) \right\|^{2}_{L^{2}} \right) dr \\ &\leq \left\| \mathcal{S}_{\varepsilon}(0) \right\|^{2}_{L^{2}} + \left\| \mathcal{I}_{\varepsilon}(0) \right\|^{2}_{L^{2}} + \left\| \mathcal{R}_{\varepsilon}(0) \right\|^{2}_{L^{2}} + \int_{0}^{t} \left( (2\overline{\beta} + \overline{\alpha}) \left\| \mathcal{I}_{\varepsilon}(r) \right\|^{2}_{L^{2}} + \overline{\alpha} \left\| \mathcal{R}_{\varepsilon}(r) \right\|^{2}_{L^{2}} \right) dr, \end{split}
$$

where  $\bar{\alpha} = \text{sup}$ *x*∈T<sup>1</sup>  $|\alpha(x)|$ .

It then follows from Gronwall's lemma that

We now add the following assumption.

**Lemma 2.4.** *For any*  $T > 0$ *, there exists a positive constant C such that for all*  $\varepsilon > 0$ *,*

**Proof:**  $\forall x \in \mathbb{T}^1$ ,  $\forall t \geq 0$  we have

from which we obtain

\int_0^T \int_{\mathbb{T}^1} \left| \nabla_{\varepsilon}^+ f_{\varepsilon}(t,x) \right|^2 dxdt \leq C \int_0^T \int_{\mathbb{T}^1} \left( \left| \nabla_{\varepsilon}^+ \beta(x) \right|^2 + \left| \nabla_{\varepsilon}^+ \mathcal{S}_{\varepsilon}(t,x) \right|^2 \right. \\ \left. + \left| \nabla_{\varepsilon}^+ \mathcal{R}_{\varepsilon}(t,x) \right|^2 + \left| \nabla_{\varepsilon}^+ \mathcal{A}_{\varepsilon}(t,x) \right|^2 \right) dxdt,
$$

where we have used Assumption 2.1, inequality (11) and Lemma 2.2. The result now follows from Lemma 2.3.

**Proof:** We first etablish (16). Applying the operator  $\nabla_{\varepsilon}^{+}$  to the first equation in (1), we get

The last term on the above right hand side is easily explicited thanks to a computation similar to that done in (15). Combining that formula with Assumption 2.1, inequality (11) and Lemma 2.2, we deduce that

Since the semigroup  $e^{t\mu_S\Delta_{\varepsilon}}$  is contracting in  $L^{\infty}$ , we deduce that

$$

Applying similar arguments to the two other equations in (1), we obtain

\begin{split} \|\nabla_{\varepsilon}^{+} \mathcal{S}_{\varepsilon}(t)\|_{\infty}+\|\nabla_{\varepsilon}^{+} \mathcal{I}_{\varepsilon}(t)\|_{\infty}+\|\nabla_{\varepsilon}^{+} \mathcal{R}_{\varepsilon}(t)\|_{\infty} &\leq \|\nabla_{\varepsilon}^{+} \mathcal{S}_{\varepsilon}(0)\|_{\infty}+\|\nabla_{\varepsilon}^{+} \mathcal{I}_{\varepsilon}(0)\|_{\infty}+\|\nabla_{\varepsilon}^{+} \mathcal{R}_{\varepsilon}(0)\|_{\infty} \\ &+C\int_{0}^{t}\left(\|\nabla_{\varepsilon}^{+} \mathcal{S}_{\varepsilon}(s)\|_{\infty}+\|\nabla_{\varepsilon}^{+} \mathcal{I}_{\varepsilon}(s)\|_{\infty}+\|\nabla_{\varepsilon}^{+} \mathcal{R}_{\varepsilon}(s)\|_{\infty}\right) ds\,. \end{split}

(16) now follows from Gronwall's Lemma and Assumption 1.1.

We now multiply (20) by  $\nabla_{\varepsilon}^+ \mathcal{S}_{\varepsilon}(t,x)$  and integrate on  $[0,t] \times \mathbb{T}^1$ , yielding

$$
\begin{aligned} \|\nabla_{\varepsilon}^{+} \mathcal{S}_{\varepsilon}(t)\|_{L^{2}} + 2\mu_{S} \int_{0}^{t} \|\Delta_{\varepsilon} \mathcal{S}_{\varepsilon}(s)\|_{L^{2}}^{2} ds &= 2 \int_{0}^{t} \left( \frac{\beta \mathcal{S}_{\varepsilon} \mathcal{I}_{\varepsilon}}{\mathcal{A}_{\varepsilon}}(s), \Delta_{\varepsilon} \mathcal{S}_{\varepsilon}(s) \right) ds \\ &\leq Ct + \mu_{S} \int_{0}^{t} \|\Delta_{\varepsilon} \mathcal{S}_{\varepsilon}(s)\|_{L^{2}}^{2} ds \,, \end{aligned}
$$

which yields one third of  $(17)$ . The rest of  $(17)$  is proved by similar computations applied to the equations for  $\nabla_{\varepsilon}^+ \mathcal{I}_{\varepsilon}$  and  $\nabla_{\varepsilon}^+ \mathcal{R}_{\varepsilon}$ . Next (18) follows from (17), (16), Assumption 2.1, (11) and Lemma 2.2.

Since

the estimate (19) follows from (16), Assumption 2.1, inequality (11), Lemma 2.2 and the fact that the norm in  $L^2(\mathbb{T}^1)$  is bounded by the norm in  $L^{\infty}(\mathbb{T}^1)$ .

*Moreover f, g*  $\in L^2(0,T; H^1)$ .

**Proof:** Let *d* be the function such that ,  $\forall t \in [0, T]$ ,  $x \in \mathbb{T}^1$  and  $\varepsilon > 0$

Furthermore, we know that  $\mathcal{S}_{\varepsilon} \longrightarrow \mathbf{s}, \quad \mathcal{I}_{\varepsilon} \longrightarrow \mathbf{i}$  and  $\mathcal{R}_{\varepsilon} \longrightarrow \mathbf{r}$  uniformly on  $[0, T] \times \mathbb{T}^1$ . Since *d* is continuous on  $\{(s,i,r) \in (\mathbb{R}_+)^3 : s + i + r > 0\}$ , then we deduce that  $f_{\varepsilon} \longrightarrow f$

uniformly on  $[0, T] \times \mathbb{T}^1$ , and in particular in  $C([0, T]; L^2(\mathbb{T}^1))$ . From (20) and similar equations for  $\nabla_{\varepsilon}^+ \mathcal{I}_{\varepsilon}(t,x)$  and  $\nabla_{\varepsilon}^+ \mathcal{R}_{\varepsilon}(t,x)$ , we obtain the convergence of  $\nabla_{\varepsilon}^{+} f_{\varepsilon} \longrightarrow \nabla f$  by an argument similar to the previous one.

The proofs of  $g_{\varepsilon} \longrightarrow g$  and  $\nabla_{\varepsilon}^+ g_{\varepsilon} \longrightarrow \nabla g$  are obtained in the same way.

In the sequel, we will write " $f_{\varepsilon}(t) \longrightarrow f(t)$  in H<sup>1</sup>" to mean that " $f_{\varepsilon}(t) \longrightarrow f(t)$  in  $L^2(\mathbb{T}^1)$  and  $\nabla_{\varepsilon}^+ f_{\varepsilon}(t) \longrightarrow \nabla f(t)$  in  $L^2(\mathbb{T}^1)$ ".

We have the following compactness result.

Lemma 2.7 (Theorem 1.69 of Bahouri et al. (2011), page 47). *For any compact subset E of*  $\mathbb{R}^d$  *and*  $s_1 < s_2$ *, the embedding of*  $H^{s_2}(E)$  *into*  $H^{s_1}(E)$  *is a compact linear operator.*

In the next section, we study the behavior of the process  $\{\Psi_{\varepsilon}, 0 < \varepsilon < 1\}$  as  $\varepsilon$  goes to zero.

## 3 Functional Central Limit Theorem

\mathcal{W}_{\varepsilon}(t) = \int_{0}^{t} \mu_{R} \Delta_{\varepsilon} \mathcal{W}_{\varepsilon}(r) dr + \int_{0}^{t} \alpha(.) \mathcal{V}_{\varepsilon}(r) dr + \mathcal{M}_{\varepsilon}^{R}(t).\n\end{cases} (21)
$$

For  $\gamma \in \mathbb{R}_+$ , we denote by  $C([0,T];H^{-\gamma})$  the complete separable metric space of continuous functions defined on  $[0, T]$  with values in H<sup>- $\gamma$ </sup>. For any  $\varepsilon > 0$ ,  $\mathcal{U}_{\varepsilon}$ ,  $\mathcal{V}_{\varepsilon}$  and  $\mathcal{W}_{\varepsilon}$  can be viewed as continuous processes taking values in some Hilbert space  $H^{-\gamma}$ . Hence we will study the weak convergence of the process  $(\mathscr{U}_{\varepsilon}, \mathscr{V}_{\varepsilon}, \mathscr{W}_{\varepsilon})$  in  $C([0, T]; (H^{-\gamma})^3)$ .

In the sequel we will need to control the stochastic convolution integrals  $\int_0^t \mathsf{T}_{\varepsilon,J}(t-r) d\mathcal{M}^J_{\varepsilon}(r)$ , with  $J \in \{S, I, R\}$ . For that sake, we shall need a maximal inequality which is a special case of Theorem 2.1 of Kotelenez (1984), which we first recall.

### Lemma 3.1 (Kotelenez (1984)).

*Let*  $(H; \| \| \|$ *h*) *be a separable Hilbert space,* M *an* H-valued locally square integrable càdlàg *martingale and*  $T(t)$  *a contraction semigroup operator of*  $\mathcal{L}(H)$ *. Then, there is a finite constant c* depending only on the Hilbert norm  $\Vert . \Vert_H$  such that for all  $T \geq 0$ 

$$
\mathbb{E}\left(\sup_{0\leq t\leq T}\Big\|\int_{0}^{t}T(t-r)d\mathcal{M}(r)\Big\|_{\mathcal{H}}^{2}\right)\leq c\,e^{4\sigma T}\mathbb{E}\left(\left\|\mathcal{M}(T)\right\|_{\mathcal{H}}^{2}\right),\tag{22}
$$

where  $\sigma$  is a real number such that  $\left\|T(t)\right\|_{\mathcal{L}(H)} \leq e^{\sigma t}$ .

We want to take tke limit as  $\varepsilon \to 0$  in the system of SDEs (21) satisfied by  $\mathscr{Y}_{\varepsilon}$ . To this end we will split our system into two subsystems.

First, we consider the following linear system

$$

u_{\varepsilon}(0) = v_{\varepsilon}(0) = w_{\varepsilon}(0) = 0.\n\end{cases}
$$
\n(23)

Next, we shall consider the second system

$$
\begin{cases}\n\frac{d\overline{u}_{\varepsilon}}{dt}(t) = \mu_{S} \Delta_{\varepsilon} \overline{u}_{\varepsilon}(t) - f_{\varepsilon}(t) \overline{u}_{\varepsilon}(t) - g_{\varepsilon}(t) \overline{v}_{\varepsilon}(t) - f_{\varepsilon}(t) u_{\varepsilon}(t) - g_{\varepsilon}(t) v_{\varepsilon}(t) \\
\frac{d\overline{v}_{\varepsilon}}{dt}(t) = \mu_{I} \Delta_{\varepsilon} \overline{v}_{\varepsilon}(t) + f_{\varepsilon}(t) \overline{u}_{\varepsilon}(t) + (g_{\varepsilon}(t) - \alpha) \overline{v}_{\varepsilon}(t) + f_{\varepsilon}(t) u_{\varepsilon}(t) + (g_{\varepsilon}(t) - \alpha) v_{\varepsilon}(t) \\
\frac{d\overline{w}_{\varepsilon}}{dt}(t) = \mu_{R} \Delta_{\varepsilon} \overline{w}_{\varepsilon} + \alpha (v_{\varepsilon} + \overline{v}_{\varepsilon}) \\
\overline{u}_{\varepsilon}(0) = \overline{v}_{\varepsilon}(0) = \overline{w}_{\varepsilon}(0) = 0,\n\end{cases}
$$
\n(24)

and finally, we note that

$$
\mathscr{U}_{\varepsilon} = u_{\varepsilon} + \overline{u}_{\varepsilon}, \quad \mathscr{V}_{\varepsilon} = u_{\varepsilon} + \overline{v}_{\varepsilon}, \quad \mathscr{W}_{\varepsilon} = w_{\varepsilon} + \overline{w}_{\varepsilon}.
$$

Then the convergence of  $\mathscr{Y}_{\varepsilon} := (\mathscr{U}_{\varepsilon}, \mathscr{V}_{\varepsilon}, \mathscr{W}_{\varepsilon})$  will follow from both the convergence of  $(u_{\varepsilon}, v_{\varepsilon}, w_{\varepsilon})$  and of  $(\overline{u}_{\varepsilon}, \overline{v}_{\varepsilon}, \overline{w}_{\varepsilon})$ .

Let us first look at the convergence of  $(u_{\varepsilon}, v_{\varepsilon}, w_{\varepsilon})$ .

Let

\mathcal{M}_{\varepsilon} = (\mathcal{M}_{\varepsilon}^S, \mathcal{M}_{\varepsilon}^I, \mathcal{M}_{\varepsilon}^R)^T

Recall that we denote by  $" \Longrightarrow"$  the weak convergence.

**Proposition 3.1.** For any  $\gamma > 3/2$ , the Gaussian martingale  $\mathcal{M}_{\varepsilon} \Longrightarrow \mathcal{M} := (\mathcal{M}^S, \mathcal{M}^I, \mathcal{M}^R)^T$  $\int$ *in*  $C([0,T];(H^{-\gamma})^3)$  as  $\varepsilon \to 0$ , where for all  $\varphi \in H^{\gamma}$ 

$$
\langle \mathscr{M}^S(t), \varphi \rangle = -\int_0^t \int_{\mathbb{T}^1} \varphi(x) \sqrt{\frac{\beta(x) s(r,x) i(r,x)}{a(r,x)}} \, \dot{W}_1(dr,dx) - \sqrt{2\mu_s} \int_0^t \int_{\mathbb{T}^1} \varphi'(x) \sqrt{s(r,x)} \, \dot{W}_2(dr,dx),
$$

$$
\langle \mathcal{M}^{I}(t), \varphi \rangle = \int_{0}^{t} \int_{\mathbb{T}^{1}} \varphi(x) \sqrt{\frac{\beta(x) s(r, x) i(r, x)}{a(r, x)}} \, W_{1}(dr, dx) + \int_{0}^{t} \int_{\mathbb{T}^{1}} \varphi(x) \sqrt{\alpha(x) i(r, x)} W_{3}(dr, dx) - \sqrt{2\mu_{I}} \int_{0}^{t} \int_{\mathbb{T}^{1}} \varphi'(x) \sqrt{i(r, x)} \, W_{4}(dr, dx),
$$

$$
\langle \mathscr{M}^R(t), \varphi \rangle = -\int_0^t \int_{\mathbb{T}^1} \varphi(x) \sqrt{\alpha(x) \mathbf{i}(r, x)} \dot{W}_3(dr, dx) - \sqrt{2\mu_R} \int_0^t \int_{\mathbb{T}^1} \varphi'(x) \sqrt{\mathbf{r}(r, x)} \, \dot{W}_5(dr, dx),
$$

*and W*˙ <sup>1</sup>*, W*˙ <sup>2</sup>*, W*˙ <sup>3</sup>*, W*˙ <sup>4</sup> *and W*˙ <sup>5</sup> *are standard space-time white noises which are mutually independent.*

**Proof:** First, we are going to show that there exists a positive constant *C* independent of  $\varepsilon$  such

\sup_{0 < \varepsilon < 1} \mathbb{E} \left( \sup_{0 \le t \le T} \left\| \mathcal{M}_{\varepsilon}(t) \right\|_{H^{-\gamma}}^2 \right) \le C. \tag{25}

Recall that  $\|\mathcal{M}_{\varepsilon}(t)\|$ 2  $\mathcal{U}_{H-\gamma}^2 := \left\|\mathcal{M}_{\varepsilon}^S(t)\right\|$ 2  $\frac{2}{H-\gamma} + ||\mathcal{M}_{\varepsilon}^{I}(t)||$ 2  $\frac{2}{H-\gamma} + ||\mathcal{M}_{\varepsilon}^R(t)||$ 2 H−γ . Applying Doob's inequality to the martingale  $\mathcal{M}_{\varepsilon}^S$ , we have

$$
= 4 \sum_{m \text{ even}}\mathbb{E}\left(\left\langle\mathscr{M}_{\varepsilon}^{S}(T), \mathbf{f}_{m}\right\rangle^{2}\right)(1+\lambda_{m})^{-\gamma}, \text{ with } \mathbf{f}_{m} \in \{\varphi_{m}, \psi_{m}\}
$$
\n
$$
= \frac{4}{\varepsilon} \int_{0}^{T} \sum_{m \text{ even}}\sum_{i=1}^{\varepsilon^{-1}} \frac{\beta(x_{i})S_{\varepsilon}(r, x_{i})I_{\varepsilon}(r, x_{i})}{A_{\varepsilon}(r, x_{i})}\left(\int_{V_{i}}\mathbf{f}_{m}(x)dx\right)^{2}(1+\lambda_{m})^{-\gamma}dr
$$
\n
$$
+ \frac{4\mu_{S}}{\varepsilon} \int_{0}^{T} \sum_{m \text{ even}}\sum_{i=1}^{\varepsilon^{-1}} S_{\varepsilon}(r, x_{i})\left[\left(\int_{V_{i}}\nabla_{\varepsilon}^{+}\mathbf{f}_{m}(x)dx\right)^{2} + \left(\int_{V_{i}}\nabla_{\varepsilon}^{-}\mathbf{f}_{m}(x)dx\right)^{2}\right](1+\lambda_{m})^{-\gamma}dr.
$$

But since  $\frac{S_{\varepsilon}(r, x_i)I_{\varepsilon}(r, x_i)}{I_{\varepsilon}(r)}$  $A_{\varepsilon}(r,x_i)$  $\leq M$  (indeed  $\frac{I_{\varepsilon}(r, x_i)}{I_{\varepsilon}(r)}$  $\frac{\mathcal{L}_{\epsilon}(r, x_i)}{\mathcal{A}_{\epsilon}(r, x_i)} \leq 1$  and  $S_{\epsilon}(r, x_i) \leq M$ , see (11) and the line which follows) and  $|\nabla_{\varepsilon}^{\pm} \mathbf{f}_m(x)|^2 \leq 2\pi^2 m^2$ , then we obtain

$$
\mathbb{E}\left(\sup_{0\leq t\leq T}\left\|\mathscr{M}_{\varepsilon}^{S}(t)\right\|_{H^{-\gamma}}^{2}\right)\leq C(\overline{\beta},\mu_{S},T)\left(\sum_{m \text{ even}}\frac{1}{m^{2\gamma}}+\sum_{m \text{ even}}\frac{1}{m^{2(\gamma-1)}}\right).
$$

Since  $\sum_{m \text{ even}} \frac{1}{m^2(\gamma)}$  $\frac{1}{m^{2(\gamma-1)}} < \infty$  iff  $\gamma > 3/2$ , we then have

$$
\sup_{0 < \varepsilon < 1} \mathbb{E} \left( \sup_{0 \le t \le T} \left| \left| \mathcal{M}_{\varepsilon}^S(t) \right| \right|_{H^{-\gamma}}^2 \right) \le C(\overline{\beta}, \mu_S, T), \quad \text{for all } \gamma > 3/2. \tag{26}
$$

Similar inequalities hold for the martingales  $\mathcal{M}_{\varepsilon}^I$  and  $\mathcal{M}_{\varepsilon}^R$ . Hence we obtain

$$
\sup_{0 < \varepsilon < 1} \mathbb{E} \left( \sup_{0 \le t \le T} \left\| \mathcal{M}_{\varepsilon}(t) \right\|_{H^{-\gamma}}^2 \right) \le C. \tag{27}
$$

Inequality (27) and standard tightness criteria for martingales (see e.g. the proof of Theorem 3.1) implies that the martingale  $\mathcal{M}_{\varepsilon}$  is tight in  $C([0,T];(H^{-\gamma})^3)$ , with  $\gamma > 3/2$ . In what follows  $\ll M_{\epsilon}^{S,\gamma_0} \gg_t$  denotes the operator–valued increasing process associated to the  $L^2(\mathbb{T}^1)$ –valued martingale  $\mathcal{M}_{\varepsilon}^{S,\gamma_0}(t)$ , whose trace is the increasing process associated to the

real valued submartingale  $\|\mathscr{M}_{\varepsilon}^{S, Y_0}(t)\|_{L^2(\mathbb{T}^1)}^2$ . Let  $\varphi \in H^{\gamma}$ . We set  $\mathscr{M}_{\varepsilon}^{S, \varphi} = \langle \mathscr{M}_{\varepsilon}^S, \varphi \rangle$ .  $\mathscr{M}_{\varepsilon}^{I, \varphi}$  and  $\mathcal{M}_{\varepsilon}^{R,\varphi}$  are defined in the same way.  $\forall t \in [0,T]$ , we have

\ll \mathscr{M}_{\varepsilon}^{S,\varphi} \gg_t \ = \ \frac{1}{\varepsilon} \int_0^t \sum_{i=1}^{\varepsilon^{-1}} \beta(x_i) \frac{S_{\varepsilon}(r,x_i) I_{\varepsilon}(r,x_i)}{A_{\varepsilon}(r,x_i)} \left( \int_{V_i} \varphi(x) \, dx \right)^2 dr

+ \ \frac{\mu_S}{\varepsilon} \int_0^t \sum_{i=1}^{\varepsilon^{-1}} S_{\varepsilon}(r,x_i) \left[ \left( \int_{V_i} \nabla_{\varepsilon}^+ \varphi(x) \, dx \right)^2 + \left( \int_{V_i} \nabla_{\varepsilon}^- \varphi(x) \, dx \right)^2 \right] dr.
$$

We have

$$
\frac{1}{\varepsilon} \int_0^t \sum_{i=1}^{\varepsilon^{-1}} \beta(x_i) \frac{S_{\varepsilon}(r, x_i) I_{\varepsilon}(r, x_i)}{A_{\varepsilon}(r, x_i)} \left( \int_{V_i} \varphi(x) dx \right)^2 dr \n= \frac{1}{\varepsilon} \int_0^t \sum_{i=1}^{\varepsilon^{-1}} \beta(x_i) \frac{S_{\varepsilon}(r, x_i) I_{\varepsilon}(r, x_i)}{A_{\varepsilon}(r, x_i)} \left( \int_{V_i} \varphi(x) dx \right) \left[ \int_{V_i} (\varphi(x) - \varphi(x_i)) dx \right] dr \n+ \int_0^t \int_{\mathbb{T}^1} \sum_{i=1}^{\varepsilon^{-1}} \beta(x_i) \frac{S_{\varepsilon}(r, x_i) I_{\varepsilon}(r, x_i)}{A_{\varepsilon}(r, x_i)} \varphi(x) \varphi(x_i) 1_{V x_i}(x) dx dr.

On the one hand we have

\left| \frac{1}{\varepsilon} \sum_{i=1}^{\varepsilon^{-1}} \beta(x_i) \frac{S_{\varepsilon}(r, x_i) I_{\varepsilon}(r, x_i)}{A_{\varepsilon}(r, x_i)} \left( \int_{V_i} \varphi(x) dx \right) \left[ \int_{V_i} \left( \varphi(x) - \varphi(x_i) \right) dx \right] \right|
$$
  

$$
\leq C \varepsilon ||\varphi||_{H^{\gamma}} \int_{\mathbb{T}^1} \frac{\beta_{\varepsilon}(x) S_{\varepsilon}(r, x) \mathcal{I}_{\varepsilon}(r, x) |\varphi(x)|}{A_{\varepsilon}(r, x)} dx \longrightarrow 0,
$$

because the quantity  $\int_{\mathbb{T}^1}$  $\beta_{\varepsilon}(x)S_{\varepsilon}(r,x)\mathcal{I}_{\varepsilon}(r,x)|\varphi(x)|$  $\frac{A_{\varepsilon}(r,x)-\varphi(x)}{A_{\varepsilon}(r,x)}dx$  is bounded uniformly in  $\varepsilon$ . Hence  $\frac{1}{2}$ ε  $\int_0^t$  $\boldsymbol{0}$  $\varepsilon^{-1}$ ∑ *i*=1  $\beta(x_i) \frac{S_{\varepsilon}(r, x_i) I_{\varepsilon}(r, x_i)}{\Delta(x_i)}$  $A_{\varepsilon}(r,x_i)$  $\sqrt{2}$  $\int_{V_i} \varphi(x) dx \bigg) \bigg[ \int_{V_i}$  $\left( \varphi(x) - \varphi(x_i) \right) dx \right] \longrightarrow 0$ , as  $\varepsilon \rightarrow$ 0.

On the other hand, the fact that sup 0≤*t*≤*T*  $\|\mathbf{X}_{\varepsilon}(t) - \mathbf{X}(t)\|_{\infty} \longrightarrow 0$ , as  $\varepsilon \longrightarrow 0$ , leads to

$$
\left| \int_{\mathbb{T}^1} \sum_{i=1}^{\varepsilon^{-1}} \beta(x_i) \frac{S_{\varepsilon}(r,x_i) I_{\varepsilon}(r,x_i)}{A_{\varepsilon}(r,x_i)} \varphi(x) \varphi(x_i) \mathbb{1}_{V x_i}(x) dx - \int_{\mathbb{T}^1} \beta(x) \frac{s(r,x) \mathbf{i}(r,x)}{a(r,x)} \varphi^2(x) dx \right| \longrightarrow 0.

\frac{1}{\varepsilon} \int_0^t \sum_{i=1}^{\varepsilon^{-1}} \beta(x_i) \frac{S_{\varepsilon}(r, x_i) I_{\varepsilon}(r, x_i)}{A_{\varepsilon}(r, x_i)} \left( \int_{V_i} \varphi(x) dx \right)^2 dr \longrightarrow \int_0^t \int_{\mathbb{T}^1} \beta(x) \frac{s(r, x) \mathbf{i}(r, x)}{\mathbf{a}(r, x)} \varphi^2(x) dx dr
$$

as  $\varepsilon \to 0$ . Similar computation shows that

\frac{\mu_S}{\varepsilon} \int_0^t \sum_{i=1}^{\varepsilon^{-1}} S_{\varepsilon}(r, x_i) \left[ \left( \int_{V_i} \nabla_{\varepsilon}^+ \varphi(x) \, dx \right)^2 + \left( \int_{V_i} \nabla_{\varepsilon}^- \varphi(x) \, dx \right)^2 \right] dr \longrightarrow 2 \mu_S \int_0^t \int_{\mathbb{T}^1} \mathbf{s}(r, x) \big( \varphi'(x) \big)^2 dx dr
$$

from which we deduce that

$$
\ll \mathcal{M}_{\varepsilon}^{S,\varphi} \gg_t \xrightarrow{\varepsilon \to 0} \int_0^t \int_{\mathbb{T}^1} \beta(x) \frac{\mathbf{s}(r,x) \mathbf{i}(r,x)}{\mathbf{a}(r,x)} \varphi^2(x) dx dr + 2 \mu_S \int_0^t \int_{\mathbb{T}^1} \mathbf{s}(r,x) (\varphi'(x))^2 dx dr.
$$

Hence, if  $\dot{W}_1$ ,  $\dot{W}_2$  and  $\dot{W}_3$  are space-time white noises which are mutually independent, so the limit of the centered Gaussian martingale  $\mathcal{M}_{\varepsilon}^{S,\varphi}(t)$  can be identified with

$$
-\int_0^t \int_{\mathbb{T}^1} \varphi(x) \sqrt{\frac{\beta(x) s(r,x) i(r,x)}{a(r,x)}} \, \dot{W}_1(dr,dx) - \sqrt{2\mu_s} \int_0^t \int_{\mathbb{T}^1} \varphi'(x) \sqrt{s(r,x)} \, \dot{W}_2(dr,dx).
$$

In the same way

$$
\mathcal{M}_{\varepsilon}^{1,\varphi}(t) \Longrightarrow \int_0^t \int_{\mathbb{T}^1} \varphi(x) \sqrt{\frac{\beta(x) s(r,x) i(r,x)}{a(r,x)}} \, \dot{W}_1(dr,dx) + \int_0^t \int_{\mathbb{T}^1} \varphi(x) \sqrt{\alpha(x) i(r,x)} \dot{W}_3(dr,dx) \n- \sqrt{2\mu_1} \int_0^t \int_{\mathbb{T}^1} \varphi'(x) \sqrt{i(r,x)} \, \dot{W}_4(dr,dx)
$$

and

$$
\mathscr{M}_{\varepsilon}^{R,\varphi}(t) \Longrightarrow -\int_0^t \int_{\mathbb{T}^1} \varphi(x) \sqrt{\alpha(x) \mathbf{i}(r,x)} \dot{W}_3(dr,dx) - \sqrt{2\mu_R} \int_0^t \int_{\mathbb{T}^1} \varphi'(x) \sqrt{\mathbf{r}(r,x)} \, \dot{W}_5(dr,dx),

where  $\dot{W}_3$ ,  $\dot{W}_4$  and  $\dot{W}_5$  are also space-time white noises which are mutually independent, and independent from  $\dot{W}_1$ ,  $\dot{W}_2$ .

Let set

\mathfrak{S}_{\varepsilon} = (u_{\varepsilon}, v_{\varepsilon}, w_{\varepsilon})^{\mathrm{T}}
$$
.

We need to check tightness of the sequence of process  $\{\mathcal{F}_{\varepsilon}(t), t \in [0, T], 0 < \varepsilon < 1\}.$ 

**Theorem 3.1.** *For any*  $\gamma > 3/2$ , *the process*  $\{\mathfrak{S}_{\varepsilon}(t), t \in [0,T], 0 < \varepsilon < 1\}$  *is tight in*  $C([0,T];(H^{-\gamma})^3)$ .

**Proof:** : We denote by  $\mathcal{G}_{\varepsilon}^T$  the collection of  $\mathcal{F}_{t}^{\varepsilon}$ -stopping times  $\overline{\tau}$  such that  $\overline{\tau} \leq T$ . Following Aldous' tightness criterion (see Joffe and Metivier (1986)), in oder to show that the process  ${\mathfrak{Z}}_{\varepsilon}(t), t \in [0,T], 0 < \varepsilon < 1$ } is tight in  $C([0,T]; (H^{-\gamma})^3)$ , it suffices to establish the two following conditions:

, and  $M > 0$  there exists C such that  $\mathbb{P}(|\mathfrak{B}_{\varepsilon}(t)|_{H^{-\gamma_0}} \geq M) \leq C$ , for all  $t \in [0, T]$ ,

\begin{aligned}\n\textbf{[A]} \quad & \lim_{\theta \to 0} \lim_{\varepsilon \to 0} \sup_{\overline{\tau} \in \mathcal{G}_{\varepsilon}^{T-\theta}} \mathbb{E} \bigg( \Big\| \mathfrak{I}_{\varepsilon}(\overline{\tau} + \theta) - \mathfrak{I}_{\varepsilon}(\overline{\tau}) \Big\|_{H^{-\gamma}}^2 \bigg) = 0. \\
& \text{Let } \frac{3}{2} < \gamma_0 < \gamma. \text{ Let us set } u_{\varepsilon}^{\gamma_0}(t, x) = (\mathbf{I} - \Delta_{\varepsilon})^{-\gamma_0/2} u_{\varepsilon}(t, x). \ \forall t \in [0, T], \text{ we have} \\
& \Big\| u_{\varepsilon}(t) \Big\|_{H^{-\gamma_0}}^2 = \Big\langle u_{\varepsilon}^{\gamma_0}(t), u_{\varepsilon}^{\gamma_0}(t) \Big\rangle.\n\end{aligned}
$$

If we define  $\mathcal{M}_{\varepsilon}^{S,\gamma_0}(t) := (\mathbf{I} - \Delta_{\varepsilon})^{-\gamma_0/2} \mathcal{M}_{\varepsilon}^{S}(t)$ , since  $\gamma_0 > 3/2$ , it follows from (3.1) that  $\mathcal{M}_{\varepsilon}^{S, \gamma_0}(t)$  is bounded as  $\varepsilon \to 0$ , as an  $L^2(\mathbb{T}^1)$ –valued martingale. Applying the Itô formula to  $|u_{\varepsilon}^{\prime\hbar}(t,x)|^2$  and integrating over  $\mathbb{T}^1$  leads to

$$
\|u_{\varepsilon}(t)\|_{H^{-\gamma_0}}^2 = -2\int_0^t \left\langle \nabla_{\varepsilon}^+ u_{\varepsilon}^{\gamma_0}(r), \nabla_{\varepsilon}^+ u_{\varepsilon}^{\gamma_0}(r) \right\rangle dr + 2\int_0^t \left\langle u_{\varepsilon}^{\gamma_0}(r), d\mathcal{M}_{\varepsilon}^{S,\gamma_0}(r) \right\rangle
$$
  
+  $\int_{\mathbb{T}^1} \left\langle \nabla_{\varepsilon}^{\gamma, \gamma_0}(r), x \right\rangle \nabla_{\varepsilon} dx.$ 

Letting  $t = T$  and taking the expectation, we deduce that

$$
\mathbb{E}(\left\|u_{\varepsilon}(T)\right\|_{H^{-\gamma_0}}^2)+2\mu_S \mathbb{E}\int_0^T\left\|\nabla_{\varepsilon}^+ u_{\varepsilon}(t)\right\|_{H^{-\gamma_0}}^2 dt=\mathbb{E}\left(\left\|\mathscr{M}_{\varepsilon}^{S,\gamma_0}(T)\right\|_{L^2}^2\right).
$$

Next we want to take the supremum on  $[0, T]$  in the previous identity. For that sake, we use the Burkholder Davis Gundy inequality, which implies that

\mathbb{E}\left[\sup_{0\leq t\leq T}\left|\int_{0}^{t}\left\langle u_{\varepsilon}^{\gamma_{0}}(r),d\mathscr{M}_{\varepsilon}^{S,\gamma_{0}}(r)\right\rangle\right|\right]\leq 3\mathbb{E}\sqrt{\langle\mathbf{K}\int_{0}^{t}\left\langle u_{\varepsilon}^{\gamma_{0}}(r),d\mathscr{M}_{\varepsilon}^{S,\gamma_{0}}(r)\right\rangle>\rangle\mathbf{F}}\leq 3\mathbb{E}\left(\sup_{0\leq t\leq T}\|u_{\varepsilon}^{\gamma_{0}}(t)\|_{L^{2}}\sqrt{Tr\langle\mathbf{K}\mathscr{M}_{\varepsilon}^{S,\gamma_{0}}\rangle\mathbf{F}}\right)\leq \frac{1}{2}\mathbb{E}\left(\sup_{0\leq t\leq T}\|u_{\varepsilon}^{\gamma_{0}}(t)\|_{L^{2}}^{2}\right)+\frac{9}{2}\mathbb{E}(\|\mathscr{M}_{\varepsilon}^{S,\gamma_{0}}(T)\|_{L^{2}}^{2}).
$$

We then obtain, thanks to  $(26)$ ,

\mathbb{E}\left(\sup_{0\leq t\leq T} \left\|u_{\varepsilon}(t)\right\|_{H^{-\gamma_0}}^2\right) = 11 \mathbb{E}\left(\sup_{0\leq t\leq T} \left\|\mathscr{M}_{\varepsilon}^{S,\gamma_0}(t)\right\|_{L^2}^2\right) \leq 44 \mathcal{C}(\overline{\beta},\mu_S,T).
$$

We also obtain similar inequalities for  $v_{\varepsilon}$  and  $w_{\varepsilon}$ . Hence there exists a constant *C* such that for all  $\varepsilon > 0$ ,

+2\mathbb{E}\int_0^T\left[\mu_S\big\|\nabla_{\varepsilon}^+u_{\varepsilon}(r)\big\|_{H^{-\gamma_0}}^2+\mu_I\big\|\nabla_{\varepsilon}^+v_{\varepsilon}(r)\big\|_{H^{-\gamma_0}}^2+\mu_R\big\|\nabla_{\varepsilon}^+w_{\varepsilon}(r)\big\|_{H^{-\gamma_0}}^2\right]dr\leq C.\tag{28}
$$

Then [T] follows by using Markov's inequality.

Let  $\theta > 0$  and  $\overline{\tau} \in \mathcal{G}_{\varepsilon}^{T-\theta}$ . We have

Let us deal with each term separately. First using the inequality (9), there is a constant  $C(\gamma)$ such that

\mathbb{E}\bigg(\Big\|\big[\mathsf{T}_{\varepsilon,S}(\theta)-\mathbf{I}\big]u_{\varepsilon}(\overline{\tau})\Big\|_{\mathrm{H}^{-\gamma}}^2\bigg) \leq C(\gamma)(1+c)^{\gamma-\gamma}\mathbb{E}\bigg(\Big\|\big[\mathsf{T}_{\varepsilon,S}(\theta)-\mathbf{I}\big]u_{\varepsilon}(\overline{\tau})\Big\|_{\mathrm{H}^{-\gamma}}^2\bigg) \qquad + C(\gamma)\sum_{\lambda_m^{\varepsilon}\leq c}(e^{-\lambda_m^{\varepsilon}\theta}-1)^2\mathbb{E}\Big(\langle u_{\varepsilon}(\overline{\tau}),\mathbf{f}_m^{\varepsilon}\rangle^2\Big)(1+\lambda_m^{\varepsilon})^{-\gamma}

We note that the limit  $\mathfrak{I} := (u, v, w)^T$  of any convergent subsequence satisfies the following system of stochastic PDEs

**Proof:** The convergence  $f_{\varepsilon}u_{\varepsilon} \Longrightarrow fu$  follows to the fact that  $u_{\varepsilon} \Longrightarrow u$  in  $L^2(0,T; H^{-1})$  and  $f_{\varepsilon} \longrightarrow f$  in  $C([0,T]; H^1)$ . The proof of the convergence  $g_{\varepsilon} v_{\varepsilon} \Longrightarrow gy$  is similar.

 $\Box$ 

We are now interested in the convergence of the process  $\overline{S}_{\varepsilon} := (\overline{u}_{\varepsilon}, \overline{v}_{\varepsilon}, \overline{w}_{\varepsilon})$ . **Lemma 3.4.** *For any T*  $> 0$ *, there exists a positive constant C such that* 

$$
\sup_{0 \le t \le T} \left( \left\| \overline{u}_{\varepsilon}(t) \right\|_{L^{2}}^{2} + \left\| \overline{v}_{\varepsilon}(t) \right\|_{L^{2}}^{2} + \left\| \overline{w}_{\varepsilon}(t) \right\|_{L^{2}}^{2} \right) + C \int_{0}^{T} \left( \left\| \nabla_{\varepsilon}^{+} \overline{u}_{\varepsilon}(s) \right\|_{L^{2}}^{2} + \left\| \nabla_{\varepsilon}^{+} \overline{v}_{\varepsilon}(s) \right\|_{L^{2}}^{2} + \left\| \nabla_{\varepsilon}^{+} \overline{w}_{\varepsilon}(s) \right\|_{L^{2}}^{2} \right) ds \le C \eta_{T} e^{CT}, \tag{30}
$$

*where*  $\eta_{T} := \int_{0}^{T}$  $\boldsymbol{0}$  $(|u_{\varepsilon}(s)|)$  $\frac{2}{H^{-1}} + ||v_{\varepsilon}(s)||$ 2  $\binom{2}{H-1}$  *ds*.

**Proof:** For all  $t \in [0, T]$ , we have

\int_0^t \langle \frac{d\overline{u}_{\varepsilon}}{ds}(s), \overline{u}_{\varepsilon}(s) \rangle ds = \mu_S \int_0^t \langle \Delta_{\varepsilon} \overline{u}_{\varepsilon}(s), \overline{u}_{\varepsilon}(s) \rangle ds - \int_0^t \langle f_{\varepsilon}(s) \overline{u}_{\varepsilon}(s), \overline{u}_{\varepsilon}(s) \rangle ds - \int_0^t \langle g_{\varepsilon}(s) \overline{v}_{\varepsilon}(s), \overline{u}_{\varepsilon}(s) \rangle ds - \int_0^t \langle f_{\varepsilon}(s) u_{\varepsilon}(s), \overline{u}_{\varepsilon}(s) \rangle ds - \int_0^t \langle g_{\varepsilon}(s) v_{\varepsilon}(s), \overline{u}_{\varepsilon}(s) \rangle ds.
$$

Then

$$
\|\overline{u}_{\varepsilon}(t)\|_{L^{2}}^{2}+2\mu_{S}\int_{0}^{t}\|\nabla_{\varepsilon}^{+}\overline{u}_{\varepsilon}(s)\|_{L^{2}}^{2}ds=-2\int_{0}^{t}\langle f_{\varepsilon}(s)\overline{u}_{\varepsilon}(s),\,\overline{u}_{\varepsilon}(s)\rangle ds-2\int_{0}^{t}\langle g_{\varepsilon}(s)\overline{v}_{\varepsilon}(s),\,\overline{u}_{\varepsilon}(s)\rangle ds\\-2\int_{0}^{t}\langle f_{\varepsilon}(s)u_{\varepsilon}(s),\,\overline{u}_{\varepsilon}(s)\rangle ds-2\int_{0}^{t}\langle g_{\varepsilon}(s)v_{\varepsilon}(s),\,\overline{u}_{\varepsilon}(s)\rangle ds.
$$

Since  $f_{\varepsilon}(t)u_{\varepsilon}(t) \in \mathbf{H}^{-1}$  and  $g_{\varepsilon}(t)v_{\varepsilon}(t) \in \mathbf{H}^{-1}$ , then

\|\overline{u}_{\varepsilon}(t)\|_{L^{2}}^{2}+2\mu_{S}\int_{0}^{t}\|\nabla_{\varepsilon}^{+}\overline{u}_{\varepsilon}(s)\|_{L^{2}}^{2}ds\leq2\sup_{0\leq s\leq T}\|f_{\varepsilon}(s)\|_{\infty}\int_{0}^{t}\|\overline{u}_{\varepsilon}(s)\|_{L^{2}}^{2}ds+\int_{0}^{t}\Big(\sup_{0\leq s\leq T}\|g_{\varepsilon}(s)\|_{\infty}^{2}\|\overline{v}_{\varepsilon}(s)\|_{L^{2}}^{2}+\|\overline{u}_{\varepsilon}(s)\|_{L^{2}}^{2}\Big)ds+2\sup_{0\leq s\leq T}\|f_{\varepsilon}(s)\|_{H^{1,\varepsilon}}\int_{0}^{t}\big[\|u_{\varepsilon}(s)\|_{H^{-1}}(\|\overline{u}_{\varepsilon}(s)\|_{L^{2}}+\|\nabla_{\varepsilon}^{+}\overline{u}_{\varepsilon}(s)\|_{L^{2}})\big]ds+2\sup_{0\leq s\leq T}\|g_{\varepsilon}(s)\|_{H^{1,\varepsilon}}\int_{0}^{t}\big[\|v_{\varepsilon}(s)\|_{H^{-1}}(\|\overline{u}_{\varepsilon}(s)\|_{L^{2}}+\|\nabla_{\varepsilon}^{+}\overline{u}_{\varepsilon}(s)\|_{L^{2}})\big]ds.

Let  $\delta$  be some constant such that  $0 < \delta < \frac{\mu_S}{C}$  $\frac{\mu_s}{C}$ . We have

$$
\|\overline{u}_{\varepsilon}(t)\|_{L^{2}}^{2}+2\mu_{S}\int_{0}^{t}\left\|\nabla_{\varepsilon}^{+}\overline{u}_{\varepsilon}(s)\right\|_{L^{2}}^{2}ds\leq C\int_{0}^{t}\left\|\overline{u}_{\varepsilon}(s)\right\|_{L^{2}}^{2}ds+\int_{0}^{t}\left(C\left\|\overline{v}_{\varepsilon}(s)\right\|_{L^{2}}^{2}+\left\|\overline{u}_{\varepsilon}(s)\right\|_{L^{2}}^{2}\right)ds\\+C\int_{0}^{t}\left[2\delta\left\|\overline{u}_{\varepsilon}(s)\right\|_{L^{2}}^{2}+2\delta\left\|\nabla_{\varepsilon}^{+}\overline{u}_{\varepsilon}(s)\right\|_{L^{2}}^{2}+\frac{2}{\delta}\left\|u_{\varepsilon}(s)\right\|_{H^{-1}}^{2}+\frac{2}{\delta}\left\|v_{\varepsilon}(s)\right\|_{H^{-1}}^{2}\right]ds.

\|\overline{u}_{\varepsilon}(t)\|_{L^{2}}^{2} + 2(\mu_{S} - C\delta) \int_{0}^{t} \|\nabla_{\varepsilon}^{+} \overline{u}_{\varepsilon}(s)\|_{L^{2}}^{2} ds \leq (C + 2C\delta) \int_{0}^{t} \|\overline{u}_{\varepsilon}(s)\|_{L^{2}}^{2} ds + C \int_{0}^{t} \|\overline{v}_{\varepsilon}(s)\|_{L^{2}}^{2} + \frac{2C}{\delta} \int_{0}^{t} \left(\|u_{\varepsilon}(s)\|_{H^{-1}}^{2} + \|v_{\varepsilon}(s)\|_{H^{-1}}^{2}\right) ds. \quad (31)

\left\| \overline{w}_{\varepsilon}(t) \right\|_{L^{2}}^{2} + 2\mu_{R} \int_{0}^{t} \left\| \nabla_{\varepsilon}^{+} \overline{w}_{\varepsilon}(s) \right\|_{L^{2}}^{2} ds \leq \frac{C}{\delta} \int_{0}^{t} \left\| v_{\varepsilon}(s) \right\|_{H^{-1}}^{2} ds + C \int_{0}^{t} \left\| \overline{w}_{\varepsilon}(s) \right\|_{L^{2}}^{2} + C \int_{0}^{t} \left\| \overline{v}_{\varepsilon}(s) \right\|_{L^{2}}^{2} ds.
$$
 (33)

By adding the inequalities  $(31)$ ,  $(32)$  and  $(33)$ , we obtain

$$
\|\overline{u}_{\varepsilon}(t)\|_{L^{2}}^{2} + \|\overline{v}_{\varepsilon}(t)\|_{L^{2}}^{2} + \|\overline{w}_{\varepsilon}(t)\|_{L^{2}}^{2} + C\int_{0}^{t} \left( \|\nabla_{\varepsilon}^{+} \overline{u}_{\varepsilon}(s)\|_{L^{2}}^{2} + \|\nabla_{\varepsilon}^{+} \overline{v}_{\varepsilon}(s)\|_{L^{2}}^{2} + \|\nabla_{\varepsilon}^{+} \overline{w}_{\varepsilon}(s)\|_{L^{2}}^{2} \right) ds \n\leq C \int_{0}^{t} \left( \|\overline{u}_{\varepsilon}(s)\|_{L^{2}}^{2} + \|\overline{v}_{\varepsilon}(s)\|_{L^{2}}^{2} + \|\overline{w}_{\varepsilon}(s)\|_{L^{2}}^{2} \right) ds + C \int_{0}^{t} \left( \|\overline{u}_{\varepsilon}(s)\|_{H^{-1}}^{2} + \|\overline{v}_{\varepsilon}(s)\|_{H^{-1}}^{2} \right) ds.
$$

Hence applying Gronwall's Lemma we obtain

$$
\sup_{0\leq t\leq T}\left(\left\|\overline{u}_{\varepsilon}(t)\right\|_{L^{2}}^{2}+\left\|\overline{v}_{\varepsilon}(t)\right\|_{L^{2}}^{2}+\left\|\overline{w}_{\varepsilon}(t)\right\|_{L^{2}}^{2}\right) \n+C\int_{0}^{T}\left(\left\|\nabla_{\varepsilon}^{+}\overline{u}_{\varepsilon}(s)\right\|_{L^{2}}^{2}+\left\|\nabla_{\varepsilon}^{+}\overline{v}_{\varepsilon}(s)\right\|_{L^{2}}^{2}+\left\|\nabla_{\varepsilon}^{+}\overline{w}_{\varepsilon}(s)\right\|_{L^{2}}^{2}\right)ds \leq C\eta_{T}e^{CT}.
$$

We want to deduce from the fact that the pair  $(u_{\varepsilon}, v_{\varepsilon})$  converges in law towards  $(u, v)$  in  $L^2(0,T; (H^{-1})^2)$ , the convergence in law of  $(\overline{u}_{\varepsilon}, \overline{v}_{\varepsilon}, \overline{w}_{\varepsilon})$ .

**Lemma 3.5.** *The process*  $\{(\overline{u}_{\varepsilon}(t), \overline{v}_{\varepsilon}(t), \overline{w}_{\varepsilon}(t)), 0 \le t \le T, 0 < \varepsilon < 1\} \Rightarrow$  $\{(\overline{u}(t), \overline{v}(t), \overline{w}(t)), 0 \le t \le T\}$  in  $L^2(0,T;(L^2)^3) \cap C([0,T];(H^{-1})^3)$ , where the limit  $\{(\overline{u}(t), \overline{v}(t), \overline{w}(t)), 0 \le t \le T\}$  is the unique solution of the following system of parabolic *PDEs*

$$
\begin{cases}\n\frac{d\overline{u}}{dt}(t) = \mu_S \Delta \overline{u}(t) - f(t)\overline{u}(t) - g(t)\overline{v}(t) - f(t)u(t) - g(t)v(t) \\
\frac{d\overline{v}}{dt}(t) = \mu_I \Delta \overline{v}(t) + f(t)\overline{u}(t) + g(t)\overline{v}(t) + f(t)u(t) + g(t)v(t) - \alpha(v(t) + \overline{v}(t)) \\
\frac{d\overline{w}}{dt}(t) = \mu_R \Delta \overline{w}(t) + \alpha(v(t) + \overline{v}(t)) \\
\overline{u}(0) = \overline{v}(0) = \overline{w}(0) = 0.\n\end{cases} (34)
$$

Proof: Let

$$
\overline{\mathfrak{I}}_{\varepsilon}(t) = \begin{pmatrix} \overline{u}_{\varepsilon}(t) \\ \overline{v}_{\varepsilon}(t) \\ \overline{w}_{\varepsilon}(t) \end{pmatrix}, \quad F_{\varepsilon}(t) = \begin{pmatrix} -f_{\varepsilon}(t)u_{\varepsilon}(t) - g_{\varepsilon}(t)v_{\varepsilon}(t) \\ f_{\varepsilon}(t)u_{\varepsilon}(t) + (g_{\varepsilon}(t) - \alpha)v_{\varepsilon}(t) \\ \alpha v_{\varepsilon}(t) \end{pmatrix},
$$

$$
\Lambda_{\varepsilon}(t) = \begin{pmatrix} \mu_{\varepsilon}\Delta_{\varepsilon} - f_{\varepsilon}(t) & -g_{\varepsilon}(t) & 0 \\ f_{\varepsilon}(t) & \mu_{\varepsilon}\Delta_{\varepsilon} + g_{\varepsilon}(t) - \alpha & 0 \\ 0 & 0 & \mu_{\varepsilon}\Delta_{\varepsilon} + \alpha \end{pmatrix}.
$$

Note that both  $\overline{S}_{\varepsilon}$  and  $F_{\varepsilon}$  belong to  $L^2(0,T; (H_{\varepsilon})^3)$ . We have the following system of ODEs

$$
\frac{d\overline{\mathfrak{I}}_{\varepsilon}}{dt}(t) = \Lambda_{\varepsilon}(t)\overline{\mathfrak{I}}_{\varepsilon}(t) + F_{\varepsilon}(t), \quad \overline{\mathfrak{I}}_{\varepsilon}(0) = 0.

Lemma 3.3 tells us that whenever, as  $\varepsilon \to 0$ ,

F_{\varepsilon} \Longrightarrow F \text{ in } L^2(0,T; (H^{-1})^3),
$$

where

$$
F(t) = \begin{pmatrix} -f(t)u(t) - g(t)v(t) \\ f(t)u(t) + g(t)v(t) - \alpha v(t) \\ \alpha v(t) \end{pmatrix}.
$$
 (36)

We apply the well–known theorem due to Skorohod, which asserts that redefining the probability space, we can assume that  $F_{\varepsilon} \to F$  a.s. strongly in  $L^2((0,T);(H^{-1})^3)$ . Our assumptions and the hypotheses imply that both  $\overline{\mathcal{S}}_{\varepsilon}$  and  $\nabla_{\varepsilon}^{\perp} \overline{\mathcal{S}}_{\varepsilon}$  are bounded in  $(L^2((0,T)\times \mathbb{T}^1))^3$ . Hence along a subsequence  $\overline{\mathcal{S}}_{\varepsilon} \to \overline{\mathcal{S}}$  and  $\nabla_{\varepsilon}^{\pm} \overline{\mathcal{S}}_{\varepsilon} \to \overline{G}$  in  $(L^2((0,T) \times \mathbb{T}^1))^3$  weakly. However, it follows from a duality argument that  $G = \nabla \mathfrak{S}$ , and taking the weak limit in (35), we deduce that  $\mathfrak{S}$  is the unique solution of the system of parabolic PDEs

$$
\frac{d\overline{3}}{dt}(t) = \Lambda(t)\overline{3}(t) + F(t), \quad \overline{3}(0) = 0,
$$

with

$$
\Lambda(t) = \begin{pmatrix} \mu_S \Delta - f(t) & -g(t) & 0 \\ f(t) & \mu_I \Delta + g(t) - \alpha & 0 \\ 0 & 0 & \mu_R \Delta + \alpha \end{pmatrix}.
$$
 (37)

Hence all converging subsequences have the same limit, and the whole sequence converges.

We now show that the pair  $\langle \overline{\mathcal{F}}_{\varepsilon}, \nabla_{\varepsilon}^+ \overline{\mathcal{F}}_{\varepsilon} \rangle$  converges strongly in  $(L^2((0,T) \times \mathbb{T}^1))$ <sup>6</sup>. We first note that both  $\overline{S}_{\varepsilon}$  and  $\nabla_{\varepsilon}^{+} \overline{S}_{\varepsilon}$  are bounded in  $(L^2((0,T)\times \mathbb{T}^1))^3$ , but also  $\frac{d}{dt}\overline{S}_{\varepsilon}$  is bounded in  $L^2((0,T);(H^{-1}(\mathbb{T}^1))^3)$ . From these estimates, we deduce with the help of Theorem 5.4 in Droniou et al. (2018) that  $\overline{S}_{\varepsilon} \to \overline{S}$  strongly in  $(L^2((0,T)\times\mathbb{T}^1))^3$ . Next we deduce from (35) that

$$
\frac{1}{2}\frac{d\left\|\overline{\mathfrak{I}}_{\varepsilon}(t)\right\|^{2}_{L^{2}}}{dt}=\langle\Lambda_{\varepsilon}\overline{\mathfrak{I}}_{\varepsilon}(t),\overline{\mathfrak{I}}_{\varepsilon}(t)\rangle+\langle F_{\varepsilon}(t),\overline{\mathfrak{I}}_{\varepsilon}(t)\rangle,
$$

hence

$$
\frac{1}{2} \left\| \overline{\mathfrak{I}}_{\varepsilon}(T) \right\|_{L^{2}}^{2} + \int_{0}^{T} \left[ \mu_{S} \left\| \nabla_{\varepsilon}^{+} \overline{u}_{\varepsilon}(t) \right\|_{L^{2}}^{2} + \mu_{I} \left\| \nabla_{\varepsilon}^{+} \overline{v}_{\varepsilon}(t) \right\|_{L^{2}}^{2} + \mu_{R} \left\| \nabla_{\varepsilon}^{+} \overline{w}_{\varepsilon}(t) \right\|_{L^{2}}^{2} \right] dt \qquad (38)
$$
\n
$$
= \int_{0}^{T} \left[ \langle f_{\varepsilon}(t) \overline{u}_{\varepsilon}(t) + g_{\varepsilon}(t) \overline{v}_{\varepsilon}(t), \overline{v}_{\varepsilon}(t) - \overline{u}_{\varepsilon}(t) \rangle + \left\| \sqrt{\alpha} \, \overline{w}_{\varepsilon}(t) \right\|_{L^{2}}^{2} - \left\| \sqrt{\alpha} \, \overline{v}_{\varepsilon}(t) \right\|_{L^{2}}^{2} + \langle F_{\varepsilon}(t), \overline{\mathfrak{I}}_{\varepsilon}(t) \rangle \right] dt \, .
$$

We have an analogous identity for the limiting quantities, namely:

$$
\frac{1}{2} \left\| \overline{\mathfrak{I}}(T) \right\|_{L^2}^2 + \int_0^T \left[ \mu_S \left\| \nabla \overline{u}(t) \right\|_{L^2}^2 + \mu_I \left\| \nabla \overline{v}(t) \right\|_{L^2}^2 + \mu_R \left\| \nabla \overline{w}(t) \right\|_{L^2}^2 \right] dt \tag{39}

= \int_0^T \left[ \langle f(t) \overline{u}(t) + g(t) \overline{v}(t), \overline{v}(t) - \overline{u}(t) \rangle + \left\| \sqrt{\alpha} \overline{w}(t) \right\|_{L^2}^2 - \left\| \sqrt{\alpha} \overline{v}(t) \right\|_{L^2}^2 + \langle F(t), \overline{\mathfrak{I}}(t) \rangle \right] dt.
$$

It follows from the strong convergence of  $F_{\varepsilon}$  to *F* in  $L^2(0,T;(H^{-1})^3)$ , the strong convergence of  $\overline{\mathcal{F}}_{\varepsilon} \to \overline{\mathcal{F}}$  in  $(L^2((0,T) \times \mathbb{T}^1))^3$  and the weak convergence of  $\nabla_{\varepsilon}^{\perp} \overline{\mathcal{F}}_{\varepsilon}$  to  $\nabla \overline{\mathcal{F}}$  in  $(L^2((0,T) \times \mathbb{T}^1))^3$ that the right hand side of (38) converges to the right hand side of (39). Hence the left hand side of  $(38)$  converges to the left hand side of  $(39)$ . Consequently

$$
\frac{1}{2} \left\| \overline{\mathfrak{I}}_{\varepsilon}(T) - \overline{\mathfrak{I}}(T) \right\|_{L^{2}}^{2} + \int_{0}^{T} \left[ \mu_{S} \left\| \nabla_{\varepsilon}^{+} \overline{u}_{\varepsilon}(t) - \nabla \overline{u}(t) \right\|_{L^{2}}^{2} + \mu_{I} \left\| \nabla_{\varepsilon}^{+} \overline{v}_{\varepsilon}(t) - \nabla \overline{v}(t) \right\|_{L^{2}}^{2} + \mu_{R} \left\| \nabla_{\varepsilon}^{+} \overline{w}_{\varepsilon}(t) - \nabla \overline{w}(t) \right\|_{L^{2}}^{2} \right\} dt \to 0.
$$
 (40)

This last result follows from the convergence of the left hand side of (38) to that of (39), and the facts that

$$
\langle \overline{\mathfrak{T}}_{\varepsilon}(T),\overline{\mathfrak{T}}(T)\rangle \rightarrow ||\overline{\mathfrak{T}}(T)||_{L^2}^2,
$$

and

$$
\int_0^T \left[ \mu_S \langle \nabla_{\varepsilon}^+ \overline{u}_{\varepsilon}(t), \nabla \overline{u}(t) \rangle + \mu_I \langle \nabla_{\varepsilon}^+ \overline{v}_{\varepsilon}(t), \nabla \overline{v}(t) \rangle + \mu_R \langle \nabla_{\varepsilon}^+ \overline{w}_{\varepsilon}(t), \nabla \overline{w}(t) \rangle \right] dt \n\to \int_0^T \left[ \mu_S \left\| \nabla \overline{u}(t) \right\|_{L^2}^2 + \mu_I \left\| \nabla \overline{v}(t) \right\|_{L^2}^2 + \mu_R \left\| \nabla \overline{w}(t) \right\|_{L^2}^2 \right] dt.
$$

The second convergence follows from the fact that  $\nabla_{\epsilon}^{+}\overline{\mathcal{S}}_{\epsilon}\to \nabla\overline{\mathcal{S}}$  in  $(L^{2}((0,T)\times\mathbb{T}^{1}))_{-}^{3}$  weakly. Concerning the first one, we deduce from the equations and the above statements that  $\mathfrak{S}_{\varepsilon}(T) \to$  $\overline{\mathcal{S}}(T)$  weakly in  $(H^{-1})^3$ . But since that sequence is bounded in  $(L^2(\mathbb{T}^1))^3$ , it also converges weakly in  $(L^2(\mathbb{T}^1))^3$ .

The fact that  $\nabla_{\varepsilon}^+ \overline{\mathfrak{I}}_{\varepsilon} \to \nabla \overline{\mathfrak{I}}$  strongly in  $(L^2((0,T)\times \mathbb{T}^1))^3$  clearly follows from (40).

The above arguments imply that a.s.

$$
\langle \overline{\mathfrak{I}}_{\varepsilon}, \nabla_{\varepsilon}^+ \overline{\mathfrak{I}}_{\varepsilon} \rangle \to \langle \overline{\mathfrak{I}}, \nabla \overline{\mathfrak{I}} \rangle \text{ strongly in } (L^2((0,T) \times \mathbb{T}^1))^{6}.
$$

Now the convergence  $\overline{\mathfrak{S}}_{\varepsilon} \to \overline{\mathfrak{S}}$  in  $C([0,T];(H^{-1})^3)$  follows readily from the equation.

 $\Box$ 

Lemma 3.2 says that  $\mathfrak{I}_{\varepsilon} \Rightarrow \mathfrak{I}$  in  $C([0,T]; (H^{-\gamma})^3) \cap L^2(0,T; (H^{-1})^3)$ , we have used in Lemma 3.5 the Skorohod theorem to deduce that  $\overline{\mathcal{S}}_{\varepsilon} \Rightarrow \overline{\mathcal{S}}$  in  $L^2(0,T(L^2)^3) \cap C([0,T];(H^{-\gamma})^{-1})$ . Hence the same Skorohod theorem allows us to take the limit in the sum  $\mathfrak{S}_{\varepsilon} + \overline{\mathfrak{S}}_{\varepsilon}$ , which yields the following result.

**Theorem 3.2** (Functional central limit theorem). *For*  $3/2 < \gamma < 2$ , as  $\varepsilon \to 0$ ,  $\{\mathscr{Y}_{\varepsilon}(t), 0 \le t \le 1\}$  $T$ }<sub>0<ε<1</sub>  $\Longrightarrow$  { $\mathscr{Y}(t)$  , 0  $\leq$   $t \leq T$ } *in*  $C([0,T];$   $(\mathrm{H}^{-\gamma})^3)$   $\cap$   $L^2(0,T;(\mathrm{H}^{-1})^3)$ *, where the limit*  $\mathscr{Y}$ 

is solution of the following system of SPDEs : for all  $\varphi \in \mathrm{H}^1$ 

$$
\begin{cases}\n\langle \mathcal{U}(t), \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} = \mu_{S} \int_{0}^{t} \langle \mathcal{U}(r), \Delta \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} dr + \int_{0}^{t} \langle \mathcal{V}(r), \beta(.) \frac{\mathbf{i}(r)(\mathbf{i}(r) + \mathbf{r}(r))}{\mathbf{a}^{2}(r)} \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} dr \\
+ \int_{0}^{t} \langle \mathcal{U}(r), \beta(.) \frac{\mathbf{s}(r)(\mathbf{s}(r) + \mathbf{r}(r))}{\mathbf{a}^{2}(r)} \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} dr + \langle \mathcal{M}^{S}(t), \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} \\
\langle \mathcal{V}(t), \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} = \mu_{I} \int_{0}^{t} \langle \mathcal{V}(r), \Delta \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} dr - \int_{0}^{t} \langle \mathcal{V}(r), \beta(.) \frac{\mathbf{i}(r)(\mathbf{i}(r) + \mathbf{r}(r))}{\mathbf{a}^{2}(r)} \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} dr \\
- \int_{0}^{t} \langle \mathcal{U}(r), \beta(.) \frac{\mathbf{s}(r)(\mathbf{s}(r) + \mathbf{r}(r))}{\mathbf{a}^{2}(r)} \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} dr + \int_{0}^{t} \langle \mathcal{V}(r), \alpha(.) \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} dr + \langle \mathcal{M}^{I}(t), \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} dr \\
\langle \mathcal{W}(t), \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} = \mu_{R} \int_{0}^{t} \langle \mathcal{W}(r), \Delta \varphi \rangle_{\mathbf{H}^{-1}, \mathbf{H}^{1}} dr - \int_{0}^{t} \langle \mathcal{V}(r), \alpha(.) \varphi \rangle_{\mathbf{H}^{-
$$

Final remarks: • Our functional central limit theorem is established in dimension 1. The difficulty in higher dimension is the following.  $\gamma > 3/2$  has to be replaced by  $\gamma > 1 + d/2$ . Then in Lemma 3.2 we have convergence in  $L^2(0,T;(H^{1-\gamma})^3) \cap C([0,T];(H^{-\gamma})^3)$ . Note that  $1-\gamma < -d/2$ . Already in dimension 2, we have  $1-\gamma < -1$ , and there is a serious difficulty with the analog of Lemma 3.5.

• In this work, we have first let  $N \to \infty$ , while  $\varepsilon > 0$  is fixed, and then let  $\varepsilon \to 0$ . The case where  $N \to +\infty$  and  $\varepsilon \to 0$  together, with some constraint on the relative speeds of convergence (which does not allow N to converge too slowly to  $\infty$  while  $\varepsilon \to 0$ ) will be the subject of future work.

## Appendix A

**Lemma A.1.** Let  $(h_{\varepsilon})_{0<\varepsilon<1}$  be a sequence of  $H_{\varepsilon}$ . If  $(h_{\varepsilon})_{0<\varepsilon<1}$  is bounded in  $H^{1,\varepsilon}$ , then it is *relatively compact in*  $L^2$ *, and the limit of any convergent subsequence belongs to*  $H^1$ .

**Proof:** By using the fact that the sequence  $(h_{\varepsilon})$  is bounded in  $L^2$  and  $\|\nabla_{\varepsilon}^+ h_{\varepsilon}\|_{L^2} \leq C \|h_{\varepsilon}\|_{H^1}$ , then the result of the compactness follows from the compactness theorem of Kolmogorov in  $L^2$ .

The fact the limit of any convergent subsequence belong to  $H<sup>1</sup>$ , follows from the discrete integrating by part

$$
\int_{\mathbb{T}^1} \nabla_{\varepsilon}^+ h_{\varepsilon}(x) \varphi(x) dx = - \langle \int_0^{\cdot} h_{\varepsilon}(y) dy \, , \, \nabla_{\varepsilon}^+ \varphi \, \rangle,
$$

and letting  $\varepsilon$  go to zero in this equation.

**Lemma A.2.** For all

u_{\varepsilon} \in H_{\varepsilon}

\left\| \nabla_{\varepsilon}^{-} u_{\varepsilon} \right\|_{H^{-\gamma,\varepsilon}}^{2} = \left\| \nabla_{\varepsilon}^{+} u_{\varepsilon} \right\|_{H^{-\gamma,\varepsilon}}^{2} = \sum_{m} \left( \langle u_{\varepsilon}, \varphi_{m}^{\varepsilon} \rangle^{2} + \langle u_{\varepsilon}, \psi_{m}^{\varepsilon} \rangle^{2} \right) \lambda_{m}^{\varepsilon} (1 + \lambda_{m}^{\varepsilon})^{-\gamma}.
$$

Proof: We have

$$
\nabla_{\varepsilon}^{-} \varphi_{m}^{\varepsilon} = -b_{m,\varepsilon} \varphi_{m}^{\varepsilon} - a_{m,\varepsilon} \psi_{m}^{\varepsilon} \text{ and } \nabla_{\varepsilon}^{-} \psi_{m}^{\varepsilon} = a_{m,\varepsilon} \varphi_{m}^{\varepsilon} - b_{m,\varepsilon} \psi_{m}^{\varepsilon},
$$

where  $a_{m,\varepsilon} = \varepsilon^{-1} \sin(\pi m \varepsilon)$  and  $b_{m,\varepsilon} = \varepsilon^{-1} (\cos(\pi m \varepsilon) - 1)$ . We have

$$
a_{m,\varepsilon}^2+b_{m,\varepsilon}^2=\lambda_m^{\varepsilon}.
$$

Let  $u_{\varepsilon} \in H_{\varepsilon}$ . We have

$$
\begin{split}\n\left\|\nabla_{\varepsilon}^{+}u_{\varepsilon}\right\|_{H^{-\gamma,\varepsilon}}^{2} &= \sum_{m} \left(\langle u_{\varepsilon}, \nabla_{\varepsilon}^{-} \varphi_{m} \rangle^{2} + \langle u_{\varepsilon}, \nabla_{\varepsilon}^{-} \psi_{m} \rangle^{2}\right) (1 + \lambda_{m}^{\varepsilon})^{-\gamma} \\
&= \sum_{m} \left(\langle u_{\varepsilon}, -b_{m,\varepsilon} \varphi_{m}^{\varepsilon} - a_{m,\varepsilon} \psi_{m}^{\varepsilon}\rangle^{2} + \langle u_{\varepsilon}, a_{m,\varepsilon} \varphi_{m}^{\varepsilon} - b_{m,\varepsilon} \psi_{m}^{\varepsilon}\rangle^{2}\right) (1 + \lambda_{m}^{\varepsilon})^{-\gamma} \\
&= \sum_{m} \left(\left[-b_{m,\varepsilon} \langle u_{\varepsilon}, \varphi_{m}^{\varepsilon}\rangle - a_{m,\varepsilon} \langle u_{\varepsilon}, \psi_{m}^{\varepsilon}\rangle\right]^{2} + \left[a_{m,\varepsilon} \langle u_{\varepsilon}, \varphi_{m}^{\varepsilon}\rangle - b_{m,\varepsilon} \langle u_{\varepsilon}, \psi_{m}^{\varepsilon}\rangle\right]^{2}\right) (1 + \lambda_{m}^{\varepsilon})^{-\gamma} \\
&= \sum_{m} \left(\left[a_{m,\varepsilon}^{2} + b_{m,\varepsilon}^{2}\right] \left\{\langle u_{\varepsilon}, \varphi_{m}^{\varepsilon}\rangle^{2} + \langle u_{\varepsilon}, \psi_{m}^{\varepsilon}\rangle^{2}\right\}\right) (1 + \lambda_{m}^{\varepsilon})^{-\gamma} \\
&= \sum_{m} \left(\langle u_{\varepsilon}, \varphi_{m}^{\varepsilon}\rangle^{2} + \langle u_{\varepsilon}, \psi_{m}^{\varepsilon}\rangle^{2}\right) \lambda_{m}^{\varepsilon} (1 + \lambda_{m}^{\varepsilon})^{-\gamma}.\n\end{split}
$$

The proof of  $\left\|\nabla_{\varepsilon}^{-} u_{\varepsilon}\right\|$ 2  $\sum_{\mu=\gamma,\varepsilon}^{2} = \sum_{m} \left( \langle u_{\varepsilon}, \varphi_{m}^{\varepsilon} \rangle^{2} + \langle u_{\varepsilon}, \psi_{m}^{\varepsilon} \rangle^{2} \right) \lambda_{m}^{\varepsilon} (1 + \lambda_{m}^{\varepsilon})^{-\gamma}$  is similar by noting that

$$
\nabla_{\varepsilon}^{+}\varphi_{m}^{\varepsilon}=b_{m,\varepsilon}\varphi_{m}^{\varepsilon}-a_{m,\varepsilon}\psi_{m}^{\varepsilon} \text{ and } \nabla_{\varepsilon}^{+}\psi_{m}^{\varepsilon}=a_{m,\varepsilon}\varphi_{m}^{\varepsilon}+b_{m,\varepsilon}\psi_{m}^{\varepsilon}.
$$
