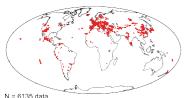

Scientific context and objectives

Archaeomagnetic data are very rare in Sub-Saharan Africa, representing only 0.7% of GEOMAGIA50 global database. This lack of data makes poorly constrained the secular variation over the last millennia in this region, while intertropical Africa is one of the areas with the most rapid changes in the modern geomagnetic field, especially because of the proximity with the South Atlantic anomaly,



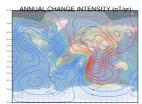
Geographic distribution of intensity data (from Brown et al., 2021)

The archaeological potential is yet important. In Sub-Saharan Africa, the best-preserved baked structures are iron furnaces and several studies have been recently published in Kenya (Tchibinda et al., 2020), Burkina Faso and Ivory Coast (Kapper et al., 2017, 2020). Kapper et al. (2020) proposed an intensity secular variation curve defined with data from West- and North Africa. This "local" curve remains uncertain, particularly because it covers a very large area.

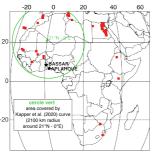
The objectives of our study are:

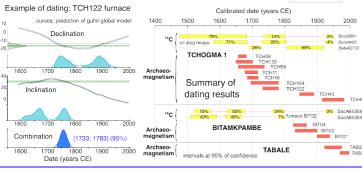

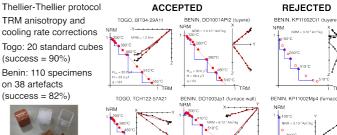

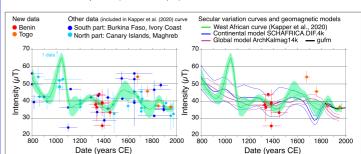

Archaeointensity results and interpretations





These good results highlight further the feasibility of archaeomagnetic analyses on such baked clays. The average intensity obtained on the most recent Togolese furnace dated [1923; 1977] (32,2 \pm 1,1 μ T) is very close to the value predicted by IGRF model at this period (32.0 - 32.5 μ T)



Comparison of new data with selected data and curve in Kapper et al. (2020) and predictions of geomagnetic models (data relocated and curves calculated at 21°N - 0°E)

- → Beninese data suggest a fast secular variation between 1300 and 1500 CE with an intensity minimum.
- Togolese data (still preliminary) show a sharp intensity decrease between 1650 and 1850 followed by a slower variation.
- New data are fairly in agreement with those from Burkina Faso and Ivory Coast (Kapper et al., 2017, 2020).
- The inconsistency with the regional curve of Kapper et al. (2020) and the prediction of the continental geomagnetic model SCHAFRICA.DIF.4k (Di Chiara et Pavon-Carrasco, 2022) between 1600 and 1800 CE could highlight a different secular variation between Sahel and North Africa.
- The predictions of global models appear more consistent with the data, even though they smooth significantly the secular variation.

Conclusions

The new intensity data constitute a further step towards a better knowledge of the secular variation in West Africa. This study also highlights the potential of archaeomagnetic dating to better reconstitute the chronology of iron metallurgy, one of the main markers of past societies in Sub-Saharan Africa.
