14 **Summary.** Nuclear Magnetic Resonance (NMR) is widely used for quantitative analysis of metabolic 15 systems. Accurate extraction of NMR parameters – such as chemical shift, intensity, coupling 16 constants, and linewidth – is essential for obtaining information on the structure, concentration, and 17 isotopic composition of metabolites. We present MultiNMRFit, an open-source software designed for 18 high-throughput analysis of one-dimensional NMR spectra, whether acquired individually or as 19 pseudo-2D experiments. MultiNMRFit extracts signal parameters (e.g. intensity, area, chemical shift, 20 and coupling constants) by fitting the experimental spectra using built-in or user-defined signal 21 models that account for multiplicity, providing high flexibility along with robust and reproducible 22 results. The software is accessible both as a Python library and via a graphical user interface, enabling 23 intuitive use by end-users without computational expertise. We demonstrate the robustness and 24 flexibility of MultiNMRFit on datasets collected in metabolomics and isotope labeling studies. 25 **Availability and Implementation.** MultiNMRFit is implemented in Python 3 and was tested on 26 Unix, Windows, and MacOS platforms. The source code and the documentation are freely distributed 27 under GPL3 license at https://github.com/NMRTeamTBI/MultiNMRFit/. 28 **Supplementary data.** Supplementary data are available online.

32 **1. Introduction** 33

34 Nuclear Magnetic Resonance (NMR) spectroscopy is a powerful tool for investigating metabolism. 35 Key applications include identifying and quantifying metabolites in metabolomics, determining the 36 isotopic content of metabolites in 13 C-fluxomics, and identifying and characterizing protein-37 metabolite interactions [1–4]. Extracting meaningful information from NMR spectra requires precise 38 characterization of each signal of interest, including their position (chemical shift), intensity (and 39 area) and shape (coupling constants and linewidth) [5]. Signal parameters can be estimated by fitting 40 spectra using various mathematical models that relate these parameters to the observed signals. This 41 fitting step is often achieved with in-house scripts, which, while functional, may lack the robustness 42 and reproducibility necessary for large-scale or complex NMR studies of metabolic systems. 43 Commercial software, such as TopSpin (Bruker) and Mnova (Mestrelab), provide alternative 44 solutions, offering a user-friendly interface but functioning as proprietary "black boxes" and restricted 45 to a limited set of signal models. Open-source R and Python packages (such as *MetaboDecon1D* [6] 46 and *BATMAN* [7,8]) have also been developed to enhance accessibility and reproducibility. However, 47 they are designed for programmatic use and do not include certain features essential for users without 48 computational expertise. Such features include statistical methods for calculating confidence intervals 49 for extracted parameters, a graphical user interface, and a logging system to save calculation 50 parameters and process information along with the results. Another key challenge is that most existing 51 tools treat each peak as an independent signal. However, NMR signals often consist of multiple peaks 52 arising from homo- and heteronuclear scalar couplings, which are intrinsic properties crucial for 53 identifying metabolites and quantifying their isotopic content. Considering signal multiplicity can also 54 improve parameter estimation in cases of overlapping peaks. However, most current tools do not 55 account for this complexity, which can limit their effectiveness in extracting and utilizing this 56 information. Consequently, the detailed analysis of NMR spectra remains a low throughput task, 57 typically performed by expert users, which can constrain the analysis of large datasets, such as those 58 generated in real-time NMR experiments. The development of user-friendly, open-source software 59 that incorporates signal multiplicity and enables flexible implementation of tailored signal models 60 would significantly enhance the scope, efficiency, and reproducibility of NMR-based metabolic 61 studies.

62 To address these challenges, we have developed MultiNMRFit, a versatile Python software for fitting 63 one dimensional NMR spectra, whether acquired individually or as pseudo-2D datasets in time-course 64 experiments. MultiNMRFit can be applied to any nucleus $(^1H, ^{13}C, ^{15}N, ^{31}P, etc.),$ any type of 1D or 65 pseudo-2D NMR experiment, and any type of signal. It includes built-in signal models for common 66 multiplets and is easily extendable with user-defined models to process less conventional signals. 67 MultiNMRFit is accessible both as a Python library and via a graphical user interface, allowing 68 biologists without computational expertise to use it effectively. We demonstrate the robustness of 69 MultiNMRFit on synthetic data and through its application to real-time metabolomics and isotope 70 labeling experiments.

72 **2. Methods and implementation**

73 The general workflow of MultiNMRFit is shown in Figure 1. MultiNMRFit is a Python-based library 74 that operates within common web browsers via a Streamlit-powered graphical user interface. Users 75 can load 1D and pseudo-2D Bruker spectra pre-processed beforehand (*i.e.* referenced, phase-corrected 76 and baseline-corrected). Spectra can also be provided as text files containing chemical shifts and 77 intensities. MultiNMRFit performs automated peak picking within a specified spectral region, and 78 users can add additional peaks manually. One or several peaks can then be grouped into a signal, and 79 a model must be selected for each signal. As detailed in the next section, each model contains 80 equations to simulate the corresponding signal based on parameters. MultiNMRFit automatically 81 suggests a list of models based on the number of peaks (e.g., *doublet of doublet*s and *quartet* for 82 signals containing four peaks) and initializes parameters based on the peak list. Note that a given peak 83 can be included in multiple signals to account for overlapping peaks. For spectrum fitting, parameters 84 p are estimated by minimizing the cost function $c(p)$, which is defined as the sum of squared residuals between the experimental intensities (a_i) and the values simulated by the model $y_i(p)$:

$$
c(p) = \sum_i (a_i - y_i(p))^2
$$

86 The cost function is minimized using the L-BFGS-B method [9], with an optional initial refinement 87 step performed by the differential evolution algorithm [10]. Standard deviations on parameters are 88 estimated from the covariance matrix. For batch processing of spectra, users can select a spectrum as 89 reference to automatically initialize signals and parameters values for the next spectra, thereby 90 automating the processing of multiple spectra for high-throughput analysis. Finally, MultiNMRFit 91 provides a range of interactive plots for visual inspection of fitting results. The results can be exported 92 as *csv* files containing *(i)* parameters values (with their confidence intervals) and *(ii)* chemical shifts 93 and intensities of experimental and fitted spectra.

94 The complete process is automatically saved as a pickle file, which can be reloaded in MultiNMRFit 95 to continue previous work or reanalyze calculation results. This file can also be shared, enabling 96 collaborative analysis across multiple users and ensuring reproducibility. Detailed usage of 97 MultiNMRFit can be found in the online documentation (https://MultiNMRFit.readthedocs.io).

99 **3. Signal models**

100 A signal model consists of *(i)* equations that describe signal intensity as a function of chemical shift 101 (used for simulations) and *(ii)* a list of parameters with their default values and bounds (used for 102 optimization). Various mathematical functions, including Lorentzian, Gaussian, and Voigt functions,

103 can be used to simulate the NMR spectrum of a given signal. For example, the intensity y_i of a 104 doublet at chemical shift x_i can be described using the following Gaussian function:

y_i = I/2 \cdot \left(e^{-(x_i - x_0 + J/2)^2/(2 \cdot l_w^2)} + e^{-(x_i - x_0 - J/2)^2/(2 \cdot l_w^2)} \right)

107 with parameters x_0 (chemical shift of the signal), I (total signal intensity), I (coupling constant), and 108 l_w (linewidth at half maximum). An NMR spectrum containing multiple signals can be simulated by 109 summing the spectra of individual signals.

110 By default, MultiNMRFit provides mixed Gaussian-Lorentzian models for common multiplets, 111 including singlet, doublet, triplet, doublet of doublets, and quadruplet. Advanced users can create 112 custom models to handle less conventional signals, such as signals with other coupling patterns or 113 described using alternative mathematical functions. A model template is included with MultiNMRFit 114 for this purpose, and a tutorial on model construction is available in the documentation.

116 **4. Validation and application to metabolomics and isotopic datasets**

117 We validated MultiNMRFit using synthetic datasets (Supplementary data). Results confirm the 118 capability of the software to handle complex spectral data and deliver robust parameter estimation 119 even under challenging conditions (such as low signal-to-noise ratio or significant signal overlaps).

120 Then, we used MultiNMRFit to monitor the dynamic conversion of glucose through the initial steps 121 of glycolysis. Glucose was added to a buffer solution containing TSP (sodium trimethylsilyl 122 propionate, used as internal standard), ATP and the first three enzymes of glycolysis: glucokinase, 123 glucose-6-phosphate isomerase, and phosphofructokinase (Figure 2A, Supplementary data). The time-124 course signals of glucose (GLC), glucose-6-phosphate (G6P), fructose-6-phosphate (F6P), fructose-125 1,6-bisphosphate (FBP), ATP and ADP were monitored in real-time using a pseudo-2D experiment 126 consisting in 1024 1D $\rm{^1H}$ spectra. All signal parameters were successfully extracted, including for 127 overlapped signals of ADP and ATP (Figure 2B). The integrals of signals specific to each metabolite 128 were normalized to the TSP signal (Figure 2C). A progressive decrease in GLC signal was observed, 129 accompanied by a transient accumulation of G6P and F6P, which were eventually converted into 130 FBP. The high precision and resolution on the estimated dynamics illustrate the value of 131 MultiNMRFit for high-throughput processing of large datasets, with the relative concentrations of the 132 six metabolites of interest quantified in less than three hours for the 1024 spectra.

133 MultiNMRFit can also exploit the multiplicity resulting from the presence of isotopes in metabolites 134 to quantify their isotopic content – a key capability for applications such as detecting counterfeit 135 chemicals, identifying metabolic pathways, and quantifying metabolic fluxes [11,12]. To demonstrate 136 this, we conducted a ¹³C-isotope labeling experiment by growing *Escherichia coli* on a mixture of 137 glucose (15 mM, 80% 1-¹³C₁-glucose + 20% U-¹³C₆-glucose) and acetate (8 mM, 100% 2-¹³C₁-

138 acetate). Samples were collected each hour to quantify the dynamics of all isotopic forms of acetate (Supplementary data). In the ${}^{1}H$ NMR spectra, the methyl protons of acetate may give raise to nine 140 peaks corresponding to the four isotopic species of this compound: a singlet for ${}^{12}C_2$ -acetate, a doublet 141 with a small (6 Hz) 2J coupling constant for $1^{-13}C_1$ -acetate, a doublet with a large (127 Hz) 1J 142 coupling constant for $2^{-13}C_1$ acetate, and a doublet of doublet for U-¹³C₂-acetate. The results showed 143 that the total acetate concentration remained stable throughout the experiment (8.5±0.1 mM), which 144 could be interpreted as an acetate flux close to zero (Figure 2D-G). However, while the provided 145 isotopic form $(2^{-13}C_1$ -acetate) initially represents 99% of the total acetate pool, its concentration 146 decreased over time (from 8.5 to 6.5 mM). Concurrently, the concentration of the other labeled forms 147 (derived from glucose) increased (from 0.1 to 1.9 mM). These results support previous findings [13] 148 that acetate is continuously exchanged between cells and their environment, even in the absence of net 149 acetate accumulation in the medium. This example illustrates the applicability of MultiNMRFit for 150 extracting quantitative isotopic information on metabolites, providing meaningful biological insights.

152 **Conclusion**

153 We present MultiNMRFit, an open-source Python software designed to extract detailed quantitative 154 parameters from NMR spectra. MultiNMRFit is applicable to spectra acquired from any nucleus, 155 whether as 1D or pseudo-2D spectra, and can handle any type of multiplicity through a flexible 156 system for implementing NMR signal models. MultiNMRFit is accessible to non-expert users through 157 a graphical user interface and can also be used as a Python package, enabling seamless integration 158 into metabolomics and fluxomics workflows. Furthermore, MultiNMRFit holds significant potential 159 for other NMR applications, including protein studies, the pharmaceutical industry, biotechnology, 160 and chemistry.

218 **Figure 1. Flow chart of MultiNMRFit.**

219 **Figure 2. Applications of MultiNMRFit to metabolomics and isotope labeling studies. (A)** 220 Scheme of the biochemical reactions monitored in a real-time NMR experiment. **(B)** Dynamic of 221 integrals of glucose (GLC, blue), glucose-6-phosphate (G6P, red), fructose-6-phosphate (F6P, 222 orange), fructose-1,6-bisphosphate (FBP, purple), adenosine triphosphate (ATP, gray), and adenosine 223 diphosphate (ADP, green). Integrals were normalized with the TSP signal. **(C)** Examples of signals 224 processed with MultiNMRFit for each molecule of interest, where individual signals are shown by the 225 shaded areas and the experimental and fitted spectra are represented by dots and lines, respectively. **(D)** Isotopic forms of acetate. **(E)** Theoretical ¹H spectrum of the methyl protons of acetate, with a singlet for $1^{2}C_{2}$ -acetate (blue), a doublet for $1^{13}C_{1}$ -acetate (orange), a doublet for $2^{13}C_{1}$ acetat singlet for ¹²C₂-acetate (blue), a doublet for 1^{-13} C₁-acetate (orange), a doublet for $2^{-13}C_1$ acetate (green), and a doublet of doublets for $U^{-13}C_2$ -acetate (red). (F) Example of spectrum processed with 229 MultiNMRFit with the experimental spectrum shown as dots, the fitted spectrum as a line, and 229 MultiNMRFit with the experimental spectrum shown as dots, the fitted spectrum as a line, and 230 individual signals as shaded areas. **(G)** Time-course concentrations of the four isotopic forms of 231 acetate (using the color code shown in panel E) and of the total acetate concentration (in grey).
