# What about work and employment in agriculture in Africa?

- The question of the employment prospects offered by a changing agricultural sector in Africa is high on the agenda
- with 250 million young people entering the job market by 2050
- jobs that must be both decent and attractive
- Work and employment : an entry point to think the future of agrifood systems
- But what does the research say about work and employment in agriculture in Africa?
- employment: status, remuneration, social protection
- work: interaction between tasks and workers and the impact of conditions on people's health and well-being
- A systematic review of literature

### Data selection and analysis

- A corpus of 726 documents
  - ➤ Extracted from 2 scientific databases (mainly journal articles), over the period 2012 2023. **Web of Science** Core Collection & **Scopus**
  - Selected using a thematic equation combining 2 concepts (in English)
    - Terms and equivalents of « WORK \*» and « AGRICULTURE\*\* » in the title and/or authors' keywords ; Terms « AFRICA » or at least one country of Africa (or its equivalent adjective) in the title, abstract, and/or authors' keywords
    - Final manuel check and sorting of experts
- Scientometric study of documents' metadata using Cortext Manager

#### Abstract

Despite the youth accounting for more than half of the population of Malawi, they have been marginalized and pushed to the periphery of several development policy interventions. This article interrogates the question of how the youth and policy-makers view agricultural development as a means of social mobility for youth in Malawi. The paper argues that even though agricultural production is the main occupation in Malawi, young people do not value agriculture as a means of upward social mobility. Furthermore, youth and agriculture policy frameworks provide little support to youth in terms of access to affordable farm inputs, land, extension services, value addition initiatives, and markets. It is argued that Malawi is missing the strategic policy direction by not implementing non-traditional agriculture interventions that would engage the youth in a bid to reduce massive youth unemployment. © 2018 SAGE Publications.








### Disciplinary fields mobilized in the corpus

# Conclusions – Key findings (1)

1 Countries of authors' affiliations: More than half of documents contain an African author. Geographical spread of countries studied: research spanning more than 60 countries; Nigeria, Ghana and South Africa emerge as the most frequently studied

2 Economics are the most mobilized disciplines with Humanities and Social Sciences disciplines, agronomy and health. Research methods cover qualitative, quantitative and mixed

**3 Five macro themes**: labor (youth) market; agrarian changes; health, household, cropping systems

4 Health is not connected to other clusters

# Conclusion – Key findings (2)

**5 Youth:** mainly through « youth employment, labor market and driver of changes » theme.

**Gender: spread in various themes:** inequality, health, off farm...

**6 The corpus pay little attention to**: livestock; work organisation patterns; musculoskeletal disorders, well being & job satisfaction
