Suspensions of attractive microcapsules: a non-colloidal fragile gel?

We investigated the rheological properties of suspensions of attractive microcapsules, which formed a weak gel at volume fractions ϕ as low as 0.1. These microcapsules, measuring 100 µm in diameter, were constructed with a droplet of positively charged chitosan solution protected by a membrane formed through the complexation of chitosan with a negatively charged surfactant. Iso-density matched suspensions were achieved by dispersing these microcapsules in silicone oils. Plate-plate rheometry revealed that these suspensions displayed a yield stress raging from about 0.1 to 3 Pa for ϕ increasing from 0.1 to 0.5. At much higher stresses, the suspension viscosity was almost shear independent. Furthermore, these suspensions exhibited a frequency sweep signature akin to attractive colloidal suspensions, with a shear elastic modulus plateauing at low frequencies, indicative of an elastic microstructure within the suspensions. Remarkably, a degree of microstructural anisotropy, reminiscent of fragile matter, was evidenced by the transient fluidization of the suspension when the direction of applied stress, which remained below the yield stress, was reversed. Beyond the yield stress, both symmetric and asymmetric stress reversal experiments demonstrated that the suspension structure was influenced by the applied stress. It changed from an anisotropic and fragile network at low stress levels to a dispersion of isolated particles at high stress levels. We concluded that suspensions of attractive microcapsules could be classified as a fragile particulate gel, whose microstructure depends on the stress and its direction.

INTRODUCTION Ι. 20

Suspensions of non-Brownian particles are ubiquitous ⁵² in nature and industry, presenting rheological features $^{\rm 53}$ 22 that are challenging to describe, as small changes in com- ⁵⁴ 23 position or driving forces can tune their flow properties 55 24 56 from liquid to solid.^{1,2} 25

At low volume fractions, the viscosity of suspensions of $^{\rm 57}$ 26 hard and non-Brownian particles increases with the solid 5827 volume fraction ϕ until it diverges at a jamming volume $^{\rm 59}$ 28 fraction ϕ_m ranging from 0.50 to 0.63, depending on the 60 system. Numerical simulations, considering both lubri-⁶¹ 30 cated and contact friction, show that the contact friction 62 controls ϕ_m .^{3,4} Rheological investigation of soft and ad-⁶³ hesive suspensions of micro-particles show that the pres- 64 33 ence of adhesive forces induces shear-thinning.⁵ A way to ⁶⁵ demonstrate that the liquid-to-solid transition depends 66 on the driving forces is to plot ϕ_m as a function of the 67 applied shear stress σ at a fixed ϕ . In this framework, 68 37 at the same applied stress, Gilbert *et al.* show that $\phi_{m_{69}}$ increases with the particle elasticity. For stresses much $_{70}$ higher than the characteristic adhesion stress, such sus-71 pensions behave like usual frictional suspensions with a $_{72}$ viscosity controlled by both ϕ and the contact friction. ⁷³

Considering now the transient response to stress/strain 74 43 of non-Brownian suspensions, one important feature is 75 44 the fact that the flow and the interactions lead to the $_{76}$ 45 emergence of an anisotropic microstructure. Key fea-77 46 tures of the microstructure was revealed by shear rever-78 47 sal experiments, where a suspension initially sheared in 79 48 steady state is suddenly sheared with a rate of opposite $_{80}$ 49

direction.^{6,7} Usually, the viscosity displays a sudden decrease upon reversal, reaching a minimum value before gradually returning to its steady-state level over a few strain units. This phenomenon is attributed to the presence of an anisotropic microstructure, which is developed under finite strain conditions and can bears stress at high concentrations only in the shear direction.^{3,6,8} The drop in viscosity occurs because the anisotropic microstructure cannot sustain the new shear direction. Moreover, shear reversal experiments demonstrated the decreasing relative contribution of hydrodynamic stresses versus contact stresses as the particle volume fraction ϕ increased.⁸

When the size scale is changed, this description undergoes significant alterations owing to colloidal interactions between Brownian particles. Suspensions of attractive colloidal particles form elastic gels at very low volume fractions, and their rheological properties depend on the strength of the attraction potential and the volume fraction ϕ .^{9,10}

Strikingly, non-Brownian suspensions, resembling colloidal systems, have been reported very recently by Dhand et al.¹¹ Their system consisted of water and polyelectrolyte droplets protected by a composite membrane of cellulose nanofibrils dispersed in an organic solution. These suspensions of microcapsules exhibited a vield stress for a volume fraction as low as 0.2. Such behavior cannot be explained by classic factors influencing non-Brownian suspensions, like friction, adhesion, or deformability; instead, their results suggest attractive interactions between the objects, leading to the formation of a network, such as in attractive colloidal suspensions.

In this article, using another system, we describe the 81 rheology of this new class of non-Brownian suspensions 82 consisting of attractive microcapsules, connecting the 83 spontaneous formation of aggregates and the anisotropy 84 of the structure in shear flow by both steady-state shear 85

rheology and shear reversal experiments. 86

The microcapsules studied were composed of a droplet₁₄₁ 87 of a positively charged biopolymer, chitosan, protected₁₄₂ by a thin membrane obtained through the complexation₁₄₃ at the oil-water interface of chitosan with a short-chain $_{144}$ fatty acid dissolved in the oil phase^{12,13}. The membrane₁₄₅ is on the order of few micrometers in thickness,¹⁴ and its₁₄₆ elasticity is characterized by a surface shear elastic modu-147 lus G_s^{15} . G_s can be controlled and varied, by varying the₁₄₈ complexation time and the fatty acid concentration^{13,15},₁₄₉ enabling to discriminate the role of the particle deforma-150 96 bility on the rheological behavior. 151

Firstly, we provided qualitative evidence of the aggre-152 98 gation of these microcapsules when immersed in silicone153 99 oil. Secondly, small amplitude oscillatory tests demon-100 strated that these suspensions form gels. Thirdly, we 101 investigated the steady rheological properties for differ-154 102 ent formulations of microcapsules. Finally, shear reversal 103 experiments were carried out, not only to evaluate the 104 relative contribution of contact and hydrodynamic forces 105 on the shear stress, but also to probe the structure of 156 106 the suspensions, thanks to an original asymmetric shear 107 158 reversal protocol. The latter revealed its sensitivity to 108 159 the shear history. We concluded that this system can be 109 160 classified as a fragile gel, whose microstructure depends 110 on the applied stress. 111 162

MATERIALS AND METHODS П. 112

Chemicals and Solutions Α. 113

The assembly of microcapsules was achieved₁₆₉ 114 by interfacial complexation of oppositely-charged₁₇₀ 115 polyelectrolytes.^{12,15,16} Chitosan, a water soluble₁₇₁ 116 cationic polymer, forms a complex with oil soluble₁₇₂ 117 anionic phosphatidic fatty acids (PFacid) at a water/oil173 118 interface. 119 174

PFacid was used in a form of a commercial lecithin175 120 known as lecithin YN (Palsgaard 4455, food-grade, E442)₁₇₆ 121 which was kindly provided by Palsgaard. PFacid was177 122 dissolved in food-grade rapeseed oil (Géant Casino) at a178 123 concentration of 20% w/w at 35 °C during the night to₁₇₉ 124 create a stock solution. Then PFacid solution was cen-180 125 trifuged at 3500 g to remove the insoluble residuals. The₁₈₁ 126 stock solution was further diluted with rapeseed oil at re-182 127 quired concentrations (0.1 % w/w for droplet generation₁₈₃ 128 and 3 % w/w for interfacial complexation of the shell). ¹⁸⁴ 129

Chitosan (CAS n° 9012-76-4, Sigma-Aldrich) with 185 130 medium molecular weight and 75-85% deacetylation was186 131 dissolved in Millipore water (Resistivity > 18.2 m Ω .cm)₁₈₇ 132 at a concentration of 1 % w/w by adjusting the pH with188 133 hydrochloric acid (1 mol/L) at 3.0. The chitosan solution₁₈₉ 134 was then filtered to remove undissolved particles through 190 135 Minisart syringe filters (pore size 5.0 μ m). The solution¹⁹¹ 136 was diluted at 0.25 % w/w with water and glycerol (99.5₁₉₂ 137 % purity, VWR) mixture. The water to glycerol ratio was₁₉₃ 138 adjusted when needed in order to control the density of₁₉₄ 139

the microcapsules.

Two silicone oils were used: AK1000 $(C_3H_9Si(OSiC_2H_6)_XSiC_3H_9,$ M_w = 15.000 M, viscosity 0.855 Pa.s, CAS 63148-62-9) and AP1000 $(C_3H_9Si(OSiC_8H_8)_X(OSiC_2H_6)_YSiC_3H_9,$ unkown molecular weight, viscosity 1.03 Pa.s, CAS 63148-58-3) purchased from Wacker Chemie GMBH. AK are dimethylpolysiloxanes whose unbranched chains are made up of alternate silicone and oxygen atoms, the free valancies of the silicone being saturated by methyl groups. AP are polydimethylsiloxanes with a high proportion of phenyl groups. The presence of phenyl groups increases the relative permittivity from 3.1 for AK to 3.35 for AP.¹⁷

B. Production and Preparation of suspensions

Suspensions of microcapsules were prepared with a lab-scale membrane emulsification system marketed by Micropore Technologies Ltd (UK) under the commercial name Micropore LDC-1, as detailed in our previous publication.¹⁶ Briefly, it included a hydrophobic micro-engineered emulsification membrane with 20 μ m diameter pores under a paddle-blade stirrer.¹⁸ 500 mL of PFacid dissolved in commercial rapeseed oil (0.1 %)w/w) were stirred by the paddle at a rotational speed of 600 rpm. 50 mL of chitosan solution was injected by a syringe pump (neMESYS, CETONI) with a flow rate of 2 mL/min through the membrane. The droplets were sucked up from the dispersion cell with a tube and collected in a beaker. Once the injection was finished. a large volume of rapeseed oil highly concentrated in PFacid was added to the suspension, bringing the overall PFacid concentration to 3%. Then the microcapsules were kept under gentle stirring in the PFacid solution until the membrane reached the desired stiffness. The duration of chitosan / PFacid complexation process determines the structure and elasticity of the membrane of microcapsules.^{13,15} Thus, two suspensions with complexation times of 4 and 8 minutes were produced to create two populations of capsules with distinct shell elasticity.

The complexation of the PFacid with chitosan was stopped by washing the rapeseed oil phase with large volumes of cyclohexane. The washing procedure was repeated ten times to ensure the removal of all PFacid traces. Then the microcapsules were resuspended in silicone oil AP1000 or AK 1000. The residual cyclohexane in the suspending fluid was removed through dilution with a large amount of silicone oil, then centrifuging the suspension and removing the silicone oil. At each step of dilution and centrifugation, the size distribution, shape, and the presence of shell fragments were compared to the control population to ensure that microcapsules were not damaged. This procedure was continued until the difference in the viscosity between the extracted and pure oils was less than 1%. This precaution was taken to ensure that there was no evaporation of residual of cyclohexane

 ²⁵⁰ the continuous phase was a constant throughout the ex ²⁵¹ periments.

The densities of AP1000 and AK1000 were respec-198 tively 1085.78 and 968.57 kg/m³ at 25 °C which were $^{253}_{254}$ 199 measured by a precise densimeter (DMA 4500M, $Anton_{255}$ 200 Paar). Glycerol was added to the chitosan solution in_{256} 201 order to tune the density of the microcapsules. The den-202 sity of the capsules suspended in AP1000 was adjusted₂₅₈ 203 at 1065.52 kg/m³ by adding 28 % w/w of glycerol in the $_{259}$ 204 chitosan solution. For capsules suspended in AK1000, it 205 was not required to add glycerol in the chitosan solution. 206 The difference in density between the silicone oil and the 207 chitosan solution was of 1.86 % and 2.93 % for AK1000₂₆₀ 208 and AP1000 respectively. This small density contrast fa-209 cilitated the washing procedure in the suspension prepa-210 261 ration. 211 262

212 C. Characterization of physical properties

Volume fraction and size distribution of microcapsule₂₆₇ suspensions were measured by bright field microscopy.₂₆₈ Firstly, 40 mL of the produced dense suspension of mi-₂₆₉ crocapsules was well mixed to be homogenized. Then at₂₇₀ least three samples of 0.4 mL were diluted with 10 mL₂₇₁ of silicone oil. Microcapsules were placed on large mi-₂₇₂ croscope slides and scanned entirely by an inverted mi-₂₇₃

croscope Olympus IX-73 equipped with a 4, 10, or 20 × objective, a Marzhauser motorized stage, and a camera Hamamatsu ORCA-Flash 4.0. The size and total volume of the microcapsules were measured with a custom written software based on the Matlab image processing toolbox (Mathworks). The volume fraction of the produced dense suspension of mirocapsules was then calculated by determining the total volume of microcapsules in the three samples. Then the dense suspension was diluted with silicone oil to produce suspensions with volume fraction ranging from $\phi = 0.1$ to 0.52.

The surface shear elasticity G_s of the microcapsule shell, i.e. its interfacial linear elastic modulus, was measured in an extensional flow chamber¹⁹ that has been automatized to study a large number of microcapsules according to the methodology shown in our previous publication, see Ref.¹⁶ for details. Briefly, the characterization involves injecting a sample of microcapsules into a millifluidic cross-slot chamber and observing their deformation under a range of hydrodynamic extensional stresses, σ_h , by bright field microscopy and high speed imaging. In such flow, the capsules deform into ellipses. In the small deformation regime, the Taylor parameter (= (L-S)/(L+S), with L and S the large and small length of the ellipse, respectively of the ellipse) evolves linearly with the Capillary number, $Ca = \sigma_h R/G_s$, allowing us to determine G_s for each microcapsule. Since the suspension of microcapsules is not homogeneous, we plotted the probability distribution function of G_s and computed the mean value for the sample, Figure 1.

Finally, size and G_s distribution are shown in Figure 1 for both populations of microcapsule suspensions. As expected, the average G_s increased from 0.8 to 1.7 N/m when the time of complexation increased from 4 to 8 min, standard deviation of 18% and 8% respectively. Both populations had a mean radius of 57 μ m with a standard deviation of 36%. These values were independent of the kind of silicone oil in which the capsules were dispersed. From previous studies,^{13,14} we expect that the thickness of the membrane was about 1 μ m.

D. Rheometry

Rheological measurements were carried out with a stress-controlled rheometer (DHR3, TA) with a rotating parallel plate disk geometry. The gap and the diameter of the geometry were 1.5 mm and 60 mm respectively. This gap value was chosen to accommodate 10 to 15 microcapsules in the gap. Moreover, we observed that the apparent viscosity of the suspension was independent of the gap, if the latter was larger than 1 mm. Smooth and rough surfaces were used, without any incidences on the results, meaning that there was no evidence of wall slip effects. Since in a parallel plate geometry the shear rate is not constant and varies from the center to the rim, we corrected the measured viscosity with the Mooney-

274 Rabinovitch correction,²⁰

where η_{app} is the apparent viscosity measured by the rheometer, d the diameter of the geometry and $\dot{\gamma}$ the shear rate at the rim. The temperature was controlled with a Peltier system at 25°C.

²⁷⁹ The shear viscosities of the suspending silicone oils ²⁸⁰ AP1000 and AK1000 were measured. Both oils were a ²⁸¹ Newtonian fluid at least up to 200 s⁻¹ with a viscosity of ²⁸² $\eta_c = 1.03 \pm 0.01$ Pa.s for AP1000 and 0.855 ± 0.01 Pa.s ²⁸³ for AK1000 at 25°C. Additionally, it was verified that³²⁷ ²⁸⁴ silicone oils did not have a viscoelastic behavior.

Shear-reversal experiments were carried out to $study_{328}$ 285 the microstructure of the suspension under a given shear 286 stress, as proposed by Gadala-Maria et al.⁶ The suspen-287 sions were pre-sheared with a shear stress σ of 10 Pa for₃₂₀ 288 30 s. Then, a constant shear stress (from 1 to 100 Pa)₃₃₀ 289 was imposed on the suspension until the measured vis-331 290 cosity achieved a steady state. Then, the imposed $\operatorname{stress}_{\scriptscriptstyle 332}$ 291 was set to zero for 20 seconds. The last step consisted in₃₃₃ 292 shearing the suspension with the same stress but in the_{334} 293 opposite direction. 294 335

Carrying out shear reversal experiments required care-336 295 ful consideration of inertia issues.²¹ To confirm that the³³⁷ 296 rheometer measures an accurate shear rate after rever-338 297 sal, we performed shear reversal on newtonian silicone 298 oil AP1000 without microcapsules, testing waiting times $^{\scriptscriptstyle 339}$ 299 of 1, 2, and 10 s for torques ranging from 8 to 2,048 $\mu \rm N \cdot m.^{340}$ 300 When the stress was reversed after the waiting time, $it^{^{341}}$ 301 took 0.1 seconds to reach a steady viscosity value, re-³⁴² 302 gardless of the waiting time or torque. This indicates $^{\scriptscriptstyle 343}$ 303 that the reliable time over which we can assess shear re- $^{\rm 344}$ 304 versal was 0.1 s for waiting times longer than 1 s. $\mathrm{We}^{{}^{345}}$ 305 also hypothesized that the suspension of microcapsules $^{\scriptscriptstyle 346}$ 306 could rearrange during the waiting period. To rule out^{347} 307 this hypothesis, we tested waiting times of 1, 10, and³⁴⁸ 308 100 s at a stress of 10 Pa for a suspension of microcap- $^{\rm 349}$ 309 sules ($\phi = 0.23\%$) in AP1000, and observed no significant³⁵⁰ 310 impact on the viscosity dynamics with respect to strain³⁵¹ 311 rate. 312 352

The transient evolution of the viscosity after stress re-353 313 versal was analyzed within the same framework as for₃₅₄ 314 non-Brownian suspensions,^{6,7,21} by decoupling the steady₃₅₅ 315 viscosity of the suspension η_s into hydrodynamic viscos-356 316 ity η_h and contact viscosity η_c , i.e., $\eta_s = \eta_c + \eta_h$. Just³⁵⁷ 317 before shear reversal, the suspension is in a steady state.358 318 Upon reversal, in hard-sphere systems, contact forces will₃₅₉ 319 drop to zero immediately after reversal. It takes a few₃₆₀ 320 units of strain for the contact forces to rebuild, mak-361 321 ing the viscosity temporarily dominated by the hydrody-362 322 namic contribution. Consequently, the minimum viscos-363 323 ity observed is interpreted as the hydrodynamic viscosity, 364 324 325 and the contact viscosity is deduced by the relationships₃₆₅ $\eta_c = \eta_s - \eta_h.$ 366 326

III. RESULTS AND DISCUSSION

A. Aggregation in suspensions of microcapsules

The microcapsules used to create the various suspensions were produced through interfacial complexation of a positively charged biopolymer, chitosan, with a negatively charged surfactant, PFacid. Three different systems were examined. Two density-matched suspensions were prepared in AP1000 silicone oil with capsules exhibiting a twofold increase in shear elasticity, as shown in Fig. 1. The stiffer capsules were also studied in AK1000 silicone oil. The rheological properties were studied for ϕ varying between 0.1 and 0.52.

When dispersed in silicone oil, microcapsules tended to spontaneously form aggregates at rest. Figure 2-a, b shows a suspension of microcapsules with a volume fraction ϕ of about 0.3 suspended in AK1000 and AP1000. Initially, the microcapsules were well dispersed in the petri dish. After few hours at rest, the capsules were assembled. Millimetre flocs were observed for both oils with AP1000 having smaller aggregates than AK1000, whereas the microcapsules tended to form chains in AP1000. These structures were easily broken by touching them with a needle. When subjected to an electric field, the microcapsules created a network-like structure, Fig. 2, c.

What arouses our curiosity in these preliminary qualitative observations is that this system of non-brownian particles exhibits a reversible aggregation phenomenon that is ubiquitous in colloidal suspensions.⁹ The fact that such behaviour is not common in suspensions of particles, where interactions are mainly controlled by hydrodynamic and friction, motivated us to study the rheological properties of such suspensions. The physical origin of these interactions is an open question outside the scope of this paper. However, it is highly unlikely that the attraction is due to depletion phenomena, as the continuous phase (silicone oil) was washed several times to remove any excess surfactant (PFacid). The formation of chains led us to speculate that these capsules could exhibit a dipole moment when subjected to an electric field.

367 B. Viscoelastic properties

The kinetics of gelation was characterized with a time $^{\scriptscriptstyle 388}$ 368 sweep oscillation at constant amplitude γ and frequency³⁸⁹ 369 f for the microcapsules suspended in AK1000, which had $^{\rm 390}$ 370 shown the strongest aggregation, Fig. 2-left. For each³⁹¹ 371 sample, the choices of γ and f were justified by a com-³⁹² 372 promise between signal sensibility and minimizing the $^{\scriptscriptstyle 393}$ 373 disturbance of the gelation by the applied stress, see cap-³⁹⁴ 374 tion of Fig. 3 for details. For the largest volume fraction³⁹⁵ 375 $(\phi = 0.4), G''$ increased slowly, whereas G' gained almost³⁹⁶ 376 one order of magnitude in one hour, Fig. 3-a. The elastic³⁹⁷ 377 contribution was larger than the viscous one after 100 s. $^{\scriptscriptstyle 398}$ 378 which corresponded to the critical onset of a solid net-399 379 work. This rheological behaviour is typical of colloidal⁴⁰⁰ 380 systems in the process of forming a network.²² At low⁴⁰¹ 381 volume fraction ($\phi = 0.25$), G' also increased with time⁴⁰² 382 403 but never exceeded G'' on the time scale investigated. 383

The linear viscoelastic properties of the suspensions when the network was formed were probed by frequency $_{406}^{405}$

step tests at constant γ , Figure 3-b. Before each frequency step, the suspension was pre-sheared to rejuvenate the sample and break the network formed during the previous step. The pre-shear was set to 100 and 30 Pa for 10 seconds for $\phi = 0.4$ and 0.25, respectively, at which point continuous shear rheometry showed that the network was broken (see details below). Then, the suspension left to rest for a given time in order to let it form a new microstructure. Waiting times were set to 400 and 3000 s for $\phi = 0.4$ and 0.25, respectively, the time at which G' roughly stabilized, Fig. 3-a.

For both volume fractions, G' and G'' increased nearly linearly with the frequency $f (G \sim f^{0.8})$ at high f. For the largest volume fraction ($\phi = 0.4$), a plateau for both moduli at low frequency was found and G'' was lower than G'. These rheological characteristics were reminiscent of those of suspensions of attractive colloids forming a percolated network. Trappe and Weitz⁹ established that the frequency-dependent linear viscoelastic moduli of suspensions of attractive colloidal suspensions can be scaled onto a universal master curve characterized by a plateau at low frequency and a power law at high frequency. The suspensions of microcapsules behaved remarkably similar to their Brownian counterpart. Behind this scaling, the physical picture is that the microcapsules form a solid network with a frequency-independent elastic modulus G'_0 , obtained at low frequency. G'_0 increases with ϕ , meaning that the network becomes more robust when ϕ increases. At large frequencies, the viscosity of the suspending phase inside the network dominates the viscoelastic response.⁹

C. Steady state rheology

Steady state viscosities η_s of the suspensions of microcapsules were measured in a stress-controlled plateplate geometry. Figure 4-a shows the steady-state flow curve σ vs. $\dot{\gamma}$. The flow curves where obtained in stressimposed experiments, following a pre-shear of 10 Pa for each stress. In this example, the suspensions behaved like a yield stress fluids even for ϕ of 0.1. Flow curves were well-fitted by the Herschell-Bulkley constitutive equations $\sigma = \sigma_y + K \dot{\gamma}^n$ where σ_y is the yield stress, K is the consistency factor and n the shear-thinning exponent. σ_{u} was deduced from the transient response of the supsension, η as a function of the deformation γ , as shown in Figure 4-b. At high stress, η reached a steady state for γ of about 10. At low stress, η diverged for $\gamma = 2$, which allowed us to identify σ_y . σ_y was so indicated arbitriraly at a shear rate of 10^{-3} s⁻¹ in Figure 4-a.

Figure 5 shows σ_y and n as a function of ϕ for AK1000 and AP1000 and microcapsule complexation time of 4 and 8 min. For AK1000, the suspensions showed a yield stress σ_y of 0.2 Pa as soon as ϕ was larger than 0.1 and increased exponentially with ϕ up to 4 Pa for $\phi = 0.4$. The behaviour was slightly different for AP1000. Below a critical volume fraction of 0.25, the suspensions

were Newtonian. Above this value, σ_y was well-fitted by critical-like functional form introduced by Trappe *et al.*¹⁰ for attractive colloidal suspensions $\sigma_y = \sigma_0(\phi - \phi_c)^{\alpha}$ where $\phi_c = 0.2$ is the critical volume fraction, $\alpha = 2.2$ is a power law exponent and $\sigma_0 = 15$ Pa, solid line in Fig. 5-a. Regardless of the suspending fluid, *n* decreased slightly up to 0.8 for $\phi = 0.52$.

haviour could be attributed to the deformability of the 456 particles, as numerical simulations have shown that de-457 formability tends to increase the maximal volume frac-458 tion ϕ_m .^{24,25} Moreover, the maximal capillary number 459 $Ca = \sigma R/G_s$, that represents the ratio of viscous stress 460 over the elastic shell response, was of the order of 10^{-3} for 461 $\sigma = 20$ Pa. Moreover, the low degree of shear-thinning 462 contrasts with suspensions of soft particle glasses near 463 jamming, which interact via soft elastic interactions and 464 exhibit a n coefficient of 0.5^{26-28} due to elastohydro-465 dynamic interactions.²⁹ For microcapsules suspended in 466 AP1000, we compared a twofold increase in surface shear 467 elasticity G_s . For ϕ below 0.4, there were no effects of 468 G_s on σ_y . For ϕ values exceeding 0.4, σ_y was slightly 469 larger for the softest capsules but remained within the 470 uncertainty of the yield stress measurement, Fig. 5. If 471 472 the yielding of these suspensions of microcapsules were controlled by soft lubrication interactions, we would expect σ_y to scale with G_s .²⁹ However, post-yielding, the 473 474 fact that n decreases with ϕ could be attributed to soft 475 lubrication between the microcapsules at high stress, a 476 hypothesis further supported by shear reversal experi-477 478 ments.

To the best of our knowledge, only one similar system 479 has been presented recently by Dhand *et al.*¹¹ in which 480 the interactions between microcapsules of few hundreds 481 micrometers were induced, equally, by the presence of a 482 charged polymer in the capsule. Similarly to our system,⁵¹⁰ 483 yield stresses of the order of 10^{-2} Pa were reported for ϕ^{511} 484 of 0.2. 512 485

It is also instructive to compute the apparent volume⁵¹³ 486 fraction ϕ_a as a function of the applied stress σ of the⁵¹⁴ 487 suspensions by using correlations established for repul-515 488 sive suspensions of solid particles. Chevremont *et al.*⁴⁵¹⁶ 489 introduced the following correlations 490 517

 $(2)_{522}$ where $\mu_1 = 0.36$, $\mu_2 = 0.7$, $I_0 = 0.0133$ are coefficients₅₂₃ 491 obtained by fitting this relation to a minimal model based 492 on lubrication and contact forces between hard particles.⁴ 493 This expression is asymptotically equivalent to Einstein 494 relation³⁰ at low ϕ and also asymptotically equivalent to⁵²⁴ 495 the Krieger-Dougherty form when ϕ is approaching ϕ_m .³¹ 496

 ϕ_m can range from 0.63 to 0.55 depending on the friction⁵²⁵ 497 coefficient between the particles.⁴ 526 498

Figure 6 shows the ratio ϕ_a/ϕ as a function of σ for⁵²⁷ 499 AK1000 (circles) and AP1000 (squares) for different ϕ^{528} 500 (color code). At low stress, ϕ_a was 2 to 3 times larger⁵²⁹ 501 than ϕ . This is consistent with the existence of aggre-530 502 gates at low stress, since the effective volume of an ag-531 503 gregate is larger than the volume of capsules constituting⁵³² 504 it. Thus, the apparent volume fraction of a suspension of 533 505 aggregates of particles is higher than that of a suspension⁵³⁴ 506 of isolated particles. At high stress, ϕ_a/ϕ tends to 1,535 507 508 meaning that the stress was enough to overcome the at-536 tractive interactions and broke the aggregates. Moreover, 537 509

the viscosity of the suspension was controlled by conventional hydrodynamic and contact interactions. The value of ϕ_m to calculate ϕ_a from the experimental data did not provide any meaningful interpretation regarding the frictional nature of the contact. Comparing the two oils revealed a tenfold difference in the critical stress separating the two regimes. This set of results suggested strongly that the aggregated state of the suspension under flow was dependent on the applied stress. If the stress was low enough, a percolated network of aggregates was formed in the suspension leading to an apparent gelation of the fluid. At high stress, these aggregates were broken and the system behaved as a classic suspension of solid particles.

D. Hydrodynamic & contact viscosities

Transient rheometrical tests were carried out in order to probe the relationships between the applied stress and the structure of suspensions of microcapsules. We tested two protocols of shear reversal experiments: symmetric and asymmetric.

In symmetric shear reversal experiments, a specific shear stress magnitude (σ^{-}) is initially applied in one direction. The direction of this shear stress is then reversed when the shear rate reaches a steady state, maintaining the same magnitude in the reversed direction, i.e. $\sigma^+ = \sigma^-.$

Figure 4-b and its sub-caption shows the apparent viscosity η as a function of γ after reversal of the stress direcJournal of Rheology

595 tion. One initial observation is that when the stress was $_{596}$ 538 below the yield stress (blue curve, $\sigma < \sigma_y$), the viscosity₅₉₇ 539 η experienced a sudden drop to a minimum, followed by $a_{_{598}}$ 540 continuous increase until it reached an apparent plateau 541 within the range of γ values between 0.1 and 1. Beyond₆₀₀ 542 γ = 2, η diverged: the reversal of the stress induced $a_{_{601}}$ 543 transient fluidization of the suspension. This feature is $_{602}$ 544 characteristic of an anisotropic structure of the suspen- $^{603}_{604}$ sion, that has to rearrange when the stress is reversed.⁸ 545 546 604

⁵⁴⁷ When the stress was greater than σ_y , the apparent vis-⁶⁰⁵ ⁵⁴⁸ cosity decreased to reach a minimum for a deformation⁶⁰⁶ ⁵⁴⁹ of about 2-3 decreased (interepreted as η_h) and then con-⁶⁰⁷ stinuously increased to reach the steady state value η_s . This qualitative behaviour is in line with the case of solid particles. When the shear is reversed, it triggers a rapid relaxation of contact forces.⁶ This relaxation occurs over a deformation typically on the order of unity and results in a notable decrease in viscosity, the viscosity reaching a minimum value. Subsequently, the long-term evolution of the system is influenced by the development of shear-induced microstructure. In the case of solid particles, numerical simulations^{32,33} enabled to interpret the minimum viscosity at $\gamma = 2-3$ as the hydrodynamic viscosity η_h , obtained when the contact forces are vanished. The difference between the steady viscosity η_s and η_h is shown to be proportional to the contact contribution to the steady viscosity.^{32,33} Due to the similarity of the transient evolution of the viscosity after reversal with the case of solid particles, we adopted the same interpretation of $\eta(t)$ when $\sigma > \sigma_y$.

Fig. 7 shows η_h (open symbol) and η_c (closed symbols) as a function of σ and different ϕ for AK1000. σ is always larger than σ_y . At low stress, η_c and η_h are of the same order of magnitude, whereas η_c drops of several orders of magnitude and η_h stabilize when $\sigma > 10 \times \sigma_y$. For a given σ , η_c and η_h increases with ϕ . It is worth highlighting that η_c was strongly shear-thinning, with n being approximately 0.5. This is potentially a signature of hydrodynamic interactions controlled by the deformability of the microcapsules.²⁹

In our asymmetrical shear reversal experiments, we ensured that σ^- exceeded the critical threshold necessary to break the clusters of microcapsules, i.e. $\sigma^- >> \sigma_u$. Following this step, we systematically varied σ^+ within the range of σ_y to 100 $\times \sigma_y$. Fig. 8 illustrates the behavior of η_h as a function σ^+/σ_y for different ϕ , employing both symmetric (open symbols) and asymmetric (closed symbols) protocols. At low stress, η_h exhibited a marked increase in the asymmetric protocol compared to the symmetric one. This is consistent with the picture that, in the asymmetric proctol, we reversed the shear with a suspension of individual particles, whereas in the symmetric one, aggregates of microcapsules were initially formed. Conversely, at high stress, the values of η_h were consistent, regardless of the employed protocol. The stress σ_c above which both protocols lead to the same values of η_h was much larger for suspension in AK1000 than in AP1000. Since this characteristic stress could be interpreted as the typical stress to overcome attractions between capsules, this difference between the two suspensions is consistent with the interpretation of the fact that the yield stress originated from attractive interactions, the latter being stronger for capsules dispersed in AK1000 than in AP1000. As shown in Figure 8-d, the stress σ_c increased when the volume fraction was increased, and is typically 10 times higher than the yield stress. Above this characteristic stress, the suspension could be viewed as a suspension of weakly interacting isolated spheres, in contrast with weaker stresses where the suspension is made of dispersed aggregates, whose size

613 E. Key Findings

The different key rheological elements of these suspen-⁶⁷² sions of attractive microcapsules, which show rheological⁶⁷³ features akin to colloidal attractive systems, are summa-⁶⁷⁴ rized.⁶⁷⁵

Time and frequency sweep oscillations demonstrate the⁶⁷⁶ spontaneous aggregation of these microcapsules, lead-⁶⁷⁷ ing to the formation of a gel depending on the vol-⁶⁷⁸ ume fraction, Fig. 3. Analogous to attractive colloidal⁶⁷⁹ systems^{9,10}, G' tending to a constant at low frequency⁶⁸⁰ was interpreted as the signature of a percolated network⁶⁸¹ of aggregates.

In consistency with these oscillatory experiments,⁶⁸³ 625 steady-state rheology shows the emergence of yield stress 684 626 for volume fractions as low as 0.1, Fig. 4, 5. Moreover,⁶⁸⁵ 627 over the range of volume fractions studied (up to 0.5), 686 628 the shear thinning is very moderate, making these sus-629 pensions a rare example of a Bingham fluid. All these⁶⁸⁸ 630 elements support the idea that at low stress, microcap-689 631 sules form a percolated network of aggregates, and at 690 632 high stress, the suspension of microcapsules ressembles $^{\rm 691}$ 633 that of a suspension of non-Brownian hard spheres, Fig.⁶⁹² 634 693 6. 635

Unsteady rheology was also tested by symmetric shear $^{\rm 694}$ 636 reversal experiments, Fig. 7. The apparent viscosity⁶⁹⁵ 637 showed a decay when the stress was reversed at \log^{696} 638 stress, demonstrating that the microstructure of the per-639 colated network of aggregates is anisotropic, depends on⁶⁹⁸ 640 the shear direction, and is unable to sustain changes in 699 641 stress direction. This makes these suspensions a kind⁷⁰⁰ 642 of "fragile gel" based on non-colloidal particles.^{34,35} A⁷⁰¹ 643 "fragile" gel has a self-organized internal structure com-⁷⁰² 644 posed of force chains, whose mechanical properties have⁷⁰³ 645 evolved to support the load itself. However, the material⁷⁰⁴ 646 is not an elastic body; if one attempts to shear the sample $^{\rm 705}$ 647 in a slightly different direction, static equilibrium cannot⁷⁰⁶ 648 be maintained without altering the existing force chains⁷⁰⁷ 649 and creating new ones with a slightly different orienta-650 tion. Consequently, when the force direction is changed, 651 the suspension flows again and stops only once a ${\rm certain}^{708}$ 652 strain is accumulated to recreate the force chains. 653

Shear reversal also revealed that the interaction be-709 654 tween the microcapsules is controlled by elastohydrody-710 655 namic interactions at high stress, similar to soft glassy711 656 particles,²⁹ as the contact viscosity was strongly shear-712 657 thinning. This allowed us to interpret the moderate de-713 658 cay of n at high volume fractions as a sign of soft lubri-714 659 cation. Moreover, it is interesting to note that transient₇₁₅ 660 661 rheological experiments, such as shear reversal, appear⁷¹⁶ to be much more sensitive to elastohydrodynamic inter-717 662

actions than classic steady-state rheometry. This could be further analyzed through numerical simulations.

We also introduced asymmetric shear reversal protocols, which provide physical insights for this kind of fragile suspension: the hydrodynamic viscosity was larger at low stress when the pre-stress (σ^-) was high enough to break the aggregates compared to when the prestress was equal to the stress ($\sigma^- = \sigma^+$). At high stress, there was no influence of the protocol on the hydrodynamic stress, and the hydrodynamic contribution to the viscosity tends to be rate independent. These results confirm our interpretation of the steady-state rheology.

All these observations differ significantly from those of a soft adhesive suspension, as recently reported by Gilbert *et al.*⁵. The systems are rather different since homogeneous PDMS particles were considered instead of microcapsules. Gilbert et al. demonstrated that this system is deformable (with an elastic modulus of 1.8 MPa) and adhesive (with a characteristic adhesive stress of a few Pa). The main rheological signature of this system is the presence of shear-thinning behavior at low shear rates and high volume fractions (greater than 0.3). No yield stress was directly evidenced. This behavior is thus very different to the present observations of a Bingham fluid down to very low volume fraction. It indicates that adhesion plays a minor role. The fact that the surface modulus has no influence on the rheological properties, and the presence of a reduced viscosity after reversal also confirm that adhesion is negligible. Indeed, adhesion forces are very sensitive to contact area and thus to particle stiffness, and, if contacts were adhesive, they would mostly remain just after shear reversal.

To sum up, the rheology of these suspensions of attractive microcapsules is controlled by long-range interactions at low stress, making them a kind of fragile gel. However, at high stress and high volume fraction, soft lubrication also plays a role in shear-thinning.

We also identified that the type of silicone oil changes the constitutive parameters of these suspensions and the stress at which the aggregates are broken. Preliminary experiments (Fig. 2) lead us to speculate that this is due to dipolar or coulombic interactions between the objects, whose range depends on the relative permittivity of the oil. The detailed physical characterization of these interactions however require dedicated investigations.

IV. CONCLUSION

In conclusion, this article shows that these suspensions of droplets of a positively charged biopolymer, chitosan, encapsulated by complexation with an anionic fatty acid, constitute a novel class of non-Brownian suspensions, exhibiting similarities with their Brownian counterparts due to the presence of long-range interactions between particles. At low stress and low volume fraction, these attractive microcapsules form an anisotropic percolated network. Due to this anisotropy, these gels cannot sus-

tain changes in shear direction, categorizing these sus-778 718 pensions as an example of a fragile suspension.^{34,35} 779 719

The exact physical origin of the attractive interaction⁷⁸⁰ 720 remains an open question, and deserve further investiga-⁷⁸¹ 721 tions. We showed in this paper that it is possible to tune $\frac{1}{783}$ 722 this interaction - and thus to tune the gel elasticity and₇₈₄ 723 yield stress - by changing the suspending liquid dielectric⁷⁸⁵ 724 properties, which we believe to be a promising outcome⁷⁸⁶ 725 787 in terms of potential applications. 726 788
