Fauzia Husain, *The Stigma Matrix: Gender, Globalization, and the Agency of Pakistan's Frontline Women*, (Stanford, CA: Stanford University Press, 2024), *xii* + 306 pp.

Husain's book provides a compelling exploration of the layered challenges facing Pakistani women in public service sectors, particularly in health, law enforcement, and aviation. Combining theoretical rigour with narrative-driven fieldwork, Husain examines how Pakistani women navigate social stigmas intertwined with local, colonial, and global forces. The book's interdisciplinary approach makes it a valuable resource for scholars in social sciences and law, as well as policymakers seeking action grounded in real-life challenges. Educated readers interested in Pakistani society will also find it enlightening.

In chapter 1, Husain introduces the 'stigma matrix', as a conceptual framework that explains how historical legacies, neoliberal economic policies, and culturally specific expectations converge to shape the stigmatization of women in public roles. Through vivid fieldwork scenes in settings such as police stations, health outreach projects, and airline cabins, Husain illustrates how women working in these sectors endure hostility in public spaces while performing essential duties. Her portrayal of Lady Health Workers, for example, shows how these women are perceived as cultural transgressors merely for delivering vaccines. Such encounters underscore the complexities of gendered labour and societal expectations in Pakistan.

Central to Husain's theoretical model is *purdah*, a concept that reinforces cultural propriety and serves as a tool for gendered exclusion *(pp. 84-90 / chapter 2)*. Women who observe *purdah* may gain a degree of respectability, while those who defy it in public-facing roles face intensified stigma. Husain integrates intersectionality, globalization, and agency theory within a multiscalar model, providing a comprehensive view of how women negotiate gendered stigma across different societal layers.

Husain examines the influence of colonial legacies, neoliberal economic pressures, security imperatives, and waves of Islamization in Pakistan, arguing that these forces create push-and-pull dynamics that drive public resistance to women's participation in the workforce. The book then shifts focus to the workplaces themselves—such as police stations (*pp. 100-114 / chapter 3*) healthcare outreach programs (*pp. 130-150 / chapter 4*), and airline cabins (*pp. 170-189 / chapter 5*) — where Husain details the environment-specific stigmas women encounter. Each of these settings carries unique gender expectations that add complexity to the stigma matrix.

Policewomen, for instance, navigate male-dominated spaces by deploying strategies like 'veiled delicacy' (p. 113) to counteract the stigma they face, though these efforts often fail to dismantle underlying gendered exclusions. Lady Health Workers adopt a 'martial motherhood' (p. 148) persona to protect their respectability, though class-based barriers keep them marginalized within the health sector. Airline attendants embrace 'postfeminist cosmopolitanism' (p. 172) to redefine themselves in a globalised space, yet stigma rooted in local biases about women's propriety persists. These accounts not only illustrate the unique challenges faced by each profession but also highlight the resilience of these women as they redefine their roles.

In *chapter 6* the book introduces the concept of 'spectacular agency' (p. 203), where women engage in public acts of defiance to challenge societal norms and gain visibility. Husain describes these as brief, powerful gestures that offer some forms of momentary triumph against pervasive stigma. This approach underscores how public performances serve as a tactic for women to assert their rights and demand recognition, even if these victories are temporary.

Husain's analysis points to colonial history as a key influence, noting that colonial norms around gender and modesty were embedded and institutionalised and shaped the public's perception of women who challenge traditional roles. In *chapter 7* Husain argues that reform must address these historical influences by reframing public-facing roles for women as honourable rather than culturally transgressive. Such a shift could help dissolve the colonial echoes that continue to stigmatise women in public service.

*Chapter* 7 discusses the pressures of contrasting forces on Pakistan regarding the inclusion of women in the workforce. Complicating the stigma matrix are the influences of globalization and Islamization, especially since the 1970s. Neoliberal policies encourage female workforce participation to boost economic productivity, yet this push often lacks the cultural and organisational support needed for women to thrive. While globalisation calls for greater female participation in public life, Islamisation reinforces traditional values, demanding that women adhere to norms of modesty, particularly in public roles. Husain suggests that meaningful reform will require the creation of new narratives and symbols of authority that allow women to gain respect without compromising cultural values. Husain's recommendations urge policymakers to go beyond recruitment numbers and consider comprehensive reforms to create genuinely inclusive work environments.

In the conclusion, Husain ties these themes together, arguing that the challenges faced by Pakistani women in public positions reflect broader societal issues. She emphasizes that overcoming stigma requires structural transformation, urging policymakers to address the root causes rather than implementing surface-level solutions like recruitment quotas. Husain critiques existing gender mainstreaming policies, which she feels often ignore the 'gendered authority threats' (p.258) women face, which result in their authority being systematically undermined due to ingrained stigmas. She contends that effective support systems must go beyond legal reforms, offering concrete backing for women to assert their roles confidently. Husain also stresses the absence of informal networks for women in male-dominated sectors. Such networks enable women to have more allies and resources to navigate workplace challenges. Husain argues for policies that would facilitate opportunities for women to build these networks. She advocates for mentorship programs and networking events that create structured support networks that would empower women to navigate entrenched power dynamics. In her analysis, Husain highlights that staging reliance and defiance required resources like financial support, community solidarity, and media platforms which are crucial tools for women to help them amplify their voices and challenge ingrained biases. Finally, Husain calls for redefining symbols of respectability and professionalism, moving beyond classed and gendered expectations like *purdah*, which often forces women to choose between their safety and their dignity. She envisions a society where new symbols allow women to assert authority without risking reputational harm.

*The Stigma Matrix* is both a critical and hopeful read, as it draws attention to the necessity of structural reforms that move beyond recruitment quotas or surface-level policies. Husain calls for a reimagining of workplace respectability and symbols of authority, proposing that society embrace new narratives that allow women to maintain dignity while embodying their cultural values. Her analysis invites readers to consider the historical and socio-political layers that uphold stigma and to imagine a future where the contributions of these women are valued in full, without the burdens of exclusion or marginalization.
