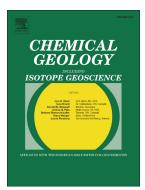

# An improved model for $CO_2$ solubility in aqueous $Na^+-Cl^ SO_4^{2-}$ systems up to 473.15 K and 40 MPa

## ABSTRACT

This article contributes to the development of a thermody amy model for simulating CO<sub>2</sub> solubility in pure water and aqueous brines under different condition of umperature, pressure and ionic strength. The modeling activity-fugacity ( $\gamma$ - $\varphi$ ) approach allow calculating CO<sub>2</sub> solubility, based on the Pitzer electrolyte theory for activity coefficient and Pitzer and CO<sub>2</sub> solubility at a for fugacity. The present work proposes a new set of Pitzer interaction parameters through the set of CO<sub>2</sub> solubility data in saline systems such as CO<sub>2</sub>-H<sub>2</sub>O-NaC<sub>1</sub> and CO<sub>2</sub>-H<sub>2</sub>O-Na<sub>2</sub>SO<sub>4</sub>. The determined model is capable of covering a wide T – P – I range (273, (5 4, 3.15 K, 0.1-40 MPa and 0-6 meq/kg). Average absolute deviation of CO<sub>2</sub> solubility is abour 5% compared to a large number of experimental data available (more than 700 data analyzed). New experimental solubility data for the CO<sub>2</sub>-H<sub>2</sub>O-NaCl-Na<sub>2</sub>SO<sub>4</sub> system were also acquired in this study (303.15-423.15 K, 1.5-20 MPa and 0-6 mol/kg) to test the model's capacity: it is able to a scribe the CO<sub>2</sub> solubility in aqueous salt mixtures without any further optimizations of interactio, parameters.

#### **1. INTRODUCTION**

Studies related to the determination of the aqueous solubility of carbon dioxide for capture and geological storage of  $CO_2$  applications, have been investigated in the last years (Benson and Cole, 2008; Eiken et al., 2011; Farret et al., 2017; TORP and GALE, 2003). This acquisition of solubility data is of immense importance for the characterization and better understanding of the complex chemical behavior of these systems (aquifers with different salt compositions, temperature and pressure). When many published studies have focused on the characterization of the solubility of  $CO_2$  in pure water, only few studies were interested in the  $CO_2$  solubility in aqueous electrolyte solutions

(dos Santos et al., 2020). Most of these studies were carried out on NaCl aqueous solutions and, to a much lesser extent to other salts such as  $CaCl_2$ ,  $Na_2SO_4$ , KCl and MgCl\_2. They have contributed to enriching significantly the variety of experimental data (dos Santos et al., 2020; Lara Cruz et al., 2020; Messabeb et al., 2017; Poulain et al., 2019; Tong et al., 2013; Zhao et al., 2015b). These data are extremely important for the improvement of high quality thermodynamic and geochemical models capable of simulating and predicting the  $CO_2$  solubility in pure water or in aqueous brine solutions under different conditions of temperature, pressure and salt concentration (Duan et al., 2006; Duan and Sun, 2003; Li and Duan, 2007, 2011; Shi and Mao, 2017; Springer et al., 2012). The improvement of these models depends directly on the available set of experimental data.

There is a wide range of thermodynamic models for the solu bility of  $CO_2$  in pure water and in aqueous brine solutions, but few use the Pitzer semi-empirical model, which was developed to calculate the properties of the electrolyte-rich liquid phases. mc. as water activity and activity coefficients of aqueous species. The Pitzer model proved to be one of the best for determining the activity coefficients in solutions rich in salts, so much so that it serves as the basis for many thermodynamic models (Duan et al., 2006; Duan and Snn, 2003; Mao et al., 2013; Springer et al., 2012; Zhao et al., 2015a, 2015b, 2015c). Duan and Sun (2003) and Duan et al. (2006) proposed a model that can predict CO<sub>2</sub> solubility in pure wate<sup>1</sup> single-salt solutions and mixed salt-solutions with a concentration of up to 4.3 mol/kg (moles of calt per kilogram of water), for temperatures between 273 and 533 K and for pressures between 0 and 200 MPa. Duan's model is able to predict with great precision the solubility of CO<sub>2</sub> in aquants colutions of NaCl, MgCl<sub>2</sub> and CaCl<sub>2</sub>. However, large deviations are found (deviations of up 29 %) in systems containing SO<sub>4</sub><sup>2-</sup>. Spycher and Pruess (2010) established one similar activity expression as Duan and Sun (2003) did, with simplifications for salts other than NaCl, producing de iations similar to Duan, as pointed out by Zhao et al. (2015b). Based on The Pitzer equation Alanfiev and Diamond (2010) worked only with the CO<sub>2</sub>-H<sub>2</sub>O-NaCl system, covering a limited commentative range between 251-373 K, with some high deviations from the literature. Li and Duan (20 1) presented a model capable of predicting  $CO_2$  solubility in  $CO_2$ -H<sub>2</sub>O-NaCl-CaCO<sub>3</sub>-CaSO<sub>4</sub> systems at temperatures from 273 to 523 K, pressures from 0.1 to 100 MPa and NaCl concentrations until saturation - using the interaction parameter  $CO_2$ -Na<sup>+</sup> proposed by Duan and Sun (2003) as a basis. Springer et al. (2012) proposed a model based on the Mixed-Solvent Electrolyte (MSE) framework that has an extensive validity of temperature and pressure (up to 573 K and 400 MPa). However, it does not applied to systems containing aqueous Na<sub>2</sub>SO<sub>4</sub>. Mao et al., 2013 developed a model similar to Duan's for aqueous systems containing NaCl only, but increasing the temperature range by up to 723 K. Zhao et al. (2015b) and Zhao et al. (2015c) proposed a fugacityactivity model for predicting CO<sub>2</sub> solubility in aqueous systems containing NaCl, CaCl<sub>2</sub>, KCl, MgCl<sub>2</sub> and Na<sub>2</sub>SO<sub>4</sub>. The model covers a range of  $T - P - m_{salt}$  from 288 to 523 K, from 0.1 to 150 MPa and up to salinities close to saturation, respectively. In summary, despite the high quality of the models

described above, there are still gaps in their ability to cover the wide range of temperatures and chemical compositions of aqueous brines that are encountered in natural deep media targeted for  $CO_2$  geological storage applications. These gaps concern mostly  $CO_2$  solubility in single-salt aqueous systems containing either Na<sub>2</sub>SO<sub>4</sub>, CaCl<sub>2</sub>, or MgCl<sub>2</sub> electrolytes near saturation, and in salt mixtures. This means that new developments are still needed to fill these gaps in order to make the model predictions more reliable and, thus, more useful to industrial operators.

In this study, we report the development of a model to calculate the solubility of  $CO_2$  in pure water and in aqueous NaCl and Na<sub>2</sub>SO<sub>4</sub> solutions with temperatures up to 473.15 K, pressures up to 40 MPa and salt concentrations near the saturation. Because of the high salinity of the solutions, the Pitzer formalism is applied. We determined a new set of interaction parameters to address the chemical behavior of  $CO_2$ -H<sub>2</sub>O-salt systems. All the calculations were performed with the PhreeSCALE geochemical simulation software (Lach et al.,  $20^{14}$ ). This code is an extension of the well-known PHREEQC code widely used by the geochemist on munity (Appelo, 2015; Appelo et al., 2014; Parkhurst and Appelo, 2013). Like PHREEQC, Phic SCALE is capable of calculating water properties of brines like activity coefficients of aqueous species and activity of water according to the Pitzer formalism. The originality of PhreeSCAL's is that it was developed to add calculation capabilities regarding the thermal (apparent relative morar enthalpy and heat capacity) and volumetric (density) properties of brines in a consisten the retical framework based on Pitzer's equations (Lach et al., 2017b). The software also uses the standard properties of solutes computed from the HKF theory (Helgeson et al., 1981; Tanger ... 1 r.elgeson, 1988), which is widely acknowledged by the geochemists community. The input files are similar for the two codes, only some additional output keywords are declared in PhreeSCA. E to write the corresponding properties in the output files (Lach et al., 2016). The thermodynamic database is regularly increasing with new chemical systems and it is available on demand (André et al., 2020).

For the estimation or specific interaction parameters, a selection of experimental data was made first. The PhreeSCALE software allows calculating CO<sub>2</sub> solubility using an activity-fugacity ( $\gamma - \phi$ ) approach. By combining the use of PhreeSCALE with that of the PEST software (Doherty, 2004), a software designed for parameter estimation, the interaction parameters of the Pitzer activity coefficient model can be determined. This method was applied in the present work to determine a new set of binary interaction parameters, capable of accurately simulating the solubility of CO<sub>2</sub> in pure water and in solutions of NaCl and Na<sub>2</sub>SO<sub>4</sub>, for concentrations close to saturation. More than 1200 experimental data were evaluated and compared in this study, the average absolute deviations (AAD) were calculated, covering a wide range of temperatures (from 273 to 473.15 K) and of pressures (from 0.1 to 40 MPa).

Experimental solubility data for the  $CO_2$ -H<sub>2</sub>O-NaCl-Na<sub>2</sub>SO<sub>4</sub> system were also acquired to test the model's capacity to describe the  $CO_2$  solubility in aqueous salt mixtures. A mixture of 3 mol NaCl /kg and 1 mol Na<sub>2</sub>SO<sub>4</sub>/kg was prepared and  $CO_2$  solubility data were acquired for pressures between 1.5 and 20 MPa, and temperatures at 303.15, 323.15, 373.15 and 423.15 K. The experimental methodology used was previously proposed by dos Santos et al. (2020). The model was also tested and the AAD calculated with the acquired experimental data without any further optimization.

#### 2. REVIEW OF EXPERIMENTAL DATA FOR CO<sub>2</sub> SOLUBILITY

## **2.1. IN PURE WATER**

The topic of  $CO_2$  solubility in pure water is widely treated in the literature since more than 100 references were found; representing about 1990 experimental data (Supplementary Data). Some of them concern low  $CO_2$  pressures ( $\leq 0.1$  MPa), and they are not considered in this study. A selection was done to check the consistency of the data, according to tenperature and pressure ranges. At last, about 650 data were selected and used to determine the thermodynamic and the Pitzer interaction parameters necessary to model both the solubility of  $CO_2$  in mare water and the chemical properties of dissolved  $CO_2$ .

## 2.2. CO<sub>2</sub>-H<sub>2</sub>O-NaCl SYSTEM

The CO<sub>2</sub> solubility in aqueous syste.  $\infty$  containing NaCl has not been studied as much as in pure water; however, there is already large number of studies that started to work with this electrolyte. The presence of salts in aqueous systems decreases the solubility of the gas. In this way, the CO<sub>2</sub> solubility is reduced by increasing the temperature and the salt concentration. Several studies covering extensive ranges of  $T - F - m_{salt}$  have been carried out, but many are at low salt concentrations or in pressure ranges not so high. Yet, the number of studies has increased over the years and, today a lot of enperimental CO<sub>2</sub> solubility data are available up to salinity values close to NaCl saturation (Table 1).

Despite the various studies have entryhed the theme, some of them present problems of precision or of consistency. Thus, for our  $o_{r}$  imization work, we work with pressure, temperature and NaCl concentration ranges confirmed by studies made at the Laboratory of Thermal Engineering, Energy and Process (LaTEP). Messibel et al. (2016) conducted a study for a system containing NaCl concentrations of 1, 3 and 6 mol/k<sub>b</sub> for various temperatures (323–423 K) and pressures (5–20 MPa). In this way, we reduced the a rout of data used for the optimization work to the selection shown in Table 2.

An experimental  $O_2$  solubility isotherm at 6 mol/kg of NaCl and 303.15 K (as there are no previously published data in these conditions) was additionally acquired in the present work (see Table 7). These new solubility data were not used in the optimization process. They were used only for comparison with the proposed model.

## 2.3. CO<sub>2</sub>-H<sub>2</sub>O-Na<sub>2</sub>SO<sub>4</sub>SYSTEM

For  $Na_2SO_4$ , the amount of data is even less then with NaCl (as shown in Table 1). Studies that investigated the solubility of  $CO_2$  in aqueous  $Na_2SO_4$  solution at pressures other than atmospheric pressure started in the 1990s, however, some with problems of inconsistency or precision problems, such as Corti et al. (1990) and Gilbert et al. (2016), as appointed by Shi and Mao (2017) and dos Santos et al. (2020). Only the data by dos Santos et al. were used for the parameterization process.

#### 2.4. CO<sub>2</sub>-H<sub>2</sub>O-NaCl-Na<sub>2</sub>SO<sub>4</sub> SYSTEM

Experimental studies in mixed-salt solutions containing NaCl and  $Na_2SO_4$  at different concentrations, different temperatures and pressures, are scarce. We can only mention the study made by Yasunishi et al. (1979), at one single temperature (298.15 K) and fixed pressure (0.1 MPa) for different concentrations of NaCl and  $Na_2SO_4$  (Table 1). None of these Yasunishi's data were used in our study in the optimization process, however the AAD were also calculated from the proposed model, posteriorly.

In view of the lack of mixed-salt data on NaCl and Na<sub>2</sub>SO<sub>4</sub> mixed-salt solutions experimental  $CO_2$  solubility data were measured in a mixture containing 3 mol/kg NaCl and 1 mol/kg Na<sub>2</sub>SO<sub>4</sub>, at temperatures of 303.15, 323.15, 373.15 and 423.15 K, in a pressure range between 1.5 and 20 MPa. Twenty-four new  $CO_2$  solubility points were obtained for these mixt res of NaCl and Na<sub>2</sub>SO<sub>4</sub> aqueous solutions (see Table 7). By calculating the AAD, these data were used to test the model proposed through the optimization of the single-salt systems presented above

#### **3. MATERIALS AND METHODS**

The carbon dioxide used in all experiments was An. Lquide with a purity of 99.7% wt. Water was purified by a Barnstead Smart2Pure system and the resistivity was below 18.2 M $\Omega$ .cm. All aqueous salt solutions were prepared using this princed water and sodium sulfate (Na<sub>2</sub>SO<sub>4</sub>, Merck, > 99% wt) and sodium chloride (Acros Organes, 99.5% wt). The experimental system consisted of a one-liter Hastelloy C276 autoclave (Top Industral), which can operate at temperatures between 293.15 and 473.15 K with a maximum pressure or 20 MPa. For sampling, a syringe containing a precisely known quantity of sodium hydroxide (right r Scientife, 46/51% wt) is connected to the autoclave for recovery the samples. An automatic titrator using a pH electrode makes the measurements of carbon dioxide solubility. The content of the syringe is dosed with 0.1 M hydrochloric acid solution (VWR, 0.1  $\pm$  2% mol/L). Details on the CO<sub>2</sub> solubility measuring technique and the uncertainty analysis approach can be found in dos Santos et al. (2020). The experimental CO<sub>2</sub> solubility results at a pressure range between 1.5-30 MPa and temperatures from 303.15 to 423.15 K in aqueous mixed-salt solutions of Na<sub>2</sub>SO<sub>4</sub> and NaCl at the ionic strength up to 6 mol/kg are listed in Table 7.

#### 4. THERMODYNAMIC MODELING

The condition for thermodynamic equilibrium in a  $CO_2$ -aqueous solution system implies in the equality of pressure, temperature and fugacity of the constituent both in the aqueous and in the gaseous (or supercritical) phases:

In this work, the chemical equilibrium is described with PhreeSCALE (Lach et al., 2016). In this software, the solubility of gas  $CO_2$  is calculated using a geochemical model present by Appelo (2015) and Appelo et al. (2014) :

Where P is the system pressure (atm) and  $y_{CO_2}$  is the molar fraction in the gas phase (-). Like in Appelo (2015) and Appelo et al. (2014),  $V_{m,CO_2}$  can be computed using the Helgeson-Kirkham-Flowers models (Johnson et al., 1992). The Henry's constant (K<sub>H</sub>) corresponds to the equilibrium constant for the  $CO_2(g) \leftrightarrow CO_2(aq)$  reaction and its values are given by Plummer and Busenberg (1982). m is the molality, R is the ideal gas constant, and T is the temperature. The subscript 0 represents the standard state, P<sub>0</sub> is equal to 1 atm, and m<sub>0</sub> to 1 mol/kg. The fugacity coefficient ( $\phi$ ) is computed using the Peng-Robinson equation of state, which involves the acentric factor in addition to Van der Waals' a and b factors:

Where  $V_m$  is the molar volume (cm<sup>3</sup>/mol), b is the minimal molar volume (cm<sup>3</sup>/mol),  $\alpha$  is the correction factor that is temperature dependent (-) and  $\alpha$  is the Van der Waals' attraction (Pa cm<sup>3</sup>/mol).  $\alpha$ , a and b factors can be calculated from the critical imperature (T<sub>c</sub>), critical pressure (P<sub>c</sub>) and factor acentric ( $\omega$ ) of the gas:

From the Eq. (3), the 1.3 coefficient is:

A virial expansion of excess Gibbs energy proposed by Pitzer (1991) is used to obtain the activity coefficient ( $\gamma_{CO_2}^m$ ). This model has a dependence on temperature, species molality and their respective molecular interactions.

Where  $\lambda$  and  $\zeta$  are binary and ternary interaction parameters, respectively. c and a stand for cations and anions, respectively. For the temperature dependence for the interaction parameters, the following expression is assumed (which is the combination of equations of Møller (1988) and Christov and Møller (2004a)) as propose by Lach et al. (2016):

Y can be any of the adjustable specific interaction. Most of the time in practice, only a limited number of the coefficients in Eq. (9) are necessary.

## 4.1. OPTIMIZATION OF INTERACTION PARAMETERS

The interaction parameters  $\lambda_{CO_2,CO_2}$ ,  $\lambda_{CO_2,a}$ ,  $\lambda_{CO_2,c}$  and  $\zeta_{CO_2,c,a}$  of the Pitzer model in Eq. (8) were determined using experimental CO<sub>2</sub> solubility data. First, the interaction parameters were optimized for a simple CO<sub>2</sub>-H<sub>2</sub>O system and then for systems containing salt, NaCl and Na<sub>2</sub>SO<sub>4</sub>, respectively. The data set used for the optimization process are presented in Table 1 for the CO<sub>2</sub>-H<sub>2</sub>O system and, for the CO<sub>2</sub>-H<sub>2</sub>O-Na<sub>2</sub>SO<sub>4</sub> systems, the variable of the constant of

The optimizations were carried out by coupling PhreeSCALE with PEST (Doherty, 2004) according to the following principle (André et al., 2009). PEST calls PhreeSCALE to calculate target properties of the chemical systems of interest (e.g.  $CO_2$  solubility), by using an initial set of values for the parameters to estimate (e.g., specific interaction parameters). The calculation results are then compared to the experimental properties values by calculating the objective function characterizing the deviation from the experimental data. If the convergence criterion is not satisfied, a new series of calculations is launched with a new set of parameters. Optimization is carried out by successive iterations of this procedure until the convergence criterion is satisfied or if there is no more evolution of the results.

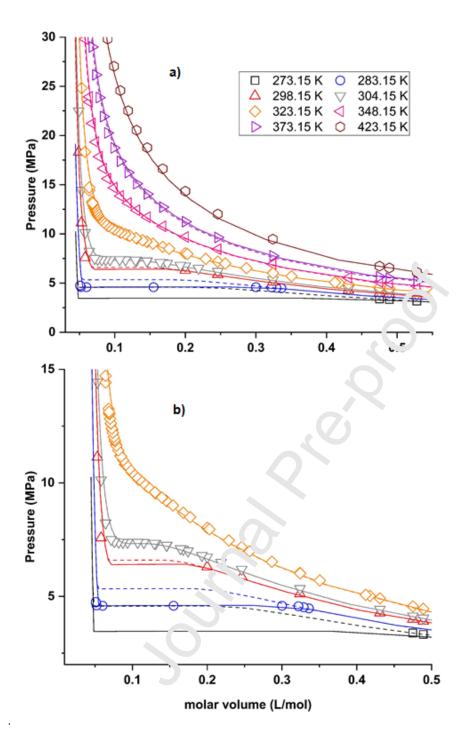
## 4.2. IMPROVEMENTS IN THE RESOLUTIC NO1' THE EOS PENG-ROBINSON

In PHREEQC code, the properties of the give one phase is computed by the Peng-Robinson equation of state when all constituents own their crucial pressure, critical temperature and acentric factor reported in the thermodynamic database. Thus, the cubic equation of state is solve using the Cardan approach (see e.g. Nickalls (1993)), the equation gives three roots and it is necessary to make a choice.

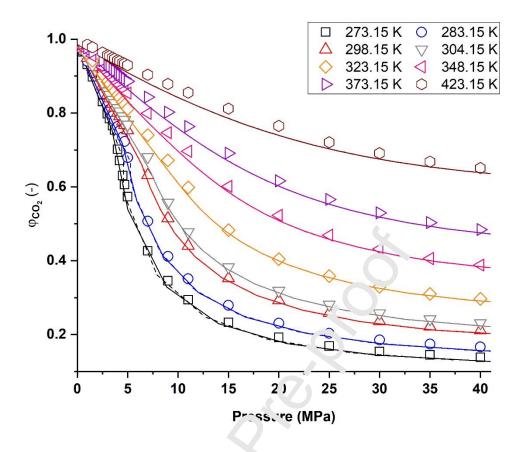
Cubic equations of state have three roots for molar volume, two of which can be complex numbers depending on the sign of the determinant. The values of  $V_m$  with physical significance are always real and positive numbers and greater than those of the constant b since b represents the minimal molar volume of the compound (see Eq. 3). For an isotherm at  $T > T_c$  (critical temperature), the solution of  $V_m$ , at any positive value of pressure, provides only a positive real root. For the critical isotherm ( $T = T_c$ ), this is also true, except for the critical pressure, in which there are three roots, just like  $V_m$  at the critical point. For isotherms  $T < T_c$  (i.e. when the discriminant is negative), the equation can display one or three real roots, depending on the pressure. Although these roots are real and positive, they do not represent stable physical states for the part of an isotherm located between the saturated liquid and the saturated vapor. In the original version of PHREEQC, the larger root (i.e. the one corresponding to gas) is chosen. Actually, the code calculate only this root.

Thus, the description of  $CO_2$  behavior for temperatures below 304.15 K with the original PHREEQC code remains limited as explained by Appelo et al. (2014). Aiming the applicability of the model also at lower temperatures, the PhreeSCALE code was modified so that it was possible to go beyond the critical point: we inserted the calculation of all roots of the cubic equation of state and an

equilibrium condition able to choose the relevant root to use in subsequent calculation. The modification of PHREEQC consisted mainly to implement in the source code the Maxwell construction (CLERK-MAXWELL, 1875). Thus, such a change is clear as shown in Figure 1, comparing with experimental data and the PHREEQC code. This will also have a direct impact on the calculation of the gas fugacity, as shown in Figure 2. The comparisons with the experimental data for the molar volume (Michels et al., 1937, 1935; Michels and Michels, 1935) and with the Duan Polynomial for the fugacity coefficient (Duan et al., 2006; Duan and Sun, 2003) were made to show that the results are essentially the same.

Thus, the possible improvement window pointed out by Appelo et al., 2014 could be exploited in this work, and the correction made to the code extends our calculation capacity below the critical temperature of  $CO_2$ .

#### 5. RESULTS AND DISCUSSIONS

The characterization of interaction parameters to implement the Pitzer database is always challenging, whatever the studied system, the main issue being the consistency of the database. The success in determining new parameters depends on the methodology applied. Here, we proceed step by step: the solubility of the gas in pure water is considered first, then in NaCl and, finally, in aqueous  $Na_2SO_4$  solutions. At last, the model of gas solubility is applied to more complex systems like the salt mixture  $NaCl-Na_2SO_4$  solutions.

Before dealing with CO<sub>2</sub> solubility in brine systems, a focus must be done on the CO<sub>2</sub>-H<sub>2</sub>O system. Many numerical studies deal with this chemical system among them Shock and Helgeson (1988), Schulte et al. (2001), Plyasunov and Shock (2001), Springer et al. (2012), Appelo et al. (2014). All of these studies revisit the HKF (Helgeson-Kirkham-Flowers) parameters in order to calculate the Log K of the reaction  $CO_2(g) \leftrightarrow CO_2(aq)$ , but also volumic properties of the solution (standard partial molar volume, density, heat capacity...).

To model the CO<sub>2</sub> solubility when the system deviates from ideality, authors determined a lambda Pitzer interaction parameter ( $\lambda_{CO_2,CO_2}$ ) to take into account specific interactions between the CO<sub>2</sub> aqueous species. Li and Duan (2007) defined a lambda parameter dependent in temperature and pressure whereas Appelo et al. (2014) considered a parameter that on v varies with temperature.

In this study, we tested all these approaches in order to ccmpa e the results of the numerical calculations with experimental data for a variety of thermodyna nic l roperties:

- CO<sub>2</sub> solubility measurements listed in Figures 10 and 11 (Supplementary Data);
- Solution density (experimental data from McBride-Wrig): et al., 2015);
- Standard partial molar volume of CO<sub>2(aq)</sub> at infini e *i* ution (McBride-Wright et al., 2015);
- Heat capacity (Barbero et al., 1983; Hnědkovs' v and Wood, 1997).

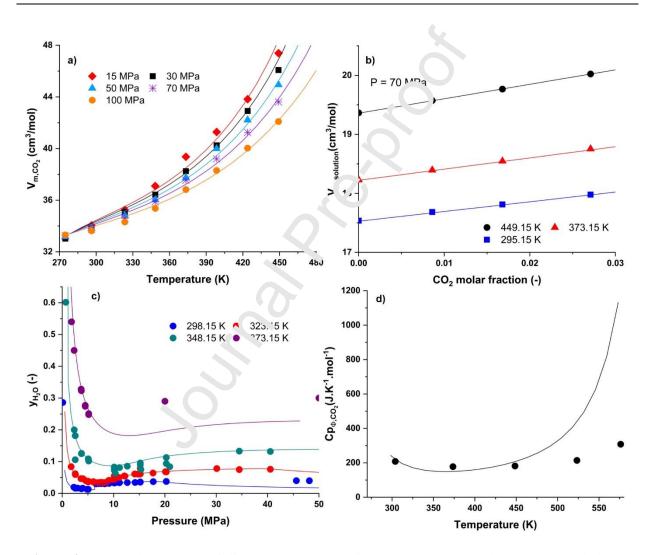
It was found that none of the sets of nor'el parameters available in the literature can accurately calculate all the properties of the solution and the dissolved species (Parmentier et al., 2016). The models of Shock and Helgeson (1988) at Schulte et al. (2001) represent the CO<sub>2</sub> solubility data up to high pressure and temperature. However, their HKF parameters don't allow modelling the standard partial molar volume of  $CO_{2(aq)}$  and the solution molar volumes published many years later by McBride-Wright et al. (2015) (Cota not shown here). The approach of Plyasunov and Shock (2001) are also tested but, as indicated by the authors, their extension of the revisited HKF model to the neutral species does not bring a relevant improvement especially for the volume properties. At last, the model proposed by Appel et al. (2014) allows determining the solubility of CO<sub>2</sub> up to high temperature and pressure, but no  $c_1$  and  $c_2$  parameters are given, preventing heat capacities calculations of solutions. This led us to revisit some of these thermodynamic parameters.

Concerning the HKF parameters, i.e.  $a_i$  (i = 1 to 4) and  $\omega_i$  the values proposed by Appelo et al. (2014) allow calculating the molar volume of dissolved CO<sub>2</sub> with accuracy (Figure 3a). It was decided to keep these parameters (Table 3) and to estimate only  $c_1$  and  $c_2$  parameters, needed for the calculation of the heat capacity, which were not given by the authors. These parameters are estimated using PEST software and the heat capacity data from Hnědkovský et al. (1997).  $c_1$  and  $c_2$  values allow reproducing the heat capacity of dissolved CO<sub>2</sub> up to 450 K (Figure 3d).

Then, from these estimated HKF parameters, the  $\Delta G^{\circ}$  of the reaction  $CO_2(g) \leftrightarrow CO_2(aq)$  is estimated leading to the determination of Log K at different temperatures. According to the formalism selected in the PhreeSCALE code, the variation of Log K according to temperature is given by the Eq.10:

The estimation of the five parameters is by minimizing the least-square solution leading to the following values:  $A_1$ =109.534; A2 =0.019913; A3 = -6986.04; A4 = -40.83; A5 = 669370. These parameters are not new since they were already used in a previous version of the Pitzer.dat database released with PHREEQC code and that uses the same temperature function as Eq.10. They are valid between 273.15 K and 523.15 K.

Finally, we decided to use the temperature variation of the interaction parameter  $\lambda_{CO_2,CO_2}$  proposed by Appelo et al. (2014). However, since he temperature-function polynom are different in PHREEQC and PhreeSCALE (see equation 9) the factors of the polynomial function are reinterpreted (Table 4).

Figure 3 shows that all the properties of the solution that can be described correctly with this new parametrization, and that the solubility of  $CO_2$  in pure water is also well reproduced (see Supplementary Data).

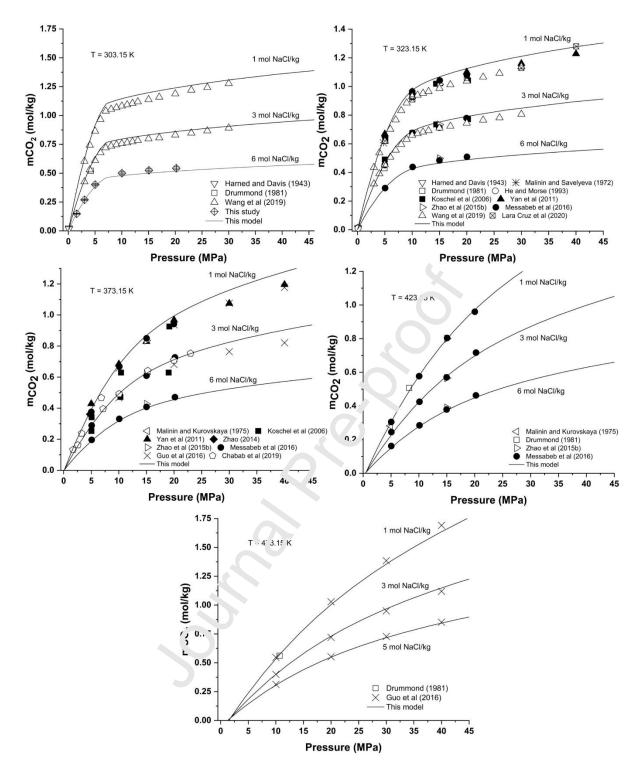
In the end, this consistency in the thermodynamic properties of aqueous  $CO_2$  implies a revision of the models describing the solubility of this gas in brines.

#### 5.2. CO<sub>2</sub>-Na<sup>+</sup>-Cl<sup>-</sup>-H<sub>2</sub>O SYSTEM

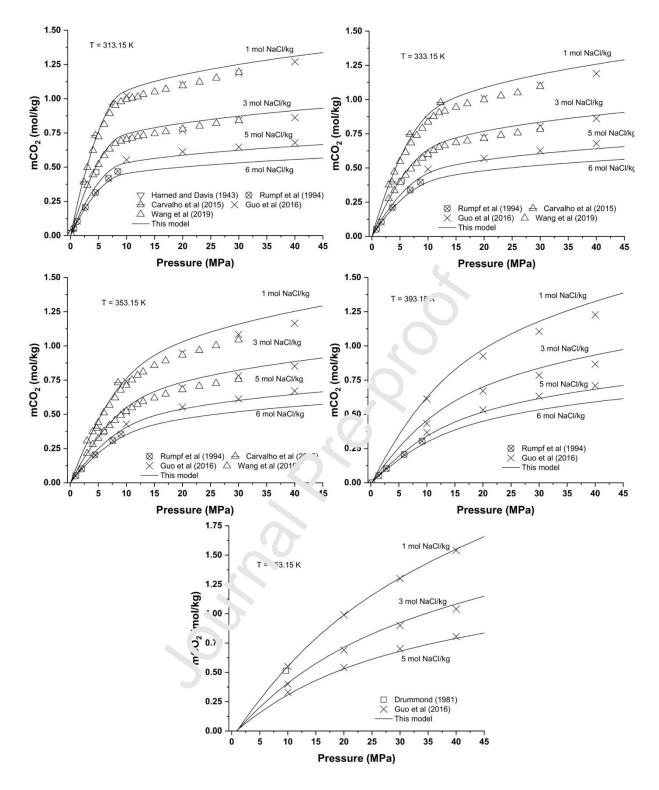
Many parameters can be envisaged to fit the experimental data. However, in order to avoid over parameterization, the objective is to reduce as much as possible their number in the modeling. According to previous studies (Duan et al., 2006; Duan and Sun, 2003; Shi and Mao, 2017), it is assumed that  $\lambda_{CO_2,CI^-}$  is zero. Two parameters are then investigated:  $\lambda_{CO_2,Na^+}$  and  $\zeta_{CO_2,Na^+,CI^-}$ . A first attempt consisted to consider a constant parameter  $\lambda_{CO_2,Na^+}$  (independent of temperature) without the ternary parameter ( $\zeta_{CO_2,Na^+,CI^-} = 0$ ), but we have identified a very strong influence of temperature. We therefore went to look for a temperature dependent parameter  $\lambda_{CO_2,Na^+}$  (Eq. 9) which was also done by previous authors (Christov and Møller, 2004a; Møller, 1986). Because of the high carbon concentrations in solutions, the pH of the NaCl-bearing securic is is ranging between 2.5 and 3.9 (Li et al., 2018), i.e. far below the pKa of the  $CO_{2(aq)}/HCO_3^-$  complet. Consequently,  $CO_{2(aq)}$  is the main carbon species in solution and no interaction parameters w = 1 itted for  $HCO_3^-$  species. According to this speciation, pH calculations have been done  $w = 2\pi^2 - 2\pi^2 - 3\pi^2 - 3$ 

However, the temperature dependence was not sufficient to correctly fit the experimental data and we found an influence of me ality rather at 323.15 K and 373.15 K. We added the ternary  $\zeta_{CO_2,Na^+,Cl^-}$  (independent of temperature) to reduce the effect of the salt concentration. It is also consistent with the approaches of J uan et al. (2006), Duan and Sun (2003), Mao et al. (2013) and Shi and Mao (2017), who use  $1 \lambda_{C,J_2,Na^+}$  and  $\zeta_{CO_2,Na^+,Cl^-}$  parameters. The parameters are a function of temperature in addition to being a function of pressure too for these authors.

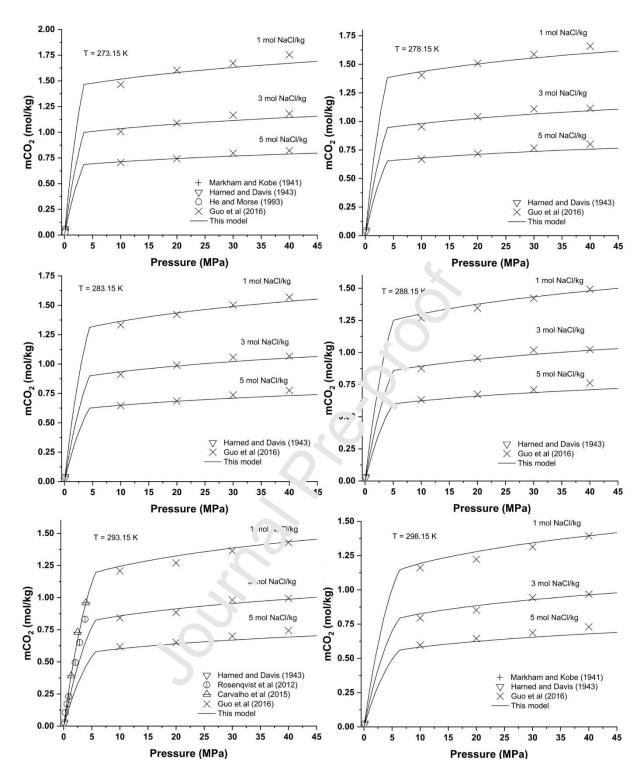
Figures 4-6 show that the measured  $CO_2$  solubilities in aqueous NaCl solutions calculated are in good agreement with the model proposed in this work. Covering a wide range of NaCl temperature, pressure and concentration. The solubility of  $CO_2$  increases with increasing pressure and decreases with increasing temperature, as well as decreasing with increasing salt concentration. The model proposed in this study is capable of covering a wide  $T - P - m_{salt}$  range (273.15-473.15 K, 0.1-40 MPa and 0-6 mol/kg) for  $CO_2$ -H<sub>2</sub>O-NaCl system.

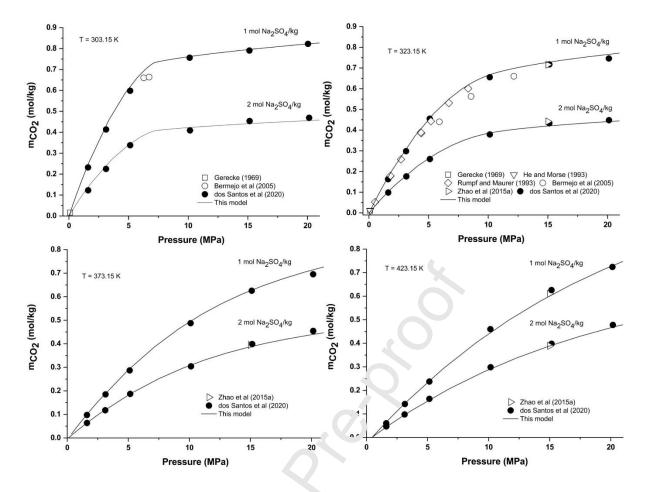
## 5.3. CO<sub>2</sub>-Na<sup>+</sup>-SO<sub>4</sub><sup>-2</sup>-H<sub>2</sub>O SYSTEM

Finally, the investigations focused on the Na<sub>2</sub>SO<sub>4</sub> system. Since the binary  $\lambda_{CO_2,Na^+}$  is already defined, the  $\lambda_{CO_2,SO_4^{2^-}}$  interaction parameter is to be considered. In a first step, no ternary parameter is

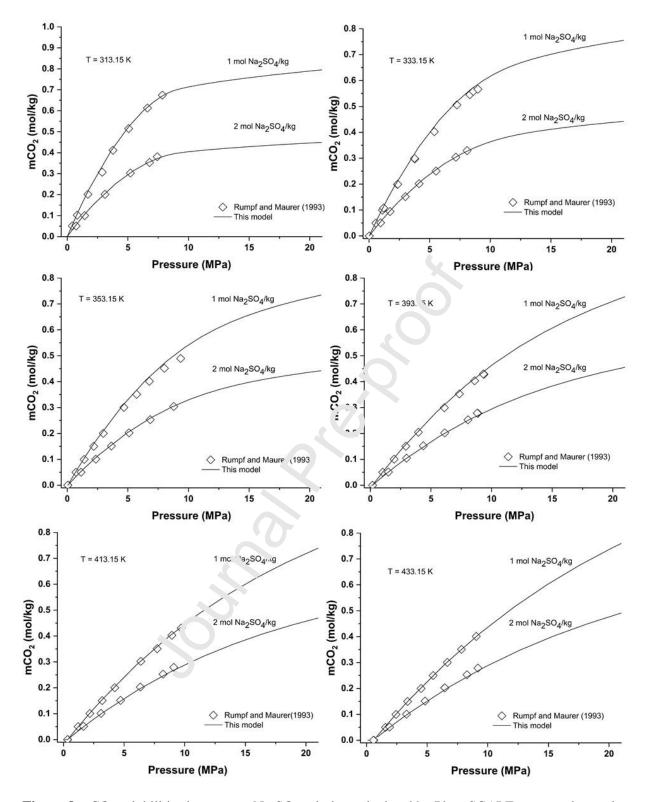
selected. The experimental data used for the parameterization are only issued from dos Santos et al. (2020) (see Table 2). These data covered the temperature range 303.15-423.15 K and the pressure range 1.5-20 MPa whereas the  $Na_2SO_4$  concentration is 1 and 2 mol.kg<sup>-1</sup>.

For the  $CO_2$ -H<sub>2</sub>O-Na<sub>2</sub>SO<sub>4</sub> system, like for the previous system, the first step consisted in selecting the adequate species in solution. The pH values calculated using different thermodynamic databases are ranging between 3 and 4, i.e. far above the pKa of the HSO<sub>4</sub><sup>-/</sup>SO<sub>4</sub><sup>-2</sup> couple and far below the pKa of the  $CO_{2(aq)}/HCO_3^{-}$  couple. These calculations are also consistent with data published by Anabaraonye (2017). Consequently, Na<sup>+</sup>, SO<sub>4</sub><sup>-2</sup> and CO<sub>2(aq)</sub> are the main species in solution.

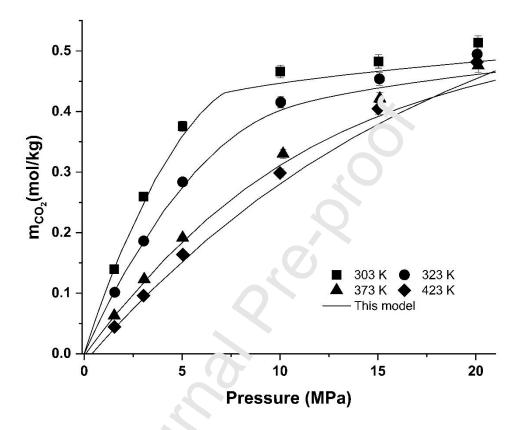


**Figure 8** –  $CO_2$  solubilities in aqueous  $Na_2SO_4$  solution calculated by PhreeSCALE vs. experimental data (Rumpf and Maurer, 1993).

For the CO<sub>2</sub>-H<sub>2</sub>O-Na<sub>2</sub>SO<sub>4</sub> system, the influence of the salt concentration is much less strong than for the NaCl, so it was possible to work without ternary parame  $\zeta^{-}(\zeta_{CO_2,Na^+,SO_4^{2-}} = 0)$ , as was it adopted by Shi and Mao (2017). Only a temperature dependence for  $\lambda_{CO_2,SO_4^{2-}}$  is needed to fit the experimental data. Shi and Mao (2017) comments in their work that the binary parameter  $\lambda_{CO_2,SO_4^{2-}}$ cannot be seen as a simple constant when they are comparing their model to that of Duan et al. (2006), which treats  $\lambda_{CO_2,SO_4^{2-}}$  as a constant. Shi and Mao (2017) presents the binary parameter as a function of temperature and pressure, despite the influence of pressure being negligible. Thus, describing  $\lambda_{CO_2,SO_4^{2-}}$  as an equation is coherent to cover a wide range of temperature, pressure and concentration. The results of the interaction parameters and shown in Table 4. Figures 7 and 8 show that the CO<sub>2</sub> solubilities in aqueous Na<sub>2</sub>SO<sub>4</sub> solution from this model are in agreement with the experimental data. The model is capable of covering a  $\sqrt{1 - P} - m_{salt}$  range, 288-433 K, 0.1-20 MPa and 0-2 mol/kg.

## 5.4. CO<sub>2</sub>-H<sub>2</sub>O-MIXED SALT SYSTEMS

The results of CO<sub>2</sub> solubility for the CO<sub>2</sub>-H<sub>2</sub>O-NaCl and CO<sub>2</sub>-H<sub>2</sub>O-NaCl-Na<sub>2</sub>SO<sub>4</sub> system were obtained at an ionic strength of 6 mol/kg and at 4 different temperatures, 303.15 K, 323.15 K, 373.15

K and 423.15 K, at a pressure range between 1.5 MPa and 20 MPa. All experimental data are reported in Table 7, thus the deviations of the model in relation to the experimental data and the AAD values. The Figure 9 compare all experimental solubilities of  $CO_2$  in NaCl-Na<sub>2</sub>SO<sub>4</sub> solutions in this study with the model respectively at 303.15 K, 373.15 K and 423.15 K.

The model proposed through the optimization of single-salt systems, NaCl and then  $Na_2SO_4$ , is capable of reproducing the mixed-salt solutions a wide  $T - P - m_{salt}$  range, 298.15-423.15 K, 0.1-20 MPa and 0-3 mol/kg.

#### 5.5. AAD'S CALCULATIONS

Tables 5 and 6 show the average absolute deviations (AAD) between the proposed model  $(m_{CO_2,i}^{cal})$  and the experimental  $(m_{CO_2,i}^{exp})$  CO<sub>2</sub> solubility data in aqueous systems containing NaCl and Na<sub>2</sub>SO<sub>4</sub>. As well as Figs. 3-9 show the comparison between the experimental data and our model.

Where Np is the number of points.

The model was also tested for different temperatures and concentrations on data published in the literature that were not used in the optimization process. Almost 560 data were analyzed for NaCl, with the overall AAD of approximately 5%. As for Na<sub>2</sub>SO<sub>4</sub>, almost 180 data have been analyzed and the overall AAD is approximately 4%. The AAD calculations were also done by salt concentration to show the model's capacity to reproduce solubility data at high salt concentrations. If we look at the AAD values for concentrations close to the saturation of the salts (6 mol/kg for NaCl and 2 mol/kg for Na<sub>2</sub>SO<sub>4</sub>), we see that the values are below 4%, more precisely 3.6% for NaCl and 3 % for Na<sub>2</sub>SO<sub>4</sub>, respectively.

In general, observing the calculated isotherms and experimental data, the model is capable of satisfactorily reproducing pressures up to 20 MPa. Given the temperatures between 273.15-313.15 K and 453.15 and 473.15 K, we see that the model is capable of catisfactorily describing solubility points up to 40 MPa. Notably the data by Guo et al. (2016) that have an AAD below 4% for all molalities. Important fact, if we look at Table 3, we see that ( uo s data were used only to optimize the parameters at 473.15 K, showing the extensibility for temperature of our model (temperatures below 303.15 K).

Despite the little data available .\* concentrations of NaCl close to saturation, we see when analyzing the Figures 4-6 and Table 5, .nc. the model is capable of reproducing such available points. The points of Rumpf et al. (1994), v in the were also not used in the optimization process, its 69 points were reproduced by the model that obtained an AAD below 3.3%. Showing the extensibility for concentration of salt of our model to swell. Also confirming this good extension of the model, with the experimental data acquired in this work at 6 mol/kg of NaCl at 303.15 K, the AAD value was 3.24%.

Analyzing the isoth rms between 313-393 K for the  $CO_2$ -H<sub>2</sub>O-NaCl system, it is possible to notice more notable deviations between the simulations generated by the model and experimental points of Guo et al. (2016) and Wang et al. (2019), which can reach up to 7 % and 7.7% respectively. The deviations are more marked in the isotherms at 1 mol/kg in this temperature range, having a good behavior up to 15 MPa, then the deviations become more marked. Note that when we increase the salt concentration, such deviations decrease. An attempt to satisfy these points was made, significant improvements were obtained in the AAD values at 1 mol/kg and 3 mol/kg, but the results were considerably degraded at 5 and 6 mol/kg globally. Reaching AAD values of up to 11% and 14% for isotherms at 5 and 6 mol/kg, respectively. Thus, as we aim to propose a model that can reproduce  $CO_2$  solubility data in saline systems that can reach saturation, we decided to keep the proposed configuration.

Duan and Sun (2003) proposed a model which is widely used in several studies with regard to the CO<sub>2</sub>-H<sub>2</sub>O-NaCl system, where the CO<sub>2</sub> solubility can be coloriated with an accuracy of 5 % (Li and Duan, 2011). In view of this set of data, Table 5 shows (see also Appendix B) the good coherence of the proposed model (AAD of 5%), not only with the experimental data but with the Duan's models as well (Duan et al., 2006; Duan and Sun, 2003; Li and Dran, 2011).

Distinctly that NaCl, the system containing so in n sulfate presents much less data available in the literature (Table 1). Only dos Santos et al. (2020, dataset was used for  $\lambda_{CO_2,SO_4^{2-}}$  optimization and analyzing the results of AAD and Figures 7 and 8, we see how the proposed model is able to satisfactorily predict the experimental data (AAD approximately 3 %).

With the exception of Bermeje et al. (2005), all simulation results have AAD lower than 5 %. For Gerecke (1969) points, values below 2 % were obtained and for Zhao et al. (2015a), values below 2.3 %. Despite not being considered for optimization, the model was able to accurately simulate the 102 solubility data generated by Kumpf and Maurer (1993) at different temperatures, concentrations and pressure (AAD < 4 %) as highlighted in Figures 8.

Sun et al. (2021) showed that the AAD calculated for the Man's model (Duan et al., 2006; Duan and Sun, 2003) for the CO<sub>2</sub>-H<sub>2</sub>O-Na<sub>2</sub>SO<sub>4</sub> system is 27.33 % (ov r  $\ge$ 15 evaluated data) probably because of the absence of the interaction parameters  $\lambda_{CO_2,SO^2}$ . Table 7 shows how the new experimental data - remembering that they were not used in the model creation process - are consistent vit' the model's predictions. In general, the AAD values are less than 4%, only 423 K for the matture that is less than 4.5%. Observing the values in Table 7 and Figure 9, we can highlight that for the NaCl+Na<sub>2</sub>SO<sub>4</sub> isotherm that the biggest differences are between the highest pressure values and that when we increase the temperature, the AAD values increase, however, globally, the model continues to respond well to experimental data. It is also important to note that the model is able to represent Yasunishi et al. (1979) experimental data very well. The average absolute deviations were calculated and it is about 1.65 %. Even if these data are not used at any point in the optimization process, the model is able to represent them perfectly and it is usable from very low to very high ionic strength.

In addition to single-salts aqueous systems containing NaCl or  $Na_2SO_4$ , the model proposed by Li and Duan (2011) can reproduce the experimental  $CO_2$  solubility data in the  $CO_2$ -H<sub>2</sub>O-NaCl-Na<sub>2</sub>SO<sub>4</sub>

system. The superiority of the model developed in the present work for this system is here again demonstrated by the comparison of the global AAD: < 5% for the present model versus < 10% for the Li and Duan's one (see also Appendix B).

#### 6. CONCLUSIONS

An improved  $\gamma - \varphi$  equilibrium model was presented to calculate the CO<sub>2</sub> solubility in aqueous solutions containing NaCl and Na<sub>2</sub>SO<sub>4</sub> covering a wide P – T – m<sub>salt</sub> range of 273.15–473.15 K, 0.1–40 MPa and 0–6 mol/kg with great precision to the experimental data available in the literature. The chemical equilibrium was described by PhreeSCALE software (Lach et al., 2016), which is based on the equations of Appelo et al. (2014). Using the available experimental data, it was possible to propose a new set of specific interaction parameters. for Pitzer's formulation. The optimizations of the Pitzer interaction parameters occurred at first in th  $\geq$  CO<sub>2</sub>-H<sub>2</sub>O system, then CO<sub>2</sub>-H<sub>2</sub>O-NaCl and finally, CO<sub>2</sub>-H<sub>2</sub>O-Na<sub>2</sub>SO<sub>4</sub>. The average at solu  $\geq$  deviations (AAD) were also calculated to compare the results of the simulations and the  $\langle x \rangle$  perimental data, more than 700 points were compared and the AAD values globally were less th in 5 %.

In addition, new CO<sub>2</sub> solubility data in  $a_4u$  ous NaCl and NaCl-Na<sub>2</sub>SO<sub>4</sub> solutions were measured at temperatures from 303 to 423 K, the only strengths from 6 mol/kg and a pressure range between 1.5-20 MPa. The comparison with the model was made and it is worth highlighting its capacity to reproduce the experimental data of the system containing salt mix, CO<sub>2</sub>-H<sub>2</sub>O-NaCl-Na<sub>2</sub>SO<sub>4</sub>. In this way, the model created from the optimization of the Pitzer parameters in single-salts systems, is capable of reproducing mixe t-salt systems for NaCl and Na<sub>2</sub>SO<sub>4</sub> equally well. Thus, the proposed model has great value to a sist studies and projects in the area of CO<sub>2</sub> injection in deep saline geological formations in CCS, contributing to the mitigation of global warming.

#### SUPPLEMENTARY DATA

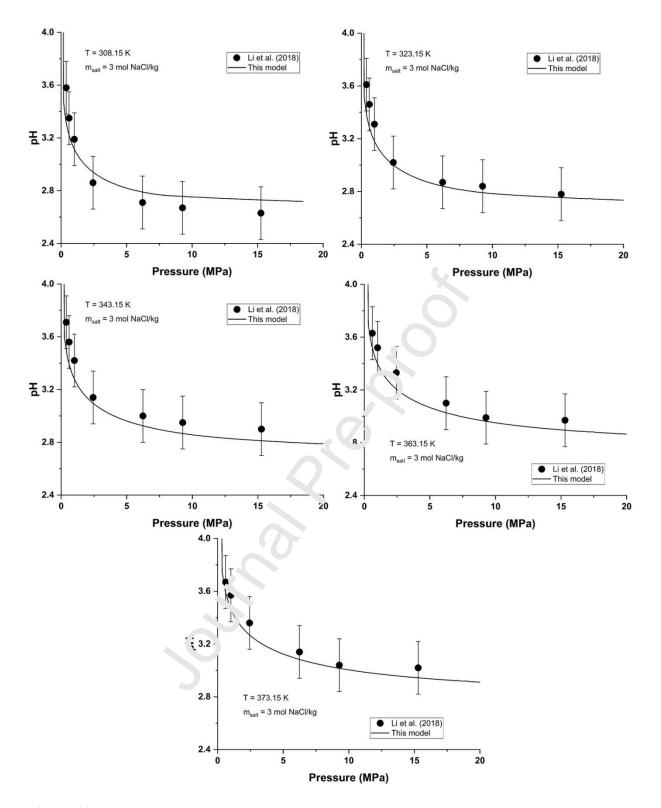
**Figure 10** –  $CO_2$  solubility in pure water from 273.15 to 323.15 K: symbols are experimental data (Table 1) whereas lines are calculated data with PhreeSCALE and the interaction parameters of the Pitzer model given in the text (Table 4).



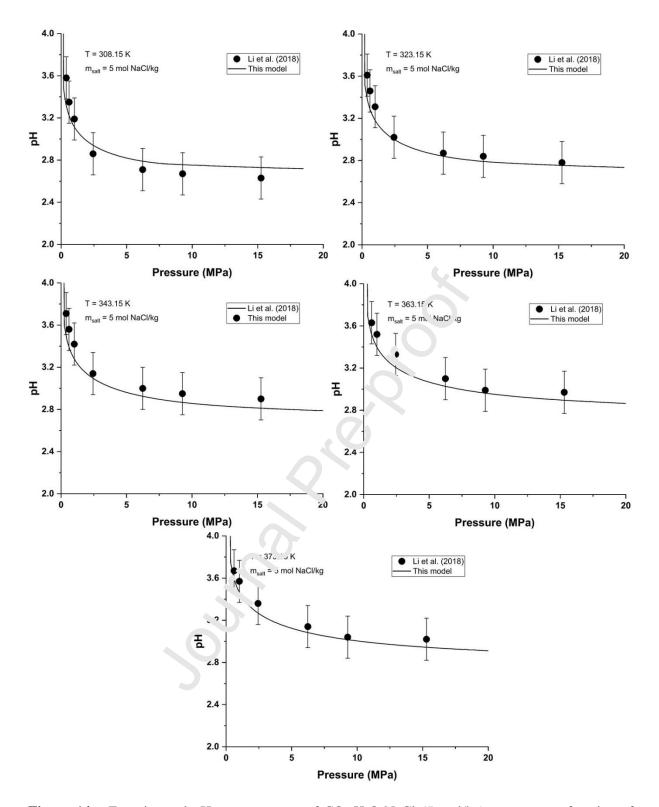
**Figure 11** –  $CO_2$  solubility in pure water from 373.15 to 448.15 K: symbols are experimental data (Table 1) whereas lines are calculated data with PhreeSCALE and the interaction parameters of the Pitzer model given in the text (Table 4).

The literature references used by the present work for experimental measurements of phase equilibrium in the  $CO_2$ -H<sub>2</sub>O system are found in Table 8. Details of the experimental information, including authors, number of measurements, temperature and pressure ranges are shown in Table 8. Measurements of the solubility of  $CO_2$  in the aqueous phase are gathered from 102 available literature studies. Figures 10 and 11 show the reproduction of experimental data for  $CO_2$ -H<sub>2</sub>O by the present model.

Figures 12, 13 and 14 refer to the model calculations regarding pH in  $CO_2$ -H<sub>2</sub>O-NaCl systems, compared to experimental data (Li et al., 2018).

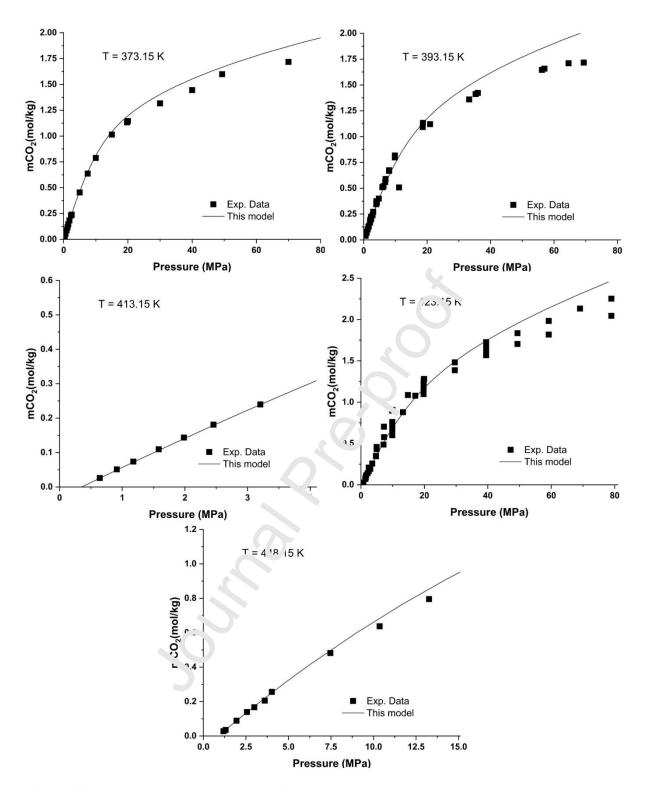

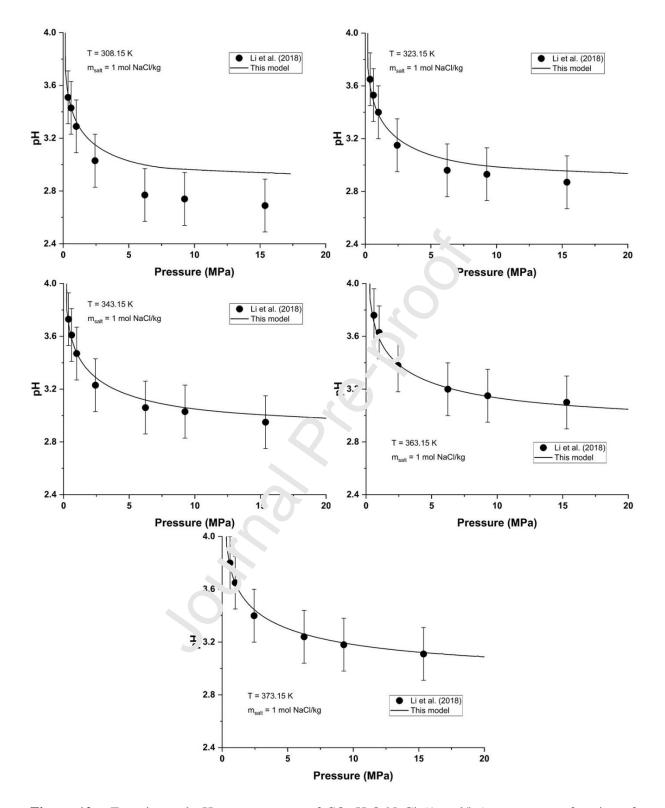
